Tuesday, January 24th, 1928.

THREE O'CLOCK P.M.

This being the first day of the fourth meeting of the Sixteenth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable ROBERT RANDOLPH BRUCE, Lieutenant-Governor of the Province, dated the 15th day of December, 1927,

His Honour Robert Randolph Bruce, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I welcome you to this the Fourth Session of the Sixteenth Parliament of British Columbia. Since you last met the Province has suffered a severe loss in the death of the late Premier, Honourable John Oliver, whose passing was deeply mourned by all our people. His unselfish public service and high personal character will long be an inspiration to the people of this Province.

The year 1927 was an eventful one in the history of Canada as marking the Sixtieth Anniversary of Confederation. British Columbia joined with her sister Provinces in celebrating this occasion, which was happily accompanied by general prosperity throughout the Dominion.

In connection with the Diamond Jubilee, the Dominion was honoured by a visit from His Royal Highness the Prince of Wales and His Royal Highness Prince George. Their Royal Highnesses included British Columbia in their tour and were most loyally received. Their presence served to awaken renewed expressions of attachment of our people to the Throne.

The Province was further honoured by the first official visit of His Excellency The Viscount Willingdon as Governor-General of Canada, who was accompanied by Her Excellency the Viscountess.

The Dominion was also favoured by a visit from the Right Honourable Stanley Baldwin, Prime Minister of Great Britain, and is now further favoured by a visit from the Right Honourable L. C. M. S. Amery, Secretary of State for Dominion Affairs. There is no doubt that the effect of the presence of these distinguished visitors will be to consolidate still more firmly the unity of the Empire.

My Premier and my Attorney-General represented the Province at the Dominion-Provincial Conference held in Ottawa last November. The Conference was conducted with entire harmony. There is reason to hope that the result will be an adjustment of the outstanding differences between the Dominion and the Province that will be of general material benefit.

PROVINCIAL LIBRARY, VICTORIA, B. C.

I am pleased to note that throughout the year just closed there has been a continued improvement in business conditions as indicated by greater production in our basic industries, increased bank clearings, and continued activity in the building trade.

I am pleased also to note that the credit of the Province continues to stand high in the money markets of the world.

Since you last met the "Old-age Pensions Act" has been brought into operation with beneficent results.

Upon the request of my Ministers His Excellency the Governor-General in Council was pleased to appoint a Commissioner, the Honourable Mr. Justice William Melville Martin, to inquire into the claim of this Province for the reconveyance by the Government of Canada of the Railway Belt and the Peace River Block. The Commission has completed its investigations and it is anticipated that the Report of the Commissioner will shortly be presented.

A Bill to ratify the amalgamation of the City of Vancouver and the Municipalities of South Vancouver and Point Grey will be placed before you.

Amendments to various Acts will be submitted for your consideration.

The Report of the Special Commissioner appointed to investigate the irrigation problem in the dry belt will be presented to you.

The Reports of the various Departments of my Government, the Public Accounts, and the Estimates for the coming fiscal year will be submitted for your consideration.

I leave you in the hope that the work of the Session will inure to the benefit of the people of British Columbia and I pray that the blessing of Providence may rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. Charles de V. Schofield, Bishop of Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

On the motion of the Hon. Mr. Manson, Bill (No. 1) intituled "An Act to amend the 'Notaries Act'" was introduced, read a first time, and Ordered to be read a second time at the next sitting.

On the motion of the Hon. Dr. MacLean, seconded by the Hon. Mr. Sloan, it was Resolved,—
That the Speech of His Honour the Lieutenant-Governor be taken into consideration at the next sitting of the House, and that this Order have precedence over all other business, except the introduction of Bills, until disposed of.

Ordered, That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

Resolved, That if it shall appear that any person hath been elected or returned a member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

James Albert McDonald, Esquire, having been duly sworn, was introduced by the Hon. the Premier and the Hon. the Minister of Public Works, and took his seat.

On the motion of the Hon. Dr. MacLean, seconded by Mr. Pooley, it was Resolved,-

That this House place on record its deep sorrow and sense of loss in the death of the late Prime Minister, the Honourable John Oliver, who for many years devoted his great gifts to the service of the Province, and whose high personal character won the respect of all who knew him; and that copies of this Resolution be forwarded to Mrs. Oliver and members of the bereaved family.

"Mr. Speaker,—In accordance with constitutional practice on similar occasions and with the permission of the Crown, it is my duty to acquaint the House with the proceedings which took place consequent upon the lamented death of the Honourable John Oliver on Wednesday, the 17th day of August last.

"Upon the morning of the following day I received His Honour the Lieutenant-Governor's command to await upon him. In the course of the interview the Lieutenant-Governor did me the honour to propose that I should undertake the formation of a new administration. I conceived it my duty to accept the responsibility. I ascertained from my colleagues of the Executive Council that they were content to retain their respective portfolios and I advised His Honour to that effect. On the late afternoon of Saturday, the 20th of August, I again attended upon His Honour and was sworn as President of the Executive Council.

"Some months ago the Honourable Mr. Sloan advised me that his physician had urged upon him the exercise of every care and the avoidance of too great labour until such time as his health was completely restored after his severe illness of some months ago, and Mr. Sloan asked to be relieved of the portfolio of Provincial Secretary. In deference to the request of my colleague I recommended to His Honour the acceptance of the resignation of the Honourable Mr. Sloan as Provincial Secretary and the appointment in his stead of my colleague the Honourable T. D. Pattullo. Mr. Pattullo was sworn as Provincial Secretary on the 30th day of December, 1927."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

The Hon. Mr. Pattullo, on behalf of the Hon. the Premier, replied as follows:—

- "10. Cost of this shovel, \$18,000. It would not have been economical for the Department to have purchased shovel especially for this work.
- "11. 150 cubic yards per day at a cost of approximately \$1.50 per cubic yard. The unit price of 1912 contract on Malahat for similar excavation was \$2.50 per cubic yard."

Mr. Pooley asked the Hon. the Minister of Public Works the following questions:-

- 1. Has the Department built a bridge across the Chilcotin River at Hanceville during the past year?
 - 2. If yes, what was the cost thereof?
 - 3. Was the work done by contract or day-work?
 - 4. If yes, who tendered, what were their bids, and who got the contract?
 - 5. Who supplied the sawed timber for this bridge?
 - 6. What was the contract or agreed price per thousand feet therefor?
 - 7. What was the quantity of timber: (a) Contracted for; (b) supplied?
 - 8. What was the final price per thousand feet paid by the Department for said timber?

The Hon. Dr. Sutherland replied as follows:--

- "1. No. Material being procured for the new bridge.
- "2, 3, and 4. Answered by No. 1.
- "5. C. Spencer, of Chilco Ranch.
- "6. A quotation was submitted to District Engineer and accepted of \$40 per thousand feet B.M.
 - "7. (a) 105,000 feet B.M. approximately; (b) not yet supplied; in course of delivery.
- "8. \$42, on recommendation of District Engineer that timber was considerably cheaper than could be obtained elsewhere and to include stumpage and royalty omitted in original quotation."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.

And then the House adjourned at 4.35 p.m.

Prayers by Mr. Speaker.

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

Proposed questions may not have my approval and may therefore never appear upon the notice paper. Several questions have been sent to the Clerk's table which are obviously in violation of the rules. These have been withheld from the notice paper. Honourable members will find the practice with regard to questions fully dealt with in our Rules and in the 13th Edition of May, pages 238 et seq.

"I am sure that I have only to call the matter to the attention of honourable members to bring about compliance with our Rules."

Mr. Poolcy asked the Hon. the Minister of Lands the following questions:—

- 1. What was the total cost of maintaining the Grazing Commissioner's Department for the years 1925, 1926, up to the end of December, 1927?
 - 2. What was the total revenue received from grazing fees during the said periods?

The Hon, Mr. Pattullo replied as follows:-

- "1. Headquarters and field administration, \$39,771; wild-horse extermination, \$7,881.15; range improvements, \$14,134.23.
 - " 2. \$42,972.63."
