Your petitioners the undersigned actual residents of this Colony, and deeply interested in its prosperity, having viewed with alarm the departure of many of Her Majesty's Loyal Subjects and others from this Colony to the neighbouring Republic,

and having learned that their departure has been induced by the difficulty of obtaining Agricultural Lands at once, on application, and by not being obtainable on such terms as would afford equal encouragement to actual Settlers, in this Colony, as are offered in the neighbouring Republic, and believing that we shall lose many more of Her Majesty's Loyal Subjects and others whom it is desirable to retain, as well as induce those who are now on the way here or desirous of coming, to turn their attention to Countries where greater encouragement is offered to Agriculturalists and pursuaded that except the Land System of the Colony is materially modified, the prosperity and settlement of the Country will be seriously retarded, and believing that the encouragement of Agriculture is the surest way to secure the enduring prosperity of the Country and that a Liberal Land System is best calculated to rapidly populate the Colony, and holding that the Public Lands are the patrimony of the People vested in the Crown for their benefit, and presuming that Your Honorable Body have at heart the well being and prosperity of the Country, and are desirous of introducing those changes which you may deem necessary to secure so desirable a result.

Therefore, Your Petitioners would respectfully submit to your Honorable Body that they humbly pray that the Crown Lands of this Colony may be opened at once to actual Settlers, that a preference may be given to them in the choice of the Public Lands, surveyed or unsurveyed, over Capitalists, that they may be secured in a preëmptive right, that the highest price of Land to actual Settlers may not exceed one Dollar and Twenty Cents per Acre, or such price as will barely cover the Expenses of Survey, and that five Years may be allowed for its payment.

All of which is most respectfully Submitted, hoping that it may please Your Honorable Body to take this our Humble Petition into your favorable consideration, and Your petitioners as in duty bound will every pray.

No. 1.

Government House Victoria, Vancouvers Island 15th July 1859.

To the Speaker and Gentlemen of the House of Assembly.

I have much pleasure in transmitting herewith for your information, copies of a Correspondence with Her Majestys principal Secretary of State for the Colonial Department, relative to the erection of Lighthouses in the Straits of Juan del Fuca, and the approaches to Esquimalt Harbour.

- 2. You will observe that Her Majesty's Government, have in the most liberal manner advanced the sum of Seven Thousand Pounds Sterling in aid of these contemplated works which will so materially promote the commercial progress of this Colony.
- 3. It is my intention to have the exact site selected without delay for one Light House on the Race Rocks, and for a second and smaller light at the Entrance of Esquimalt Harbour: we will then provide materials and enter upon the construction of those important works as soon as we receive drawings of the Lanterns and tops of the Towers, which are daily expected from England for the information of the Engineer who designs the Towers.
- 4. It is the intention of Her Majesty's Government to provide and send from England the Lanterns and Light Apparatus, and it is supposed that the remainder of the Parliamentary Grant of Seven thousand Pounds will be sufficient to meet the expense of the buildings.
- 5. The cost of maintaining those Lights, is to be borne by the Colony, and I have therefore to urge upon the House the propriety of at once entering upon the consideration of the ways and means of meeting that outlay; either by imposing a direct tax on property, or by charging a "Light due" on all ships entering the Harbours of this Colony, or by any other mode of taxation which may appear advisable to the House.
- 6. The House will also be prepared to repay the proportion of the advance of Seven Thousand Pounds chargeable to Vancouvers Island, vizt. One Thousand Seven Hundred and Fifty Pounds.

No. 2. Copy of a Despatch from Governor Douglas to Sir Edward Bulwer Lytton Bt.—(No. 76).

Victoria, Vancouvers Island 15th January 1859.

Sir

I beg you will allow me to solicit your earnest attention to a subject which is one of the highest importance to the progress and prosperity of the Colonies of Vancouvers Island and British Columbia.

2. I allude to the necessity which exists for the early construction of Light Houses upon some of the salient points of the approaches to the Harbours and Anchorages of these Colonies.

- 3. At the present moment however I will only mention two positions which are of the first importance and which the experience of every succeeding day renders more and more evident should be properly lighted at the earliest possible period.
- 4. The first of these is the Race Rocks situated in the Straits of Fuca, between two and three miles from the Mainland of Vancouvers Island, and about 12 miles from the Harbour of Esquimalt. These Rocks or rocky Islets may be viewed as the turning point in the Strait for ships bound to Vancouvers Island, or to the Gulf of Georgia. They form a most dangerous cluster, and the making them out, is, not only an object anxiously sought, but it is one of essential help in the determination of position.

They are mostly above water and the largest of them would be found an admirable situation for placing a Light House. It has some considerable elevation above high water mark, and the materials for building can be found in abundance close to the spot.

The Light at this position should be one of the first order.

5. The next spot upon which I would urge the establishment of a Light House is the Fisgard Rocks, at the Entrance of Esquimalt Harbour, a harbour whose growing importance can scarcely be estimated. It is capacious and secure. Her Majesty's Ships always resort to it, the Admiralty and Military Buildings are also there;—and it is the Harbour to which all Vessels of large size must come and consequently it must be the great Depot of the Ocean traffic.

The entrance being narrow, the back ground composed of high hills exhibiting no remarkable leading marks, and the Coast line adjacent being rugged and full of indentations, the Harbour of Esquimalt presents no characteristic features to guide the mariner to its tranquil security.

During the day the entrance is difficult enough to find to those possessing no previous knowledge of the locality, but at night the difficulties of distinguishing it are so great that the attempt to enter the harbour is never made except by those whose long acquaintance with the coast has rendered them intimately familiar with every peculiarity.

The Establishment of a Light upon Fisgard Rocks would at once unmistakably point out the position of the Harbour and would render access to it, or exit from it, safe and easy at all times.

6. The navigation of the Straits of Fuca, and the inland waters leading from it, is attended with no small amount of danger without the valuable assistance of lights. The Government of the United States have already acted very promptly and liberally in lighting their portion of the Strait.

They have placed a light of the first order upon Tatooch Island, at the Entrance of the Strait, and vessels from seaward are now enabled to continue their course up the strait at all times. This light has a range of 20 miles, and if a light of the first order were placed on the Race Rocks, as I now submit, and a Light of an inferior order upon the Fisgard Rocks, a Vessel running up Fuca Strait would scarcely lose sight of the Tatooch Light before she would discern the Race light, after rounding which she would perceive the Fisgard Light, and thus be enabled to proceed into Esquimalt Harbour without a check, and by such means valuable time would be saved and considerable risk avoided.

- 7. The United States Government have also placed lights upon two other points in the Strait of Fuca. Dungeness, near the entrance of Pugets Sound and upon Smiths' Island near to the Southern termination of the Rosario Strait. The Light at Tatooch Island is undoubtedly of equal advantage to the British possessions in this quarter of the Globe, as to those of the United States, the other lights are also useful; and I therefore conceive that we are in honor bound to reciprocate the benefit.
- 8. I am not aware of any funds that may be appropriated to these objects, nor do I know to what department of State I should properly apply for assistance; the

infant State of the two Colonies precludes the possibility of their being able to help themselves; and the matter being one which it is manifest must materially affect their future development, I trust you will pardon me in bringing it before you, and in earnestly soliciting your aid towards the accomplishment of the desired object.

With reference to my despatch of the 15th Ultimo No. 76, upon the subject of the erection of LightHouses upon two very important positions off the Coast of Vancouver's Island, I have now the honor to submit to you herewith a very complete and valuable Report upon the subject, which has kindly been made to me, in accordance with my request, by Captn. Richards of H. M. S. "Plumper", together with tracings of the line of coast exhibiting the exact positions upon which the Lights should be placed.

No. 4. Copy of a Despatch from Sir E. B. Lytton to Governor Douglas.

Downing Street 11th May 1859.

Sir

I have received your Despatches No. 76 of the 15th of January, and No. 90 of the 4th of February, on the subject of the erection of Light Houses in Fucas Straits and the approaches to Esquimalt Harbour.

I transmit for your information and guidance the copies of a correspondence which has passed between the Admiralty, the Board of Trade, the Treasury, and this Department on the subject.*

You will perceive that the Expense of the construction of the two LightHouses suggested by Captain Richards has been estimated by Captain Sullivan of the Board of Trade at Seven Thousand Pounds, and in compliance with my recommendation the Lords Commissioners of the Treasury have consented to advance this sum on condition that one moiety of it shall be repaid by the Colonies of Vancouver Island and British Columbia jointly.

The Board of Trade have been requested to send out immediately from this Country the necessary apparatus, and to give you any advice or information in their power, and the Lords Commissioners of the Admiralty have been requested to instruct the Naval officers on the spot to give you every assistance by their advice or otherwise to facilitate the work. But you will distinctly understand that the responsibility of the Selection of proper sites and of the superintendence of the work, rests with yourself, and I need not impress upon you the necessity of promptness and energy in carrying out an undertaking which is calculated so materially to promote the commercial progress of the two Colonies under your Government.

With regard to the repayment by British Columbia and Vancouvers Island to the Imperial Treasury of the moiety of the advance of Seven Thousand Pounds, I must leave it to you to decide the proportion of that sum which it would be equitable that each Colony should contribute; but I must instruct you that this debt should be repaid within the earliest practicable period.

John Swanson Esquire, Elected on the 23rd of June, to represent the District of Nanaimo, in the House of Assembly, Came into the House and stated that he was not prepared to Qualify.

Mr. Speaker said in that case he could not take his seat, And declared his Election null and void.

Government House, July 18th, 1859

To the Speaker and Gentlemen of the House of Assembly.

I herewith enclose an "Act to provide for the resignation and vacating of Seats in the House of Assembly of the Colony of Vancouvers Island and for the Election of members on Vacancies."

In transmitting this Bill I wish to inform the House that the Council were of opinion that a measure which would enable Members to resign their seats in the most simple manner possible, whenever through ill-health or any other cause, they wished to do so, was preferable to the expedient proposed by the House of creating an office of Wardens of the Hills for that purpose.

I would further remark that this Bill has been framed with a view to its being hereafter incorporated into a more comprehensive measure for Settling the Constitution of the Legislature, whenever such a measure shall be brought under considera-

tion.

No. 1

Government House, Victoria 3rd August 1859.

To the Legislative Council and House of Assembly of the Colony of Vancouver's Island Gentlemen

I have the honor to communicate for your information intelligence of the landing of a Detachment of United States Troops on the Island of San Juan, avowedly, see Enclosures Nos. 1 & 2, for the purpose of forming a Military Post and of asserting the sovereignty of the United States to that Island.

Having received no intimation from any quarter that the Government of the United States ever contemplated taking Military possession of any part of the disputed Territory, while the Boundary line remained unsettled, I am forced to believe that the late unwarrantable and discourteous act, so contrary to the usages of Civilized Nations, has originated in error, and been undertaken without the authority of that Government.

That impression is corroberated by a letter (a copy of which is herewith enclosed) from the Honble. Wm. L. Marcy, Secretary for the United States, dated Washington, 17th July 1855 to Her Majesty's Minister at Washington, which contains instructions from the President of the United States to the Governor of Washington Territory, and displays in the clearest manner, the conciliatory and moderate views, entertained by his Government on the subject of the disputed Territory.

Though the right of Great Britain to all the Islands situated to the Westward of "Vancouver" or "Rosario" Straits, is to our minds, clearly established by the 1st Article of the Treaty of 1846, and though those Islands have since the foundation of this Colony, been considered as a Dependency of Vancouvers' Island, it is well known to you Gentlemen, that out of respect to the construction that has been put upon that Treaty, by the Government of the United States, we have abstained from exercising exclusive Sovereignty over them.

Convinced that any officious or unjust assumption on either side, of exclusive right to the disputed Territory, would simply be a fruitless and mischevious waste of energy, neither detracting from, nor adding force to, the claims of either Nation; wise and considerate policy enjoins upon us, the part of leaving so important a national question for settlement by the proper authorities, and of avoiding complications foreign to the views and wishes of, and probably embarrassing to, both Governments.

Immediately on being informed of the landing of United States Troops at San Juan, Her Majesty's Ship "Tribune" under the command of Captain Hornby, was dispatched to that Quarter, and soon afterwards a Detachment of Royal Engineers, and Royal Marine Light Infantry, were ordered from New Westminster by Her Majesty's Ship "Plumper" Captain Richards, and those Troops will be landed at San Juan to protect the lives and property of British Subjects.

You will observe Gentlemen from Enclosure No. 1 that the Captain in Command of the United States Detachment of Troops, in a public notice dated 27th of July, assumes the exercise of exclusive sovereign rights in the Island of San Juan, while the President of the United States altogether disclaims such pretensions, and seeks at most to continue the joint right of Sovereignty and domain in common with Great Britain.

We may presume from that circumstance, that the notice in question was framed in ignorance of the intentions of the United States Government, and that the pretensions set forth will not be maintained.

Entertaining such opinions, I have not failed to impress on Her Majesty's Naval Officers, now stationed at San Juan, the desire of Her Majesty's Government, to avoid every course which may unnecessarily involve the suspension of the amicable relations, subsisting between Great Britain and the United States; at the same time those officers have been instructed and are prepared to assert the rights, and to maintain the honor and dignity of our Sovereign and Her Dominions.

1. In compliance with orders and instructions from the General Commanding, a Military Post will be established on this island on whatever site the Commanding Officer may select.

2. All the Inhabitants of the Island are requested to report at once to the Commanding officer in case of any incursion by the Northern Indians, so that he may take such steps as he may deem necessary to prevent any further occurrence of the same.

This being United States Territory, no Laws other than those of the United States Courts, except such as are held by virtue of said laws will be recognised or allowed on this Island.

Sir

I am under some apprehension that collision may take place between Our Citizens and British Subjects, in regard to the occupation of the disputed points along the line between Washington Territory, and the British possessions on the North of it.

In the hope of avoiding such a difficulty I have by the direction of the President, addressed a letter to the Governor of that Territory on the subject, and herewith furnish you with an extract from it.

I presume that the Government of H. B. M. will be willing to recommend to Her Subjects along the boundary in question, a similar course until the line can be established.

In that way I sincerely hope all collision may be avoided.

State Department, Washington. July 14th 1855.

The President has instructed me to say to you that the officers of the Territory should abstain from all acts on the disputed grounds, which are calculated to provoke any conflicts, so far as it can be done, without implying the concession to the Authority of Great Britain of an exclusive right over the premises.

The title ought to be settled before either party should exclude the other by force, or exercise complete and exclusive Sovoreign rights within the fairly disputed limits.

Application will be made to the British Government to interpose with the local authorities on the Northern borders of our Territory to abstain from like acts of exclusive ownership, with the explicit understanding that any forbearance on either side to assert the rights respectively, shall not be construed into any concession to the adverse party.

By a conciliatory and moderate course on both sides, it is sincerely hoped that all difficulties will be avoided until an adjustment of the boundary line can be made in a manner mutually satisfactory.

The Government of the United States will do what it can to have the line established at an early period.

CORRESPONDENCE BETWEEN GEN. HARNEY AND GOV. DOUGLAS GEN. HARNEY'S LETTER TO GOV. DOUGLAS

Head-Quarters Department of Oregon, Fort Vancouver, W.T., Aug. 6th, 1859.

His Excellency, James Douglas, C.B., Governor of Vancouver's Island, &c., and Vice Admiral of the same.

Sir: I have the honor to inform you of the receipt of an official copy of a protest made by you to the occupation of San Juan Island, in Puget Sound, by a company of United States troops under my command.

This aforesaid copy was furnished by Capt. Hornby, of Her Majesty's ship Tribune, to the United States officer in command at San Juan Island, Capt. George Pickett, of the 9th Infantry of the American army, together with a communication threatening a joint occupation of the San Juan Island, by the forces of Her Majesty's ships Tribune, Plumper, and Satellite, now in the harbor of that Island by your orders.

As the military commander of the department of Oregon, assigned to that command by the orders of the President of the United States, I have the honor to state for your information, that by such authority invested in me, I placed a military command upon the Island of San Juan to protect the American citizens residing on that island from the insults and indignities which the British authorities of Vancouver Island, and the establishment of the Hudson's Bay Company have recently offered them, by sending a British ship of war from Vancouver Island, to convey the chief factor of the Hudson's Bay Company to San Juan, for the purpose of seizing an American citizen and forcibly transporting him to Vancouver Island to be tried by British laws.

I have reported this attempted outrage to my government, and they will doubtless seek the proper redress from the British government. In the meantime, I have the honor to inform your Excellency, I shall not permit a repetition of the insult, and shall retain a command on San Juan Island to protect its citizens in the name of the United States, until I receive further orders from my government.

REPLY OF GOV. DOUGLAS TO GEN. HARNEY.

Government House, Victoria. Vancouver's Island, 13th Aug. 1859.

Brigadier-General Wm. S. Harney, Commanding the Troops in the Department of Oregon—

Sir: On the evening of the 10th inst., I had the honor of receiving your Dispatch dated Fort Vancouver, August 6th, 1859.

In reply thereto, I must thank you for the frank and straightforward manner in which you communicate to me your reasons for occupying the Island of San Juan in the Haro Archipelago with a portion of the military forces of the United States under your command.

I am glad to find that you have done so under your general instructions from the President of the United States as Military Commander of the Department of Oregon, and not by direct authority emanating from the Cabinet at Washington.

You state that the reasons which induced you to take that course are the "insults and indignities which the British authorities of Vancouver's Island, and the Establishment of the Hudson's Bay Company have recently offered to 'American citizens residing on the Island of San Juan,' by sending a British ship of war from Vancouver's Island to convey the Chief Factor of the Hudson's Bay Company to San Juan, for the purpose of seizing an American citizen, and forcibly transporting him to Vancouver's Island to be tried by British Laws."

I will explain for your information that the Agents of the Hudson's Bay Co. hold no official position in Vancouver's Island, nor exercise any official power or authority, and are as entirely distinct from the officers of the Executive Government as are any of the other inhabitants of Vancouver's Island.

To the reported outrage on an American citizen, I beg to give the most unhesitating and unqualified denial. None of Her Majesty's ships have ever been sent to convey the Chief Factor or any officer of the Hudson's Bay Company to San Juan for the purpose of seizing an American citizen, nor has any attempt ever been made to seize any American citizen and to transport him forcibly to Vancouver's Island for trial as represented by you.

Up to a very recent period but one American citizen has been resident on San Juan. About the commencement of the present year a few American citizens began to "squat" upon the Island, and upon one occasion a complaint was made to me by a British subject of some wrong committed against his property by an American citizen, but no attention was paid to that complaint, out of consideration and respect to the friendly government to which the alleged offender belonged, and whose citizens, I think it cannot be denied, have always been treated with marked attention by all the British authorities in these parts. With reference to San Juan in particular, I have always acted with the utmost caution to prevent, so far as might lie in my power, any ill feelings arising from collisions between British subjects and American citizens, and have in that respect cordially endeavored to carry out the views of the United States Government as expressed in a dispatch from Mr. Marcy, dated 17th July, 1855, to Her Majesty's Minister at Washington, a copy of which I herewith enclose for your information, as I presume that the document cannot be in your possession.

Following the dignified policy recommended by that dispatch, I should in any well grounded case of complaint against an American citizen have referred the matter to the Federal authorities in Washington Territory, well assured that if wrong had been committed reparation would have followed.

I deeply regret that you did not communicate with me for information upon the subject of the alleged grievance, you would then have learned how unfounded was the complaint, and the grave action you have adopted might have been avoided. I also deeply regret that you did not mention the matter verbally to me when I had the pleasure of seeing you at Victoria last month, for a few words from me would, I am sure, have removed from your mind any erroneous impressions, and you would have ascertained personally from me how anxious I have ever been to co-operate to the utmost of my power with the officers of the United States Government in any measures which might be mutually beneficial to the citizens of the two countries.

Having given you a distinct and emphatic denial to the circumstances which you allege induced you to occupy the Island of San Juan with United States troops; having shown you that the reasons you assign do not exist, and having endeavored to assure you of my readiness on all occasions to act for the protection of American citizens, and for the promotion of their welfare, I must call upon you, sir, if not as a matter of right, at least as a matter of justice and of humanity, to withdraw the troops now quartered upon the Island of San Juan; for those troops are not required for the protection of American citizens against British authorities, and the continuance of these troops upon an Island, the sovereignty of which is in dispute, not only is a marked discourtesy to a friendly Government, but complicates to an undue degree the settlement in an amicable manner of the question of sovereignty, and is also calculated to provoke a collision between the military forces of two friendly Nations, in a distant part of the world.

I beg to draw Your Excellency's attention to the memorandum of agreement entered into between the Honble. the H. B. Company and myself on Septr. 13th 1854 by virtue of which,

- 1. I undertook "the charge of a District or Parish" at Victoria, coupled with the appointment of Chaplain to the Company.
 - 2. I accepted as a remuneration for my Services
 - (1) "Of a Parsonage and Glebe of 100 Acres."
 - (2) "A Stipend of £300 per Annum charged with the Sanction of the Colonial office on the fund arising from the Sales of Land."
 - (3) "Of £100. a year for Acting as Chaplain to the Company."
- 3. The engagement was understood to be for five years, after which a free passage home would be granted should the clergyman wish to return; or, on the contrary, a fresh engagement might be entered into. In the event of misconduct the engagement might at any time be cancelled on the recommendation of the Governor, and with the sanction of the Secretary of State for the Colonies.

In conformity with the last paragraph of the agreement, and in view of the approaching expiration of the above mentioned period of five years, I beg, through Your Excellency to signify to the proper authorities (in case of Your Excellency's favorable recommendation) my willingness to enter into a fresh agreement.

Believing also, and assuming that circumstances unforeseen and unprovided for in the memorandum may be found to render necessary some revision of its terms, I shall be most happy, if it will tend to facilitate or expedite an arrangement, to enter into a preliminary communication with Your Excellency in reference to those terms; or otherwise I will await the enunciation of them from Her Majesty's Government or the Honble. Company.

In either case I should esteem it a favor that the matter should be arranged with as little delay as may be convenient.

It seems impossible that the poor Creatures can be turned on the streets to die, or be left to the precarious charity of the passers by; and there is no asylum to which they can be consigned but the Hospital.

Your Excellency is therefore earnestly implored to provide, or to ask the House of Assembly to provide, the means of carrying on an Institution so indispensable to the Colony.

The Revenue derived from Spirit Licenses has been already expended by vote of the House, and no funds whatever remain in the Exchequer.

I therefore desire that the House may at once take measures, either by way of loan or otherwise, to provide the Sum of £250, which has been so considerately voted for the relief of the Hospital; otherwise the humane intention of the House cannot be carried into effect.

Government House Victoria, Vancouvers Island November 3rd 1859

Sir,

I have to communicate to you for the information of the House of Assembly, that the "Bill to amend the Law relating to the Representation of the Colony of Vancouvers Island," with the amendments proposed by the House, finally passed the Council, and received my assent, this day.

To the Speaker of the House of Assembly.

The House, having been summoned to attend the Council, then proceeded to the Council Chamber, where were assembled, His Excellency the Governor; and the following Members of Council, the Honble. John Work, Rodk. Finlayson and Donald Fraser.

His Excellency the Governor addressed the House as follows,

Gentlemen of the House of Assembly,

I have summoned you to meet me on this occasion in order to release you from your legislative duties.

A protracted Session extending over a period exceeding three years, has led to many changes in the Colony. The Town and District of Victoria, as well as other Districts of Vancouver's Island, have during that time advanced in wealth and population, with a rapidity surpassing our warmest expectations; and I am, from circumstances, led to entertain the most confident hopes of the future progress of the Colony.

I thank you Gentlemen, for the zeal and diligence, with which you have applied yourselves to your public duties, and for the support which I have received from you.

It is my intention to dissolve this present Assembly without delay, and to summon a new House fully representing the growing Constituencies of the Colony; and I sincerely hope that in the exercise of the high functions, which according to the free constitution of our Country will devolve upon those constituencies, they may be led to the selection of representatives whose wisdom and patriotism may aid me, in devising and carrying into effect, the measures which appear to be indispensably necessary in promoting the early settlement of the country, the development of its resources, and the general well being and prosperity of the Colony.

It is not my intention to take up the time of the House by entering into a review of those measures at present; but I will nevertheless, remark, that there appears to be an obvious necessity for an early revision of the Land System, which ought to be placed on a sound and liberal basis for the encouragement of settlers.

The records of History prove that Nations must be producers in order to become prosperous and healthy.

I shall therefore recommend that early measures be adopted to encourage agriculture; the raising of stock; and the improvement of sheep and cattle; to stimulate the establishment of fisheries; the working of coal mines; the export and manufacture of ship's masts and timber: sources of wealth with which the Colony abounds.

The repair and construction of Public Roads, and other important works will have the strongest claims upon the attention of the Legislature.

The Legislature will further have to take into early consideration the means of raising a revenue for defraying the necessary expenses of Government, and especially for extending and improving national education as the most certain means of elevating the moral and social conditions of the people.

With those few remarks, I will release you, Gentlemen, from further attendance.

The Secretary to the Council then proceeded to announce the prorogation of the assembly, to Thursday the 2nd day of February next.

The Members of the House of Assembly then withdrew.
