Mr. Reid presented the Report of the Special Committee on Redistribution, as follows:—

#### REPORT.

LEGISLATIVE COMMITTEE ROOM,
March 9th, 1955.

MR. SPEAKER:

Your Special Committee on Redistribution begs leave to report as follows:-

During the last three Sessions the Special Committee appointed by the Legislative Assembly to consider the desirability of amending section 14 of the "Constitution Act" has made an intensive study of the problems involved and has gathered much material.

The Special Committee appointed by this Legislative Assembly has arrived at certain

concrete conclusions within the limits of its experience.

The influx of people into British Columbia during the past several years, the continuing shift of population within British Columbia, and the vast industrial expansion which is opening up hitherto sparsely populated areas of the Province lead inevitably to the conclusion that certain areas should have more equitable representation in the Legislative Assembly. Particularly is this true in respect of two areas: (a) The Lower Mainland area and (b) the Peace River area.

The Special Committee therefore recommends:—

(1) That the Electoral Districts of Burnaby, Delta, and North Vancouver in the Lower Mainland area shall be multiple-member constituencies, being represented in each case by two members instead of one:

(2) That the Electoral District of Peace River be divided into two electoral districts respectively, to be known as the North Peace River and South Peace River constituencies, and that the Peace River itself be the boundary between the two districts created; each electoral district shall be represented by one member.

After considerable and exhaustive study the Committee does not feel favourably disposed to altering the historical boundaries of any other electoral districts in the Province.

Accordingly, and because of population conditions referred to herein which, in the opinion of the Special Committee, will be of a continuing and possibly accelerated nature, the Special Committee recommends for consideration of the Legislative Assembly that continuing study be given to the whole problem of redistribution.

The Hon. W. A. C. Bennett replied as follows:—

"1. No surveys have been carried out by the British Columbia Power Commission on the proposal to dam Buttle Lake since April, 1954; complete surveys in this connection were carried out previously to that date; surveys and investigations covering alternative sources of power on Campbell River have been carried out on Upper Campbell Lake and at the existing Ladore Falls Dam at the outlet of Lower Campbell Lake.

"2. Surveys for Upper Campbell Lake project were started on May 17th, 1954, and are still continuing; they included aerial photographic surveys, topographical and geological surveys, and diamond-drilling and boring work; the number of men employed has varied between six and twenty; as of December 31st, 1954, a sum of \$56,507.89 had been expended on these surveys. The surveys in connection with Ladore Falls were started on January 27th, 1954; they included topographic and geological surveys, diamond-drilling and boring work; the work was completed in December, 1954; the number of men employed has varied, generally being in the order of two to six; the total expenditure as of December 31st, 1954, was \$14,060.80."

Mr. Shantz presented the Report of the Select Standing Committee on Agriculture, as follows:—

#### REPORT.

LEGISLATIVE COMMITTEE ROOM,
March 10th, 1955.

#### MR. SPEAKER:

Your Select Standing Committee on Agriculture begs leave to report as follows:—Your Committee met the Advisory Board of Farmers' Institutes and heard the presentation of a list of resolutions as submitted by them. Careful consideration was given to these resolutions and:—

- (1) Your Committee recommends that an investigation be made to ascertain if any farm services are being curtailed due to lack of appropriations to the Department of Agriculture:
- (2) Your Committee recommends that the Superintendent of Farmers' Institutes spend more time visiting the various Institutes to encourage and stimulate interest so that the organization will grow and expand:

- (3) It is felt that some misunderstanding exists regarding the Forage Analysis Laboratory, in that this service is available to the individual farmer, whereas it was set up as a service to be used by the district agriculturists in co-operation with the farmers so as to get a test of the general area, not a specific piece of land; however, your Committee recommends the expansion of this service under the Field Crops Branch:
- (4) After careful consideration by this Committee, it is felt in the best interests of this Province that grazing lands remain under the Department of Lands and Forests where it is at the present time:
- (5) It is felt that every effort should be made to control erosion of our agricultural land and realizing that the cost of preventing this erosion is prohibitive to the individual land-owner, this Committee urges that the Department of Government involved continue to work toward a concrete policy and press the Federal Government for participation in this type of control work under the section of the "Prairie Farms Rehabilitation Act" and the "Conservation Act" of 1953:
- (6) Where, due to physical or financial difficulties, certain farmers find it impossible to pay the taxes on their lands or where the side roads are not receiving adequate maintenance, your Committee recommends that farmers needing to work out their taxes be allowed to do so at the discretion of the Engineer or Minister concerned; that the Minister examine into the possible economies to be obtained by using local farmers, loggers, or contractors on some types of road maintenance;
- (7) It is generally agreed that if we are to retain the services of the younger generation on the farms and in agriculture, it is necessary that increased efforts be put forward by all power companies and the British Columbia Power Commission to extend rural electrification and this Committee recommends that the British Columbia Power Commission do its utmost to electrify the rural areas:
- (8) As the results of equalization of assessments and the new school formula have not as yet been fully realized, this Committee feels it unwise to make any recommendation on the resolution dealing with school taxes on land.

For the purpose of licensing under the 'Motor-vehicle Act,' the passenger and commercial motor-vehicle licences are issued on the following basis: Passenger licences (all motor-vehicles designed solely for carrying passengers, up to a total of eight passengers exclusive of driver) and commercial licences ((a) passenger-carrying motor-vehicles over total of eight passengers, (b) all vehicles designed for carrying freight, and (c) vehicles designed for dual purpose of carrying both passengers and freight)."
