LEGISLATIVE COMMITTEE ROOM,

MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders begs leave to report as follows:---

That the preamble of the undermentioned Bill has been proved, and the Bill ordered to be reported as amended. Bill (No. 53) intituled "An Act relating to certain Local Improvement Works and By-laws of the Corporation of the City of North Vancouver."

All of which is respectfully submitted.

The report was received.

The Rules were suspended and the report adopted.

"Mr. *Guthrie* moved that his Bill, 'An Act to amend the "Workmen's Compensation Act,"' be read a first time now.

"The Honourable the Attorney-General raised the point of order as to whether it was competent for the honourable mover to present such a Bill and as to whether it did not come under Rule 118.

"The mover contended that the Bill did not deal with public money and therefore did not come under Rule 118.

"Rule 119, which is based upon section 54. 'British North America Act,' says: 'It shall not be lawful for the House to adopt or pass any vote, resolution, address, or Bill for the appropriation of any part of the public revenue, or of any tax or impost, to any purpose that has not been first recommended to the House by Message of the Lieutenant-Governor in the session in which such vote, resolution, address, or Bill is proposed.'

"The Board created by the 'Workmen's Compensation Act,' chapter 77, 1916, is authorized to collect certain taxes or imposts and pay them into the Consolidated Revenue Fund. Section 48 of said Act recites: 'No moneys collected or received on account of the Accident Fund shall be expended or paid out without first passing into the Provincial Treasury and being drawn therefrom as provided in this Part.'

"Under the authority of this Act certain taxes are imposed for a specified purpose and until so made use of are part of the Consolidated Revenue Fund.

"See Mr. Speaker Manson, H.J., 1921 (2nd Session), also Mr. Speaker Eberts, H.J., B.C., 1910, page 106.

"I must rule that under Rule 118 and Rule 119 the motion is out of order."

Mr. Guthrie appealed from the ruling of the Chair.

And whereas this practice is resulting in the exploitation of one of our natural resources with little benefit to the Province:

And whereas numbers of wage-earners are leaving British Columbia on account of an insufficiency of employment:

And whereas the manufacture of all timber cut in this Province would materially increase employment and conserve the timber resources for the benefit of Canada:

Therefore be it Resolved, That this House is of the opinion that a heavy export duty should be imposed by the Dominion Government on all unmanufactured British Columbia timber going outside of Canada.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted to the Hon. Secretary of State or other proper official at Ottawa.

And on the amendment thereto moved by the Hon. Mr. Pattullo on 21st November, as follows :---

That all the words of the Preamble and of the Resolution after the first word "Whereas" be struck out, and the following words substituted therefor :--

"Quantities of timber are being cut from forests in British Columbia and elsewhere in Canada and taken out of Canada in an unmanufactured condition:

"And whereas it is desirable that Canadian timber should, as far as practicable, be fully manufactured before leaving Canada:

"And whereas the Canadian Government has appointed a Royal Commission for the purpose of inquiring into the exportation of pulp-wood:

"Therefore be it Resolved, That this House would respectfully request the Canadian Government to extend the powers of the before-mentioned Royal Commission, and to instruct them to inquire into all the circumstances relating to the export of unmanufactured timber, and to report as to what action, if any, should be taken in respect thereof.

"And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted by telegraph to the Honourable the Secretary of State for Canada."

And on the amendment to the amendment moved by Mr. Hinchliffe on 29th November, as follows :---

That all the words of the amendment after the word "Canada," in the fourth line of the Preamble, be deleted, and the following words substituted therefor:----

"Therefore be it Resolved, That this House regrets that the Government has not seen fit to submit legislation providing for the prohibition of the exportation from this Province, after the 31st day of December, 1924, of logs not fully manufactured."

Therefore be it Resolved, That this Legislature of British Columbia respectfully requests the Government of Canada to leave open the way for the presentation, reception, and payment of such claims until the last claim has been adjusted.

3. How many planks had to be replaced owing to this fire, and what was the extent of such repairs?

4. Who carried out the repair-work, and what did it cost?

5. Did the bridge foreman hire a car and go to the bridge from Merritt for a consultation with the District Engineer or his assistant? If not, where was the bridge foreman then working?

The Hon. Dr. Sutherland replied as follows :--

"1. Yes.

"2. Assistant District Engineer investigated the matter the day after the fire, July 29th, while on a trip to Lytton, having to pass through Ashcroft en route.

"3. As a result of the fire four planks had to be renewed, a small hole about 5 inches in diameter having been burnt completely through the deck. This bridge has a double deck, a deck of 4-inch plank crosswise covered longitudinally with a deck of 2-inch plank. In order to replace the two planks in the lower deck it was necessary to remove a full section of longitudinal planks, about eighteen or twenty in all. The top deck was then replaced with two new planks to take the place of those damaged.

"4. The repairs were carried out by R. S. Coldwell, of Ashcroft; \$8.30.

"5. No."

Prayers by Mr. Speaker.

Mr. *Perry* presented the First Report from the Select Standing Committee on Municipal Matters, as follows:---

REPORT NO. 1.

LEGISLATIVE COMMITTEE ROOM, December 11th, 1923.

MR. SPEAKER:

Your Committee has heard delegations from many associations and persons interested in municipal affairs.

Various amendments to several Statutes affecting the welfare of municipalities will be submitted for your consideration.

Your Committee heard delegations representing many public-spirited organizations urging a "survey of the educational system of the Province."

We are advised by the advocates of the "survey" that the estimated cost would be \$40,000 or over.

Your Committee has not been convinced there is anything radically wrong with the educational affairs of this Province, particularly in comparison with other Provinces of this Dominion.

We believe a survey conducted by qualified advisers independent of the Education Department, and with a knowledge of the social, economic, and financial conditions in this Province, the functions of School Boards, the Provincial and municipal financing of education, as well as the most modern knowledge of educational requirements, should result in great good to the community when suggested improvements are adopted.

In view of the necessity for economy and for good business reasons, we believe the Department of Education could gather a great deal of valuable and necessary data together during the coming year, and we advise this before embarking on any costly "survey."

All of which is respectfully submitted.

"(g.) Ratio of salaries to expenditure: 1915-16, 22.2 per cent.; 1918-19, 17.2 per cent.; 1922-23, 15 per cent.

"(h.) Total collected revenue and expenditure: 1915-16, \$15.652.062; 1918-19, \$22,420,429; 1922-23, \$38,819,514.

"(i.) Ratio of salaries to collected revenue and expenditure: 1915-16, 14.3 per cent.; 1918-19, 9.3 per cent.; 1922-23, 8 per cent."

2. Is the interest added to the Superannuation Fund?

3. If so, how often is the interest added to the principal?

The Hon. Dr. MacLean replied as follows :----

"1. 5 per cent. per annum.

"2. Yes.

"3. Half-yearly-September 30th and March 31st."

Mr. Pooley asked the Hon. the Attorney-General the following questions :---

1. Is one Charles McDonald the Sheriff of the County of Vancouver?

2. Is he supposed to give his whole time to his duties as Sheriff?

3. Is he on salary? If yes, what is his salary?

4. Are all fees earned by said McDonald supposed to be paid in by him to the Department?

5. Has the Department any knowledge of the said McDonald holding any position in the Admiralty Court?

6. Has the said McDonald paid in any fees and emoluments collected by him as Marshal or other officer of the Admiralty Court to the Provincial Government?

7. If not, why not? Or is the said McDonald permitted to keep said fees and emoluments (if any) for his own use?

S. Has the Department any knowledge of the amount of said fees and emoluments (if any) received by said McDonald as an officer of said Court?

9. If yes, what is said amount from the date of his appointment as Sheriff to date?

The Hon. Mr. Manson replied as follows :--

"1. Yes.

"2. Yes.

"3. Yes; \$4,120 per annum.

"4. Yes, as such Sheriff.

"5. Mr. McDonald acts as Deputy Marshal of the Admiralty Court at Victoria when occasion requires. The profession generally have asked him to act for convenience' sake.

"6. No.

"7. The fees, which are small amounts, are paid to Mr. McDonald. The Marshal asked that the work be done for half-fees, but Mr. McDonald refused to have anything to do with it unless all the fees were paid to him.

"8. No.

"9. Advised by the Sheriff that he has no records of the amounts received, but in the aggregate they have been small. Last year, 1922, they were under \$100."

Mr. W. A. McKenzie asked the Hon. the Minister of Public Works the following questions :-

1. What was the estimated cost of excavation in connection with the Industrial School at Essondale?

2. Who prepared such estimates?

3. On what date was excavation commenced?

4. On what date was it completed?

5. What was the estimated cost of the concrete foundations in connection with the same building?

6. Who prepared such estimates?

7. On what date was work in connection with concrete foundations commenced?

8. On what date was the concrete-work completed sufficiently to allow contractors to proceed with building construction?

9. On what date did the contractors complete the building?

The Hon, Dr. Sutherland replied as follows :--

"1. Estimates were not prepared as work was to be done by patients of the Mental Hospital. "2. Answered by No. 1.

"3 to 9. See replies to question No. 13 on to-day's Orders of the Day."

2. What has been the total amount paid to him to date under the headings of: (a) Salary; (b) travelling expenses?

The Hon. Mr. Manson replied as follows :--

"1. August 15th, 1918.

"2. Salary: 1918–19, \$5,000; 1919–20, \$7,999.89; 1920–21, \$7,999.92; 1921–22, \$7,999.92; 1922–23, \$8,000; to November 1st, 1923, \$5,000; total, \$41,999.73.

"Travelling expenses: 1918–19, \$1,230.21; 1919–20, \$914.07; 1920–21, \$1,135.02; 1921–22, \$1,689.92; 1922–23, \$3,278.78; to November 1st, 1923, \$987; total, \$9.235."
