The Honourable Attorney-General raised the point of order that the Bill was unconstitutional.

Mr. Speaker *Higgins* ruled the Bill out of order on the following grounds:—

I rule Bill (No. 18) intituled "An Act to amend the 'Coal Mines Regulation Act' and 'Amending Act, 1890,'" out of order, for the following reasons:—First, because it aims to impose indirect taxation, contrary to the provisions of the B. N. A. Act; and, second, because it has been decided by the Supreme Court of the Province that the power to impose unequal taxation does not reside with the Provincial Legislature. (*See* ruling January 29th, present Session.)

Whereas there are large sections of the interior of our Province in which irrigation is necessary to the successful cultivation of the soil;

And whereas it would be desirable in surveying the Crown lands in such sections of the Province that information should be obtained for the use of intending settlers as to the practicability and cost of irrigating ditches for the benefit of such lands; and it is also expedient to amend and extend our present laws with regard to water rights for irrigating purposes;

Therefore be it Resolved, That a Select Committee, consisting of Messrs. *Smith*, *Semlin*, and the mover, be appointed to consider the subject of irrigation as affecting our Province, and to report thereon to this House, with such recommendations as to legislation as may be in the interests of the Province.

The Honourable Colonel *Baker* presented, by command of His Honour the Lieutenant-Governor, a Return of copies of the reports received from the Honourable *Theodore Davie* on his missions to *Ottawa* and *New York* in 1892, and to *Ottawa* in 1893; the missions of the Honourable *J. H. Turner* to *England* in 1891, and to *Ottawa* and *Chicago* in 1893; and the mission of the Honourable *James Baker* to *England* in 1893; together with copies of the Orders in Council authorizing each of them to proceed on the said missions on behalf of the Province.

The Honourable Mr. *Turner* presented a Return showing the amount of timber royalty collected during the period from 1st July, 1890, to this date, in the Districts of *Yale*, *Cariboo*, *West Kootenay*, and *Lillooet*, giving amount collected in each district, names of the parties, and amount paid by each.

The Honourable Mr. *Turner* presented a Return showing the prices at which the Trustees for the sinking funds under the Loan Acts, 1877 and 1887, bought B. C. Inscribed Stock.

Pursuant to Order, the Honourable Mr. *Vernon* moved that Bill (No. 40) intituled "An Act for the redistribution of British Columbia into Electoral Districts, and for amending the law applicable to Elections to the Legislative Assembly, and for other purposes in furtherance of or consequent on the aforesaid objects," be now read a second time.
