MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders begs leave to report as follows:—

That Bill (No. 17) intituled "An Act respecting Sanipractic Physicians" was referred to your Committee.

Representations were made to your Committee for and against the Bill, which representations have been considered with the utmost care.

There are no Sanipractic Colleges in Canada, and it is therefore impossible to say that the medical attainments of those now asking for a change in the present law are sufficiently high to warrant the granting of the same privileges now accorded to the medical profession.

Under the Bill now before your Committee, all existing sanipractic physicians would automatically be accorded all the rights and privileges of a physician and have the same right to practise as a licensed medical practitioner.

The question to be decided by your Committee is: Have the sanipractic physicians made out a case for an alteration of the present medical law, so without hindrance they may be permitted to practise?

Your Committee is of the opinion that if sanipractic physicians wish to practise and avail themselves of all the powers and responsibilities of the medical profession, they should qualify under the "Medical Act" and they could then specialize in sanipractic.

Your Committee recommends that Bill No. 17 be not proceeded with, and further recommends that, if the sanipractic physicians so desire, the "Medical Act" be amended providing for exami-

nations in a similar manner as provided for chiropractors or osteopaths. This would guarantee to the public that they were qualified practitioners capable of rendering efficient service to the public health. It would not be in the public interest at the present time for sanipractic physicians to set their own standards for a medical examination and have a Statute and governing body of their own.

Prayers by Mr. Speaker.

Dr. Rothwell presented a petition from Reid & McDonald; Johnston's Big Shoe House, Limited; Hume & Rumble, Limited, and others, in favour of introducing legislation to abolish the personal-property tax.

Dr. Rothwell presented the report of the Select Standing Committee on Agriculture, as follows:—

LEGISLATIVE COMMITTEE ROOM,
December 4th, 1924.

MR. SPEAKER:

Your Select Standing Committee on Agriculture begs leave to submit its First Report, as follows:—

1. The Secretary of Wemen's Institutes of British Columbia appeared before the Committee and submitted a full report dealing with the activities of that organization during the year.

It was shown that this organization had been very active and had accomplished a large amount of very valuable executive work, particularly along the lines of home economics, public health, child-welfare, community betterment, education, and school environment.

Your Committee desires to express its unqualified approval of the activities of the Women's Institutes, and notes with particular satisfaction the ability and success of this organization in so satisfactorily meeting its financial requirements.

2. Your Committee received delegations from the Advisory Board of Farmers' Institutes several times. They made many very excellent recommendations having for their object the development of the best interests of the agriculture and allied interests of our Province.

Due consideration has been given to all of these recommendations, and where the interests of other sections of our communities have been involved the Committee has considered representations from such other interests in order to arrive at decisions that should be as far as possible fair to all concerned.

- 3. Your Committee begs to recommend as follows:--
- (a.) Re Equalization of Taxation.—Whereas it has come about that women are competing with men in many occupations and industries, and in many ways enjoying privileges and receiving remuneration on a parity with men:

Therefore we urge that the word "male" be eliminated wherever it occurs in the "Poll-tax Act," chapter 253 of the "Revised Statutes of British Columbia, 1924."

- (b.) Re Delinquent Date of Taxation Extension.—That the date when taxes become delinquent be extended from June 30th to October 31st.
- (c.) Re Fair Grants.—The Advisory Board begs to point out that some seventy fairs were held in the Province this year and some three of the large fairs received over 50 per cent. of the total grant, and we recommend that in future they should not receive more than 40 per cent.

Further, that we are of the opinion that not more than one fair should be supported by the Government that is held in each municipality in the Province, and that if possible they should not be less than 15 miles apart that receive the grant.

In our opinion some deep study should be made to centralize efforts where this is possible and avoid duplication.

- It is clear that the time has arrived for some fairer distribution of the grant provided by the Government for the carrying-on of fairs throughout the Province, and it is hoped that the publicity given to this matter will produce a more satisfactory basis. This resolution is submitted with the idea of focusing attention on the whole subject.
- (d.) Re Elevator Screenings.—(1.) Whereas, owing to the recent establishment of grainelevators at our ports, a large amount of grain is being shipped from the Prairies into this Province, such grain coming in without having been previously cleaned:
- (2.) And whereas, before being reshipped, such grain is screened by the elevators, and the screenings sold to farmers, poultry-keepers, and others for feeding purposes; such screenings containing a large amount of weed-seeds, which under this method of distribution must inevitably get into our agricultural land, with disastrous effects:
- (3.) And whereas the most effective, and probably the only, method by which our farm lands can be saved from becoming almost valueless by spread of such weeds would be by a system of rescreening of the screenings before they are placed on the market:
- (4.) And whereas the effect of such rescreening would result also in the removal of poisonous products—e.g., darnel, purple cockle, wild mustard, false flax, wormseed mustard, tumbling mustard, stinkweed, and ergotized grains (smut)—and thus render the rescreened product much less injurious, and hence more valuable as feed:
- (5.) Therefore be it Resolved, That this Select Board of Agriculture do strongly recommend and urgently request that such steps as may be necessary be taken at this Session of the Legislature to secure, by co-operation, if necessary, with other Legislatures, Provincial and Federal, effective prevention of the spread of such highly injurious weed-seeds.
- (e.) Re Agricultural Bills.—That all Bills dealing with agriculture and allied subjects be referred to this Select Standing Committee on Agriculture upon their presentation to the Legislature.
- (f.) Re Tuberculosis Problems.—A great deal of data upon this subject was presented to the Committee by means of which it was conclusively shown that the health of the people in the matter of risk of infection from milk infected from tuberculous cows is not being as thoroughly safeguarded by the present system of inspection and destruction of cattle as is desirable that it should be.

It was recommended, therefore, that the Government put into effect an improved and more thorough method of controlling this menace to the health of our people, such as has been found by trial in other places to be very much more effective.

(g.) Re Sheep-protection and Dog-control.—In view of the fact that under present conditions legislation for protection of sheep from ravages of dogs is not effective in satisfactorily checking very serious losses in this respect, this Committee recommends and strongly urges the early passing of legislation making it compulsory for all dogs to be tagged and, if necessary for the carrying-out of this provision, to be licensed; and that all dogs found without such identification marks be considered outlaws.

And it is further recommended that the Department of Agriculture take up with the Department of Indian Affairs this matter of protection of sheep from the ravages of dogs, and urge upon them the absolute necessity of their co-operation in order to save this important industry from destruction.

(h.) The following recommendation was made to your Committee bearing upon the absolute necessity of legislation being effected for the purpose of thorough protection of our chief industry:—

"Referring to the resolution passed by the Select Standing Committee on Agriculture, of which you have a copy, we are agreed to the amendment of the 'Animals Act' to the extent of placing a section similar to section 8 of the 'Sheep Protection Act' in the 'Animals Act' in its appropriate place. We also recommend that the whole of the Interior of British Columbia from a line 10 miles north of the Canadian National Railway (Grand Trunk) south to the

International Boundary should be declared one large sheep-protection district under the 'Sheep Protection Act,' chapter 57, Statutes of British Columbia, 1917."

In recommendation of this resolution it was moved by A. Paterson, seconded by J. A. Catherwood. That the Minister of Agriculture, in association with Messrs. Whitney-Griffith, Secretary of Advisory Board of Farmers' Institutes, and Mr. T. P. McKenzie, Grazing Commissioner, be requested to draft an amendment to the "Sheep Protection Act" embodying the recommendations of this Standing Committee bearing upon that subject.

All of which is respectfully submitted.
