Prayers by Mr. Speaker.

Mr. Putnam presented the First Report of the Select Standing Committee on Mining, as follows:—

REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM, February 10th, 1942.

MR. SPEAKER:

Your Select Standing Committee on Mining begs leave to report as follows:—
The Select Standing Committee on Mining had six meetings and discussed the advisability of an iron and steel smelter in British Columbia.

Dr. Walker, Deputy Minister of Mines, gave a very lengthy talk on this subject advising the necessity and feasibility of such an undertaking. This, we feel, would stimulate the industry in general and would add to the present war effort and greatly assist the post-war development.

Your Committee, in view of the criticism of the "Securities Act," thought it advisable to investigate it. This was done by calling before the Committee witnesses who had been complaining that the Act was a hindrance to prospectors and mining development in general. Twelve witnesses were called who gave evidence for and against the Act.

After fully considering this evidence, your Committee feels that it has not had enough time nor the opportunity to hear as much evidence on this subject as it should to justify any recommendation other than the repeal of subsection (4), section 10, of the Act. Your Committee also feels that more publicity should be given to the purposes of the "Securities Act" and its aims in connection with the mining industry; and that further study be given this matter during the interval and submitted with recommendations at the next Session of the Legislature.

The Committee also strongly recommends further progress in mining roads and trails in assistance to new development as well as the extension of present mining roads.

All of which is respectfully submitted.

 $\operatorname{Mr.} E.\ C.\ Carson$ presented the First Report of the Select Standing Committee on Agriculture, as follows:—

REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM, February 10th, 1942.

MR. SPEAKER:

Your Select Standing Committee on Agriculture begs leave to report as follows:—Your Committee—authorized by Resolution of the Legislative Assembly "to consider such matters affecting the agricultural industry as may be laid before it by the

Advisory Board of Farmers' Institutes, to call members of the British Columbia Agricultural Production Committee, the Interdepartmental Committee on Farm Labour, and such departmental officials as may be representatives on other agricultural bodies with a view to securing information on matters affecting the agricultural welfare of the Province, and to report its findings to this House"—held three sittings.

At one of these sittings the Farmers' Institute Advisory Board presented a total

of thirteen resolutions dealing with the following matters:-

A. Predatory-animal bounties.

B. Farmer-member on Game Board.

C. Export on eggs assistance.

D. Agricultural lime bonus increase.

E. Grain-growers' assistance.

F. Bonus to feed-grain growers.

G. Starch factories.

H. Farmers' taxes.

I. School taxes.

J. Tractors used by farmers.

K. Farm-labour organization.

L. Drain-tile.

M. Old-age pensions.

Four of the above resolutions—namely, C, E, F, and L—were tabled pending the securing of further information regarding representations. Six resolutions—namely, G, H, I, J, K, and M—are deserving of consideration by the respective Departments of Government to which they are directed.

Your Committee recognizes the fact that Resolutions A, B, and D involve the revenues of the Crown. However, they are of immediate importance and are passed on to the Departments concerned with the recommendation of this Committee that they be implemented in so far as possible. At the same time, your Committee recommends that in view of the importance of the agricultural industry the appropriations for agriculture ought to be sufficiently increased to permit of the extension and expansion of such policies as that dealing with the subsidy on agricultural lime.

Resolution A, referring to predatory-animal bounties, is of paramount importance in all sections where predatory animals are decimating farm herds and flocks. We recommend, therefore, that a bounty of \$5 on coyotes, \$20 on wolves, and \$30 on cougars be paid from Provincial funds and that restrictions respecting the destruction of birds damaging farm property be relaxed.

It is further suggested by this Committee that, upon request, farmers be given

permission to destroy pheasants when they are found doing damage to crops.

This Committee regrets to note that, while the appropriation for predatory-animal bounties is considerably decreased in the Estimates for the coming year, there is provided a large appropriation to be used in the distribution of pheasants and other game birds that are frequently detrimental to farm crops.

Resolution B, advocating a farmer-member on the Game Board, is endorsed with the recommendation that this suggestion receive the immediate attention of the Honourable the Attorney-General under whose Department game administration comes.

Resolution D, asking for the lime bonus increase from 50 cents to \$1 a ton on lime used for soil improvement, is approved. In this connection your Committee points out that the appropriation for agriculture is entirely inadequate to take care of extension and expansion, imperative for the sound establishment of farming as a primary industry of a large number of our people.

The Select Standing Committee on Agriculture has carefully studied the matters laid before it by the Advisory Board of Farmers' Institutes, and it concurs in the opinion that an increase in the Estimates for the Department of Agriculture is essential.

With reference to Resolution K, it is the opinion of this Committee that leadership must be given by the Government in the organizing and making available of suitable and adequate labour to assist in agricultural operations during the current year.

Your Select Standing Committee on Agriculture called in the Agricultural Production Committee in order to ascertain what further action had been taken with a view to informing and advising farmers respecting their agricultural pursuits. We express complete satisfaction with the findings resulting from the questioning of this Committee. Since the outbreak of war in 1939 they have issued forty-six separate circulars to agricultural organizations and the farm press dealing with pertinent farm topics and advising on production matters of the greatest importance.

The Agricultural Production Committee recognizes its responsibility and is fully aware of the seriousness of the existing situation and the necessity for continued vigilance and diligence in maintaining the agricultural efficiency of British Columbia.

LEGISLATIVE COMMITTEE ROOM,

February 11th, 1942.

MR. SPEAKER:

Your Select Standing Committee on Social Welfare begs leave to present the

following report and recommendations to the Legislature:-

After receiving full information on their respective institutions from the following men: Dr. Crease, Provincial Psychiatrist; Dr. Ryan, Medical Superintendent of Essondale Mental Hospital; Dr. Sauriol, Superintendent, School for the Feeble-minded; Mr. Geo. Ross, Superintendent, Boys' Industrial School; Mr. E. C. MacDonald, Principal, School for the Deaf and the Blind, Vancouver; Dr. Geo. Davidson, Director of Social Welfare; the Committee recommends:—

Re the Psychiatric Clinic.—Because of the excellent work done by the Psychiatric Clinic under Dr. Crease, as attested by those institutions using it, and because its services, so greatly in demand, are limited by its small staff:

That this Legislature take into serious consideration means to enlarge the staff of the Psychiatric Clinic so that its work may be extended, and so as to enable it to do more field-work throughout the Province.

It is further recommended that when psychiatric facilities are enlarged they should be provided for the inmates of the Saanich Mental Institution as well.

Re the Mental Hospital at Essondale.—As both doctors from the Mental Hospital at Essondale stressed the overcrowding and stated that 400 senile cases could be cared for equally well elsewhere at less cost:

That this Legislature be asked to take steps to have these 400 senile cases moved out into some other accommodation so that the room and care given to them can be used for more serious cases.

Re the New Westminster Institution for the Feeble-minded.—Since overcrowding there is quite evident and since the programme of training is excellent but limited:

That this Legislature be asked to increase accommodation for the inmates, and to provide additional facilities for occupational therapy.

Re the Boys' Industrial School.—In view of the difficulties caused by the two types of sentences (definite and indeterminate) given to boys by different Courts causing unrest and resentment among them:

That this Legislature be asked to consider making the indeterminate sentence the rule, and to have the length of detention determined by the Superintendent of the school.

Further, as the normal capacity of the school is 38, and as it now houses 52; and in order to facilitate segregation for incorrigibility and communicable diseases; and to provide adequate space for different types and ages; and because of present unsuitable location:

That this Legislature be asked to take steps to have the present site changed and

suitable accommodation provided elsewhere.

Re the School for the Deaf and the Blind.—In view of the overcrowding since 1925 and the great fire risk involved in the present building, and in view of the long waiting-list of children both of school age and of a pre-school age:

That this Legislature be asked to consider providing more suitable accommodation

elsewhere.

Finally, the Committee recommends, aside from improving the institutional care of individuals:

That this Legislature be urged to place increasing emphasis on preventive

measures and on follow-up and after-care in all cases.

The Committee wishes to commend heartily the work of the Superintendents of all institutions reported upon. The Committee feels that excellent work is being done in every case, and its only recommendations are for the removal of difficulties and the increase of facilities so that the good work may be extended.

All of which is respectfully submitted.

Mr. Gillis presented the First Report of the Select Standing Committee on Labour, as follows:—

REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM,

MR. SPEAKER:

February 11th, 1942.

Your Select Standing Committee on Labour begs leave to report as follows:—

Your Committee held two meetings, one on January 28th, 1942, to consider the following Resolution of Mr. H. E. Winch:—

"That the Standing Committee on Labour be instructed to examine into the present jurisdictional position of Provincial Statutes appertaining to labour in relation to Federal Orders in Council with a view to recommending to the Legislature ways and means of removing any conflict that may be found to exist or which would assist in clarifying the situation as regards interpretation and jurisdiction."

The Honourable the Minister, Mr. Pearson, attended and pointed out that the Resolution would imply that conflict exists in jurisdiction as between Dominion and

Province.

This, he stated, is not correct in that when the Dominion exercises its prerogative under the "War Measures Act" and occupies any legislative field in whole or in part, the Province is excluded from that field to the extent occupied by the Dominion.

The Minister quoted section 91, "British North America Act," defining "Powers of Parliament"; section 92, "British North America Act," defining "Exclusive

Powers of Provincial Legislatures."

Said section 91 authorizes Parliament to enact laws for the "peace, order, and good government of Canada," and while on the surface this may not appear to vest sufficient authority in Parliament to empower it to go as far as it has gone in enacting certain drastic war-time laws, the Courts have upheld Parliament on the grounds that full and ample authority is implied if not actually expressed.

The Minister explained what had been done to ascertain and set out respective

fields of responsibility with a view to avoiding confusion.

Industrial Disputes.—He explained that the Dominion had assumed full responsibility for industrial disputes by extending the "Industrial Disputes Investigation Act" of Canada to cover (a) munitions of war, (b) supplies, and (c) defence projects.

Your Committee held two meetings, one on February 2nd, 1942.

James Robertson, representing the Canadian Congress of Labour, addressed the meeting and read a brief which he left with the Committee.

Mr. Robertson stressed the point that section 5 of the "Industrial Conciliation and Arbitration Act" should be repealed chiefly on account of the fact that this section gives an opportunity to delay the commencement of negotiations.

C. H. Chivers also addressed the meeting and also stressed the same point. Mr. Chivers represented the American Federation of Labour,

Mr. Gargrave moved, seconded by Mr. Herridge,-

That the section of the "Industrial Conciliation and Arbitration Act" referred to be referred to the Minister of Labour, and that this Labour Committee recommend it to the favourable consideration of this Session.

Motion carried.

The meeting adjourned.

The Labour Committee met on February 11th, at 10 a.m.

Whereas Canada has been at war for over two years and casualties are already returning from overseas:

And whereas it is already known that business will be greatly dislocated due to war conditions:

And whereas it is expected that there will be a great influx of immigration from the British Empire and from the war-torn countries of our allies:

"1. Measures likely to be necessary to supplement Federal Government plans for the civil re-establishment of demobilized members of the forces in respect of training, employment, and settlement.

"2. Measures likely to be necessary to provide alternative employment for workers now engaged in war industries and provisions for the training and transfer of such workers to peace-time occupations.

"3. Plans for the conversion of industrial equipment from war-time to peace-time purposes and for the development of new industries.

"4. Plans for the satisfactory use of surplus primary products.

"5. All such other matters as may be considered necessary for post-war readjustment and development.

"The said Commission to report as required to His Honour the Lieutenant-Governor and to report its findings and recommendations at the next Session of the Legislature."

The Hon. Mr. Maitland rose to a point of order with reference to the following notice of motion standing on the Order Paper in the name of Mr. Lefeaux:—

That, in the opinion of this House, the Government should take into consideration the appointment of permanent District Crown Prosecutors.

Mr. Speaker reserved his decision.

Prayers by Mr. Speaker.

On the motion of the Hon. Mr. Hart, the House proceeded to the Orders of the Day, "Motions and Adjourned Debates on Motions."

Mr. Speaker delivered his reserved decision on the point of order raised on the 11th instant by the Hon. Mr. Maitland on the following notice of motion standing on the Order Paper in the name of Mr. Lefeaux:—

That, in the opinion of this House, the Government should take into consideration the appointment of permanent District Crown Prosecutors.

Honourable Members,—The Honourable the Attorney-General raised a point of order with reference to the motion of the honourable second member for Vancouver Centre which reads as follows: "That, in the opinion of this House, the Government should take into consideration the appointment of permanent District Crown Prosecutors." He suggested the motion is out of order on two grounds: (1) That it would involve Government expenditure and (2) that it dictates Government policy.

At the present time, except in isolated instances, Crown Prosecutors are appointed whenever the occasion requires. I have no means of telling whether the system suggested by the motion would be more or less expensive than the present system. I feel I ought not to assume that the motion would involve increased Government expenditure.

On the second point I would point out that a Bill would not be required to inaugurate the system of appointment suggested by the motion.

Appointments are not made at the present time under the authority of any Statute. They are made under the general authority vested in the Attorney-General for the administration of the Criminal Law. I hesitate to extend the principle that a private member may not dictate Government policy, to a mere matter of administration.

I rule, therefore, that the motion is in order.

Whereas the prosecution of the war against Nazism and Fascism is the first concern of the Governments of Canada;

This Legislative Assembly of British Columbia, recognizing the grave perils facing the British Commonwealth of Nations and all those united nations of the world now opposing in war the aggression of the Axis powers, hereby pledges the total resources of the Province to Canada for the purpose of victory:

Therefore be it Resolved, That without any desire to encroach upon the rights and privileges of the Federal Parliament, we urge the Government and Parliament of Canada to implement the pledge given as a signatory to the Twenty-six Nations Pact on January 1st, 1942, wherein each Government pledged to employ its full resources against those members of the Tripartite Pact and its adherents with which such Government is at war by a compulsory national selection of man-power and the mobilization of the whole resources of Canada, both human and material, for the purpose of victory:

And, further, that it concurs in the "call for total war" made to the Prime Minister of Canada by the Canadian Legion of the British Empire Service League at Ottawa, October 21st, 1941.

On the motion of Mr. H. E. Winch, seconded by Mr. Turner, it was Resolved,-

Whereas scientific advances throughout the world would appear to indicate that if British Columbia is to keep abreast of world trade and world demand we must press ahead with development of new technical processes:

And whereas if this Province does not undertake extensive research so as to apply the general discoveries of science to our own particular problems we may find our present products superseded by newer ones, and our resources inadequately used:

And whereas the constant progress of industry hinges on the pioneering of the scientist:

Therefore be it Resolved, That in the opinion of this Legislature the question of establishing a British Columbia Research Institute is a matter worthy of the immediate sympathetic consideration of the Government.

Mrs. Steeves moved, seconded by Mrs. Jamieson,—

Whereas by a referendum vote of the electorate of this Province in 1937 a considerable majority voted in favour of "a comprehensive Health Insurance Plan progressively applied":

And whereas no effective action has been taken by the Government to implement this expression of opinion by the people:

And whereas war conditions have made the need for effective medical services for all more acute:

Therefore be it Resolved, That this House is of the opinion that the Government should take under immediate consideration the implementation of a Provincial Health Insurance system.

The Hon. Mr. Perry rose to a point of order.

Mr. Speaker ruled the motion out of order on the ground that it involved the expenditure of public money and as one not competent for a private member to move without the consent of the Crown.

Mr. Uphill moved, seconded by Mr. Guthrie,-

Whereas there are many persons at present detained in internment camps in this country against whom the only charge laid is in that these persons have endeavoured to avail themselves of the right or privilege of free speech:

And whereas many of these persons are desirous and capable of rendering military or skilled mechanical services to this country either in the service of the naval, military, or air forces, or in the factories:

Therefore be it Resolved, That this Legislature recommends to the Government of the Dominion of Canada that wherever practicable such persons be given immediate opportunity to render service to the country wherever such services would be most appropriate according to the circumstances of each case.

The Hon. Mr. Perry moved in amendment, seconded by the Hon. Mr. Pearson,-

To strike out all the words after "whereas" in the first line, and to substitute therefor the words "it is alleged there are persons whose domicile was in British Columbia, who are detained in custody or otherwise by authority of the Federal Government and have not been brought to trial for any offences:

"Therefore be it Resolved, That this Legislature requests the Attorney-General of British Columbia to seek information from the Federal authorities as to the causes and reasons for the detention of all persons so detained whose domicile was in the Province of British Columbia."

Amendment agreed to.

Motion as amended agreed to.

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. Paton was withdrawn:—

That this House memorialize the Federal Government asking it to extend the area of the Pacific Coast Defence Zone to include the Fraser Canyon to a point north of Lytton and the line of the Kettle Valley Railway between the towns of Princeton and Hope.

Mrs. Jamieson moved, seconded by Mrs. Steeves,—

That in the opinion of this House, the fruit and vegetable industry should not be exempt from the "Hours of Work Act," except in so far as the same shall relate to perishable fruit and vegetables which cannot be prevented from deterioration except by immediate processing.

By leave of the House, the motion was withdrawn.

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. Shepherd was withdrawn:—

Whereas in many instances insufficient time is available for Select Standing Committees to complete their work during the Session, thereby reducing their usefulness:

Therefore be it Resolved, That the House resolve itself into a Committee of the Whole to discuss procedure and powers of Select Standing Committees and recommend such changes in the Rules of the House as will enable them to function more efficiently.

On the motion of the Hon. Mr. Perry (in the absence of the Hon. Mr. Hart), seconded by Mr. H. E. Winch, it was Resolved,—

This Legislative Assembly of British Columbia, conscious of the gravity of the war and more particularly in its relation to the security of the people of the Province of British Columbia, consider it our solemn duty to call the attention of the Federal Government of Canada to the immediate necessity of completing the strongest and fullest measures of defence against our enemies.

Mr. Paton asked the Hon. the Minister of Public Works the following questions:—

- 1. Was any money received from the estate of the late J. Haldi in or about the year 1932?
 - 2. If yes, how much was it?
 - 3. Under what conditions was it given?
 - 4. Were any of the moneys expended?
 - 5. If yes, what for?
 - 6. How much remains unexpended?

The Hon. Mr. Anscomb (Minister of Mines) replied as follows:—

- "3. Subject to the condition that the Provincial Government would construct a bridge between Fort Langley and McMillan Island within two years after the date of his decease, in accordance with plans and specifications approved by his executors.
 - "4. Yes.
 - "5. Construction of bridge and approaches.
 - "6. None."

Resolved, That the House, at its rising, do stand adjourned until 3 o'clock p.m. to-day.

His Honour was pleased, in His Majesty's name, to give assent to the said Bills.

The said assent was announced by the Clerk of the House in the following words:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth assent to these Bills."

Then Mr. Speaker addressed His Honour the Lieutenant-Governor as follows:—MAY IT PLEASE YOUR HONOUR:

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government and humbly beg to present for Your Honour's acceptance Bill (No. 37) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

At the close of the First Session of the Twentieth Parliament of British Columbia, it is my desire, in relieving you from your legislative duties, to express my sincere appreciation of the care and earnestness that have characterized your deliberations.

It was with deep regret that I learned of the recent death of His Royal Highness the Duke of Connaught, our former Governor-General. I am pleased to note that your Assembly have passed an appropriate resolution of sympathy with His Majesty the King and members of the Royal Family.

I observe with satisfaction that this Legislature have ratified an agreement whereby are surrendered certain Provincial revenues to the Dominion Government for the furtherance of the nation's war effort.

I also have noted with gratification and pleasure that provision has been made for increasing the allowances to Old-age Pensioners, whose domestic and pecuniary position has been disturbed by the exigencies of the war. This provision, I am sure, will do much to ameliorate the situation in which many of these aged people have been placed.

The Act providing for the establishment of a Post-war Rehabilitation Council, working in close co-operation with the Federal authorities, is a wise measure, providing, as it does, a means of anticipating and endeavouring to find satisfactory solutions of the serious problems that may arise when hostilities cease.

Acts have been passed to further safeguard the interests of our gallant men in the fighting services, and I have noted the sincerity of the Members in pledging themselves to any undertaking within the scope of their power to prosecute the war until victory is ours.

The further strengthening of British Columbia's financial position by debt retirement, with consequent savings in interest and sinking fund charges, I am sure, will commend itself to all citizens.

The assurances that have been given to co-operate to the full in the nation's war programme, and the measures that already have been taken to implement these pledges, are evidence of the Government's compliance with the people's will.

Since you last assembled, many of our valiant men have been in action in the bitter struggle in which this Dominion, as a member of the great Commonwealth of Nations, has become involved. We face the outcome of that struggle with fortitude and unbounded confidence, and with a supreme faith in the rightness of our cause.

I thank you for the adequate provision you have made for the public services, and I sincerely trust that the efforts you have put forth during the Session now closed will result in the continued development and prosperity of all parts of British Columbia.

In relieving you from your legislative duties, I join with you in invoking the aid of Divine Providence for the preservation of those Christian and democratic institutions for which the British Empire and her Allies now are fighting, and trust that, when this Legislature again convenes, events will have occurred which will bring us to a closer realization of that lasting peace so longed for by all free-thinking people.

The Hon. Mr. Pearson, Provincial Secretary, then said:

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
