The Lieutenant-Governor transmits herewith a Bill intituled "An Act to amend the Motor-vehicle Act," and recommends the same to the Legislative Assembly.

Government House, March 3rd, 1960.

Ordered, That the said Message, and the Bill accompanying the same, be referred to a Committee of the Whole House forthwith.

(IN THE COMMITTEE.)

Resolved, That the Committee rise and report to the House, recommending the introduction of a Bill (No. 68) intituled "An Act to amend the Motor-vehicle Act," a draft of which is annexed to this Resolution.

Resolution and Bill reported.
Report adopted.
Bill introduced and read a first time.
Second reading at the next sitting after to-day.

The Hon. L. Wicks (Minister of Commercial Transport) presented the Interim Report of the Royal Commission on Road User Charges, dated February 26th, 1960.

Mr. Eddie asked the Hon. the Minister of Commercial Transport the following questions:—

With reference to the "Department of Commercial Transport Act," 1959:—

- 1. What was the amount collected by way of overload permits under this Act to December 31st, 1959?
- 2. What was the amount collected by way of oversize permits under this Act to December 31st, 1959?
- 3. What was the total cost of administration, including salaries, for the collection of overload and oversize permits?

The Hon. L. Wicks replied as follows:-

- "1. There has been collected, by way of overload permits, to December 31st, 1959, the sum of \$102,922.99.
- "2. There has been collected, by way of oversize permits, to December 31st, 1959, the sum of \$114,422.
 - "3. Figures not available."

Mrs. Brown asked the Hon. the Minister of Social Welfare the following question:—

Under the Child Welfare Division, how many adoptions were completed by Court order in (a) 1954/55 and (b) 1958/59?

The Hon. W. D. Black replied as follows:-

"(a) 1954/55, 1,102, and (b) 1958/59, 1,309."

Mr. Gregory asked the Hon. the Provincial Secretary the following questions:—

- 1. Has a group life insurance policy been purchased for members of the Civil Service and, if so, (a) with what company and through what agent was the policy purchased and what is the first year's premium and (b) were tenders called and, if so, when were they called, what was the closing date, and what companies submitted tenders and, if not, why not?
- 2. If the answer to No. 1 is no, is the purchase of a group life insurance policy for members of the Civil Service under consideration and, if so, will tenders be called, when will they be called, and what will the closing date be and, if not, why not?

The Hon. W. D. Black replied as follows:—

- "1. No; (a) and (b) answered by No. 1.
- "2. The firm of Marsh & McLennan Limited, consulting actuaries, which assisted in the preliminary studies of the proposed plan, has been retained as agent for the Government; in order to institute the proposed plan at the earliest possible time and, subject to the approval of Bill No. 42, the firm, on February 22nd, 1960, invited the submission of tenders, with a closing date of 12 o'clock noon on March 29th, 1960."

Mrs. Haggen asked the Hon. the Attorney-General the following questions:—

With respect to prisoners transported by the Royal Canadian Mounted Police during 1959 to prisons in British Columbia:—

- 1. How many prisoners were transported to each prison in British Columbia?
- 2. What was the total cost of transporting these prisoners?
- 3. What was the total cost of escorting these prisoners?
- 4. What was the total cost for each form of transport for (a) prisoners and (b) escorts?
- 5. How many prisoners were transported by (a) Grand Forks detachment and (b) Greenwood detachment?
- 6. What was the cost of transporting (a) prisoners and (b) escorts from each of these detachments by each means of transport?

The Hon. R. W. Bonner replied as follows:-

- "Material unavailable in the detail requested, but see Report of Director of Correction."
- Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—
- 1. During the year 1959, did any psychiatrists resign from the Mental Health Services?
- 2. If the answer to No. 1 is yes, (a) what was the total number of resignations, (b) in which departments did the resignations take place, and (c) what reasons, if any, were given for the resignations in each case?

The Hon. E. C. F. Martin replied as follows:-

- "1. Yes.
- "2. (a) Four; (b) Crease Clinic, 2; Provincial Mental Hospital, 1; Mental Health Centre, 1; and (c) three resigned to enter private practice and one resigned to accept a position of Assistant Professor of Psychiatry at the University of Cincinnati."

Mr. Gibson asked the Hon. the Minister of Municipal Affairs the following questions:—

With reference to the 1959/60 winter work incentive programme:—

- 1. How many projects have been approved in British Columbia to February 29th, 1960?
- 2. Approximately how many persons would be employed in the projects approved to February 29th, 1960?
- 3. What was the total estimated cost of the 1959/60 approved projects to February 29th, 1960?

The Hon. W. D. Black replied as follows:—

- "1, 341.
- "2. 3,561 men with a total of 201,015 man-days.
- "3. In thousands of dollars: Total cost of projects,\$12,600; total direct payroll, \$4,962; direct payroll to end of programme, \$3,250; shared as follows: Canada, \$1,525; Province, \$865; and municipalities, \$860."

Mr. Eddie asked the Hon. the Provincial Secretary the following questions:—

- 1. Will complete enumeration of voters be undertaken in any areas prior to the next Provincial election?
- 2. If the answer to No. 1 is yes, in which areas will such enumeration take place?

The Hon. W. D. Black replied as follows:—

- "1. Yes.
- "2. In practically every electoral district partial enumeration will be undertaken; those districts where a complete door-to-door canvass will take place are Burnaby, North Vancouver, Vancouver-Burrard, Vancouver Centre, Vancouver East, Vancouver-Point Grey, Chilliwack, Delta, Dewdney, New Westminster, Esquimalt (urban), Oak Bay, Saanich, and Victoria City."

Mr. Newton asked the Hon. the Minister of Social Welfare the following question:—

Have Social Allowance basic rates been increased since 1952 and, if so, when and in what amounts?

The Hon. W. D. Black replied as follows:—

"Effective April 1st, 1954, \$5 per month for each head of family or single person and \$2 per month for each dependent; effective April 1st, 1956, \$5 per month for each head of family or single person and \$2 per month for each dependent; effective April 1st, 1958, \$10 per month for family of two, plus \$2 per month for each additional dependent, and \$5 per month for each single person; and effective April 1st, 1960 (subject to approval of the Legislature), 20 per cent increase in basic Social Allowances presently paid."

Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. Has any plan been made to provide a new surgery wing to the Crease Clinic?
- 2. If the answer to No. 1 is yes, what progress has been made on this project?

The Hon. E. C. F. Martin replied as follows:—

- " 1. Yes.
- "2. Architect's plans prepared."

- Mr. Gregory asked the Hon. the Attorney-General the following questions:— In each year since 1952:—
- 1. How many persons have been charged with indictable offences in the Province?
- 2. How many persons were (a) found guilty, (b) found not guilty, and (c) cases dismissed?
- 3. Of persons found guilty, how many were (a) under 30 years of age and (b) under 20 years of age?

The Hon. R. W. Bonner replied as follows:-

"See Reports of the Director of Correction (formerly Inspector of Gaols) for British Columbia and 'Statistics of Criminal and Other Offences,' compiled by the Dominion Bureau of Statistics, for the relevant years."

Mr. Reid asked the Hon. the Provincial Secretary the following questions:—

With reference to grants under the "Elderly Citizens Housing Aid Act":—

- 1. What were the total amounts of grants for each of the following fiscal years: 1955/56, 1956/57, 1957/58, and 1958/59?
- 2. What was the total accommodation supplied by operating projects at December 31st, 1959?
- 3. At December 31st, 1959, approximately what was the total accommodation supplied in (a) self-contained housing units and (b) projects supplying board?

The Hon. W. D. Black replied as follows:—

- "1. 1955/56, \$123,056.02; 1956/57, \$300,000; 1957/58, \$343,849.17; and 1958/59, \$512,200.65.
 - "2. 2,318 persons.
 - "3. (a) 1,578 persons and (b) 740 persons."

Mr. Tisdalle asked the Hon. the Minister of Social Welfare the following question:—

Have maximum supplementary assistance rates been increased since 1952 and, if so, when and in what amounts?

The Hon. W. D. Black replied as follows:-

"Effective April 1st, 1954, \$5 per month to maximum of \$15 per month; effective April 1st, 1956, \$5 per month to maximum of \$20 per month; and effective April 1st, 1960 (subject to approval of the Legislature), 20 per cent increase in supplementary assistance presently paid."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. on Monday next.

And then the House adjourned at 5.20 p.m.
