And whereas the inauguration of an air ambulance service would prove of great value to encourage industrial expansion, pioneering, and land settlement in the remote areas:

And whereas a Provincial Government operated air ambulance service could also be used to provide transportation of social-service personnel, nurses, doctors, dentists, and the injured in urgent cases:

Therefore be it Resolved, That this Legislature recommends to the Government that consideration be given to the advisability of establishing an air ambulance service in the Province of British Columbia.

A debate arose, which was, on the motion of the Hon. R. W. Bonner, adjourned to the next sitting of the House.

7. By whom were the members of the said committee appointed?

8. What moneys have been available to and for the uses of the said committee in each of the several years since the inception of the said committee and by whom?

9. How many certificates of entitlement have been issued by the said committee in each of the several years since the inception of the said committee?

10. How many applications for certificates of entitlement have been refused by the said committee in each of the several years since its inception?

11. What amounts have been paid pursuant to such certificates of entitlement in each of the several years since the inception of the said committee?

12. In each of the several years since the inception of the said committee, what is the total amount of judgment debts alleged by unsuccessful applicants for certificates of entitlement to have been unpaid?

Mr. Speaker made the following statement:---

Honourable Members,—The Chairman of the Committee of Supply, the honourable member for Prince George, has drawn my attention to a news item on the front page of the Colonist of March 14th, headed "Liberal Slaps Down Socred House Tyro," and reports that this item is correct and in part is as follows: "'This discussion on the "Elections Act" has gone far enough, and I . . . ,' he began. The honourable member for Skeena exploded, 'What's that? Who are you to tell us what we can discuss and what we can't? I never heard of such a thing. I'm amazed at your audacity. Who do you think you are?'"

May I draw the attention of the House to the fact that the Chairman was quite within his right in his suggestion that the debate should no longer follow the line that had developed, in view of the fact that a ruling on these lines had already been made.

All this arose out of a question regarding statutory votes and in the matter of estimates. In the matter of the estimates and in the matter of the statutory votes, these votes are of two kinds. One is where the Statute provides for the payment of a fixed amount and states that it is payable out of Consolidated Revenue, such as Vote 282 in the current Estimates. The other is where the Statute provides for certain expenditures and states that if there has been no vote for such, passed with the Estimates, payment may be made out of Consolidated Revenue; for example, Vote 283.

As to whether these should be presented in the Estimates and passed is a legal question not to be determined by me. As I find the former practice has always been not to include them under a vote number and not to submit a Resolution, this should be a good authority. Presumably they are for information to members as to what is included in the Grant of Supply.

Sir Erskine May is our authority that no vote may be passed over and not moved, so that, where an item is in the Estimates as a vote and the Resolution presented to the Chairman, it follows that the item is open to debate even though it may not be varied.

Let me again remind you of the limitations of debate on the Estimates. We have no relevant Standing Order but we find good authority in Sir Erskine May's Treatise, 15th edition, from which I quote as follows: "The procedure of the Committee of Supply follows the ordinary usage of the Committee of the Whole House. No amendment can be moved which is not relevant to the grant under consideration. No vote may be passed over and not moved, but a motion for postponing a proposed Resolution can be entertained. Each Resolution forms a distinct motion which can only be dealt with by being agreed to, reduced, negatived, superseded, or, by leave, withdrawn; and the withdrawal can be made although the decision of the Committee has been taken upon an amendment proposed to the Resolution. Here, however, the power of the Committee ceases. The Committee may vote or refuse a grant or may reduce the amount thereof either by a reduction of the whole grant or by the omission or reduction of the items of expenditure of which the grant is composed, but the Committee has no other functions" (page 709).

And again: "No method has been established for obtaining in the Committee a joint discussion upon the administration of the expenditure sanctioned by the several estimates; the debate must be kept to the specific object of the grant which is placed before the Committee" (page 713).

And again: "The necessity for legislation and matters involving legislation cannot be discussed in Committee of Supply" (page 717).

During the Address in reply to the Speech from the Throne and on the motion "That Mr. Speaker do now leave the chair" for the House to go into Committee of Supply, and even under the debate on the granting of salary to a Minister, a great deal of latitude is permitted in the subjects for discussion. When one considers that so much time has already been devoted to these matters, the justice of a rule such as the one given above is very obvious. Discussions of subject-matter of this type—that is, legislation—can only be brought up under a substantive motion and it ill becomes an experienced member of the House to use such language in questioning the authority of the Chairman. It would be permissible to challenge the ruling but it is not courteous to address a Chairman in such a manner.

I would respectfully request that members do seriously study what I have said as it will be an invaluable guide in future Committee of Supply and Ways and Means debates.

Honourable Members,—Arising out of the ruling given by the Speaker on Monday, March 16th, the Hon. the Leader of Her Majesty's Most Loyal Opposition raised the point that for at least the last twenty years any item shown as a statutory vote could be

discussed under the preceding numbered vote. There is no record of alleged practices of this House in respect to this matter, consequently I may only be guided by and rule upon our own Standing Orders and the practices obtaining in the Mother of Parliaments.

In respect to this, I would ask you to look at Standing Order No. 1, which says, and I quote:-

"1. In all cases not provided for hereafter or by sessional or other orders, the usages and customs of the House of Commons of the United Kingdom of Great Britain and Northern Ireland as in force at the time shall be followed as far as they may be applicable to this House."

In view of the fact that there are no sessional or other orders covering the procedure outlined, this House is bound by Standing Order No. 1. There is a further fact and that is that the House, whether sitting formally or in Committee, cannot indulge in indiscriminate discussion but must have something tangible to discuss—that is, a motion.

Any numbered item in the Estimates constitutes a motion and is subject to discussion, but any unnumbered item in the Estimates is equally, obviously, not a motion and, therefore, is not subject to discussion.

The House, of course, has always within itself the right to make any amendments to its Standing Orders or to lay down any ruling that it may regard as necessary for the proper conduct of the House, but I am bound by the knowledge at my disposal to adhere to the ruling made yesterday.
