## Monday, 19th November, 1923.

TWO O'CLOCK P.M.

Prayers by Mr. Speaker.

Mr. Anderson presented a petition from the Corporation of the District of Oak Bay, objecting to certain provisions of Bill (No. 52) intituled "An Act relating to the Corporation of the City of Victoria."

On the motion of the Hon. Mr. Manson, the following Bills were introduced, read a first time, and Ordered to be read a second time at the next sitting:—

Bill (No. 28) intituled "An Act to amend the 'Legal Professions Act.'"

Bill (No. 29) intituled "An Act to amend the 'Distress Act."

Bill (No. 30) intituled "An Act to amend the 'Court of Appeal Act.'"

Mr. Duncan moved, seconded by Mr. Menzies,-

Whereas a large quantity of timber is being cut from British Columbia forests and taken outside of Canada for manufacture:

And whereas this practice is resulting in the exploitation of one of our natural resources with little benefit to the Province:

And whereas numbers of wage-earners are leaving British Columbia on account of an insufficiency of employment:

And whereas the manufacture of all timber cut in this Province would materially increase employment and conserve the timber resources for the benefit of Canada:

Therefore be it Resolved, That this House is of the opinion that a heavy export duty should be imposed by the Dominion Government on all unmanufactured British Columbia timber going outside of Canada.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted to the Hon. Secretary of State or other proper official at Ottawa.

A debate arose, which was, on the motion of the Hon. Mr. Pattullo, adjourned to the next sitting.

On the point of order raised by the Hon. Mr. Oliver on 16th instant with reference to questions (No. 10 on the Order Paper of November 16th) standing in the name of Mr. Pooley, Mr. Speaker delivered his reserved decision, as follows:—

- "On Friday, the 16th instant, Mr. *Pooley* asked the Honourable the Attorney-General the following questions:—
- "'1. What has been the total amount paid to date to the legal firm in Vancouver of which Robert Smith is a member since this Government took office until November 1st, 1923?
  - "'2. Is the said Robert Smith a son of the lady Member of Vancouver?'
- "The Honourable the Premier objected to the questions as being contrary to the Rules of this House.
- "As to the first question, after careful consideration I find it indefinite and not necessarily related to the public affairs of the Province.
  - "As to the second question, I can see no relation to the information sought for.
  - "Attention was drawn to questions on page 75, Journals, 1916.
- "There I find two sets of questions directed to the then Honourable Attorney-General as to his business relations with a certain legal firm, the title of the firm being stated.
  - "The questions now asked differ materially from those quoted.
  - "I must rule them out of order."

  - 2. Is said work being done by contract or day-labour?
  - 3. What is the object of the said road?
  - 4. Does the Government intend to put on a ferry across Sooke Harbour to East Sooke?

The Hon. Dr. Sutherland replied as follows:-

The Hon. Dr. MacLean replied as follows:—

"This question was answered by the Hon, the Minister of Public Works a few days ago."

Mr. Lister asked the Hon. the Provincial Secretary the following questions:-

- 1. What sum is in hand arising out of the administration of the "Superannuation Act"?
- 2. In what securities are the funds invested?
- 3. If not invested in securities, what form does the investment take?

The Hon, Dr. MacLean replied as follows:-

Mr. Jones asked the Hon. the Minister of Agriculture the following questions:-

- 3. What sum has been received from the sale of lands or in return from the expenditures on this area?

Mr. Neelands asked the Hon. the Minister of Education the following questions:-

  - 4. If not, why not? If so, how many?

Mr. Duncan asked the Hon. the Minister of Lands the following question:-

What quantity of unmanufactured timber was exported from British Columbia during the years 1920 and 1921 respectively?

The Hon. Mr. Pattullo replied as follows:-

"1920: From exportable lands, 20,643,389 F.B.M.; from non-exportable lands, 8,030,549 F.B.M.; total for 1920, 28,673,938 F.B.M. 1921: From exportable lands, 61,944,649 F.B.M.; from non-exportable lands, 28,271,858 F.B.M.; total for 1921, 90,216,707 F.B.M."

Mr. Menzies asked the Hon. the Minister of Agriculture the following questions:-

- 1. How many acres in the Merville Settlement were seeded to grass following the fire in July, 1922?
  - 2. What quantities of seed were used?
  - 3. What was the total cost of said seed?
  - 4. What was the cost of labour in seeding?
  - 5. How was the total cost apportioned?

The Hon. Mr. Barrow replied as follows:-

- "1, 2.175 acres.
- "2, 17,399 lb.
- " 3. \$5,654.40.
- " 4. \$1,484.80.
- "5. Each lot seeded was charged its own proper proportion of seed (and labour, if any), except twenty-four burnt-out settlers, whose land was seeded free of charge."

Mr. W. A. McKenzie asked the Hon, the Minister of Public Works the following questions:-

- 1. Has the Department authorized the building of a road from Fort St. John towards Fort Nelson?
  - 2. If so, what is the length of that road, and what will be the cost of same?
  - 3. Is the work going on at present? If so, will it be continued this winter?
- 4. How many settlers are there on the road after it leaves Fort St. John going towards the Nelson River?
  - 5. What is the reason or justification for building this road?

The Hon. Dr. Sutherland replied as follows:-

- "2, About 165 miles; probably \$15,000 or less.
- "3. Expect work will be completed this fall, but work to continue only as climatic conditions permit.
  - "1. Yes, a sleigh-road.
- "4 and 5, Present trail inadequate to take care of increasing freight traffic. Freight that formerly went through Alberta will go this route for the north country. Settlers will be in a position to have work provided for their teams and it will also provide a local market for the settlers."

Mr. W. A. McKenzie asked the Hon. the Minister of Public Works the following questions:-

- 1. Did one A. B. Currie, of Salmon Arm, receive a contract last year to rock 2 miles or more of Otter Road without tender?
  - 2. If so, why was this done, and what amount was paid said Currie?
- 3. Did the same Currie obtain work from the Department this year without tender between Chase and Notch Hill?
  - 4. If so, why, and what amount was paid Currie?

The Hon. Dr. Sutherland replied as follows:-

- "1. One mile of main trunk road, Salmon Arm to Vernon, surfaced with rock. Submitted price to District Engineer and approved by Department.
  - "2. Work done in this instance was economically and efficiently carried out
- "3. District Engineer authorized to carry out work. A. B. Currie employed on station-work by contract.
  - "4. See first part of answer No. 2; paid to date, \$6,001.64."

Mr. W. A. McKenzie asked the Hon, the Minister of Public Works the following questions:-

- 1. Has the work in connection with the erection of the Acute Mental Hospital at Essondale been carried out according to plans and specifications as at the time contract was awarded?
  - 2. If not, what changes have been made, and why?

The Hon. Dr. Sutherland replied as follows:-

"1 and 2. Plumbing fixtures altered so as to enable British and Canadian firms to fulfil requirements of specifications; otherwise no material change made."

Mr. Lister asked the Hon, the Provincial Secretary the following questions:—

- 1. Have representations been made by the Provincial Civil Servants' Association with a view to the placing under the dome of the Parliament Buildings of a memorial to those members of the Civil Service of British Columbia who gave up their lives during the Great War?
  - 2. Are other memorials already placed there?
  - 3. What reply was given to the request of the above-mentioned association?
  - 4. If a refusal was given, why?

The Hon. Dr. MacLean replied as follows:-

- "1. Yes.
- "2. Yes.
- "3. Request would be given consideration.
- "4. Answered by No. 3."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

And then the House adjourned at 4.45 p.m.

On the motion of the Hon, Mr. Manson, Bill (No. 31) intituled "An Act to make Uniform the Law respecting Life Insurance Contracts" was introduced, read a first time, and Ordered to be read a second time at the next sitting.

The House resumed the adjourned debate on the motion moved by Mr. Duncan on 19th instant, as follows:—

Whereas a large quantity of timber is being cut from British Columbia forests and taken outside of Canada for manufacture:

And whereas this practice is resulting in the exploitation of one of our natural resources with little benefit to the Province:

And whereas numbers of wage-earners are leaving British Columbia on account of an insufficiency of employment:

And whereas the manufacture of all timber cut in this Province would materially increase employment and conserve the timber resources for the benefit of Canada:

Therefore be it Resolved, That this House is of the opinion that a heavy export duty should be imposed by the Dominion Government on all unmanufactured British Columbia timber going outside of Canada.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted to the Hon. Secretary of State or other proper official at Ottawa.

The Hon. Mr. Pattullo moved in amendment, seconded by the Hon. Dr. MacLean,—

That all the words of the Preamble and of the Resolution after the first word "Whereas" be struck out, and the following words substituted therefor:—

"Quantities of timber are being cut from forests in British Columbia and elsewhere in Canada and taken out of Canada in an unmanufactured condition:

"And whereas it is desirable that Canadian timber should, as far as practicable, be fully manufactured before leaving Canada:

"And whereas the Canadian Government has appointed a Royal Commission for the purpose of inquiring into the exportation of pulp-wood:

"Therefore be it Resolved, That this House would respectfully request the Canadian Government to extend the powers of the before-mentioned Royal Commission, and to instruct them to inquire into all the circumstances relating to the export of unmanufactured timber, and to report as to what action, if any, should be taken in respect thereof.

"And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted by telegraph to the Honourable the Secretary of State for Canada."

On the motion of Mr. Hanes, the debate was adjourned to the next sitting.

Mr. Hanes moved, seconded by Mr. Menzies,-

That in the opinion of this House the Government should consider the introduction of a Bill at this Session extending the following privileges to married women in this Province: (a) All property owned by either husband or wife before marriage to be his or her separate estate, over which he or she has entire control; (b) all property acquired after marriage (except by gift or bequest) to be joint property, of which neither partner may give away, will away, or otherwise alienate more than half, without the written consent of the other partner; (c) the joint estate to be administered by the spouse transacting the business of the family; (d) all the aforesaid to be subject to the "Testator's Family Maintenance Act" (chap. 94, 1920).

A debate arose, which was, on the motion of the Hon. Mr. Manson, adjourned to the next sitting.

Mr. Burde moved, seconded by Mr. Hanes,—

Whereas certain representatives of India, at the Imperial Conference and elsewhere, have been urging that natives of India should be given the vote in Canada:

And whereas practically the whole Hindu population in Canada is resident in British

And whereas the Indian franchise in India is so extremely limited that if the franchise in British Columbia were extended to those here on the same basis, less than a score would be able to vote:

And whereas those Hindus now here have never voted in India, and have expressed no desire to have the franchise here:

And whereas the Premier of Canada, at the Imperial Conference, stated that the matter would be debated in the House of Commons at its next sitting while dealing with the "Franchise Act"; and also expressed himself in the House of Commons as wishing to hear the views of British Columbia:

And whereas it is desirable that this Legislature should give expression to the wishes of British Columbia on this important subject:

Therefore be it Resolved, That this Legislature is strongly opposed, on economic and social grounds, to allowing any Oriental to vote in this Province, either in Provincial or Dominion elections, and therefore urge the Federal Government to take no steps that would interfere with

the undoubted right of the Province to prescribe the form and extent of its own franchise, and further urge the Government of Canada, when defining its Dominion franchise, not to enfranchise Orientals.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that he will cause a copy of the Preamble and Resolution hereinbefore set out to be transmitted to the Right Honourable W. L. McKenzie King, Premier of Canada.

A debate arose, which was, on the motion of the Hon. Mr. Sloan, adjourned to the next sitting.

"And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted by telegraph to the Honourable the Secretary of State for Canada."

Mr. Hanes moved in amendment to the amendment, seconded by Mr. Neelands,-

That all the words after the word "therefor," in the second line, be struck out, and the following substituted therefor:—

"It is desirable that all timber cut in this Province (coming within the jurisdiction of the British Columbia Legislature) be manufactured within the Province:

"Therefore be it Resolved, That in the opinion of this House all timber coming under the jurisdiction of this Province be manufactured within the Province before leaving Canada."

On the motion of Mr. Farris, the debate was adjourned to the next sitting.

  - "3. Yes. Year 1915, \$7,786.15; year 1917, \$2,974.27; year 1918, \$8,423.42.
- "4. Years 1915 and 1917, promissory notes; year 1918, lien notes chargeable against the land. Frequent applications by this Department and through the Government Agents."

Mr. Lister asked the Hon. the Minister of Lands the following questions:-

- 1. Was R. W. Haggen, B.C.L.S., employed in the survey of Provincial lands in Cariboo District during the years 1921, 1922, and 1923?
- 2. Did any returned soldiers, qualified British Columbia land surveyors, or practising and residing in Cariboo District, apply for employment in the survey of Provincial lands in each of the years 1921, 1922, and 1923?
  - 3. If so, what were their names?
  - 4. Were they so employed?
  - 5. If not, why not?
  - 6. Is R. W. Haggen a returned soldier?
- 7. Was R. W. Haggen employed in the field in the survey of Provincial lands in each of the years 1914 to 1919, inclusive?
- 8. Was said Haggen also employed as Judge of the Court of Revision for the Barkerville Assessment District?
  - 9. If so, how long has he held this position?
  - 10. Is the said Haggen also President of the Quesnel Liberal Association?

The Hon. Mr. Pattullo replied as follows:-

- " 1. Yes.
- "2. Yes.
- "3. E. J. Gook and G. B. Bagshaw.
- " 4. No
- "5. Appointments of surveyors are made to do survey-work as required. The surveyor with the best experience and local knowledge is selected for obvious reasons. Seventy-five per cent. of survey-work has been in charge of returned soldier surveyors.
  - "6. No.
  - "7. Yes.
  - "S. No information.
  - "9. No information.
  - "10. No information."

Mr. Catherwood asked the Hon, the Minister of Lands the following question:-

What was the total cost to the Department of Lands of furnishing the new Prince Rupert Court-house?

The Hon. Mr. Pattullo replied as follows:-

"No new purchases made."

Mr. W. A. McKenzie asked the Hon, the Attorney-General the following questions:—

- 1. Does the Liquor Board ship liquor from Victoria to Fernie, Cranbrook, and other Kootenay points?
  - 2. If yes, why is this practice carried out?
- 3. What extra cost per car-load is earned by shipping car-load lots from Victoria as against shipments from Vancouver?
  - 4. Is the Board in the habit of shipping liquor from Vancouver to Victoria?
- 5. If yes, is it the practice to reship any of the aforesaid liquor to Fernie, Cranbrook, or other Kootenay points?

The Hon. Mr. Manson replied as follows:-

- "1. Yes
- "2. Because Victoria is the distributing centre for these stores and freight rates are the same from Victoria as from Vancouver. The locality of the store, convenience in shipping and freight rates, determine the stores to be supplied from each warehouse. The division of such stores is made as nearly equal as possible consistent with the above.
  - "3. No additional cost is involved.
  - " 4. No.
  - "5. Answered by No. 4."

Mr. Jones asked the Hon. the Attorney-General the following questions:—

- 1. How many motor-licence number-plates were purchased by the Government for 1922 and 1923 respectively?
- 2. Were tenders called for? If so, who tendered, and what were the amounts of said tenders?
  - 3. Which tender was accepted?

The Hon, Mr. Manson replied as follows:--

- "1, 1922: 34,500 pairs motor number-plate markers (patented device). 1923: 41,300 pairs motor number-plates; 2,600 single motor number-plates.
- "2. 1922 plates cost \$8,500. No tenders called for as J. R. Tacey & Son, Vancouver, controlled the patents.
- "1923. Tenders called for and the following tenders were received: The Thomas Metal Sign Co. of Ontario, \$7,421; The B.C. Iron Works, Victoria, \$10,444; J. R. Tacey & Son, Vancouver, \$10,500; F. Mellor, Esq., Victoria, \$11,190; E. L. Woodruff, Esq., Victoria, 22 gauge \$19,046, 24 gauge \$18,446; The Western Engineering Co., Vancouver, \$22,250; The Hiker Manufacturing Co., Victoria, 24 U.S. \$26,110, 22 English \$26,110; T. A. Hill, Esq., Vancouver, \$26,995; The Western Toy Co., Vancouver, \$28,302.
  - "3. Tender awarded to J. R. Tacey & Son, Vancouver, B.C."

Mr. Esling asked the Hon. the Minister of Railways the following questions:—

- 1. Did the Pacific Great Eastern Railway lend the Dominion Government any rails?
- 2. If so, how many tons, and when?
- 3. Have these rails been returned or payment made for same by the Federal Government?
- 4. If so, when and where were they delivered; or, if payment was made, what was the amount and when was it paid?

The Hon. Dr. MacLean replied as follows:-

- "1. Yes.
- " 2. 10,022.10 tons in 1918.
- "3. Returned.
- "4. 1920; 4,902.30 tons to Prince George, 5,119.80 tons to Squamish."

Mr. Lister asked the Hon. the Minister of Finance the following questions:—

- 1. What employees of the Department of Finance have received increases of salary since March 31st, 1923?
- 2. Give the salary now received by each of the above, the amount of increase, and the date of the previous increase?

The Hon. Mr. Hart replied as follows:-

"These questions will be answered in a Return to be brought down by the Hon. the Provincial Secretary."

Mr. W. A. McKenzie asked the Hon, the Provincial Secretary the following questions:-

- 1. Did Civil Service Commissioner MacInnes make a trip to Atlin this year?
- 2. If so, on what duties?
- 3. How many persons were employed in the offices in Atlin inspected by said MacInnes?
- 4. What was the total cost of this trip allowed by the Department?
- 5. What was the amount of the voucher submitted by said MacInnes?
- 6. Was any deduction made in said bill?
- 7. If so, how much, and the reasons for making said deductions?
- 8. Did an Auditor of the Comptroller-General's Department duplicate this trip to Atlin shortly afterwards?
  - 9. If so, what was the justification for both officials taking this trip?
  - 10. What was the expense of the Auditor's trip to Atlin?

The Hon. Dr. MacLean replied as follows:—

- "1. Yes.
- "2. Inspection.
- "3. Four.
- "4. Trip to Atlin was made in connection with a trip of inspection of the offices at Atlin, Prince Rupert, Smithers, Fort Fraser, Fort George, Quesnel, Barkerville, Williams Lake, Clinton, Ashcroft, Lillooet, and Vancouver. Total cost of whole trip, \$344.15.
  - " 5. \$370.15.
- "6 and 7. Voucher submitted included item for all days absent from Victoria at \$6.50 per diem allowance pursuant to Order in Council No. 1256, 1922. Audit Office expressed opinion that per diem allowance should not be paid for the four days on steamer. Commissioner altered youcher accordingly to \$344.15. Voucher as amended paid without any deduction.
- "8, 9, and 10. No information in this Department regarding movements of officials of Comptroller-General's Department. Duties of Civil Service Commissioner quite distinct from those of the Comptroller-General and his staff,"

Mr. Menzies asked the Hon, the Provincial Secretary the following questions:-

- 1. How many white children were born in the Province in the years 1900, 1910, and 1922 respectively?
  - 2. How many Chinese and Japanese children were born in the Province in the same years?
- 3. How many Chinese, Japanese, and Hindus entered the Province during the years 1900, 1910, and 1922 respectively?

The Hon, Dr. MacLean replied as follows:-

- "1. It is impossible to give accurate information on this point, as (a) all births of children born in the Province are not registered, and (b) registrations of births are frequently delayed until years after birth actually occurred; e.g., births that occurred in the years 1881 to 1886 appear in registrations of 1922. The number of registrations, irrespective of the date of birth, was as follows: 1900, 1,774; 1910, 5,005; 1922, 10,834. The following information can be given re birth registrations in the year 1922: Total registrations in 1922, 10,834; born and registered in 1922, 8,959; born in 1921, but registered in 1922, 1,236; born in 1920, registered in 1922, 107; born prior to 1920, 532.
- "2. The following particulars can be given. Registrations assigned to year of birth. Chinese: 1900, 61; 1910, 106; 1922, 173. Japanese: 1900, 2; 1910, 38; 1922, 553. The number of registrations for 1922 was as follows: Chinese, 264; Japanese, 745.
  - "3. Information not available here."

Mr. Lister asked the Hon. the Minister of Public Works the following questions:-

- 1. Has the Government Architect examined the Lloyd George School at Kamloops?
- 2. Has he recommended the repair of said school?
- 3. If so, what will said repairs cost?
- 4. Will the Government contribute anything to said repairs?
- 5. If so, what responsibility has the Government for contributing?

The Hon. Dr. Sutherland replied as follows:-

- "1. Yes.
- "2. Yes.
- "3. No report or costs given by Architect to Board.
- "4 and 5. Not under jurisdiction of this Department."

Mr. Jones asked the Hon. the Minister of Finance the following questions:—

- 1. What is the assessed value respectively of real property, personal property, wild land, and school lands in the Vernon Agency for 1923?
  - 2. What are the sums levied for taxes on each for 1923?
- 3. What sums of money have been collected to date for motor licences, gun licences, probate duties, or any other tax in the Vernon Agency for 1923?
  - 4. What is the total sum of money received as revenue from the Vernon Agency for 1923? The Hon, Mr. Hart replied as follows:—
- "1. Real property, \$11,372,712; personal property, \$1,167,103; wild land, \$46,680; school lands, \$8,587,377.
- "2. Real property, \$113,745.17; personal property, \$11,671.03; wild land, \$2.334; school taxes, \$51,521.52.
- "3. Real property, \$73,373.53; wild land, \$1,016; income, \$12,824.05; personal property, \$17,171.57; acreage tax, \$266.75; school tax, \$36,346.70; interest, \$4,469.68; tax-sale deeds, \$130; tax-sale advertising, \$79.25; poll-tax, \$605; amusements-tax, \$5,530.70; real-estate licences, \$287; miscellaneous receipts, \$240.38.
  - "4. \$152,340.61."

Mr. Lister asked the Hon. the Minister of Agriculture the following questions:-

- 1. What moneys have been paid C. E. Whitney-Griffiths in the way of salary and expenses since October 1st, 1922, to date, with details?
  - 2. What position does he hold?

The Hon. Mr. Barrow replied as follows:-

- "1. No salary. Time allowance, \$787.50; travelling expenses, \$1,044.63.
- "2. Secretary and member of Advisory Board of Farmers' Institutes."

Mr. Catherwood asked the Hon. the Attorney-General the following question:-

What was the total cost to the Attorney-General's Department of furnishing the new Prince Rupert Court-house?

The Hon. Mr. Manson replied as follows:-

"\$2,059.95, including alterations, repairs, and reconditioning old furnishings."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. on Monday next.
