186. *Resolved*, That a sum not exceeding \$400 be granted to Her Majesty to defray the expenses of Miscellaneous, Destruction of Wolves and Panthers, to 30th June, 1890.

192A. *Resolved*, That a sum not exceeding \$1,550 be granted to Her Majesty to defray the expenses of Miscellaneous, Compensation to Settlers at Howe Sound, to 30th June, 1890.

192B. *Resolved*, That a sum not exceeding \$1,800 be granted to Her Majesty to defray the expenses of Miscellaneous, Aid to Settlers at Nicola, seed grain on account of destruction of crops by locusts, to 30th June, 1890.

Schedule A. *Resolved*, That a sum not exceeding \$682.85 be granted to Her Majesty to dispose of a certain sum which appears in the Balance Sheet of the Province as an Asset, and to bring the same to account in the Expenditure of the Province, for the year ending 30th June, 1890 (H. B. Roycraft—Defalcations in accounting for Revenue Collections at Victoria in 1889).

Schedule B. *Resolved*, That a sum not exceeding \$45,278.33 be granted to Her Majesty to make good certain sums expended for the Public Service for the year ended 30th June, 1889, and to indemnify the several officers and persons for making such expenditures.

Upon Mr. Speaker resuming the Chair, Mr. *Duck*, Chairman of the Committee, reported that the Committee had come to several Resolutions, and asked leave to sit again.

Ordered, That the Report be considered at the next sitting of the House.

Resolved, That the House will, at its next sitting, again resolve itself into the said Committee.

The Report on Bill (No. 2) intituled "An Act to amend the 'Municipal Act, 1889,'" was further considered.

Mr. *Beaven* moved the following as a new clause:—

Section 96 of the "Municipal Act, 1889," is hereby amended by adding thereto the following sub-sections:—

"(121.) For purchasing, acquiring, holding, managing, maintaining land, or improvements, or both, for the purpose of a fire hall, or halls, within the municipal limits:

“(122.) For purchasing, acquiring, holding, managing, maintaining land, or improvements, or both, for the purpose of a site for a free public library, or a partially free library, within the municipal limits.”

Carried.

Mr. *Croft* moved the following as a new clause:—

Section 96 of the “Municipal Act, 1889,” is hereby amended by adding the following as sub-section (4a):—

“(4a.) For subsidizing by way of bonus, or by guaranteeing the payment of bonds of or the interest on bonds of, such line or lines of steamships or steamboats as shall establish, within or without the limits of the Municipality, a port of call or the terminus of such line or lines.”

Carried.

Mr. *Croft* moved the following as a new clause:—

Part (6) of sub-section (6) of section 96 of the “Municipal Act 1889,” is hereby amended by striking out the word “six” in the first line and inserting in lieu thereof the word “seven.”

Carried.

Mr. *Grant* moved the following as a new clause:—

Section 168 of the “Municipal Act, 1889,” is hereby amended by adding the following as sub-section (24):—

“(24.) From every express company, gas company, telephone company, electric light company, street railway or tramway company, investment and loan societies, fur dealers or fur traders, a sum not exceeding fifty dollars for every six months.”

Carried.

Mr. *Grant* moved the following as a new clause:

If on account of a sum being on hand from a previous year or years, or from the investment of the sinking fund, or on account of the increased value of property liable to assessment, it is found to be unnecessary to levy the full rate imposed by the by-law in order to raise the instalment of the sinking fund and interest required to be raised for any year, or to raise such instalments for any future years of the then unexpired time which the debentures have to run, the Council may pass a by-law reducing the rate for such year or for any such future years, so that no more money may be collected than the amount required. No such by-law shall be passed unless, having regard to the time the debentures have to run, a proper proportion of sinking fund and interest has been levied, according to the intention of the original by-law.

Carried.

Mr. *Grant* moved the following as a new clause:—

No by-law passed under the preceding section shall be valid unless, after it is passed, it is approved by the Lieutenant-Governor in Council; and the facts which authorized the passing of such by-law shall, on its submission for approval, be verified by solemn declaration by the head of the Council, and by the treasurer and clerk thereof in case of the death or absence of such officer, upon the declaration of any other member of the Council whose declaration the Lieutenant-Governor in Council may accept.

Carried.

Mr. *Grant* moved the following as a new clause:—

In any case of passing a by-law for contracting a debt by borrowing money for any purpose, the Municipal Council may in its discretion make the principal of the debt repayable by annual instalments during the currency of the period within which the debt is to be discharged; such instalments to be of such amounts that the aggregate amount payable for principal and interest in any year shall be equal, as nearly as may be, to what is payable for principal and interest during each of the other years of such period, and may issue the debentures of the Municipal Corporation for the amounts and payable at the times corresponding with such instalments, together with interest, annually or semi-annually, as may be set forth and provided in the by-law.

“The by-law shall set forth a certain specific sum to be raised in each year during the currency of the debt, which annual sum shall be sufficient to discharge the several instalments of principal and interest accruing due on such debt as the said instalments and interest become respectively payable, according to the terms of the by-law; and in cases within this section it shall not be necessary that any provision be made for a sinking fund.”

The motion was withdrawn.

On the motion of Mr. *Beaven* it was *Resolved*,—

That the Law Clerk of the House be authorized to re-arrange the amended sections of Bill No. 2 so as to read them consecutively in conjunction with the "Municipal Act, 1889."

The further consideration of the report was adjourned to Thursday next.

The Hon. Mr. *Vernon* asked leave to introduce a Bill (No. 64) intituled "An Act to alter and amend the 'Coal Mines Act.'"

Leave granted.

Bill introduced and read a first time.

Ordered to be read a second time on Wednesday next.

Pursuant to Order, the House went into Committee of the Whole, with Mr. *Croft* in the Chair, to consider the Message of His Honour the Lieutenant-Governor enclosing a Bill, *re* subsidy in aid of the Shuswap and Okanagan Railway.

On the motion of the Honourable Mr. *Robson*, seconded by the Honourable Mr. *Davie*, it was *Resolved*,—

That a Bill intituled "An Act in aid of the Shuswap and Okanagan Railway Company," be reported to the House.

The Committee reported the Resolution.

Report adopted

Bill (No. 62) intituled "An Act in aid of the Shuswap and Okanagan Railway Company," was read a first time.

Ordered to be read a second time to-morrow.

The Honourable Mr. *Vernon* asked leave to introduce a Bill (No. 65) intituled "An Act to further amend the 'Land Registry Act.'"

Leave granted.

Bill introduced and read a first time.

Ordered to be read a second time to-morrow.

Pursuant to Order, the House went into Committee of the Whole, with Mr. *Mason* in the Chair, to consider the Message of His Honour the Lieutenant Governor enclosing a Bill, *re* Lands in aid of the Columbia and Kootenay Railway.

On the motion of the Hon. Mr. *Davie*, it was *Resolved*,—

Prayers by the Rev. *A. Beanlands*.

The consideration of the Report on Bill (No. 2) intituled "An Act to amend the 'Municipal Act, 1889,'" was adjourned until Tuesday next.

Mr. *Cunningham* asked the Hon. the Chief Commissioner of Lands and Works the following question:—

Why has not the Government issued to *Samuel Greer* a Crown grant of the land comprised in pre-emption 1,003, in conformity with the recommendation of the Select Committee's report, which was adopted by the House on the 27th day of April, 1888?

The Honourable Mr. *Vernon* replied as follows:—

The land to which Mr. Greer prefers a claim is situated on the south side of English Bay, immediately east of Lot 192, Group 1. It was within and formed part of a certain timber limit, which was granted to "The British Columbia and Vancouver Island Spar, Lumber and Saw Mill Company, Limited," under a lease dated 30th November, 1865.

This lease reserved the right of pre-emption to *bona fide* settlers upon the written sanction of the Governor and Superintendent of the Company.

Sanction to pre-empt was granted to Mr. S. Preston on 3rd April, 1873, and a pre-emption record was issued to him, numbered 1,003, and dated 14th April, 1873.

No evidence has been produced to show that Preston ever occupied the claim, as provided by the Land Laws. On the contrary, the sworn evidence taken by the Select Committee appointed by the Legislature in 1885 proves that he never legally occupied it, *e. g.*,—

1st. S. Greer, being examined, says "At the time that Spinks' claim was applied for, it (Preston's claim) was open for pre-emption according to the Land Laws of British Columbia" (Journals 1885, p. ix.), which is an admission that it was not legally held by Preston.

2nd. R. H. Alexander, giving evidence touching the claims of Preston and others, says "None of these ever took up their claims" (Journals 1885, p. xii.).

3rd. J. C. Hughes says of S. Preston's claim, "It was abandoned long ago" (Journals 1885, p. xvii.).

4th. The evidence of Mr. Mackie, Sr., shows conclusively that Preston's claim had been abandoned, and that he (Mackie) had been on the land six or seven months before Greer appeared (Journals, p. xxv.).

Mr. Greer's claim has not been recognized by the Government for the following reasons, viz. :—

1st. S. Preston's pre-emption claim being abandoned, was cancelled by Section 7 of the "Land Amendment Act, 1882.";

2nd. Preston had never obtained a Certificate of Improvement, and consequently could not legally transfer any interest he may have had (if any) to Greer or any other person. (See Sec. 13, Land Act, 1870.)

3rd. Greer was at that time, and still is, the holder of a pre-emption claim at Chilliwhack, and could not hold a second pre-emption claim at the same time legally.

Mr. Greer wrote to the Lands and Works Department on 1st November, 1886, enclosing a cheque in payment of the purchase money due on his pre-emption at Chilliwhack, and requested the issue of a Crown grant.

In reply, Mr. Greer was informed by a letter from the Land Office, dated 3rd November, 1886, that a Crown grant would be issued for his pre-emption claim upon receipt of his original certificate of pre-emption record and certificate of improvement, as is customary in such cases. No reply was received from Mr. Greer, and so the matter now rests.

4th. Putting Preston out of the question, the land was reserved officially from sale or settlement, and not open to pre-emption at, prior, or subsequent to the date Greer took possession, which was in June, 1884. In addition to the reserve, a notice was published on the 2nd May, 1884, warning all persons not to squat upon or otherwise deal with lands in that vicinity. Mr. Greer ignored this notice, and should have no advantage over law-obeying citizens, who paying heed to it did not seek to acquire public lands illegally.

5th. A Crown grant, including the land in question, was issued to Donald A. Smith and Richard B. Angus on 13th February, 1886, in accordance with an agreement previously entered into with the Canadian Pacific Railway Company.

The inconsistency of the grounds upon which Mr. Greer based his claim to the land in question is apparent when it is borne in mind that he first rested such claim, say from June, 1884, up to December, 1886, not upon any rights acquired through Preston, but through a purchase from certain Indians, in evidence of which a deed was produced which was subsequently impeached and formed the subject of an inquiry by Royal Commission (dated 20th March, 1885), and pronounced by Sir M. B. Begbie, the Commissioner, to be a forgery. The Indian claim failing him, Mr. Greer then sought to acquire through Preston.

With respect to the claim by pre-emption advanced by Walls, Spinks, Greer and others, the Commissioner in his Report says :—

"The title of the applicants, Messrs. Walls and others, so far as it is based, the pre-emption application 17th June, 1884, and their purchase from the alleged pre-emptor, appears obvious to the following objections, among others :—

"1st. The land was in the Hastings Mill leasehold, and could not be pre-empted without the consent of the Manager and Chief Commissioner, which had not been procured.

"2nd. It was not 'unreserved land,' having been expressly reserved by the Chief Commissioner, 30th May, 1884.

"3rd. It was not 'unoccupied' land. There were two Indians and one or two white men raising crops there.

"4th. Neither the attempting pre-emptor, nor any person on his behalf, erected a single post, as required by the Act, or of any kind.

"5th. The alleged pre-emptor has never yet spent a night on the land, although in his letter of application, 17th June, he alleges that he is 'living on the land.'

"6th. The pre-emption record was at once and definitely refused.

"7th. No certificate of improvement appears to have been issued, without which no pre-emptor can convey any title, even if his pre-emption record be unimpeachable."

Bill (No. 43) intituled "An Act to amend the 'Vancouver Incorporation Act, 1886,'" was read a third time and passed.

The adjourned debate on the motion for the third reading of Bill (No. 19) intituled "An Act to amend the 'Crow's Nest and Kootenay Lake Railway Company Act, 1888,'" was resumed.

Mr. Speaker *Higgins* gave his decision on the point of order raised on the 26th instant, as follows:—

I am asked to rule whether the principle of a Private Bill, which was brought regularly before the House and subsequently withdrawn, can be revived and embodied in another Private Bill, which also came before the House in regular course, without the sanction and co-operation, by petition or otherwise, of the promoters of the original Bill, and without having been before the Private Bills Committee in its amended form.

The point arose in this way:—The Hon. Member for *Kootenay*, at the third reading stage, gave notice of an amendment to a Bill entitled "An Act to amend the 'Crow's Nest and Kootenay Lake Railway Company's Act, 1888.'" This amendment embodies the principle and powers contained in a Bill introduced during the present Session, entitled "An Act to incorporate the Nelson and Kootenay Lake Railway Company." The order for the second reading of this Bill was discharged by the House, on motion of the Hon. Member for *Kootenay*. To the amendment exception was taken by the Hon. Senior Member for *Victoria City*.

After a careful examination, I am of opinion that the authorities mainly relied upon by the Hon. Member for *Kootenay* have reference to Public and not to Private Bills, and that the Bill, as he proposes to amend it, must come under the head of Amalgamated Bills, page 826, *May*, which says:—

"When powers are applied for to amalgamate with any other company, or to sell or lease the undertaking, or purchase or take or lease another undertaking, or to enter into traffic arrangements, all such particulars are to be specified in the Bill as introduced into Parliament."

It is unnecessary for me to point out that this course has not been adopted, and I have serious doubts as to the power of amalgamation without the consent of both parties having first been obtained. The agreement should be mutual in its character; for surely it will not be contended that one company can amalgamate with another company without the consent of both having first been obtained, any more than that a marriage ceremony can be legally performed without the consent of both parties to the contract having been obtained. The discharge of the order for the second reading of a Private Bill cannot be accepted as evidence of the dissolution of the company that promoted it.

I would advise that a petition from the "Nelson and Kootenay Lake Company," and another from the "Crow's Nest and Kootenay Lake Company," for amalgamation, be first presented, and that the whole matter be then referred to the Private Bills Committee, with instructions to report an amalgamated Bill to the House.

The debate was further adjourned until to-morrow.

Pursuant to Order, the House went into Committee of the Whole, with Mr. *Tolmie* in the Chair, to consider the Messages of His Honour the Lieutenant-Governor of 14th and 25th March, instant, respectively, enclosing Bill, and amendment thereto, *re* grants of Land for Charitable and other purposes.

The Bill was reported complete with amendments.

Report *Ordered* to be considered at the next sitting of the House.

Bill (No. 11) intituled "An Act respecting Railways," was again considered in Committee of the Whole, with Mr. *Cunningham* in the Chair.

The Committee reported progress and asked leave to sit again.

Ordered, That leave be granted for to-morrow.

Resolved, That the House, at its rising, do stand adjourned until two o'clock to-morrow.

And then the House adjourned at 5:55 o'clock, p. m.

Prayers by the Rev. A. *Beanlands*.

On the motion of the Hon. Mr. *Turner*, seconded by Mr. *Cunningham*, it was *Resolved*,—

That whereas it is shown by the Customs reports that *Victoria* is the sixth port in the Dominion of Canada, the Customs duties collected in the year ending 30th June, 1889, amounting to \$796,723, and the number of vessels entering that year being 585, of a total tonnage of 558,678, and the number of passengers landing being 118,783, and the exports for the same year being \$1,946,186 ;

That whereas the trade of this port is likely to increase very considerably during the coming year, owing to new lines of steamers being put on, and to the greater efficiency of present lines, and to the larger number of sailing vessels making this port their destination ;

And whereas owing in part to the great amount of steamer traffic, and partly to natural causes, the harbour of *Victoria* is becoming silted up, and the water, particularly in front of wharves, is decreasing in depth, and the trade of the port is thereby greatly inconvenienced ;

And whereas it is of the utmost importance in the interest of the Dominion, as well as of the Province, that the trade of this port should be encouraged and developed ;

And whereas by a systematic and regular plan of dredging the harbour of *Victoria* could at a comparatively small cost be kept in a thoroughly commodious and safe condition for the vessels frequenting it ;

And whereas large expenditures are annually made in eastern ports to render them commodious for shipping, and to promote the commerce of the Dominion ;

Be it therefore resolved, That an humble Address be presented to His Honour the Lieutenant-Governor praying His Honour to urgently press on the Dominion Government the importance of having the harbour of *Victoria* properly dredged and deepened, and having some rocks removed from the channel for the purpose of straightening it, and the necessity, in the interest of commerce, of the work being at once proceeded with.

Mr. *Ladner* presented a Report from the Select Committee to whom was referred Bill (No. 12) intituled "An Act to amend the 'Game Protection Act, 1889,'" reporting an amended Bill.

The Report was received.

On the motion of Mr. *Ladner* Bill (No. 12) intituled "An Act to amend the 'Game Protection Act,'" was read a first time.
