Honourable Members,—At the last Session the Honourable the Leader of the Opposition placed on the Order Paper a notice of motion for the House to resolve itself into a Committee of the Whole to consider the advisability of revising the Rules, Orders, and Forms of Procedure of the Legislative Assembly. The notice of motion was withdrawn on the understanding that I would, in the interval between Sessions, make a study of the subject-matter of the motion and report to the House.

I accordingly engaged the services of Major W. H. Langley, K.C., formerly Clerk of the House, and have now received from Major Langley a statement in which he says:---

"I may add that I have given this matter very careful consideration during the past few months and have been unable to come to any other conclusion than as verbally advised you; there is not, in my opinion, any good or useful reason for making any material change in such Standing Orders at the present time."

Major Langley corresponded with Mr. Arthur Beauchesne, C.M.G., Clerk of the House of Commons, in this connection and, in addition, consulted the Standing Orders of other Parliaments and made a comprehensive study of the whole question. I also have given the matter serious consideration and do not see in what respect the Standing Orders could be greatly improved. They were revised in the year 1930 by a Special Committee composed of the Speaker and several members of the Legislature. They were adopted by the House following the report of that Committee. They are based upon the Standing Orders of the Canadian House of Commons and embody relevant provisions of the "British North America Act" and the British Columbia "Constitution Act." Mr. Beauchesne advises Major Langley that the only change in the Standing Orders of the House of Commons since 1930 was a provision providing for the appointment of a Deputy Chairman of Committees.

I gather from remarks made by the Honourable the Leader of the Opposition, in the course of a speech delivered earlier this Session, that he feels the restrictions on private members are too great, especially in the matter of motions brought forward by a private member dealing with Government policy. There are numerous Speakers' decisions on the point which have been sustained on appeal to the House. The main reason for those decisions is that the Government, being charged with the responsibility of carrying out Government policy, ought not to have responsibilities thrust upon it which it is not prepared to assume. The responsibility for carrying out the policy suggested by the private member does not rest upon the private member, but upon the Government.

Since the House has, on appeal, frequently affirmed the rule against private members dictating the policy of the Government by way of motions, I feel that it is for the House to decide whether there should be any relaxation of the rule.

If a resident of some other Province in Canada hunts in British Columbia and illegally exports game, action can be taken against such violator under the Canada 'Game Export Act.' United States fish and wild-life agents in the United States always closely check game shipments, and if some are not in order, the British Columbia Game Department is promptly advised and proper action taken." Mr. E. E. Winch asked the Hon. the Minister of Labour the following questions:-----

1. In how many instances last year was an aeroplane used to convey an injured workman to hospital?

2. In how many instances last year was the cost of conveyance by aeroplane of an injured workman defrayed by the Workmen's Compensation Board?

The Hon. Mr. Pearson replied as follows:---

"1. Under the first-aid service requirements, employers must in the first instances provide an injured workman 'proper care and attention and shall have available at all times suitable speedy transportation by land, air, or water, with competent attendant, to the nearest doctor or hospital, or both, where the treatment appropriate to the case is available.' The responsibility is placed directly on the employer to arrange for and provide such transportation. The Board keeps no record of transportation so provided.

"2. In three cases in 1946 it was found necessary for the Board to transport injured workmen by aeroplane after the employer had in the first instance conveyed them to places where the treatment eventually proved inappropriate for the disability which developed. In an undetermined number of other cases, apart from initial transportation as required and provided by the employer, workmen purchased transportation by aeroplane and were subsequently reimbursed by the Board for such transportation."

6. What were the purchases by the Liquor Control Board of Burton type ale from the Coast Breweries, Ltd.—namely, Westminster Breweries, Ltd.; Victoria Phoenix Brewery (1920) Co., Ltd.; and Silver Spring Brewery, Ltd.—for the calendar years 1933, 1943, and 1946?

7. What were purchases of malt beverages from outside the Province for the year 1939 and for the year 1946?

8. What was quantity of purchases of Liquor Control Board from Growers Wine Co., Ltd., in 1939 and in 1946?

This party continued in 1946 and for the two years a total of 1,213,010 acres has been surveyed. Maps and timber summaries are now in the process of compilation and will be available this year.

"3. Yes."

Has any sea-weed been collected and manufactured in British Columbia on a commercial scale during the past year?

The Hon. Mr. Eyres replied as follows:-

"None on a commercial scale—sampling only."

2. If so, how many?
