Honourable Members:

I have now had an opportunity to consider the matter raised earlier today pursuant to Standing Order 35 by the Honourable Leader of the Opposition. Before proceeding further I would like to remind all Honourable Members that other Speakers of this House have stated that "it is desirable and according to accepted practice that the Member ask the opinion of the Speaker before raising the matter in the House as the Speaker should be appraised of the proposed proceedings." As the merit of this practice is so evident I would hope all Honourable Members will conform.

A review of the statement of the matter offered by the Honourable Member discloses both the import of argument as well as an assumption of intent.

In May, 16th edition, at pages 369 to 371, a number of special restrictions are set forth on adjournment motions.

These restrictions include the following:

- (1) The matter must not import an argument:
- (2) The matter must not involve hypothetical circumstances; and further that
- (3) The motion has been refused when an ordinary parliamentary opportunity will occur shortly or in time:
- (4) When the matter could be raised on the Estimates.

Other Speakers of this House have ruled that the motion also fails because the House is currently engaged either in the Throne Debate or the Budget Debate. The Chair appreciates that some Members have already spoken in the Budget Debate but nevertheless those Members will have a further opportunity either shortly or in time to debate the matter during consideration of the Estimates.

Accordingly, the matter raised does not comply with the prerequisites to which I have referred as set forth in the 16th edition of Sir Erskine May and it is my opinion that the matter is not in order.

That the Committee may accept and consider as evidence before it any evidence and representations made before the Select Standing Committee on Agriculture appointed and acting during the Second Session of this Assembly, and any findings, decisions, and reports made by it, and may adopt and confirm as its findings, decisions, and reports, any findings, decisions, and reports on the record and evidence of the proceedings of that Committee.

- 6. And that the Committee may sit
- (a) during a period in which the Legislative Assembly is adjourned and during a sitting of the House, and

(b) during the recess after prorogation until the next following Session, and shall report to the House on the matters referred to it without delay at this Session, or following the adjournment, or at the next following Session, as the case may be.

Motion agreed to.

By leave, on the motion of Mr. *King*, the following notice of motion standing in his name on the Order Paper, was withdrawn:

1. That this House instructs the Select Standing Committee on Agriculture to examine, in four separate phases, all segments of the British Columbia food industry and to conduct this examination within the following parameters:

Phase I—Agricultural Land, Present and Future Requirements

- (a) Evaluate the amount of agricultural land currently in production within the agricultural land reserves, its present classifications and utilization in meeting current food requirements of the Province.
- (b) Determine the need for further development and improvement of those lands to both safeguard the Province's future food requirements as well as to provide for exports where such activity can be accomplished on an economically sound basis.

Phase II—Producer and Marketing Board Level

- (a) Examine the powers, pricing practices, and operating policies of the British Columbia Milk Board and of all commodity marketing boards established under the *British Columbia Natural Products Marketing Act* to determine their relative influence on retail prices of food commodities under their respective jurisdictions.
- (b) Examine comparative producer returns and changes in those returns at producer level over the past ten years of a selected list of food items in British Columbia, Alberta, and other areas of the Pacific Northwest. The list of food items shall include some commodities under marketing board control (e.g., apples, potatoes, tomatoes, broiler chickens, turkeys, milk, eggs, and mushrooms) and some which are not under marketing board control (e.g., salmon, beef, lamb, bread, bacon, oranges, breakfast cereals, and raspberries). The Committee shall be free to expand this list of items as it feels appropriate.
- (c) Examine the comparative costs of producing these food commodities in British Columbia, Alberta, and other areas of the Pacific Northwest.

Phase III—Processing, Distribution, and Merchandising Level

- (a) Examine pricing practices and merchandising methods of food merchandisers in the Province, including those involved in the processing, distribution, brokerage, wholesaling, and retailing of food. Undertake a critical examination of markups in food prices at the various levels.
- (b) Examine comparative prices and price changes over the past ten years in British Columbia, Alberta, and other areas of the Pacific Northwest at processor and retail levels of the food items examined in Phase I.
- (c) Examine comparative costs of processing, distribution, and merchandising food in British Columbia, Alberta, and other areas of the Pacific Northwest.

Phase IV-Overview

Develop a general overview of the food price situation as it is influenced by factors which the committee considers important. Included in these considerations will be

- (a) the impact of labour costs on food prices;
- (b) the impact of other input costs on food prices (e.g., the cost of money, transportation, packaging, labelling, additives, farm inputs, quotas, etc.);
- (c) examination of average weekly incomes in British Columbia and other areas over the past ten years, and the relationship of these to food prices in the same period;
- (d) examination of the degree of pricing competition between retailers in British Columbia;
- (e) the impact of food imports, franchises, and vertical integration on food prices;
- (f) examination of any other factors considered by the Committee to be significant in determining food prices.

2. That the Committee shall consider any changes in the present food marketing system which may be beneficial to consumers, producers, and merchandisers, and shall recommend methods whereby Government may influence the adoption of such changes.

3. That the Committee be authorized to engage the services of such research staff as it considers necessary to collect and compile the required information.

4. That the Committee shall have authority to send for persons, papers, and records, and to hear presentations from such organizations and individuals at public hearings or in camera as may, at the discretion of the Committee, appear necessary and, pursuant to section 80 of the *Constitution Act*, examine witnesses upon oath. The Committee shall have the authority to conduct hearings in any part of the Province.

5. That the Committee shall file its reports with recommendations to the Minister of Consumer and Corporate Affairs and the Minister of Agriculture on the following schedule:

> Phase I—not later than August 31, 1977. Phase II—not later than August 31, 1977. Phase III—not later than December 31, 1977. Phase IV—not later than March 31, 1978.

6. And the Committee may sit

(a) during a period in which the Legislative Assembly is adjourned and during a sitting of the House, and

(b) during the recess after prorogation until the next following session, and shall report to the Legislative Assembly on the matters referred to it following the adjournment, or at the next following session, as the case may be.

7. That all the books, records, transcripts, minutes of evidence, and submissions made to the Standing Committee on Agriculture in the past session be placed in the custody of this Committee for its consideration in carrying out the above instructions. Pursuant to Order, the House resumed the adjourned debate on the subamendment on the motion "That Mr. Speaker do now leave the Chair" for the House to go into Committee of Supply.

Honourable Members:

I have considered the matter raised under Standing Order 35 by the Honourable Member for Alberni, namely, press and other material relating to a decision placing the chemical 2, 4-D in "pre-review status" and a statement by an official in the United States that "we are looking at the studies to see if there should be a full review" with respect to the use of the said chemical. The Member further states that "it appears" to him that, without immediate action by the Assembly, certain people may be exposed to a chemical with carcinogenic properties.

This matter is similar to that raised on an earlier occasion under the same Standing Order, namely, "press release statements relating to Eurasian Milfoil weed in the Okanagan system" and the proposed use of chemicals in relation thereto. The reasons for not setting aside other business of the House on that occasion are to be found in the Votes and Proceedings of June 13, 1977.

It is my opinion that the matter clearly fails on one or more of the number of grounds set forth in the 16th edition of Sir Erskine May, at pages 370, 372, and 373, including the following:

- (1) The matter must not involve hypothetical circumstances.
- (2) It must not involve the exercise of discretion under statutory powers.
- (3) It must not be offered when facts are in dispute.

(4) The motion has been refused when an ordinary parliamentary opportunity will occur shortly or in time, namely, consideration of the Estimates which now have priority over all other business, except introduction of Bills.

Prayers by Mr. John L. Rennie.

Mr. Speaker delivered a reserved decision as follows:

Honourable Members:

In the course of yesterday's proceedings the Honourable 2nd Member for Vancouver-Burrard raised a point of order, namely, that the matter of certain questions directed initially to B.C. Hydro and thereafter to the Minister of Finance in his capacity as Director of B.C. Hydro have not been referred to the Committee by the House and therefore there should be no prohibition against questions relating thereto being put to the Minister in question period.

With reference to questions to Ministers, it is stated in the 16th edition of May, at page 359, that questions are inadmissible dealing with matters (a) before a parliamentary committee and (b) that no question can be asked regarding proceedings in a Committee which have not been placed before the House by a report from the Committee.

The authority cited by Sir Erskine May as the foundation of the rule is to be found in Parliamentary Debates (U.K.) No. 237, April 8, 1930, at page 1926. On that occasion a point of order was taken that, as a matter in question was under consideration by a Select Committee, it was highly improper that the House should be allowed to discuss it. The Speaker ruled that if the matter *is under discussion* by a Select Committee obviously it would be undesirable to raise it by questions in the House.

It is quite true, as the 2nd Member for Vancouver-Burrard stated, the matter in question was not "referred" to the Committee by the House as is the usual method of bringing a matter before a Select Standing Committee. However, it is clear from the authority quoted, that the essence of the rule is whether or not the matter is under *examination or discussion* by a Committee of the House, regardless of how the matter was placed in the hands of the Committee, so long of course the matter is within its competence to consider. Irrespective of the statement of the Minister of Finance, made on April 19th last, that he had "referred" the matter, the Committee has, of its own initiative, now undertaken consideration of the matter. Accordingly, the matter in question now falls within the rule as stated in Sir Erskine May.

Mr. *Barrett* rose on a point of order relating to the necessity of the House having knowledge of matters being examined or discussed in Committee on Crown Corporations, and the difficulty which might arise where the Committee was dealing with a matter on its own initiative as opposed to dealing with a matter referred to it by Resolution of the House.

Mr. *Gibson* rose on a point of order and requested Mr. Speaker to review the problem arising from the fact the Committee on Crown Corporations has a continuing mandate to review all of the operations of the five major Crown Corporations assigned to it, and that it was not the intent of the House in establishing the Committee to preclude discussion in the House. Mr. Speaker stated he would consider further the points raised by the Honourable Members.

Mr. Speaker delivered a reserved decision as follows:

Honourable Members:

At the closing of yesterday's sitting the Member for New Westminster rose on a point of order and requested the Chair to consider the tabling of a document intituled Committee on Crown Corporations Report No. 1 to the Legislative Asssembly of British Columbia, with other documents appended thereto, including the Minutes of a Subcommittee Meeting of the Select Standing Committee on Crown Corporations held on April 24, 1978, and a letter dated April 25, 1978, addressed to the Clerk of the House, whereas, in fact, the document was a report of a Subcommittee of the Committee on Crown Corporations.

Standing Order 72A (7) provides as follows:

"Notwithstanding any other Order or Rule of practice of the House, the Chairman of the Committee shall file reports of the Committee with the Clerk of the House as they are completed, but not less often than annually, and the reports shall include a copy of the minutes of the meetings of the Committee held in respect of the report."

Section 4 (5) of the Crown Corporation Reporting Act, Statutes of British Columbia, 1977, chapter 49, provides, and I quote:

"4 (5) The committee may make rules governing its own procedures and respecting its inquiries and examinations."

It would seem, therefore, that, in accordance with the statutory authority given to it and the practice of the House, the procedures themselves of the Committee as well as *questions* of procedure should be settled in the Committee and not be brought before the House.

It is the view of the Chair, therefore, that the question raised by the Honourable Member for New Westminster should be taken up in the Committee.

Mr. Speaker delivered a reserved decision as follows:

Honourable Members:

On Wednesday, April 19, the Minister of Finance made a statement in the House prior to the question period, by leave, and was granted leave to file a document referred to in the statement. The Liberal Leader asked leave to reply to the statement of the Minister and leave was not granted. The Liberal Leader cited a decision from page 83 of the Journals of 1976 indicating that Leaders of Recognized Parties have traditionally been allowed to make a reply to ministerial statements.

The rules relating to ministerial statements over the years have become somewhat confused largely, it appears, as a result of leave being required for the interruption of other business rather than leave itself being required to make the statement. In addition there is no provision in the daily order of business for ministerial statements.

An examination of our Journals indicates that the practice in our House with respect to ministerial statements has been *similar* to the practice in the House of Commons at Ottawa. In the Journals of 1976, at page 83, it is stated that leave was not required for ministerial statements and affirmed that a reply is allowed to the Leader of the Opposition and Leaders of Recognized Parties. The practice is summarized in the following passage at page 165 of Dawson's "Procedure in the Canadian House of Commons"

"For many years the Government has been allowed by custom to make statements of new or altered policy at the opening of the daily proceedings. These announcements usually relate to matters of general interest and urgency and the practice is accepted today as a useful vehicle by which Government policy may be made known to the House when no other proceeding offers a suitable opportunity. These announcements are not made by the consent of the House, nor are they recognized by any rule; but at least one Speaker has ruled that the practice is one of such long standing that a Minister may make such a statement by right. This right may not be exercised without restraint, for although there is no set limit on the length or content of the statements, a Minister who persisted in long and argumentative recitals would soon find himself in trouble with the Opposition.

"The rights of the Opposition in this matter have also gradually developed and become more clear. Early ministerial statements were followed by a few questions asked largely for the purpose of clearing up doubtful points of fact. These questions occasionally got out of hand and as early as 1891 a Speaker appealed to the House to support him in an effort to suppress the practice of conducting long discussions at such a time. Later Speakers appear to have had little difficulty and although from time to time they referred briefly to the "custom" which allowed only questions, they made no formal ruling. Mr. Speaker Macdonald extended the practice during his occupancy of the Chair and by 1951 the House had accepted a new "practice" by which each one of the leaders of the opposition parties was allowed to comment briefly on the statement made. Mr. Speaker Beaudoin extended the custom still further in 1954 and ruled that each party would henceforward be allowed one comment on any ministerial statement. The change was made to allow the party spokesman on a specific subject to represent his party should he so wish. The House has followed this practice since."

and further at page 82 of Beauchesne . . .

"In case of ministerial changes, explanations are generally allowed to be made when the Orders of the Day are called. It is usual to permit the leader of the Opposition to make some remarks thereon. Considerable latitude is allowed on those occasions. In the British House no debate is allowed after the ministerial statement has been made unless the adjournment of the House is moved, but such a practice could not take place in Canada, as our adjournment motions are not debatable."

also at page 84 of Beauchesne . . .

"When a minister makes a statement on government policy or ministerial administration, either under routine proceedings, between two orders of the day or shortly before the adjournment of the House, it is now firmly established that the Leader of the Opposition or the Chiefs of recognized groups are entitled to ask explanations and make a few remarks, but no debate is then allowed under any Standing Order (C.H. of C. Feb. 19, 1954)."

In our Journals, at page 19 of 1975, a decision indicates that leave is a prerequisite for both statements and replies but *that* decision does not really apply to the situation at hand as it is directed at answers to oral questions taken on notice.

In summary, ministerial statements may be made without leave at the appropriate time, namely, before proceeding to Orders of the Day. Leave is required, however, if the statement is to be made by interruption of another proceeding. When a statement has been made, whether by leave or by right, replies as previously described are allowed and do not require leave. However, as stated by Beauchesne, such replies are limited to asking explanations and to making "a few remarks" but no debate is allowed.

During a further point of order which took place during the discussion of the point of order, it was suggested that the Minister's statement was that of a Private Member and not that of a Minister so that no reply was allowed. The Minister's statement concerned his duties in office and, therefore, it can be viewed only as a ministerial statement.

Mr. Speaker delivered a reserved decision as follows:

Honourable Members:

I have now had an opportunity of considering the matter of privilege raised by the Honourable Member for Nelson-Creston.

The Honourable Member complains that, as a result of erroneous and misleading statements made by the Honourable Member for Omineca, his efforts to seek answers in the House have been frustrated. The Honourable Member for Nelson-Creston tabled transcripts relating to the speech of the Honourable Member for Omineca and a copy of a speech supplied to him by the Member for Omineca, which copy, according to the statement of the Member for Nelson-Creston, was not a copy of the speech which had been delivered.

It is the duty of the Speaker to be satisfied (a) that a *prima facie* case of breach of privilege has been established which would justify such proceedings taking precedence over all other business of the House (May, 17th edition, page 248) and (b) that the matter in question has been raised at the earliest opportunity (May, 17th edition, page 377).

If these prior conditions have been met, any further action is for the determination of the House and, if they have not been met, the matter must proceed by way of notice of motion should the Member so wish.

On the issue of whether or not the matter has been raised at the earliest opportunity, I notice from the material tabled that the statement in question was made in the House on April 12th last. Although the Honourable Member states that he raised the matter at the first opportunity there is no explanation of the delay.

I note in the 18th edition of Sir Erskine May, at page 343, that a matter was refused precedence when a newspaper article published on May 6th was not raised until the 14th day of May and that a matter involving a speech made on a Saturday was not raised until the following Tuesday. Possibly the delay in bringing this matter forward was occasioned by the Member for Nelson-Creston having to obtain the transcript which he tabled, although he has not so indicated. I, of course, accept the Honourable Member's statement that he raised the matter as soon as he was enabled to do so.

It appears from Speakers Decisions, Volume II, at page 46, a question of privilege was raised, predicated on a Member submitting to the House incomplete and erroneous information which was misrepresentative of the real facts. The Speaker ruled that no question of privilege was disclosed so as to dispense with the usual notice of motion.

I also note in the Journals of the House, 1975, at pages 29 and 35, a matter of privilege was raised relating to information given to the House which was alleged to have been inaccurate and misleading. On this occasion, the Speaker observed, and I quote:

Claims of breach of privilege raised by members relating to the veracity of statements attributed to members continue to plague the records of Hansard in Ottawa and the numerous claims of privilege to be found there have consistently been rejected by the distinguished Speakers of that House whenever they occur.

and *again* it was ruled that if the matter was to be pursued further it should be by regular notice.

There is no doubt that the House may treat the making of a *deliberately* misleading statement as a contempt. However, under the present circumstances which are closely analagous, if not identical, to those under review in the decisions

to which I have referred, I cannot find that there is a *prima facie* matter of privilege raised which requires precedence over other public business calling for the immediate interposition of the House.
