 - 2. If so, what was nature of such report?

3. If so, was there any cost of said Commission to the Province; and what amount?

The Hon. Mr. Tolmie replied as follows:-

"2. Answered by No. 1.

"3. Yes; \$87.55."

Mr. MacPherson asked the Hon. the Minister of Railways the following question:-

What was total cost of diversion of Pacific Great Eastern Railway through the town of Lillooet, including cost of new bridge over the Fraser River near Lillooet?

The Hon. Mr. Tolmie replied as follows:-

" \$556,643.96."

Mr. King asked the Hon. the Premier the following question:—

Was a cable of congratulation dispatched by any member of the Government to any member of the British House of Commons after the recent general election in Great Britain; and, if so, by whom and to whom?

The Hon. Mr. Tolmie replied as follows:-

"Yes; by Premier S. F. Tolmie to Right Honourable J. Ramsay McDonald."

Mr. Gillis asked the Hon. the Minister of Public Works the following question:-

Were any buildings, property of the Department, damaged by fire at Williams Lake since January 1st, 1929? If yes, was any inquiry held into such matter; and, if yes, what was the result of such investigation, and what was the amount of loss sustained, if any?

The Hon. Mr. McKenzie, Acting Minister of Public Works, replied as follows:-

"Yes. Equipment-shed at Williams Lake. Matter was inquired into by Provincial Police and a full inquiry was held under section 12 of 'Fire Marshal Act'; it was found that there was no direct evidence against any one. Net amount of loss, \$11,482."



Mr. King asked the Hon, the Minister of Public Works the following questions:-

- 1. Has any construction been carried out since January 1st, 1929, on the road commonly known as the Big Bend Road, to connect Golden and Revelstoke?
- 2. If so, has any proportion of cost of such construction been borne by the Dominion Government; and, if yes, what amount was expended by the Provincial and Dominion Governments, respectively, on such road during: (a) 1929; (b) 1930; and (c) 1931?

The Hon. Mr. McKenzie, Acting Minister of Public Works, replied as follows:-

Federal Government, by agreement, has undertaken the construction of the eastern section of this road, and, further, is contributing to the cost of the work done by the Province on the western section and between Golden and Donald, under 'Unemployment and Farm Relief Act, 1931,' and also contributed towards expenditures between Golden and Donald under 'Unemployment Relief Act, 1930.' For Provincial expenditures see Public Works Report. This Department has no information as to amounts of Dominion expenditures."
 - Mr. A. M. Manson asked the Hon, the Minister of Lands the following question:

Did a forest fire occur during 1931 in the vicinity of Nulki Lake, some 17 miles south-west of Vanderhoof? If yes, did the Department take steps to combat such fire; what was the area of timber burned; what was the total cost of combating said fire; when did said fire break out, and when did the Department commence fire-fighting operations?

The Hon. Mr. Lougheed replied as follows:-

"A fire occurred on Nulki Lake, south-west of Vanderhoof, which was extinguished by the Forest Service. Six hundred acres of merchantable timber were destroyed and 12,570 acres of unmerchantable timber and barren land burned over. Total cost of fighting fire was \$1,093.67. Fire started May 31st. Crew collected, transported to fire, and fire-fighting started June 1st."

Section 6: To add to enacted section 15A the following subsection:-

"(3.) In the event of a cancellation of any register of voters under this section, all expenses necessarily incurred in or about the preparation of the new list of voters, including the remuneration of any special Deputy Registrar of Voters or other officials, officers, and clerks employed for the purpose of the preparation of the new list, shall be paid by the Minister of Finance out of the Consolidated Revenue Fund."

Section 52 of said chapter 76 is amended by striking out the words 'Vancouver City Electoral District' in the fifth line of subsection (1), and substituting therefor the words 'Vancouver-Burrard Electoral District, Vancouver Centre Electoral District, Vancouver East Electoral District, Vancouver-Point Grey Electoral District'; and by striking out all the words of subsection (1) after the word 'nomination' where it first occurs in the twelfth line, and substituting therefor the words 'The full Christian names and surname of the proposer and seconder and of each of the other registered voters assenting to the nomination shall be subscribed to the nomination-paper, and their respective addresses and occupations shall be stated therein as shown in the list of voters. The nomination-paper may be in Form 15, and shall state the name, residence, and occupation of the person nominated as shown in the list of voters.'

"(2.) Said section 52 is further amended by striking out the words 'Vancouver City Electoral District' in the first line of subsection (3), and substituting therefor the words 'Vancouver-Burrard Electoral District, Vancouver Centre Electoral District, Vancouver East Electoral District, Vancouver-Point Grey Electoral District.'"

To insert the following as section 19 and renumber the following sections:—

"19. Section 81 of said chapter 76 is amended by striking out the words 'Vancouver City Electoral District' in the first line of subsection (4), and substituting therefor the words 'Vancouver-Burrard Electoral District, Vancouver Centre Electoral District, Vancouver East Electoral District, Vancouver-Point Grey Electoral District."

Section 19: To strike out the section and renumber the following sections.

To insert the following as section 20 and renumber the following sections:—

"20. Section 106 of said chapter 76, as re-enacted by section 17 of the 'Provincial Elections Act Amendment Act, 1925,' is amended by striking out subsection (3), and substituting therefor the following:—

"(3.) This section shall not apply to voters whose names are on the list of voters for Vancouver-Burrard Electoral District, Vancouver Centre Electoral District, Vancouver East Electoral District, Vancouver-Point Grey Electoral District, Victoria City Electoral District, or New Westminster Electoral District,"
