Mr. Gregory asked the Hon. the Premier and president of the Pacific Great Eastern Railway Company the following question:—

Have the directors of the Pacific Great Eastern Railway Company given consideration to the fact that whereas the railway carried 263,454 fare-paying passengers in 1957 (see Journals for 1957, page 59), it carried only 166,206 in 1958, and, if so, to what do they attribute the reduction and what, if anything, do they propose to do about it?

The Hon. W. A. C. Bennett replied as follows:—

"Yes; the reduction is attributed to:-

- "(1) Closing of Britannia Mining and Smelting Company's plant at Britannia and Mount Sheer:
- "(2) Curtailment of operations at Woodfibre:
- "(3) Extended fire season and forest closures with the resultant shut-down of lumbering and logging operations and the restriction on tourist traffic:
- "(4) Labour strike in the heavy construction industry at Shalalth:

"(5) Completion of Squamish Highway.

"The board of directors anticipated a decrease in passenger traffice in the Howe Sound area for 1958. To offset the loss in short-haul traffic, particular attention was directed to improving long-haul traffic. Train schedules were rearranged. Faster and more frequent passenger service was inaugurated. The passenger equipment rendered surplus by lack of passengers in the Howe Sound area was utilized to increase service in the north, with the result that, although there were 97,248 less fare-paying passengers, the total revenue passenger-miles travelled in 1958 was 14,700,958 compared to 16,349,224 in 1957. The average miles travelled per person has increased from 62 miles in 1957 to 88 miles in 1958. Month by month this average is still increasing. The month of November, 1958, showed 102; December, 1958, 106; and January, 1959, 117. This is an encouraging trend and one which the board of directors is confident will continue throughout 1959."

Mr. Campbell asked the Hon. the Minister of Finance the following questions:—

A debate arose.

The motion was agreed to unanimously.

Pursuant to Order and request, the members of the board of directors of the British Columbia Centennial Committee who were not members of the Legislative Assembly of British Columbia, presented themselves at the Bar of the House.

The two directors who are members of the Legislative Assembly, to wit, the Hon. R. G. Williston and the Hon. W. K. Kiernan, stood in their places in the House.

The Hon. W. A. C. Bennett (Premier), addressing the Speaker, made the following statement:—

Mr. Speaker,—Only occasionally in the life of a Province do great historical events occur of such extraordinary significance that to ignore them would render a disservice to the past and reflect discredit upon the present. The events of 1858 for British Columbia fall naturally into this category. It was the great year of decision and of transition and inevitably evoked the desire for a fitting centennial commemoration.

Nor does it necessarily follow that there will be available men and women not only willing to accept the challenge thus presented, but also sufficiently endowed with the vision to project a programme commensurate with the magnitude of the events commemorated and endowed also with the ability to ensure the successful completion of so

grand an undertaking.

To-night we have called before this House the board of directors of the British Columbia Centennial Committee so that the Legislative Assembly may, on behalf of the people of British Columbia, publicly acknowledge in this singular manner the service rendered.

Nearly three and one-half years ago, your Government by Order in Council charged eight men with the responsibility of planning and organizing our Centennial Celebration. Under statutory authority they became the board of directors of the British Columbia Centennial Committee. The enabling legislation provided only the legal framework within which they might operate. During 1958 the citizens of this Province, actively and with unprecedented abandon, joined in a birthday celebration which, in scope and character, had never been attempted in the Province before.

Perhaps the greatest tribute has already been paid the members of the board, not by the public acclaim with which their programme was received, but in the very organization they were able to create. The team spirit they consistently demonstrated and the inspired leadership they unfailingly provided aroused in the citizens of our Province an enthusiastic appreciation of the task in hand and, of equal importance, called forth unparalleled co-operation in fulfilling their objects. Rarely before has heavy responsibility been so cheerfully assumed and so effectively discharged. This in itself constitutes a contribution and benefit to us all.

The report of the British Columbia Centennial Committee, tabled this evening in this House, speaks for itself and indicates the many activities of the board of directors and their associates. There are certain outstanding features of that report, however, which merit particular reference.

The objective set by this board was an ambitious one—a birthday celebration in all parts of British Columbia, by all its citizens, in all their manifold fields of interest. Ours is the happy position of being able to acknowledge that ambition did not outrun accomplishment. The dedicated effort and untiring labour, often at no inconsiderable personal inconvenience, that makes this statement truthful, calls forth our unbounded gratitude not only to those who now stand before you, but also to their wives and families who so loyally supported and assisted them.

Nor must we ignore the financial accomplishments of this board. Many, perhaps, will find it difficult to believe that the full cost of the Province-wide, year-round celebration was less than \$2,900,000 and that included a sum slightly in excess of \$800,000,

the expenditure of which has enriched our Province by way of community Centennial projects of a permanent nature worth in excess of \$4,000,000. The care with which the financial operations were conducted, whereby every community, irrespective of its size, received equitable consideration and assistance in itself constitutes an example of the honourable stewardship of public funds which reflects alike the sincerity and the integrity of the board of directors.

In consequence of the work of the British Columbia Centennial Committee we have all become better citizens of this Province. We have been reminded, often dramatically, of the richness of our history and of our traditions. We have availed ourselves of the opportunity to honour the pioneers who so laboriously and yet effectively laid the foundations upon which to-day we build. Moreover, we have gained a better sense of our present potentialities and capabilities, for we have demonstrated that in a spirit of humility with mutual understanding and co-operation we need not limit our goals of achievement.

Mr. Speaker, there stands before this House the board of directors of the British Columbia Centennial Committee: The Hon. W. K. Kiernan, the Hon. R. G. Williston, Mr. T. R. B. Adams, Mr. E. F. Fox, Mr. W. E. Ireland, Dr. M. F. McGregor, Mr. T. F. Orr, and Mr. L. J. Wallace.

Gentlemen, we the members of the Legislative Assembly, in the name of the people of this Province, now formally extend to you, individually and collectively, our sincere and grateful appreciation of the tremendous service which you have performed in our behalf for the Province of British Columbia.

Mr. R. M. Strachan (Leader of Her Majesty's Loyal Opposition), addressing the Speaker, made the following statement:—

Mr. Speaker,—When the Act to provide for the celebration of the one hundredth anniversary of the establishment of the Mainland Colony of British Columbia passed this House in 1956, we had little concept of how much this legislation would change the face of our Province and bring inspiration to its every area.

Most of us accepted the fact that British Columbia was approaching the one hundredth anniversary, but who could have foreseen the effect such a celebration could have

on our people?

Who could have foreseen the blossoming interest of our people in their history and the grasping of the opportunity thus afforded to honour and record much of the past and to build for the future?

I think those of us who live in rural areas and participated in the local celebrations are fully appreciative of what the Centenary Year brought forth.

I myself had the honour of reading the Centennial Proclamation in the little rural church near my home, crowded for the occasion with many who normally follow different religions, and later at the community hall to help raise the Centennial flag—a flag which flew proudly throughout the year as we gathered to honour the pioneers of the district—the brave men and women who worked so hard and handed to us the Province of which we are all so proud.

The work of the Central Centennial Committee implanted in the minds of our people a knowledge of our history and a pride in our heritage. The Committee sustained and encouraged our local Centennial committees, provided sympathy for their troubles, and complimented the successes, and the successes were many and varied.

In the report of the Centennial Committee which we received to-night, I noticed that in the northern end of my riding, in my home district, the Centennial project was the extension of the Cedar Community Hall and the addition of a kitchen and dressing-rooms. In cold print this may not seem too much, but in reality this is the home stage of the

Yellow Point Players, a group which has added so much to the cultural development of our Province.

At the southern end of my riding, listed under the heading of the Cowichan Indian Band, is shown the restoration of the old stone church at Comiaken, near Duncan, originally constructed in 1860. For several years the Chamber of Commerce and other groups have been attempting to have this restoration work done, but it was not until the Centennial Year, and with the help of the Centennial Committee, that this was finally accomplished.

British Columbia is a better place because of the Centennial celebrations. The Committee laboured hard and well, its efforts have been fruitful. On behalf of the people

of the Province we can now thank them for a good job well done.

In the words found in the Book of Revelations: "They may rest from their labours, and their works do follow them."

Mr. Speaker, addressing the members of the board of directors of the British Columbia Centennial Committee at the Bar of the House, made the following statement:—

On behalf of the people of British Columbia, it devolves upon me to present each of you with a slight token of their appreciation of your efforts and accomplishments in the past year. Let it not be considered in any way remuneration for what you have done but merely a token acknowledgment for your invaluable services. It is, therefore, an honour and a pleasure to ask the Sergeant-at-Arms to present each of you with this small gift.
