REPORT NO. 1.

LEGISLATIVE COMMITTEE ROOM, March 20th, 1934.

### MR. SPEAKER:

That pursuant to the Resolution passed by this House on the 26th day of February, 1934, your Committee has duly considered the legislation recently introduced in the Parliament of

Canada, wherein it is proposed to establish the Bank of Canada as a privately owned corporation, and under the circumstances now obtaining deem it advisable to recommend for approval and adoption by the House the following Resolution :—

#### Currency, Credit, and Unemployment.

(1.) Whereas the money value of the interchange of services and commodities in the domestic trade of the people of the Dominion of Canada has fallen from more than \$46,000,000,000 in 1929 to less than \$30,000,000,000 in 1933; and

(2.) Whereas the said decline in Canadian domestic trade has been attended by a disastrous increase in Canadian unemployment; and

(3.) Whereas the Canadian domestic and internal trade wages and prices persist in remaining in an unhealthy condition; and

(4.) Whereas under the Canadian Constitution the Parliament of the Dominion of Canada enjoys an exclusive jurisdiction in the matter of the creation, issue, and circulation of the money and credit purchasing-power of the people of this and all other Provinces of the Dominion; and

(5.) Whereas the taxation now levied by the National and Provincial Governments and municipal authorities is imposing a burden of taxation that in many instances is destroying and confiscating the taxpayers' wealth; and

(6.) Whereas operations of private enterprise have been curtailed through lack of consumer purchasing-power; and

(7.) Whereas measures adopted with respect to unemployment have been entirely inadequate; and

(8.) Whereas the payment of allowances without service rendered is creating a condition detrimental to individual welfare and prejudicial to the public interest; and

(9.) Whereas it is obvious that salutary collective power should be used to meet the situation, with which individual effort is unable to cope; and

(10.) Whereas it is the opinion of this House that Bill No. 19, being an Act to incorporate the Bank of Canada, and now under consideration by the Canadian Parliament, wherein it is proposed to grant to a privately owned corporation, among others, the following powers:—

(a.) To control and regulate Canadian credit and currency:

- (b.) To control the external value of the national monetary unit:
- (c.) To manage in part the general level of Canadian production, trade, prices, and employment:

(d.) And to manage in part the economic and financial welfare of the Dominion,-

is not in the best interests of the people of this Province or the people of Canada as a whole:

Therefore be it Resolved, That this House is of the opinion that a national banking system should be established for the purpose of making national, provincial, and municipal credit available to sustain the circulation of an adequate volume of purchasing-power medium of exchange, and that national, provincial, and municipal credit should be used to relieve the existing burden of taxation and unemployment and to assist in re-establishing and maintaining the prosperity of the Canadian people.

And be it further Resolved, That this House go on record as favouring a definite scheme of effective co-operation between national, provincial, and municipal governing authorities and the proposed national banking system for the purpose of using public credit as the purchasingpower medium of exchange necessary to defray the expense of maintaining a broad programme of constructive, useful wage-distributing public enterprise, and as the means of defraying the expense of maintaining the good government of this nation, its Provinces, and all local communities and the social services that are essential to maintain the education, health, peace, contentment, and liberty of all Canadian citizens with the minimum of expense to the taxpayers throughout the land.

And be it further Resolved, That copies of this Resolution be forwarded to the members of the Canadian Parliament, to the members of the Legislative Assemblies of the other Provinces in the Dominion, and to the representatives of all local governments in the Dominion.

Prayers by Mr. Speaker.

On the motion of the Hon. Mr. *Pattullo*, the House proceeded to the Orders of the Day, "Public Bills and Orders."

Bill (No. 7) initialed "An Act to provide for the Investigation of Matters of Economic Importance, and for the Creation of an Economic Council" was committed.

The Chairman of the Committee on such Bill reported to Mr. Speaker that a point of order has arisen in the Committee on Mr. *McGeer's* motion to amend as follows:—

- Section 5: To add the following as subsections (j), (k), (l), (m), (n), (o), and (p):
  - "(*j.*) To provide for the general economic and social welfare of those engaged in the commercial life of British Columbia by promoting the organizations of industry and commerce for the purpose of advancing co-operative action among industrial, commercial, and trade groups; to induce and maintain united action by owners, managers, and employees under adequate governmental sanction and supervision; to eliminate unfair competitive practices; to promote the fullest utilization of the present productive capacity of industrial and commercial organizations; to avoid undue restriction of production, and to increase production by improving the consumption of agricultural, industrial, and all other products of human endeavour, and by improving the general facilities of trade; to increase employment and the distribution of fair wages under proper working conditions; to improve standards of business and labour, and to rehabilitate and stabilize industry and commerce in the Province, and to conserve by intelligent use all available natural resources:
  - "(k.) Upon application to the Lieutenant-Governor in Council by one or more industrial, commercial, or trade associations or groups, the Lieutenant-Governor may by Order in Council approve of a code or codes of fair competition, standardizing as far as practical the volume of production, the methods of distribution, wages, working conditions, prices, and all other matters intended to improve and benefit the consumer, labour, and industry and commerce generally; providing, however, that the Lieutenant-Governor in Council shall not approve of any such code unless the Lieutenant-Governor in Council shall decide that such code or codes is or are necessary to improve or is or are capable of improving the general economic welfare of the people of the Province of British Columbia:
  - "(l.) After the Lieutenant-Governor in Council shall have approved any such code the provision of such code shall be the standards of fair competition for such trade or industry or any division thereof so codified, and the Lieutenant-Governor may impose such penalty as is deemed advisable to prevent the violation of the standards so established, code, or any term or provision thereof:
  - "(*m*.) To inquire and report on the existing plan of Provincial and municipal government with a view to increasing the effectiveness and efficiency of governmental service, and for the purpose of eliminating unnecessary public expenditures, and effecting a general reduction in the cost of government: to recommend the consolidation of all branches of governmental service not now co-ordinated; to consider and report on the advisability of consolidating municipal and Provincial governmental service where efficiency and economy can be advanced by the elimination of duplication or unnecessary administrative authority, and to report on the advisability of eliminating unnecessary Government and administrative authority by consolidating the administration of public business by the elimination of unnecessary civic and municipal organizations; to consider and report on the advisability of consolidating the Provincial and municipal public debt, with a view to establishing a more effective means of meeting and adjusting public debts and dealing fairly with taxpayers and the bondholders:
  - "(n.) To administer the Minimum Wage Acts and all other Acts now operated, with a view to regulating the relations of employer and employee:

- "(o.) This Act is intended to inaugurate a policy of governmental co-operation with industry, commerce, labour, and municipal authority that is essential to meet the existing emergency wherein widespread unemployment, disruption of industry and commerce, and disruption of Government threatens to destroy peace and progress that should abound:
- "(p.) To effectuate this policy the Lieutenant-Governor in Council may establish such agencies and utilize such voluntary and uncompensated services; to appoint without regard to Civil Service laws such officers and employees as may be deemed necessary, and may prescribe the duties, responsibilities, and powers of all such persons so employed, and take such steps as may be necessary to co-operate with the Government of any or all of the other Provinces of the Dominion and the Government of Canada."

To strike out section 9, and substitute therefor the following :---

"9. For the purpose of carrying into effect the provisions of this Act according to true intent and to supply any deficiency therein, and for the purpose of putting into effect the recommendations or any conclusions that the Lieutenant-Governor in Council may come to in respect to the said recommendations, the Lieutenant-Governor in Council may pass such Orders in Council and make such regulations not inconsistent with the support of the Act as may be deemed necessary, advisable, or convenient. All such Orders in Council and regulations shall be published in the Gazette and shall have the same force and effect as if incorporated therein."

That the Chairman had ruled the amendments out of order on the grounds that they involved the expenditure of public money, dictated Government policy, and were not within the competence of a private member to move, and that his ruling had been appealed from.

Question proposed—" Shall the Chair be sustained?"

#### Lieutenant-Governor.

The Lieutenant-Governor transmits herewith amendments to Bill (No. 3) initialed "An Act respecting a certain Agreement entered into between the Government of the Province and the Ladner Bridge Company. Limited, on the Twentieth Day of May, 1933," enclosed herewith, and recommends the same to the Legislative Assembly.

Government House, March 23rd, 1394.

#### (ENCLOSURE.)

To amend as follows :---

"And whereas the Company has requested and agreed with the Government that a new agreement be entered into between the Company and the Government in substitution for the existing Agreement, for the purpose of :—

- "(a.) Eliminating from the Agreement all provisions imposing on the Government any liability in respect of deficits of the Company:
- "(b.) Eliminating from the Agreement all provisions vesting in the Government any right to participate in the profits of the Company:
- "(c.) Making provision by which the Government may at its option at any time after the completion of the proposed bridge require the Company to sell the same to the Government on terms more equitable to the Government than those contained in the existing Agreement:
- "(d.) The further modification of the existing Agreement as may be mutually agreed between the Company and the Government:

"And whereas in order to accede to the said request of the Company it is necessary and expedient to provide for the annulment of the existing Agreement, and to empower the Government to enter into a new agreement with the Company in substitution therefor."

Section 1: To strike out the section, and to substitute therefor the following:----

"1. This Act may be cited as the 'Ladner Bridge Agreement Modification Act."

"3. Sections 10 and 11 of the 'Ladner Bridge Company, Limited, Act,' being chapter 82 of the Statutes of 1926-27, as those sections are re-enacted by section 2 of the 'Ladner Bridge Company, Limited, Act Amendment Act, 1933,' are repealed, and the following are substituted therefor:----

"'10. (1.) The Lieutenant-Governor in Council may authorize the Minister of Public Works to enter into an agreement with the said Company pursuant to this Act on behalf of and in the name of His Majesty in right of the Province, at any time before the first day of July, 1934, or such later date as the Lieutenant-Governor in Council may fix, by which it may be provided that the said Company shall begin actual construction of the said bridge, its approaches and other appurtenant works, within six months from the date of the agreement, that the construction thereof shall be proceeded with diligently, and that the construction and cost thereof shall be subject to the supervision of the Minister of Public Works or of an engineer appointed by him. The said agreement shall also provide for the construction by His Majesty of all necessary highways to accommodate traffic to and from the said bridge when it is completed.

### MARCH 23rd.

"'(2.) The Lieutenant-Governor in Council may require the insertion in the said agreement of such terms and conditions, not inconsistent with this Act, in respect of the erection, construction, maintenance, and operation of the said bridge and its approaches and other appurtenant works, the tolls to be charged by the said Company, and the acquisition of the said bridge and its approaches and other appurtenant works by His Majesty at his option, as the Lieutenant-Governor in Council considers advisable.

"'11. (1.) Upon the execution of the said agreement by or on behalf of His Majesty and the said Company, the said Company, its successors and assigns, shall have, subject to the terms and conditions of the said agreement, the exclusive right to construct and operate a bridge across the Fraser River at or near Deas Island near Ladner, in the Province of British Columbia. The said agreement may provide, subject to the limitations and conditions imposed thereby, that the Government shall not authorize the construction of any highway traffic bridge across the Fraser River, other than the proposed bridge, at any place within such distances up-stream and down-stream from the site of the proposed bridge as may be fixed in the agreement.

"'(2.) Except as provided by or under subsection (1), nothing in this Act shall be deemed or construed to give to the said Company any exclusive rights or franchises of any nature whatsoever."

*Ordered*, That the said Message, and the amendments accompanying the same, be referred to the Committee of the Whole House forthwith.
