Tuesday, March 2nd, 1948.

THREE O'CLOCK P.M.

This being the first day of the third meeting of the Twenty-first Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable Charles Arthur Banks, Lieutenant-Governor of the Province, dated the 13th day of January, 1948.

His Honour Charles Arthur Banks, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

The Hon. Mr. Pearson, Provincial Secretary, said:

Members of the Legislative Assembly:

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

The Hon. Mr. Johnson, Premier, member for New Westminster Electoral District, addressing himself to the Clerk, moved, seconded by Mr. H. E. Winch, first member for Vancouver East Electoral District, that Robert Henry Carson, Esquire, member for Kamloops Electoral District, do take the Speaker's chair, and preside over the meeting of this Assembly, and it was so Resolved.

R. S. Stuart Yates, Esquire, the Clerk of the House, having declared Robert Henry Carson, Esquire, duly elected, he was then taken out of his place by the mover and seconder, and conducted to the chair, where, standing on the upper step, he expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

And thereupon he sat down in the chair, and the mace was laid upon the table.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect then spoke to the following effect:—

MAY IT PLEASE YOUR HONOUR:

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

The Hon. Mr. Pearson then said:—

MR. SPEAKER:

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their respective proceedings will be conducted with wisdom, temper, and prudence, he grants, and upon all occasions will recognize and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

In welcoming you to the Third Session of the Twenty-first Parliament of British Columbia, I do so with the sincere hope that the business of my Government will continue to prosper under the new leadership brought about since last you met.

Retirement of Dr. John Hart from the position of Prime Minister, I am sure, is regretted by all. His unselfish devotion to the public service during a period of twenty-two years is unequalled in the history of British Columbia. The continued confidence of the people which he has enjoyed is in itself a tribute to his integrity and an indication of the high esteem in which he is held. I feel sure that I express the sentiments of my people in wishing him every enjoyment of those years of leisure to which he is so justly entitled. His successor, undoubtedly, is inspired by the same unselfish motives, and I wish him every success in the new responsibilities he has assumed.

During the past year, Her Royal Highness the Princess Elizabeth was united in marriage with His Royal Highness the Duke of Edinburgh. This event was received with heart-felt joy. My Government, on behalf of the people, extended warm felicitations to the happy couple, accompanied by an appropriate gift as a token of our affection and as an expression of our good wishes.

Since last you met, we have lost two members of the Legislature, one through elevation in the public service and the other by death.

The appointment of the Honourable N. W. Whittaker, K.C., former Speaker of the Legislature, to the Supreme Court of British Columbia, is indeed a fitting tribute to him as a jurist. His impartiality in ruling on many important questions coming before this Assembly won for him the admiration of all.

The passing of Mr. Louis LeBourdais has removed from our midst a member who was held in high esteem by his colleagues. We extend to his family our deepest sympathy in their bereavement.

It was my pleasure recently to appoint a new Minister of the Crown in the person of the Honourable W. T. Straith, K.C., who succeeds Dr. G. M. Weir as Minister of Education. I am confident that Mr. Straith will discharge his important duties with the same depth of understanding that marked the administration of his predecessor.

I am advised by my Government that two new members have been elected to the Legislature, and I take this opportunity of congratulating Mr. Arthur Ash and Mr. Walter Hogg upon their being chosen as representatives of the Saanich and Cariboo constituencies respectively.

The convening of this Legislature marks the anniversary of an important historic It is fifty years ago that the present Parliament Buildings were officially opened. Much has been accomplished since that date, and I am confident that the passage of another fifty years will witness development far surpassing anything experienced in the history of the Province.

It is with gratification that I note the representations made to the Dominion Government recently in connection with the establishment of an even greater measure of social security than my people now enjoy. The encouraging reception accorded the plea of my Government, I am sure, has been most welcome to my people.

The serious condition of the hospital situation is engaging the attention of my Government, and proposals are being studied with a view to finding a solution to this problem.

Careful study has been given to a number of Provincial-Municipal problems, as well as to the rising cost of social security and other important public services. My Government is aware of the situation created thereby and proposes to place before you measures designed to alleviate this situation.

It is the intention of my Government to submit for your approval legislation revising and amending our labour laws, thereby bringing into effect further improvements in employer-employee relations, which is so desirable.

Further benefits will be extended through increases in certain allowances granted those coming within the scope of the "Workmen's Compensation Act."

Important amendments to the "Forest Act" will be submitted, thereby improving the economy of this important industry and widening the scope of the sustained-yield programme.

Ample provision will be made for the further improvement of our main highways and the completion of major public works projects already undertaken.

Amending legislation governing agricultural matters will be submitted with a view to improving this important basic industry.

You will be asked to give approval to legislation, the main purpose of which will be to introduce a new method of admission to our mental hospitals and to provide a clinic for treatment of patients who may be saved thereby from the stigma of being committed to a mental institution. Other legislation dealing with welfare matters will be placed before you.

You will be advised of the steps taken to provide new technical personnel and facilities for the B.C. Scientific and Industrial Research Council in order to deal with problems relating to industrial chemistry, physics, applied biology, mining, and other important fields of research.

Establishment of a new biological laboratory to develop our fishing industry, I am sure, will commend itself to you.

Amendments to existing legislation governing the mining industry will be submitted.

The development of hydro-electric power for the Interior of the Province as well as on Vancouver Island is progressing favourably.

The Public Accounts will be presented and Estimates for the ensuing year will be submitted.

Legislation affecting many branches of public service of a character designed to improve existing Acts will be placed before you.

I pray that the blessing of Divine Providence may rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. H. E. Sexton, Lord Bishop of British Columbia.

Webster, Gillis, Bennett, Welch, and H. E. Winch.

On the motion of the Hon. Mr. Johnson, seconded by Mr. H. E. Winch, it was Resolved,—

That this House express its deep sorrow in the death of Louis LeBourdais, Esquire, who for so many years served the public faithfully as a private member for the Cariboo Electoral Riding in the Provincial Legislature:

These rates are similar to or less than those in the general population. Rate in general population, 0.45 per cent. All cases of tuberculosis were

minimal in type.

"2. Tranquille: Total nurses on staff, forty-three; total nurses leaving over five-year period, 123. Reasons for leaving were as follows: Twenty-two went to other positions; fifteen, ill health; nine, for postgraduate work; thirteen, to be married; seventeen, for family reasons; five, over age and retired; ten, other reasons (isolation a factor—six of the ten asked to resign); four, to the armed services; six returned to the East; twenty-two, unknown (isolation considered a factor); total, one hundred and twenty-three. Vancouver: Total nurses on staff, fifty; total nurses leaving over five-year period, thirty-nine. Reasons for leaving were as follows: Two, no reason; six, to take further training; four, entered other fields of nursing; four, to get married; six, left Province; four, retired, due to illness; six, left for family reasons; two, resignations were requested; three, voluntarily resigned; two, because of unsatis-factory salary adjustments."

Mr. E. E. Winch asked the Hon. the Provincial Secretary the following question:-

Is information available of the known or estimated number of elderly persons in the Province whose (a) physical or (b) mental condition, due to age, warrants provision of accommodation such as is not now provided by Government, municipal, or philanthropic bodies, or by persons operating on a commercial basis?

The Hon. Mr. Pearson replied as follows:-

"No comprehensive information is available."

Mr. Corsbie asked the Hon. the Minister of Education the following questions:-

The following tonnage of ore was purchased: 1938, 104 tons; 1939, 217 tons; 1940, 171 tons; 1941, 119 tons; 1942, 30 tons; 1943, 1.6 tons; 1944, 3.5 tons; and 1945, 22 tons.
- "4. August, 1946, as practically no ore had been shipped to the plant for five years and no tonnage to justify continuing the service was in sight. The Department's grub-stake scheme was proving to be a more effective means of stimulating prospecting.
- "5. The building has been demolished and the equipment stored in Prince Rupert for possible future use."

Provincial Mental Home, Colquitz: (a) Nil and (b) nil."

- Mr. E. E. Winch asked the Hon. the Provincial Secretary the following questions:—
- 1. How many (a) male and (b) female members of the staff at each Provincial mental hospital are engaged exclusively in providing and supervising patient recreational activities?
 - 2. What is the nature of such major recreational activities?
- 3. Is provision being made for extension of recreational staff and facilities and what is the nature of same?

The Hon. Mr. Pearson replied as follows:-

- "1. At Essondale on the staff of the recreational department there is a director with his assistant. On the staff of the audio-visual department there is a director and two assistants. At New Westminster there is a full-time director, an attendant who assists him, and an attendant who gives the 16 mm. pictures. The director of the audio-visual department also gives weekly picture shows with the 35 mm. machine.
- "2. Inactive.—Social: Concerts, entertainment displays, barn dances, old-time dances, costume dances, variety dances, and picnics. Games: Cribbage, checkers, chess, bridge, whist, crokinole, and bingo. Tournaments are arranged from time to time. Active.—Indoor: Badminton, basketball, pin ball, ping pong, hand soccer, push ball, horse shoes, deck tennis, duck on the rock, swimming, and diving. Outdoor: Softball, tennis, badminton, soccer, basketball, volleyball, golf (eight-hole), handball, pin ball, padder tennis, hand soccer, goal-hi, push ball, tether ball, volley hand ball, horse shoes, deck tennis, duck on the rock, relay games, ring dodge ball, bombardment, whistle tag, over and under, croquet, archery, swimming, and diving.
- "3. Provision of extension of the recreational facilities is being started in a modest way. It is being taught to attendants and nurses with the intention that this course be enhanced to the point whereby nurses and attendants will take part in recreation."

Mr. E. E. Winch asked the Hon. the Provincial Secretary the following question:—
How many (a) children under 6 and (b) adults over 60, medically certified as mentally incompetent, were refused admission to Essondale during each of the past two calendar years?

Priority is also given to those individuals in isolated areas where no other provision for their care is available."

And then the House adjourned at 4.30 p.m.
