A reference of this nature offends a rule of debate known as the rule against anticipation which, briefly stated, is a rule forbidding anticipation by debate (or otherwise) of a matter which is before the House such as a Bill which has been introduced or a motion of which notice has been given or a matter which, as a probability, will be brought before the House within a reasonable time.

The purpose of the above rule is to ensure that a matter be not anticipated if it is contained in a more effective form of proceeding than the proceeding by which it is sought to be anticipated; consequently, a Bill or other Order of the Day is more effective than a motion and, likewise, a Bill or other Order of the Day is more effective than a discussion on the motion "That Mr. Speaker do now leave the chair" for the House to go into Committee of Supply.

While considerable latitude is permitted in the present debate, any detailed discussion in this debate of a Bill before the House clearly offends the above rule and in this regard I would refer the honourable members to the decision of Mr. Speaker Pooley contained in the Journals of the House, 1904, page 60, and also to the rule as contained in May's Parliamentary Practice, 16th edition, page 403.

This increase is largely due to two factors: (1) The inclusion of extensive areas of low-volume timber formerly classed as scrub (non-commercial), due to current improved standards of utilization, and (2) the conservative volumes of some of the older timber cruises which were used in the preliminary volume estimate.

1. Does the Censor of Moving Pictures preview all moving pictures before they are shown in public and, if not, how does he decide which pictures should be and which should not be previewed?

2. How many moving pictures did the censor preview in 1959 and of the pictures previewed, how many were censored (a) in whole and (b) in part?

The Hon. R. W. Bonner replied as follows:----

"1. The censor views all feature pictures before they are shown to the public. A feature picture is designed primarily for entertainment, even though it may be documentary in varying degrees. Pictures which are strictly documentary and designed primarily to educate or instruct are not viewed by the censor. These pictures are the property of the Public School Visual Educational Department, the University of British Columbia Audio-Visual Services Department, the Vancouver Public Library, and various commercial and technical associations. There are other documentary pictures submitted to the censor by individuals, ethnic groups, religious organizations, and cultural societies which he may or may not decide to view. In these cases he draws upon his own experience and the practice of his department over the years to help him decide. If he has any doubts whatever about the content of any of these films he views them. There has never been any difficulty with documentary films. Decisions in respect to feature films have been questioned and appealed from time to time.

"2. In 1959 there were 1,675 pictures viewed by the censor; 1,604 were approved, eight were rejected, nine were approved with eliminations or modifications, and fifty-four were classified as 'Adult Entertainment Only.'"

The agreement may, however, make increase in superannuation allowances conditional upon increased contributions being made by the employees in the manner set out in the agreement. The contributions required to be paid in accordance with the terms of the agreement shall be paid in addition to any contributions or deductions required to be made under this Act.'

"Victoria, October 19th, 1959.

"(Name and address of employer.)

"Dear Sir,—At the recent convention of the Union of British Columbia Municipalities, held at Kelowna, I took the opportunity to make reference to the plight of retired municipal employees or their widows, many of whom have indicated that they are living under very difficult financial conditions.

"This letter is to advise you that means are available under the 'Municipal Superannuation Act' for councils to take care of cases which are obviously deserving of some help. I have enclosed a copy of section 8 (2) for your reference. Several employers have already used these provisions and I would certainly commend them to you for use where they are applicable, if you consider it necessary and desirable.

"The financing of special increases by special agreement is arranged by having the employer make reimbursement, each month, to the Commissioner of Municipal Superannuation for the amount of the increases actually paid during the month.

"Complete information regarding the allowances being paid to your former employees and their widows is available from the offices of the Superannuation Branch. Please feel free to request as much information as you may require for proper consideration of this matter.
