Prayers by the Rev. Dr. W. W. McPherson.

By leave of the House, Mr. H. E. Winch made the following statement:-

Mr. Speaker,—There is a matter of importance most vital to the City of Vancouver which must be drawn to the attention of the Government and the Legislature without delay.

On March 24th, 1949, His Honour the Lieutenant-Governor gave assent to a Bill intituled the "Vancouver Enabling Act, 1949." Section 7 of the said Act reads as follows:—

"7. The Lieutenant-Governor in Council may, upon the request of the City of Vancouver, appoint a committee of three members elected to the Legislative Assembly to examine the Bill and report thereon to the Committee on Standing Orders and Private Bills when the Bill is referred to that Committee."

The honourable members will note that the section puts no limitation on time on the committee and it is therefore axiomatic that any committee appointed stands as such until such time as the "Vancouver Incorporation Consolidation Act" is referred to the Private Bills Committee.

A request was received from the City of Vancouver for the appointment of such a committee, and, in December of 1949, by Order in Council, a committee of three was appointed. Mr. *Reginald MacDougall*, M.L.A., of Vancouver, was named as chairman, Mr. J. Gould, M.L.A., and Mr. H. E. Winch, M.L.A., as members. Upon many occasions this committee met with representatives of the City Council and the special legal counsel appointed by the city. Numerous meetings were held by the committee and it was almost prepared to report at the 1952 Session. However, because the new "Vancouver Incorporation Act" was not referred to the Private Bills Committee, the report was not completed nor filed. Since the regular Session of the Legislature in 1952, some discussions have been held by members of the committee, but, owing to political and physical mortality, the composition of the committee has been reduced. Mr. *Reginald MacDougall*, M.L.A., the chairman, passed away recently, and Mr. J. Gould was not re-elected to the Legislature. This, in accordance with the Act, leaves only myself as a member of the committee.

The petition of the City of Vancouver for a consolidated Act has now been received by this House and referred to the Select Standing Committee on Private Bills, and I presume that it will be considered by that Committee.

I should now like to draw the attention of the House and the Attorney-General to section 9 of the "Vancouver Enabling Act, 1949," which says as follows:—

"9. When considering the Bill, the Committee on Standing Orders and Private Bills shall have before it the report of the committee so appointed, and may make such use thereof as it sees fit."

In view of this mandatory section of the Act there is considerable doubt as to the legality of the Private Bills Committee being able to deal with the Vancouver Act.

I draw this to the attention of the House because if an amendment is required it should be introduced and assented to immediately as there is a time limitation for the introduction of Private Bills and for the report of the committee to the House.

There may be other ways of overcoming the apparent legal obstacles.

In the interest of the City of Vancouver, which must have action at this Session, I request the immediate consideration of the Attorney-General and the Government on this matter.

The Hon. L. Wicks presented the Thirty-sixth Annual Report of the Workmen's Compensation Board of the Province of British Columbia for the Year ended December 31st, 1952.

Mr. H. E. Winch asked the Hon. the Minister of Public Works the following questions:---

1. Does the Department of Public Works operate an aeroplane?

2. If so, under whose direction does it operate?

3. Is the aeroplane ever used for other than straight Departmental business and, if so, under what circumstances?

The Hon. P. A. Gaglardi replied as follows:---

"1. Yes.

"2. The Hon. the Minister of Public Works.

"3. Yes; it is used on occasion by other departments of the Government in emergencies or proof of need."

And presented a Return in reply to the following question:-

4. What is the flight log of the aeroplane showing destination and passengers from August 1st, 1952, to February 2nd, 1953?

Mr. Kenney asked the Hon. the Minister of Lands and Forests the following questions:-

1. Has any change in scaling woods cut on Crown lands been made since August 1st, 1952?

2. If yes, (a) what scale is now used, (b) what provision is made in the new scale for waste in manufacturing, if any, and (c) what provision is made for scaling defective logs, such as forked logs and crooked logs?

3. Does the present new scale make any provision for overrun at sawmills and to what extent, if any, is it allowed?

4. How many men are required to do the scaling under the new system in respect of individual scales?

5. How many men were required under the system of scaling British Columbia log-scale?

6. What is the conversion factor of computing feet board-measure as related to cubic contents?

7. Under what statutory authority (section) of the "Forest Act" or other Act was the change made?

The Hon. R. E. Sommers replied as follows:---

"1. Yes.

"2. (a) The British Columbia cubic scale, (b) nil, and (c) same provisions as apply in scaling feet board-measure under British Columbia log-scale.

"3. No.

"4 and 5. Physical work and time element involved in scaling vary widely, being dependent upon numerous factors such as location of material, dimensional characteristics of timber, quality, grades, number of species, and number of timber-marks. It is my opinion that, as scalers become fully conversant with cubic measurement, efficiency will be on a par with that demonstrated under the British Columbia log-scale.

"6. The feet board-measure recovered from any log varies between wide limits, depending on many factors, such as the size and quality of the log, the equipment and mechanical efficiency of the mill, and the competence of the mill operators. The British Columbia log-scale purports to give the number of board-feet that the mill will recover from a log, but the actual results obtained can vary between such wide limits that they frequently have little or no relation to the log-scale. The log-scale is related exclusively to the manufacture of lumber in sawmills. The cubic scale accurately measures the quantity of wood, no matter what its end use may be. There is, therefore, no reliable standard conversion factor between cubic and log-scale, but the individual mill using a reasonably uniform type of log will be able to establish an accurate conversion factor in board-feet of plywood, pounds of pulp, as the case may be, for their own business. The recovery in board-feet of lumber for various types of logs and manufacturing plants may be expected to vary between 5 and 9 board-feet per cubic foot.

"7. Section 65, 'Forest Act,' chapter 128, R.S.B.C. 1948."

1952, (a) was there an increase in non-insured cases and, if so, by what percentage; (b) how many hospital-days were occupied by non-insured patients and what is the total of bills so incurred; (c) what percentage of these hospital bills were collected; (d) what are the costs to the hospital of the collection of these debts; (e) what amount of the per diem rate was written off as bad debts; (f) were there deficits in any of these hospitals in their 1952 budget and, if so, how much; (g) how are these deficits, if any, to be made up?

2. (a) Between August 9th and December 31st, 1952, what was the total amount charged under the dollar-a-day co-insurance; (b) what percentage of this co-insurance was collected?

Mr. Turner asked the Hon. the Minister of Health and Welfare the following questions:—

1. How much money has the Department of Health and Welfare voted to and paid to the Vancouver General Hospital for the purposes of modifying the semi-private pavilion for eventual use as a children's health centre?

2. What is the estimated total cost of this conversion and by whom was the estimate given?

The Hon. E. C. F. Martin replied as follows:---

"1. The Provincial Government, through the Department of Health and Welfare, has authorized a grant-in-aid amounting to \$27,500 to assist the Vancouver General Hospital in modifying the semi-private pavilion for pædiatrics; no payments have been made out of this authorization to date.

"2. The estimated cost of the complete conversion of the semi-private pavilion for pædiatric services is \$286,145; this estimate includes an allowance of \$110,145 for the final stage of conversion, which would consist of converting the central sterilizing and supply department on the fourth floor to operating-room space; this final stage is dependent on the completion of the proposed acute unit. The architectural firm of Sharp & Thompson, Berwick, Pratt has provided the Vancouver General Hospital with the foregoing estimates of cost."

Mr. Turner asked the Hon. the Minister of Health and Welfare the following questions:-

1. Is James Hamilton, of Minneapolis, U.S.A., still employed by the Provincial Government as a consultant in the hospital or health field?

2. If not, when was his contract terminated?

3. When was Mr. Hamilton originally hired, by whom, and on whose recommendations?

4. What is the total amount paid to James Hamilton and Associates since he was originally hired?

5. Has the Provincial Government sent personnel to study in Minneapolis under Mr. Hamilton in a course in hospital administration and, if so, how many and what are their names?

The Hon. E. C. F. Martin replied as follows:--

"1. No; James A. Hamilton and Associates are no longer directly employed by the Provincial Government as consultants. However, certain hospital construction and planning projects inaugurated under the original agreements in 1948, 1949, and 1950 are yet to be finalized by some hospitals. On all construction projects initiated since late in 1950, the staff of the Hospital Insurance Service has provided a full consultation

service to hospitals. In addition, the Hospital Insurance Service conducts space-utilization studies and other special surveys at the request of hospitals.

"2. Four separate agreements were entered into with James A. Hamilton and Associates: (a) A general hospital survey of the Province and a long-range plan for the existing and future needs; (b) management and building consultation appraisals of selected hospitals as authorized by the Minister of Health and Welfare; (c) space-utilization studies, similar in general terms to (b) above, by specific authority of the Minister of Health and Welfare; (d) a survey of policy and administration of the Hospital Insurance Service. Agreements (a) and (d) were completed in 1950 and 1951; certain phases of (b) and (c) are yet to be finalized. No new projects with James A. Hamilton and Associates have been entered into since late in 1950.

"3. The first agreement with James A. Hamilton and Associates was dated October 5th, 1948, and was signed for the Government by Dr. J. M. Hershey, former Commissioner, British Columbia Hospital Insurance Service. The firm enjoyed a wide reputation as experts in their field and had done work in 1947 in Vancouver in a private capacity.

"4. The grand total of moneys paid to date covering all agreements by the Provincial Government amounts to \$198,668.69; agreements (b) and (c), however, provide for repayments of a portion of the costs by hospitals and the Federal Government. The total sum repaid to date amounts to \$59,128.36, leaving a net cost to the Government of \$139,540.33 in all.

"5. Mr. James Mainguy, of the British Columbia Hospital Insurance Service, studied hospital administration at the University of Minnesota. The course at the university is under Mr. Hamilton's direction, but is administered by the School of Public Health. Twelve months of the twenty-one-month course were taken in a hospital and a regional council in New York State disassociated from the university. The entire cost was financed under the Dominion Health Training Grants programme."

Mr. *Turner* asked the Hon. the Minister of Health and Welfare the following quesquestion:—

Are the services of James Hamilton and Associates to any private hospital being paid for by the British Columbia Hospital Insurance Service?

The Hon. E. C. F. Martin replied as follows:---

"The services of James A. Hamilton and Associates have never been employed in conjunction with any private hospital within the meaning of the 'Hospital Act' and, therefore, nothing has been paid to them in this connection by the British Columbia Hospital Insurance Service."

Mr. Proudfoot asked the Hon. the Minister of Health and Welfare the following question:-

How many patients under the British Columbia Hospital Insurance Service paid co-insurance at the rate of \$1 *per diem* from July, 1952, to December 31st, 1952: (a) \$30 to \$40, (b) \$41 to \$50, (c) \$51 to \$60, (d) \$61 to \$70, (e) \$71 to \$80, and (f) \$81 and over?

The Hon. E. C. F. Martin replied as follows:---

"The dollar-a-day charge is collected by the hospitals; individual records of hospital collections are not maintained by the British Columbia Hospital Insurance Service; number of patients charged \$1 per day: (a) 1,266, (b) 504, (c) 318, (d) 163, (e) 126, and (f) 319."

Mr. H. E. Winch asked the Hon. the Minister of Lands and Forests the following questions:---

1. In the period for which records are readily available, since the granting of Forest Management Licence No. 1 to Columbia Cellulose Company Limited, what has been the total timber cut according to species?

2. What was the total Government revenue received from said timber cut?

The Hon. R. E. Sommers replied as follows:----

"1. Timber cut on Forest Management Licence No. 1, cubic feet, by species from date of granting of licence until January 31st, 1953: Cedar, 101,240; spruce, 2,731,861; hemlock, 5,839,990; balsam, 2,284,379; cypress, 541; cottonwood, 408,871; hard-woods, 37; total, 11,366,919 cubic feet. Total includes 1,613,950 cubic feet cut from timber licences included in the licence and on which royalty only was payable and collected.

"2. \$215,653.24."

Honourable Members,—At the afternoon sitting on Thursday, February 19th, there arose an intriguing point of procedure. The honourable the first member for Victoria drew the attention of the Chair to the fact that the Speaker was using the private names with the introducers of Message Bills. On the surface, the use of these names would appear to be a mode of censure as, in general practice, the only time the name of a member is used is when he is named by the Speaker.

Reference to Beauchesne's second edition of Parliamentary Rules and Forms, pages 336, 337, 338, and 339, shows that all forms of Bills introduced by motion bear the

private name of the person introducing. This would indicate that the form used by the Speaker recently was in order.

It has been the practice in this House to merely read the Message rather than the motion, and, in order to prevent confusion in future, this latter form will be followed, and the private names of the mover and seconder will not be used, the Speaker merely reading the face of the Message and not the motion.

1. What was the balance as at August 1st, 1952, of cash in Treasury and in transit?

2. What was the balance as at August 1st, 1952, of bank, general account?

3. What was the balance as at August 1st, 1952, of accounts receivable: (a) Assessed taxes, (b) grazing fees, (c) probate and succession duties, (d) timber royalties and stumpage, (e) land sales (principal O/S), (f) Provincial municipalities, and (g) sundry debtors?

The Hon. E. M. Gunderson replied as follows:---

" 1, 2, and 3. It is regretted that these questions cannot be answered in their present form."

Mr. Segur asked the Hon. the Minister of Lands and Forests the following questions:-

1. Have any applications been made for forest management licences in the Eagle Valley area between Sicamous and Clan William?

2. Is the Department contemplating granting any licences in this area?

3. If so, (a) who are the applicants and (b) for what area are the applications made?

The Hon. R. E. Sommers replied as follows:-

"1. Yes.

"2. The one application in this district is being studied, but has not been referred to the Government for disposition.

"3. Not applicable; see answer to No. 2 above."

Mr. Kenney asked the Hon. the Minister of Finance the following questions:---

1. When were the books of the Department of Finance finally closed covering the fiscal year 1951–52?

2. What was the surplus shown at that time covering the fiscal year 1951-52?

The Hon. E. M. Gunderson replied as follows:-

"1. May 31st, 1952.

"2. See Public Accounts for the year ended March 31st, 1952."

Mr. Calder asked the Hon. the Minister of Finance the following question:---

What is the amount in benefits, if any, paid to the Indians or Indian villages of British Columbia for the payment (a) off or (b) on the Indian reservations of the social security and municipal aid tax?

The Hon. E. M. Gunderson replied as follows:---

"No social security benefits are paid to Indians who are wards of the Government of Canada. Indians who reside within corporate limits as defined by the 'Municipal Act' and who are part of the population of that local government have so far benefited from the distribution of the municipal aid tax. Any Indian not a ward of the Crown in the right of Canada is eligible and thus receives social security benefits in the same manner as all other British Columbia residents. No accounting is kept of payments according to race or creed."

Mr. Haggen asked the Hon. the Attorney-General the following questions:—

1. Have any amounts been paid since February 26th, 1952, with respect to petition for disallowance of chapter 70, "Statutes of British Columbia, 1950," relative to the right of the Province to tax Esquimalt & Nanaimo Railway Belt lands?

2. If so, what amounts and to whom were they paid?

3. What further amounts, if any, remain to be paid?

The Hon. R. W. Bonner replied as follows:---

" 1. No.

"2. None.

"3. None, as far as known."

Mr. Haggen asked the Hon. the Attorney-General the following questions:-

1. Has any recommendation been made by you to the Federal Government for remission of sentences passed after conviction on charges of arson on any members of the Sons of Freedom sect?

2. If so, in favour of what persons?

The Hon. R. W. Bonner replied as follows:---

"1. Yes; concurring in the recommendations of the Penal Subcommittee of the Consultative Committee on Doukhobor Problems, charged with study of the rehabilitative qualities of each accused person.

"2. George G. Markin, whose sentence expires April, 1953; Peter C. Tamelin, John Nazaroff, Cecil C. Lapshinoff, Peter G. Kastrukoff, Paul Mitten, Peter Slastookin, Bill Makortoff, Pete Demoskoff, and Alex Kootnikoff, whose sentences expire May, 1953; Peter Kolodinin and Paul A. Woiken, whose sentences expire September, 1953."

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:---

1. What amount of Vote 60 of the 1952–53 Budget has been expended to date and in what particular manner?

2. Was a meeting or meetings held during the past year between representatives of any Provincial department and representatives of the Federal Narcotic Division for the purpose of considering drug addiction, its treatment, and prevention?

3. If yes, will copies of the minutes, reports, or recommendations arising from such meetings be made available to members of the Legislature?

The Hon. R. W. Bonner replied as follows:----

"1. \$1,277.84.

"2. Yes.

"3. It is not proposed to table reports until discussions are completed."

Mr. Giovando asked the Hon. the Attorney-General the following questions:-

1. At the time the Royal Canadian Mounted Police took over police duties in British Columbia, how many Provincial Police were employed by the Provincial Government?

2. What was the total cost to the Provincial Government for policing British Columbia during the last twelve months under the Provincial Police?

3. What number of Royal Canadian Mounted Police have been employed in British Columbia during each of the years since taking over?

4. What has been the total cost of policing the Province during each of the years since this work was taken over by the Royal Canadian Mounted Police?

5. Do the Royal Canadian Mounted Police perform all the duties that were done under the Provincial Police?

6. If not, what do these duties consist of and what additional sum do such duties cost the Provincial Government per year?

The Hon. R. W. Bonner replied as follows:---

"1. Five hundred and thirty-seven officers and men.

"2. April 1st, 1949, to March 31st, 1950 (fiscal year), \$1,748,762.04; less received from municipalities for policing, \$462,597.33; total, \$1,286,164.71.

"3. August 15th, 1950, 378 Provincial strength and 172 municipal strength; August 15th, 1951, 396 Provincial strength and 201 municipal strength; August 15th, 1952, 408 Provincial strength and 233 municipal strength.

"4. August 15th, 1950, to March 31st, 1951, \$332,018 (on the basis of \$1,400 per man per year); April 1st, 1951, to March 31st, 1952, \$529,200 (on the same basis). "5. No.

"6. April 1st, 1951, to March 31st, 1952: Staffing gaols, Kamloops Gaol and Prince George Men's Gaol, salaries only, \$31,037.40; sundry incidental police expense, which includes medical examinations of prisoners, meals for prisoners in lockups after convictions, legal forms, and other miscellaneous items, \$29,200.16; provision for remuneration to outside agencies issuing motor licences, \$3,321.72; total, \$63,559.28."

Mr. Bury asked the Hon. the Attorney-General the following questions:-

1. Was the Department of the Attorney-General represented at the Coroner's investigation into the death of Clarence Clemons?

2. If yes, (a) did such representative submit a report to the Department and (b) will same be made available to members of the Legislature?

The Hon. R. W. Bonner replied as follows:-

"1. Yes.

"2. (a) Yes; by letter only; and (b) yes."

Mr. Haggen asked the Hon. the Attorney-General the following questions:-

1. Has the attention of the Department been drawn to any cases of damage, by fire or bombing, on high-tension transmission-lines in the Nelson or Grand Forks districts in 1952 or 1953?

2. If so, what action, if any, has been taken?

The Hon. R. W. Bonner replied as follows:-

"1. Yes.

"2. Police action."

Mr. Calder asked the Hon. the Attorney-General the following question:-

What were the total liquor fines under the "Indian Act" for the years 1949, 1950, 1951, and 1952 in each of the Cities of Prince Rupert, Prince George, Vancouver, Kamloops, and Smithers?

The Hon. R. W. Bonner replied as follows:---

"Information not available, as fines are paid to the municipalities."

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:-

1. How many, if any, present inmates of Oakalla are suffering from tuberculosis?

2. What facilities, if any, exist within the institution for the care and treatment of tubercular patients?

3. Do such facilities conform to present-day hospital standards for this type of ailment?

4. Is the Oakalla (a) general staff or (b) those in actual contact with tubercular patients covered for tubercular infection by workmen's compensation?

The Hon. R. W. Bonner replied as follows:-

"1. There are twenty-five cases of tuberculosis present in Oakalla Prison Farm; of these, fifteen are active, five are suspects, and five are arrested cases.

"2. Infirmary-type treatment is given as prescribed by the Division of Tuberculosis Control, Willow Street, Vancouver; antibiotics only are used in the institution.

" 3. No.

"4. (a) and (b) No."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

And then the House adjourned at 5.10 p.m.
