### Thursday, 7th February, 1918.

#### THREE O'CLOCK P.M.

This being the first day of the second meeting of the Fourteenth Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of the Honourable J. A. MACDONALD, Administrator of the Province, dated the 2nd day of January, 1918,

His Honour Sir FRANK STILLMAN BARNARD, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

#### The Honourable Dr. MacLean, Provincial Secretary, said :---

#### Gentlemen of the Legislative Assembly:

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

The Hon. the Premier, the first Member for Victoria City Electoral District, moved, seconded by *William John Bowser*, Esquire, the fifth Member for Vancouver City Electoral District, That *John Keen*, Esquire, Member for Kaslo Electoral District, do take the Speaker's Chair, and preside over the meetings of this Assembly, and it was so *Resolved*.

Thornton Fell, Esquire, K.C., the Clerk of the House, having declared John Keen, Esquire, duly elected, he was taken out of his place by the mover and seconder, and conducted to the Chair, where, standing on the upper step, he expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

And thereupon he sat down in the Chair, and the Mace was laid upon the table.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect then spoke to the following effect:—

#### MAY IT PLEASE YOUR HONOUR:

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

#### The Honourable Dr. MacLean then said :--

#### MR. SPEAKER:

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their proceedings will be conducted with wisdom, temper, and prudence, he grants, and upon all occasions will recognize and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech:—

#### Mr. Speaker and Members of the Legislative Assembly:

I welcome you to this the second Session of the Fourteenth Parliament of British Columbia. Since the last Session of this House, His Excellency the Duke of Devonshire, Governor-General of Canada, has paid this Province his first official visit. The reception accorded him by the people of this Province was warm and cordial. The deep interest evinced by His Excellency in all matters pertaining to the welfare of the Province was most gratifying, and undoubtedly will redound to the benefit of our people.

During the last year the world war was signalized by the advent of our great sister Anglo-Saxon nation into the conflict as an Ally. The aims of the Allies have been enunciated clearly in the recent speeches of the Right Honourable the Premier of Great Britain and the President of the United States. With these aims this Province is in hearty accord.

While we sympathize deeply with those of our people who have suffered bereavement by the desolation of the war, the continued heroism of all branches of the Military and Naval Services of Canada evokes our warmest admiration and pride.

For the first time in the history of the Province a woman has been returned as a Member of the Assembly. Her election is a fitting tribute and recognition of the right of women to take part in the affairs of their country.

My Government, represented by the Provincial Secretary, took part in conferences recently held at Ottawa, convened by Dominion authorities to devise ways and means for taking care of returned soldiers who are mentally or physically afflicted. A measure for this purpose will be laid before you. My Government is anxious to co-operate with the Federal authorities in all matters relating to the welfare of returned soldiers.

Owing to the existing conditions under which the precious and base metals in the Esquimalt and Nanaimo Railway Belt are held jointly by the Railway Company and the Province, you will be asked to consider this situation, to the end that the area involved may be given more "attention by prospectors and investors. The disabilities against the acquisition of mineral claims under the mining laws of the Province, now existing in Strathcona Park, will be removed, subject to restrictions as to the acquisition of surface and timber rights. My Government is securing the services of an expert to advise on the electro-thermic treatment of iron ores, and measures for the encouragement of iron and steel industries will be presented for your consideration.

You will be asked at the earliest opportunity to pass upon a measure dealing with the production of spruce for aeroplane-construction, a material for which Great Britain and her Allies depend mainly upon the resources of the Pacific Coast.

The physical and financial circumstances connected with a number of irrigation projects in the Province compel consideration of ways and means to meet an acute situation. Consequently, you will be asked to approve action looking both toward the conservation of existing productive areas and the development of new areas.

The attention of my Government has been directed to the necessity of providing for the care of neglected and destitute children within the Province, and legislation will be introduced dealing with this question.

My Government proposes to submit legislation for your consideration dealing with working conditions, the eight-hour day, and wages in certain industries.

A measure will be submitted for your consideration authorizing the Department of Agriculture to furnish seed-grain to farmers.

Since the last Session the Board of Taxation authorized by you has been sitting. The findings of the Board will be laid before you with proposals for legislation.

Measures will be submitted exempting the property of soldiers and sailors, who have served or are serving overseas in the war, from sale for unpaid Provincial taxes.

The Public Accounts for the past fiscal year will be laid before you early in the Session. The Estimates of Expenditure for the coming year will be submitted for your consideration. Gentlemen, in leaving you to your deliberations, I assure you of my confidence that the work entrusted to you will be well and faithfully performed.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rev. Captain Campbell.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

*Ordered*, That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

*Ordered*, That the Select Standing Committees of this House, for the present Session, be appointed for the following purposes:—

1. On Standing Orders and Private Bills:

- 2. On Public Accounts;
- 3. On Printing;
- 4. On Railways;
- 5. On Mining;
- 6. On Agriculture;
- 7. On Municipal Matters;

which said Committees shall severally be empowered to examine and inquire into all such matters and things as shall be referred to them by the House, and to report from time to time their observations and opinions thereon, with power to send for papers, persons, and records.

*Resolved*, That if it shall appear that any person hath been elected or returned a Member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

On the motion of the Hon. Mr. *Farris*, Bill (No. 1) intituled "An Act respecting Municipal Elections held in January, 1918" was introduced, read a first time, and *Ordered* to be read a second time at the next sitting.

On the motion of the Hon. Mr. Brewster, seconded by the Hon. Mr. Sloan, it was Resolved,— That the Speech of His Honour the Lieutenant-Governor be taken into consideration on Monday next.

The Certificates of the Deputy Provincial Secretary of the result of the election of Members to represent the vacancies in the Electoral Districts of Newcastle, Similkameen, and Vancouver, also a report of the Returning Officer of the Electoral District of Alberni, were read and *Ordered* to be placed on the Journals of the House, as follows:—

Mr. Fisher (Fernie) moved, seconded by Mr. Barrow (Chilliwack),-

That an humble Address be presented to His Honour the Lieutenant-Governor, thanking His Honour for his gracious Speech at the opening of the present Session.

We much appreciate the recent visit of His Excellency the Duke of Devonshire, Governor-General of Canada, and assure His Excellency that, both as the representative of our gracious King and for his own sake, His Excellency will ever be a welcome visitor to British Columbia.

We are sensible of the importance of and deeply grateful for the entry of the United States into the war, as one of the Allied Nations, on the side of liberty and justice, and we reaffirm the unanimous support of the people of British Columbia in achieving the aims of the Allies.

Our grief over the loss of so many gallant men is tempered by pride in and admiration for the splendid heroism of all branches of Canada's Overseas Forces.

We welcome to the Legislative Assembly its first woman member, and feel certain that this recognition of the right of women to a share in the legislative functions of their country will be productive of much good.

We note with appreciation that His Honour's Government was represented by the Provincial Secretary at a Federal conference respecting returned soldiers. Our hearty co-operation will be given in all measures for the care of those who return mentally or physically afflicted.

We will be pleased to consider proposals respecting the minerals in the Esquimalt and Nanaimo Railway Belt, and for the removal of disabilities against acquiring mineral claims in Strathcona Park, in order to encourage prospecting in those areas.

We warmly approve of the action of His Honour's Government in securing expert advice on the electro-thermic treatment of iron ores, and we will give our best consideration to proposed measures for the encouragement of iron and steel industries.

We observe that the Government proposes to submit a measure dealing with the production of spruce for aeroplane purposes, to which important matter we will give fitting attention.

We regret that the situation in connection with several irrigation projects has reached an acute stage, and note that legislation will be proposed to meet this.

We commend the action of His Honour's Government in regard to proposals for caring for neglected and destitute children.

Legislation dealing with labour matters will have our careful attention.

We note that a measure will be submitted relating to the supply of seed-grain to farmers.

We are pleased to learn that proposals for legislation based upon the findings of the Board of Taxation will be submitted, and we can assure His Honour of our earnest consideration for all plans directed to such a co-ordination of the several taxes as will bring about a more equitable distribution of the burden of taxation among the various economic interests in the Province.

We are glad to know that steps will be taken to exempt the property of soldiers and sailors on overseas service from sale for unpaid Provincial taxes.

The Public Accounts for the past fiscal year and the Estimates for the ensuing year will receive our close scrutiny.

We assure His Honour that all measures laid before us shall receive our attentive and serious consideration.

1. What representations, if any, were made by Workmen's Compensation Board with respect to moving from Victoria to Vancouver?

2. Why did it move?

3. What efforts, if any, were made by Government to have Board remain in Victoria?
