Prayers by the Rev. Wm. Stevenson.

The House proceeded to the Orders of the Day.

Bill (No. 83) intituled "An Act to bring into Force the 'British Columbia Prohibition Act'" was again committed.

Reported without amendment.

Report adopted.

Bill read a third time and passed.

Bill (No. 82) intituled "An Act to remove Doubts as to the Validity of certain Acts enacted by the Legislative Assembly of British Columbia" was committed.

Reported without amendment.

Report adopted.

Bill read a third time and passed.

Mr. Ross asked the Hon. the Minister of Finance the following questions:—

- 1. What is the total amount of money paid to Price, Waterhouse & Company for services rendered between March 31st, 1917, and May 15th, 1917?
- 2. What further amount is it estimated will have to be paid to complete the work for which said firm was employed?

The Hon. Mr. Hart replied as follows:-

- "1. The amount paid between March 31st, 1917, and June 30th, 1917, was \$6,202.90 for services rendered in Victoria, and \$337 for services rendered in London, England.
  - "2. \$954.85."

Mr. Ross asked the Hon. the Minister of Finance the following questions:-

- 1. Was an audit lately made by Marwich, Mitchell, Peat & Co., on account of the Pacific Great Eastern Railway Co., in the Parliament Buildings?

Mining Recorders and Deputy Mining Recorders, and all Assessors and Collectors who are in receipt of a salary payable out of the Consolidated Revenue of the Province, without any additional remuneration therefor, and all Provincial police officers in their respective police districts; and they are allowed a commission at the rate of 5 per centum on the amount of the poll-tax collected by them, and all Deputy Mining Recorders and Collectors of Revenue, who are not in receipt of a regular salary out of the Consolidated Revenue, are to receive as remuneration for collecting the poll-tax a commission on the amount of the tax collected by them, at the rate of 10 per cent. In addition to these Collectors of Poll-tax, the following persons have been appointed by Order in Council as Special Collectors of Poll-tax and of arrears of all other taxes, on salary, at the rate of \$125 per month, without any further allowance or commission, namely: Thomas H. Leeming, David Lewis, and W. W. Moore, Victoria; Geo. H. Hill and W. H. Kelly, Vancouver; and Alexander Forrester, Nanaimo. Neither of the Special Collectors are returned soldiers. Mr. T. Allardyce, Vancouver, who had been for years acting as a Special Collector in Vancouver, being paid partly by salary and partly by commission, is now retained temporarily as a Special Collector of Poll-tax and other taxes, at a monthly salary of \$125, without commission.

The Hon. Mr. Brewster replied as follows:-

The Hon. the Premier presented the report of the Hon. Mr. Justice Galliher, the Hon. Mr. Justice Murphy, and the Hon. Mr. Justice Macdonald, the Commissioners appointed to inquire into any and all irregularities and illegal practices, etc., at the by-election in Vancouver City Electoral District on February 26th, 1916.

Mr. Pooley moved, seconded by Mr. Schofield, That the following motion be now considered:-

That, in the opinion of this House, the whole resources of the Dominion, man-power and wealth, be pledged to the prosecution of the war, and gives its unqualified support of the principle of selective conscription to ensure the country's maximum effort, and earnestly desires that legislation to this end should be enacted at the earliest date possible; and that an humble petition be presented by the Members of this Legislature to the Government of Canada, embodying a copy of this Resolution.

Mr. Speaker Weart ruled the motion out of order as the House was not under the Order of Business permitting the motion to be ruled.

QUARTER PAST FOUR O'CLOCK P.M.

His Honour the Lieutenant-Governor having entered the House, and being seated in the Chair,

Thornton Fell, K.C., the Clerk of the House, read the titles to the following Bills:-

(No. 82) An Act to remove Doubts as to the Validity of certain Acts enacted by the Legislative Assembly of British Columbia.

(No. 83) An Act to bring into Force the "British Columbia Prohibition Act."

His Honour was pleased, in His Majesty's name, to give assent to these Bills.

The said assent was announced by the Clerk of the House in the following words:-

"In His Majesty's name, His Honour the Lieutenant-Governor doth assent to these Bills."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—  $\,$ 

Mr. Speaker and Gentlemen of the Legislative Assembly:—

It affords me pleasure, in relieving you from your legislative duties, to give expression to my appreciation of the zeal and cave you have displayed in dealing with the various matters that have engaged your attention during the present Session.

It is with deep regret that I learnt of the recent death of Sir Richard McBride, K.C.M.G., our former Premier, and I am pleased to note that your Body has passed an appropriate resolution of sympathy with Lady McBride, her family and relatives.

I am pleased to note the increased production in the mining industry of the Province, with particular reference to the output of copper, lead, and zinc, so essentially necessary to the Allies in the prosecution of the World's War.

The Act making provision for mineral surveys of the Province and for development of its mineral resources is calculated to bring the Province into more prominence as one of the greatest mineral areas on the Continent, and will necessarily induce the investment of further capital. The safeguard protecting wage-earners and investors will fulfil a long-standing requirement.

An outstanding measure you have dealt with is the "British Columbia Prohibition Act." This enactment is pursuant to the report of the Commission appointed to investigate the result of the overseas vote of the soldiers on the referendum as to prohibition.

Among other important measures with which you have dealt is the Act to promote increased agricultural production, which will materially assist in land settlement and increase the supply of foodstuffs throughout the Province, at a time when the need for such production is Empirewide.

The Act provides for encouragement and assistance to returned soldiers who may elect to enter upon agricultural pursuits.

The provisions of the "Elections Act" whereby the electoral franchise is granted to women is in keeping with modern legislation on the subject, and will enable the influence of women to be more widely felt in the conduct of Provincial affairs, accepting as they will a large measure of responsibility.

The Act providing for the audit of the Public Accounts of the Province furnishes a method of dealing with public moneys and safeguards all public expenditures, and places the most important branch of the public service on a sound business basis.

The measures adopted with a view to ameliorating financial conditions of the Province will, I feel confident, have the desired effect.

While it has been deemed expedient to curtail public expenditures, a careful administration of the various departments will, I trust, ensure an efficient service.

The "Civil Service Act," modelled on Dominion legislation, provides adequate means for raising the Civil Service to a standing of high efficiency, giving employees security and permanency on the basis of merit in the Service.

The Act providing for the creation of a permanent Board of Taxation empowered to investigate methods, equalize assessments, and adopt the most modern scientific taxation will modify existing schemes and distribute the burden of taxation equitably.

I thank you for the adequate provision you have made for the necessary expenditures in assisting the general needs of the Province, and sincerely trust that the efforts you have put forth during the Session now closed will result in the continued progress and prosperity of the Province at large.

The Hon. Dr. MacLean, Provincial Secretary, then said:-

Mr. Speaker and Gentlemen of the Legislative Assembly:-
