Whereas grave hardships and injustices are being forced upon the consumers of grain and grain products in this Province because of the increased costs thereon resulting from increased and unjust domestic freight-rate charges; and

Whereas more equitable distribution of freight charges would appear imperative in the interest of the consumers of this Province:

Therefore be it Resolved, That the Select Standing Committee on Railways be instructed to investigate the present obviously unfair and unjust freight charges on the Pacific Great Eastern Railway.

The Hon. Mr. Pattullo moved in amendment, seconded by the Hon. Mr. Hart,-

To strike out all the words after the word "Whereas" in the first line, and to insert the following:—

"It is desirable that the general public shall be fully informed as to the schedule of freight rates on the Pacific Great Eastern Railway:

"Therefore be it Resolved, That the Select Standing Committee on Railways be instructed to inquire into the freight-rate structure of the Facific Great Eastern Railway and report its findings to this House."

Amendment agreed to.

Motion as amended agreed to.

Mr. Patterson asked the Hon. the Provincial Secretary the following questions:—

- 1. Was a complaint made to the Provincial Secretary by one C. Wallich with reference to certain alleged election irregularities occurring during the election on June 1st, 1937, in the Cowichan-Newcastle Riding?
 - 2. If yes, what was the nature of such complaint?
- 3. Has an investigation been made by the Department into the subject-matter of the said complaint?
 - 4. If so, who conducted the said investigation?
 - 5. Has a report been made to the Department as a result of said investigation?
- 6. Has the Department taken action to prosecute the said Cederburg or any other person as a result of the said complaint?
- 7. If the answer to question No. 6 is in the negative, why has such action not been taken?

The Hon. Mr. Weir replied as follows:-

- "1. Yes; a verbal complaint to the Deputy Provincial Secretary.
- "2. That the Deputy Returning Officer in the Cowichan Station Polling Division of the Cowichan-Newcastle Electoral District had neglected properly to carry out the provisions of the 'Provincial Elections Act' in respect to certain forms, notably Form 23, being the Declaration of Secrecy. Secondly, that C. Wallich had been arrested upon the orders of the Deputy Returning Officer without just cause.
- "3, 4, and 5. The Returning Officer for the said electoral district was requested to furnish a report after having communicated with the Deputy Returning Officer in question, and he did so.
 - "6. No.
- "7. Any irregularities on the part of the Deputy Returning Officer consisted of certain omissions in connection with forms required under the 'Provincial Elections Act,' and, as upon investigation it appeared these omissions were not wilful and no suggestion of corruption or undue influence was put forward, it was not considered advisable to prosecute, but the negligence of the Deputy Returning Officer was brought to his attention. The complaint as to C. Wallich's arrest is a matter between the two parties concerned."

- 1. How many inmates of Oakalla Prison during the past five years are known to have been drug addicts.
- 2. How many inmates, during the same period, of Provincial Mental Homes have been narcotic addicts?
- 3. Has the Department any information as to number of drug addicts at present in the New Westminster Penitentiary?
- 4. How many armed robberies have been perpetrated in the City of Vancouver during the past ten years by drug addicts?
- 5. Has the Department any information which would lead to the belief that drugs were being smuggled into British Columbia from Japan, Manchukuo, or the Colony of Hong Kong?
- 6. Is the Government planning to establish a clinic for the treatment of patients suffering from narcotic addiction?
- 7. What would be the cost of such a building and equipment for same, and what would be annual maintenance charge?
- 8. Does the Department receive regular bulletins from the Narcotics Division of the League of Nations which would assist in detection of smuggling of drugs into the Province?

Mr. Telford asked the Hon. the Attorney-General the following questions:—

- 1. How many foreclosure actions have been commenced in British Columbia since April 28th, 1932, when the "Mortgagors' and Purchasers' Relief Act" came into effect?
- 2. State the numbers in each of the calendar years 1932-33-34-35-36, and for the year 1937 to November 1st.

The Hon. Mr. Wismer replied as follows:-

"1 and 2. No information. Separate records are not kept of the different classes of actions, suits, or proceedings in Registries, and considerable time and labour would be involved in searching all the Registries in the Province to obtain data not considered to be in the public interest."

Mr. Maitland asked the Hon. the Minister of Public Works the following question:-

What was the added cost paid on the contract on Project No. 2 (now Project No. 1) awarded to the Associated Engineering Co. for reconstruction of 4.7 miles of Malahat section, Victoria-Menzies Bay Highway, over the relocation of part of the work carried out?

The Hon. Mr. MacPherson replied as follows:-

"For expenditures during 1936-37, see Public Accounts for that fiscal year, page 285, under Project No. 1, and page 286, under Project No. 2. Expenditures under this contract during the current fiscal year will be published in the Public Accounts in due course."

Mr. Patterson asked the Hon. the Minister of Public Works the following questions:-

- 1. Have the Department Engineers given an estimate for the construction of the Federally assisted hard-surfaced road from Radium to Kingsgate, on the west side of Lake Windermere; and, if yes, what was the estimate?
- 2. Have the Department Engineers given an estimate for construction of the said road if built on the existing main road through Windermere; and, if yes, what was the estimate?

Prayers by Mr. Speaker.

On the Order being called for the notice of motion standing on the Orders of the Day in the name of Mr. Telford, as follows:—

Whereas the annual interest charges on the debt of this Province is approximately nine million dollars; and

Whereas the cost of relief during the last fiscal year was approximately ten million dollars; and

Whereas the sinking funds of the Province are in arrears by several millions of dollars; and

Whereas it is admitted there is an increase in the gross debt of this Province for the fiscal year of 1936-37 of \$6,871,000, approximately; and

Whereas our natural resources and other sources of revenue are naturally dwindling as time passes; and

Whereas it would appear that we are passing on to rising generations a responsibility for which they have had no opportunity to indicate their willingness or otherwise to assume; and

Whereas other Governmental responsibilities, such as Federal and municipal, are likewise increasing at an alarming rate; and

Whereas it would appear that nothing short of a complete financial and economic breakdown, with resultant chaos, will occur unless intelligent, scientific precautions are taken at once:

Therefore be it Resolved, That this House resolve itself into Committee of the Whole to consider ways and means of assuming our full share of all financial and social obligations undertaken by us, and pass none of these on to future generations to bear.

Mr. Speaker delivered the following decision on the point of order raised by the Hon. Mr. Pattullo on the 24th of November:—

Honourable Members,—I am of the opinion that motion No. 38 is out of order.

The preamble contains such words as "it is admitted" and "it would appear." Similar expressions were held to be equivalent to citing matters and documents not before the House by Mr. Speaker Perry in two decisions appearing in the Journals of the House for 1935 at p. 124, and the Journals of 1936, 1st Session, at p. 136.

The practice of using such phraseology in Resolutions ought not to be encouraged, as wrong impressions are apt to be created in the public mind.

As the Resolution is drafted it is difficult to see how the Committee could bring in any report other than one that would be out of order as dictating Government policy or involving public expenditure or imposing taxation, but I do not think it is necessary to make any decision on this point as the Resolution is out of order for the reasons stated above.

- 5. (a.) How many gallons of gasoline were supplied to each pump for each month in 1937? (b.) What was the price per gallon and to what departments was it charged?
- 6. (a.) How much oil was delivered to the Fernie Government yards for each month in 1937, and what was the price each month? (b.) To what department was it charged and how much to each department?
- 7. (a.) Were there any motor-cars supplied with gasoline and oil at the Fernie yard in the year 1937? (b.) If yes, who owned the cars and how much gasoline and oil was supplied, and for what purpose?

If yes, how long had they been driving the same trucks, and what was the reason for change? (c.) Have any new truck-drivers been employed at the Fernie yards since June 1st, 1937? (d.) If yes, what were their names and had they previously driven trucks before?

Mr. Speaker reserved his decision.

Mr. E. E. Winch asked the Hon. the Minister of Public Works the following questions:—

- 1. Have requests been received by the Government from public bodies in Burnaby urging serious consideration of the need for the widening of Kingsway between Boundary Road and Edmonds?
- 2. Has the Government made or received estimates of the probable cost of such widening, based upon different widths?

 - "(Note.—These questions should have been asked of the Hon. the Minister of Lands.)"

Mr. Eyres asked the Hon. the Minister of Lands the following questions:-

 - 2. Is any amount due for royalties to date; and, if yes, how much?

The Hon, Mr. Gray replied as follows:-

To insert the following as sections 3, 4, and 5 of the Bill, and to renumber the following sections:—

- "3. Section 44 of said chapter 144 is amended by striking out the words 'or second-class' in the second line, and substituting therefor the words 'second-class or third-class'; and by adding to said section the following proviso: 'Provided, if any question arises in regard to the proper classification of the land or in the absence of classification of any lands as heretofore provided, the classification thereof may be made by the Surveyor-General at his discretion, from information contained in the field-notes of the surveyor or from reports of official examinations, which classification shall be adopted as the official classification of the land covered thereby.'
 - "4. Section 45 of said chapter 144 is repealed, and the following is substituted therefor:-
- "'45. Open tracts of lands suitable for agricultural purposes or wild-hay meadow lands shall rank and be classified as first-class lands. All other lands which are capable of being brought under cultivation shall rank and be classified as second-class lands. Mountainous and rocky tracts of lands which are wholly unfit for agricultural purposes, and which cannot be brought under cultivation, and which do not contain hay meadows, shall rank as and be considered to be third-class lands.'
- "5. Section 47 of said chapter 144 is amended by striking out the word 'and' where it first occurs in the second line thereof, and by inserting after the word 'acre,' in the third line, the words 'and that of third-class lands one dollar per acre.'"

To add to said Bill the following sections:-

"9. Said chapter 144 is amended by adding to the subheading immediately preceding section 130 the words 'and Leases.'

"10. Section 134 of said chapter 144 is amended by inserting the words 'or leases' after the word 'grants' in the first line; and by inserting the words 'or lease' after the word 'grant' in the sixth line.

"11. Said chapter 144 is amended by inserting therein the following as section 134a:—
"134a. Property which is forfeited to and vested in the Crown as provided in section
158 of the "Taxation Act" shall, upon the filing of the Collector's certificate of forfeiture
as therein provided in the Department of Lands, for all purposes be deemed to be Crown
lands of the Province within the meaning of this Act, and all the provisions of this Act
shall apply to those lands and to their sale or lease to the like extent as if no grant of the
land had ever been issued."

"12. Section 160 of the 'Taxation Act,' being chapter 282 of the 'Revised Statutes of British Columbia, 1936,' is amended by striking out subsections (1) and (4)."

Ordered, That the said Message, and the amendments accompanying the same, be referred to the Committee of the Whole House forthwith.
