Honourable Members:

Yesterday, the Honourable Member for Atlin sought to move, under Standing Order 35, the adjournment of the House to discuss a matter of urgent public importance, namely, the rise of water behind a dam near Stewart.

On a number of occasions it has been ruled that such a motion is out of order where facts are in dispute or the matter is hypothetical or where a normal parliamentary opportunity for discussion will shortly occur.

I note that the estimates are currently being dealt with and, accordingly, the motion does not qualify under Standing Order 35 so that the ordinary business of the House may be set aside.

Honourable Members:

On Thursday last the Honourable Member for Alberni raised as a matter of privilege what in his words he believed to be “a deliberate misrepresentation by the Social Credit Party Caucus Newsletter on May 9, 1980 of statements I have made in the Legislature.” In support the Honourable Member tabled a copy of the said Newsletter together with the Hansard Report of March 3, 1980 and cited a reference from the 19th edition of Sir Erskine May, page 153, as follows: “Misrepresentation of Members Proceedings. — Wilful misrepresentation of the proceedings of Members is an offence of the same character as a libel.”

With reference to the prerequisite in allowing such a matter to be raised, Sir Erskine May in the 18th edition says at page 342, “As a motion taken at the time for matters of privilege is thereby given precedence over the pre-arranged programme of public business, the Speaker requires to be satisfied both that, (One): there is a

prima facie case that a breach of privilege has been committed; and (Two): that the matter is being raised at the earliest opportunity.”

In determining whether or not a *prima facie* case has been made out, I have considered the fact the Hansard Report of March 3, 1980 places the words complained of in quotation marks in recording the speech of the Honourable 1st Member for Surrey. However, I believe the Chair would be delving into the merits of the case if I were to attempt to determine whether or not the purported quotation would expunge any element of wilfulness attached to the alleged misrepresentation. The validity of such an answer to a charge of “wilful misrepresentation” would be for the House or a Committee thereof to consider and not the Speaker according to the authorities.

However, on the second imperative, namely that the matter must be raised at the earliest opportunity, the Chair must take into consideration the following facts. First, the words in question appeared in Hansard nearly four months ago and the publication of the Newsletter in question is dated May 9, 1980, some seven weeks ago. In support of the rule that a matter of privilege which claims precedence over other public business be a subject which has recently arisen, Sir Erskine May cites the following instances at page 343 in the 18th edition:

“A matter concerning an article in a newspaper published on 6 May was refused precedence because it was not raised till the 14th”;

“A speech reported on a Saturday because it was not raised until the following Tuesday.”; and

“When provincial newspapers appear in London on the morning of issue, the complaint should be raised on the day of issue.”

From these examples it is clear that the rule is one of very strict application. If any explanation or reason for delay in raising the matter did exist, the Honourable Member for Alberni, in his statement of the matter, gave no such explanation or reason and accordingly the Chair is compelled to rule that the motion cannot be made without the usual notice required by Standing Orders of the House.

On Wednesday, July 2, I undertook to the House to provide guidance on the practice to be followed in regard to private consultation with the Speaker.

Every member of the House has the right to discuss in private with Mr. Speaker, any matter on which he feels advice is needed. The Speaker will and has endeavoured to assist members to resolve difficulties of procedure and to find an appropriate method of bringing matters to the floor of the House.

Such private consultations are sanctioned by practice as noted in Sir Erskine May's *Parliamentary Practice* and *Beauchesne's Parliamentary Rules and Forms*, and are of assistance to both the member and the Speaker.

When a member consults with the Speaker and matters are touched upon which will later arise in the House, the member remains responsible for the presentation of his case in the House and for presenting all the facts to the other members of the House. It would be inappropriate for the Speaker to bring to the

House personal knowledge of facts gained through private consultations which are confidential. It would be neither fair nor responsible for other members to be denied the opportunity to answer allegations when the full case is not presented in the House. The Speaker's ruling will be based only on the material brought forward in the House except where a fact is of such common knowledge, that notice of it may be taken.

I would also point out that it is highly irregular for a member to breach the confidentiality of the Speaker's office, just as it would be inappropriate for the Speaker to reveal to a member what had been discussed with another member.

On Thursday, June 26, a matter of privilege was raised in the House by the Member for Alberni. In that case prior consultations had taken place between the Member for Skeena and the Speaker by which the Speaker was informed of certain facts but these facts were not brought before the House when the Member raised the matter. Notwithstanding what personal knowledge the Speaker may have thereby gained, the House was not aware of those facts as they were not brought forward by the Honourable Member. The Speaker's personal knowledge of a particular situation or circumstance cannot be presumed, nor should it form a basis for any decision he reaches in the House.

Mr. Speaker made a statement as follows:

Honourable Members:

Yesterday the Honourable Minister of Health rose on a matter of privilege to give notice of that matter to the House at the earliest opportunity pending efforts to obtain a transcript of certain statements which give rise to the alleged breach. The Honourable Minister advised the House of the substance of the statements in question which was sufficient upon which to frame a motion.

The House will appreciate that situations of this kind present a dilemma in that, if they are not raised at the earliest opportunity priority over other business will be denied; but on the other hand, complaints founded upon reports of statements made outside the House require the tabling of the publication in question, whether it be a newspaper or other transcript. Without such tabling, a matter of privilege may not be proceeded with.

Had the Honourable Minister not brought the matter to the attention of the House until he was in a position to table a transcript and provided that he later offered a valid reason for the delay, he would be procedurally in order. This being the case, I cannot conclude that the Honourable Minister was not in order as far as he went in rising at the first opportunity to make the House aware of his intention to complete his presentation to the House upon receipt of a transcript.

However, the authorities and previous rulings by Speakers of this House make it clear that the motion intended to be made, giving the House power to impose a remedy must be presented, even although a ruling has yet to be made by the Chair on whether or not a *prima facie* case exists. Since this was not done the Chair must rule that notice as required by Standing Orders would be required in order to proceed further.
