Thursday, 2nd March, 1916.

THREE O'CLOCK P.M.

This being the first day of the fourth meeting of the Thirteenth Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of His Honour Frank Stillman Barnard, Lieutenant-Governor of the Province, dated the 3rd day of February, 1916, the Members having been sworn took their seats.

His Honour Frank Stillman Barnard, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I welcome you to the final session of the Thirteenth Parliament of British Columbia.

The war in which the Empire has been engaged since August 4th, 1914, still continues, and without any definite hopes of an early termination. The Dominion of Canada, along with British possessions, has been contributing to the utmost of its ability in support of Great Britain and her Allies, and I am very pleased that British Columbia has taken so prominent a part, both in men and money, in furthering the common cause. I am sure I express a sentiment unanimous among its people that they will continue determinedly to the end in cordial co-operation with all other portions of the Empire to bring about ultimate and decisive victory.

Since you last met, a reconstruction of the Government has taken place owing to the resignation of Sir Richard McBride, who has accepted the important post of Agent-General for British Columbia in London, England. It is fitting here to express appreciation of the long and invaluable services rendered to the Province by that gentleman as First Minister. A measure will be submitted making suitable allowance for Mr. Turner, late Agent-General, in his retirement, in recognition of faithful and efficient work for fourteen years.

It is a pleasure to state that, while the Province has not fully recovered from the conditions brought on by the war, the great natural industries of the country are prosperous and that production has remained normal. The timber industry, which was in a depressed state owing to lack of facilities for being marketed, gives promise of coming speedily to the front again; and in this connection the members of my Government have been giving careful consideration to the best means of supplying transportation by water, and will provide guarantees to assist in the matter of supplying ships for the purpose.

It is the intention of the Government to bring into operation as speedily as possible the provisions of the "Agricultural Act," passed at your last session, and arrangements are now about completed for the necessary loan.

A measure will be submitted amending the "Constitution Act," providing for the appointment of a Minister of Agriculture apart from the portfolio of Minister of Finance.

It is the intention also to make provision for the establishment of public markets.

The Estimates will contain provision for the development of the Songhees Reserve as a railway terminus and for assisting in the construction of Johnson Street bridge as a necessary part of the plans.

A measure for Workmen's Compensation, which was submitted tentatively to the Legislature of 1915, has in the meantime been under consideration by a Commission appointed for the purpose, and will be placed before you in a fully revised form for the purpose of becoming law this session.

You will have laid before you a measure for the prohibition of the sale of liquor in the Province, which will become operative on January 1st, 1917, subject to approval by popular vote. To meet conditions created by the war, amendments to the "Liquor Act" will be submitted, further restricting and regulating the sale of liquor until peace has been declared.

Authority will be taken for the purpose of rendering assistance by way of loan, looking towards speedily completing the construction of the Pacific Great Eastern Railway, which has been delayed owing to financial conditions.

Careful consideration has been given to the requirements of the mining industry, looking to further and higher development; and also to the necessities of the returned soldiers on a basis of land-settlement in suitable localities and under favourable conditions, and both these matters will have your attention.

The Public Accounts for the past fiscal year and the Estimates of Expenditure of the coming year will be duly laid before you.

I now leave you to your deliberations with confidence that in all your acts and discussions you will be governed by a high sense of duty in respect of Provincial interests.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by His Lordship the Bishop of Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

Ordered, That the Select Standing Committees of this House for the present Session be appointed for the following purposes:—

- 1. On Standing Orders and Private Bills;
- 2. On Public Accounts;
- 3. On Printing;
- 4. On Railways;
- 5. On Mining;
- 6. On Agriculture;
- 7. On Municipal Matters;

which said Committees shall severally be empowered to examine and inquire into all such matters and things as shall be referred to them by the House, and to report from time to time their observations and opinions thereon, with power to send for papers, persons, and records.

Resolved, That if it shall appear that any person hath been elected or returned a Member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

Ordered, That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

On the motion of the Hon. Mr. Bowser, seconded by the Hon. Mr. Taylor,—

Resolved, That the Speech of His Honour the Lieutenant-Governor be taken into consideration on Friday next.

On the motion of the Hon, the Attorney-General, Bill (No. 1) intituled "An Act to amend the 'Interpretation Act'" was introduced and read a first time.

Ordered to be read a second time to-morrow.

Mr. Speaker stated that he had received certificates of the election of *Malcolm Archibald Macdonald*, Esquire, to represent the Vancouver City Electoral District, and of the election of the Honourable *Lorne Argyle Campbell* to represent the Rossland City Electoral District.

- 12. We note that the Public Accounts for the past fiscal year and the Estimates of Expenditure of the coming year will be duly laid before us.
- 13. These and all other matters which may be brought before us will receive our careful and earnest attention.
 - A debate arose, which was adjourned until the next sitting of the House.

Prayers by Rev. J. W. Flinton.

The following petition was received:-

From The Nass and Skeena Rivers Railway Company, for leave to introduce a Private Bill to amend the Company's Charter Act. (No. 4.)

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

Mr. Brewster moved in amendment, seconded by Mr. M. A. Macdonald,-

That the Resolution be amended by adding thereto the following paragraphs:—

"In view of the result of the three by-elections recently held, it is quite apparent that Your Honour's Advisers no longer possess the confidence of the electorate, and we are of the opinion that the Legislature should be at once dissolved and the wishes of the electorate ascertained.

"We regret that your First Minister has announced his intention of continuing his legislative programme, notwithstanding that two of Your Honour's Advisers have been defeated at the polls by unprecedented majorities, and a third of Your Honour's Ministers failed in receiving a majority of the votes cast, and it is still a matter of doubt if a recount will not result in his defeat.

"We regret that Your Honour is being advised to continue the administration of Provincial affairs without the advice and assistance of the full number of Ministers required by law, and



especially in view of the fact that Your Honour considers it necessary to still further increase the number of your Advisers.

"We regret that Your Honour's Ministers have aided in the acquisition of large areas of the most fertile and easily accessible Crown lands of the Province by speculators in a manner which the highest Courts in Canada have declared to be a 'fraud upon the Land Act.'

"We regret that Your Honour's Ministers have not advised you to cause an investigation under the 'Public Inquiries Act' into the matter of the fraudulent acquisition of Crown lands.

"We regret that Your Honour's Ministers, during their long tenure of office, have taken no effective measures to increase our agricultural production, but that such production has been seriously hindered by their encouragement of speculative holdings of agricultural lands in immense areas.

"We regret that Your Honour's Ministers have not seen fit to advise Your Honour to recommend to this House legislation which would secure their holdings to those members of the Allied Forces engaged in their country's service (or, in case of death, to their heirs) who may by reason of such service be rendered incapable of completing their duties under the 'Mineral Act,' the 'Placer-mining Act,' or as pre-emptors under the 'Land Act.'

"In view of the fact that Your Honour's Minister of Mines stated publicly at Rossland that the coal-miners' strike on Vancouver Island (which cost the Province such a large amount of money, and which entailed such an enormous loss and suffering) was brought about by an 'American' mine-owner, who, unable to make the property pay, took that method of covering it up, and in view of the further fact that a request for an inquiry was made to Your Honour's Ministers before the difficulties became acute, we regret that your Ministers did not cause a thorough inquiry to be made into all the circumstances so as to have avoided the loss and damage which subsequently ensued.

"In view of the enormous decrease in the revenue (over \$4,500,000 in two years), and in view of the fact that a still further decrease is anticipated by your Ministers, we regret the waste and extravagance indulged in by your Ministers, as witnessed by the startling increase of over 450 per cent, in the salary list during the last ten years; in the reckless waste shown in connection with the purchase of the Songhees Indian Reserve and the Kitsilano Reserve, and expenditures on public works throughout the Province; and in the enormous sums paid out of the Treasury in connection with Royal Commissions. We would also call to Your Honour's attention the fact that certain members of this Legislature have received large sums from the Treasury, and are sitting as members of this House by virtue only of special legislation."

Debate on the amendment continued, and on the motion of the Hon, the Minister of Lands, adjourned until to-morrow.

 - "(b.) The provision of any special or technical training or treatment necessary to assist disabled soldiers who may be unable to take up their former employment to secure other employment:
 - "(e.) The devising of a practical method of placing returned soldiers on the land under such conditions as will enable them to provide comfortably for themselves and families:
 - "(d.) The finding of employment for the large number of soldiers who, within a short space of time, will return to Canada upon the conclusion of the war.
 - "4. Salaried persons, two.
 - "5. James H. Hill, Secretary; M. A. Erskine, Stenographer.
 - "6. \$100 per month; \$45 per month.
 - "7. Moneys paid to date have been borne by the Dominion Government."

Mr. Williams asked the Hon. the Acting Minister of Finance the following questions:-

- 1. Has the Government any record of a town called "Anyox," in the Province of British Columbia?
 - 2. If so, what is the estimated population of said town?

The Hon, Mr. Bowser replied as follows:

- "1. There is no official record of a town called 'Anyox' in the Province. It is a local name given to a place on Goose Bay, in the Prince Rupert Assessment District.
 - "2. There are approximately 1,500 persons on the place locally known as 'Anyox.'
- "3. The place called 'Anyox' is located on portions of District Lots 308, 479, 898, and 899, Cassiar District, and is not subdivided into town lots.
- "4. The assessed owners of said district lots are the Granby Consolidated Mining, Smelting, and Power Company, Limited.
- "5. The average assessed value of said lots is \$7.50 per acre, but, on investigation, it has been found that the Assessor has omitted to assess certain improvements, he having erroneously concluded that section 155 of the 'Taxation Act' gave him authority to exempt said improvements. A reassessment of the property will at once be ordered.
 - "6, The acreage of District Lot 766, Cassiar, as Crown-granted, is 30 acres.
 - "7. There is no official record of the estimated resident population.
- "8. This property is assessed as the townsite of 'Granby Bay,' containing about 350 irregularly sized lots, of which the Government own about 80, the assessed valuation being \$12,930.
 - "9. Yes.
 - "10. Yes."

Mr. Brewster asked the Hon. the Premier the following question:—

 - 8. Was any evidence available in support of the charges made?
 - 9. Was such evidence (if any) brought before the Court?
 - 10. Was any evidence in this case heard by Magistrate Jay?

- 11. Did Magistrate Jay consent to the persons arrested passing from the custody of the Court to the custody of the military authorities without hearing any sworn evidence?
- 12. Under what authority did Magistrate Jay release the persons arrested without disposing of the case?
- 13. Was any action taken by the military authorities in respect to the alleged offence of the persons arrested?
 - 14. If so, what action was so taken by the military authorities?
- 15. Have the persons arrested been released without any hearing of the evidence against them in connection with the alleged offence?
- 16. If the persons arrested have been discharged without hearing the evidence against them, is it the intention of the Government to take any steps to enforce the provisions of the Statute and to prosecute the alleged offenders?

On the motion of Mr. M. A. Macdonald, seconded by Mr. Brewster, it was Resolved .-

That whereas it appears from the Public Accounts for the year ending March 31st, 1913 (page C 349, Vote 1928), that there was paid out of the Public Treasury the sum of \$300,000 on account of the (alleged) purchase of the Kitsilano Indian Reserve:

And whereas a search of the records of this House fails to disclose that any such sum of money was voted by the Legislature for that purpose:

And whereas it appears that such \$300,000 was paid out of the Treasury without the authority of the Legislature:

• And whereas it appears as if the Public Accounts had been falsified by including in the items of expenditure the sum of \$300,000 under the heading of Vote 192B:

And whereas it appears from sworn testimony adduced in the suit of Cole vs. Read that out of the sum of \$300,000 before mentioned approximately \$220,000 was divided amongst the Indians concerned, and that the remainder, approximating \$80,000, was divided between Mr. H. O. Alexander (who at that time was in the employ of the Government as Stipendiary Magistrate, and also as Official Guardian) and Mr. Hamilton Read (who admittedly was, up to a very short time previous to this transaction, in the employ of the law firm of which the present Premier of British Columbia is the head):

And whereas it appears that, notwithstanding the payment of the \$300,000 from the Public Treasury, the Province has no title to the lands comprising the Kitsilano Indian Reserve:

And whereas the circumstances attendant upon the payment of this money have not been inquired into by the Public Accounts Committee of this House:

Be it therefore Resolved, That a Select Committee, consisting of five members of this House—namely, Messrs. *Miller*, *Gifford*, *Shatford*, *Williams*, and the mover—be appointed to inquire whether or no the expenditure of this \$300,000 was authorized by the Legislature;

Whether or no the Public Accounts have been falsified in connection therewith;

Whether or no the Province has acquired a good and sufficient title to the lands comprising the Kitsilano Indian Reserve;

What sum of money was paid to the Indians in connection with the alleged purchase of their lands;

What sum of money (if any) was received by Mr. H. O. Alexander, directly or indirectly, over and above that paid to the Indians in connection with this transaction;

What sum of money (if any) was received by Mr. Hamilton Read, directly or indirectly, in connection with this transaction;

What sum of money (if any) was received by Mr. Joseph Cole, directly or indirectly, in connection with this transaction;

What was the final disposition of the moneys paid out in this connection over and above the amount paid to the Indians.

And the said Committee shall have power to call for persons, papers, documents, telegraph and telephone messages, and to examine witnesses and take evidence under oath, and shall report (either interim or final) the evidence and their findings to this House, and shall prosecute such inquiry with diligence.

On the motion of Mr. Brewster, seconded by Mr. M. A. Macdonald, it was Resolved,—

That an Order of the House be granted for a Return showing receipts and expenditures for the Province of British Columbia, under their proper headings (but with "wild land," "timber land," and "coal land" taxes segregated), for the period from April 1st, 1915, to date, as near as possible.

Mr. Brewster asked the Hon. the Minister of Mines the following questions:-

- 1. Was Mr. P. R. Flemming employed by the Government as Relief Officer at any time during the years 1913, 1914, or 1915?
- 2. If so, did the said Mr. P. R. Flemming, acting as Relief Officer, cause, aid, or assist in the removal of coal-miners from any district within the Province of British Columbia to any place outside of the Province?
 - 3. What number of coal-miners have been so removed?
 - 4. Where have said miners removed, or been removed, to?
 - 5. Have any Provincial moneys been expended in connection with such removal?
 - 6. If so, how much?

The Hon, Mr. Campbell replied as follows:-

- " 1. Yes.
- "2. Yes, at the request of the miners and the local representative of the United Mine Workers of America.
 - "3. Forty-four.

- "4. Six to Tabor, twenty-two to Belleview, three to Hillcrest, thirteen to Coleman.
- " 5. Yes.
- "6. \$1,429.80, \$300 of which has been repaid."
- Mr. Brewster asked the Hon, the Minister of Mines the following questions:-
- 1. Has Mr. E. Jacobs been employed by the Government in any capacity during the last four years?
 - 2. If so, in what capacity is or was Mr. Jacobs employed?
 - 3. For what length of time has Mr. Jacobs been employed?

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session, and the amendment thereto moved by Mr. *Brewster* on the 9th instant.

On the motion of the Hon, the Minister of Public Works, the debate was again adjourned until to-morrow.

On the motion of Mr. Place, Bill (No. 9) intituled "An Act to extend the Franchise to Women" was introduced, read a first time, and Ordered to be read a second time to-morrow.

The Hon, the Minister of Public Works presented a Return of copies of all correspondence between the Government or any member thereof and any other person or persons in any way relating to the construction of or settlement of accounts in connection with the new wing to the Parliament Buildings.

Mr. Brewster asked the Hon, the Premier the following questions:-

- 1. Has the Government entered into any agreement, tentative or otherwise, with the Canadian Puget Sound Lumber Company for the construction of any wooden sailing-vessels?
 - 2. If so, what are the particulars of such contract or arrangements; and
 - 3. What authority has the Government for making such contract or arrangement?

The Hon. Mr. Bowser replied as follows:-

- "2. Answered by No. 1.
- "3. No authority without the sanction of the Legislature."

Mr. M. A. Macdonald asked the Hon, the Minister of Finance the following questions:—

- 1. Was the interests of F. A. Heinze in the subsidy lands granted to the Columbia and Western Railway Company assessed during the whole or any portion of the period of time from 1901 to 1913, inclusive?
 - 2. Has the interest of F. A. Heinze in such lands been assessed since the year 1913?
 - 3. If so, what amount of taxes have been assessed and collected on account of such lands?

The Hon. Mr. Campbell replied as follows:-

- "1. No.
- "2. Yes.
- "3. 1914, \$11,556.17; 1915, \$11,556.17; 1916, \$11,556.17. These are the amounts assessed each year; the 1916 taxes are subject to a discount of 10 per cent., if paid on or before the 30th June next. No taxes have yet been collected. Solicitors of Heinze Estate inform the Government that estate is prepared to pay before any steps are taken to advertise the lands for sale at the next public tax sale of lands for delinquent taxes. The taxes delinquent for 1914 and 1915 are subject to interest at 6 per cent. from the dates of delinquency."

Mr. Williams asked the Hon. the Premier the following questions:—

- 1. Has the Government in its possession reliable statistics showing the extent of the operations within British Columbia of accident insurance companies?
- 2. If so, will the Government place such information before the Members of the Legislature at the earliest possible date?

The Hon. Mr. Bowser replied as follows:—

- "1. Yes. For 1913 returns see Report of Superintendent of Insurance in Volume II., Sessional Papers, 1914; for 1914 returns see Fourth Annual Report of Superintendent. The 1915 returns, which must be deposited with the Superintendent before March 31st, 1916, are being received and compiled.
 - "2. Answered by No. 1."

Mr. M. A. Macdonald asked the Hon. the Minister of Finance the following questions:—

- 1. What amount of taxes were assessed and collected on account of each year's assessment during the period 1902 to 1912, inclusive, on account of the subsidy lands granted to the British Columbia Southern Railway Company?
- 2. What was the total amount of taxes from the payment of which the British Columbia Southern Railway Company was released by virtue of chapter 37, 1912?

The Hon. Mr. Campbell replied as follows:-

- "1. The amount of taxes assessed were: For 1908, \$64,228; 1909, \$64,228; 1910, \$61,802; 1911, \$61,655. No taxes were collected.
- "2. The total amount of taxes from which the company was released in virtue of chapter 37, 1912, was \$251,913."

Mr. M. A. Macdonald asked the Hon. the Minister of Finance the following questions:—

- 1. Were the subsidy lands of the Columbia and Western Railway Company (apart from the Heinze interests) at any time assessed and taxed?
 - 2. If so, when were such lands assessed and what was the amount of taxes imposed?
 - 3. What was the amount (if any) of the taxes collected?

The Hon. Mr. Campbell replied as follows:—

- "1. Yes.
- "2. For the year 1912, \$43,094.45.
- "3. No taxes collected."

Mr. Williams asked the Hon. the Minister of Finance the following questions:—

- 1. What is the estimated population of the following "towns" respectively: (a) Powell River; (b) Bevan; (c) Britannia?
 - 2. What is the assessed value—land and improvements—per acre of each of these towns?
 - 3. What is the assessed value per acre of "Chinatown" and "Japtown," Cumberland?

The Hon. Mr. Campbell replied as follows:-

- "1. No official record of 'towns' called: (a) Powell River, (b) Bevan, (c) Britannia; but in the Comox Assessment District there are places locally called: (a) Powell River, estimated population 2,000; (b) Bevan, estimated population 700; and in Vancouver Assessment District a place locally called (c) Britannia, estimated population 1,200.
- "2. The assessed value of land and improvements per acre is as follows: (a) Powell River, \$810; (b) Bevan, \$344; (c) Britannia, \$333. As these places are not subdivided by any registered plan, but form part of district lots, the assessed values given are the averages of the district lot.
- "3. No official record of 'Chinatown' and 'Japtown,' but in the Assessment District of Comox, near Cumberland, there are places locally known as 'Chinatown' and 'Japtown.' The assessed value per acre thereof is \$52. As these places are not subdivided by any registered plan, they form part of Section 24, Nelson District; the assessed value given being the average of that section."
