Mr. Burde presented the report of the Select Committee appointed by Order of the House dated February 11th re Bill (No. 36) intituled "An Act to incorporate the Hairdressers of British Columbia," as follows:—

LEGISLATIVE COMMITTEE ROOM,

March 1st, 1927.

MR. SPEAKER:

Your Select Committee appointed on the 11th day of February met and considered pursuant to instructions the Bill No. 36, being a Bill to incorporate the Hairdressers of British Columbia.

Your Committee heard the promoters of the Bill and its opponents and discussed the representations made. The barbers secured legislation a few years ago and time has indicated that it has worked well from the standpoint of cleanliness and health. It was suggested that the barbers and hairdressers, being allied trades, get together and see if they could arrive at an agreement on their differences. Having failed to do so, your Committee recommends that the Bill be allowed to proceed. In view of the large investments made by the hairdressers and beauticians, it would seem reasonable that they get the same protection as was accorded to the barbers.

All of which is respectfully submitted.

- 1. How many trappers' licences were granted in the Peace River Block during the years 1925-26?
  - 2. To whom were such trappers' licences granted?
  - 3. What sum of money by way of royalty was paid by each licence-holder during 1925-26?
- 4. What sum of money was paid by fur-dealers in royalties within the Peace River Block during the years 1925 and 1926?

- 5. Has it ever been brought to the attention of the Department that some police officers were interested, directly or indirectly, in the fur-trading business in said district?
  - 6. If so, by whom, when, and has the complaint been investigated, and with what result?
- 7. Have any Federal postmasters in the Peace River Block been granted a trapper's or furtrader's licence? If so, to whom?
- 8. Were instructions issued by the Provincial Police officers, or any other official, forbidding licensed fur-trappers in the Peace River Block disposing of their furs to any dealer other than those doing business within the Peace River Block?
  - 9. If so, why were such orders or regulations issued?
- 10. Were instructions issued to any postmasters in the Peace River Block to see that no trappers were permitted to ship their furs to any dealer in other portions of the Province?
- 11. Has it been brought to the attention of the Department that many trappers are carrying their furs across the Provincial boundary into Alberta in order to secure a better price for their furs? If so, by whom, and when?

tax, \$87,715.71; school tax, \$183,892.36; acreage tax, \$10,757.43; special survey fees, \$1,109.44; noxious weeds tax, \$39.37; codling-moth, \$649.80; penalty on arrears, \$73,485.78; penalty tax (Land Settlement Board), \$15,805.72; total, \$2,374,889.53.

Mr. Lister asked the Hon, the Minister of Lands the following questions:—

- 1. How many motor-launches, boats, or gas-boats are in possession of the Department of Lands as at December 31st, 1926, and what is the approximate value thereof?
- 2. How many men are employed operating such boats, and what was the total cost for the year 1926?
  - 3. What was the total cost of maintenance for the year 1926?

The Hon. Mr. Pattullo replied as follows:-

- "1. Forty-three boats; value, \$103,113 approximately.
- "2. Sixty-one men. Of this number, forty-three carry on other duties, as Supervisor, Ranger, or Assistant Ranger. Cost for fiscal year to date, \$23,657.
  - "3. Cost of maintenance for fiscal year to date, \$28,845."

Mr. Hinchliffe asked the Hon. the Minister of Lands the following questions:-

- 1. Has the Government leased or does it contemplate leasing the water-power that may be developed from the Campbell River, Vancouver Island?
  - 2. If so, to whom?
  - 3. On what terms?
  - 4. For what purpose is the power that may be developed to be used?
- 5. Does the lease, or contemplated lease, include all the power that may be developed from the Campbell River? If not, what proportion of the power does it include?

The Hon. Mr. Pattullo replied as follows:—

- "1. Permission will be granted to the Canadian, Crown Willamette Company to make application for the development of water-power of Campbell River under the terms of the 'Water Act.'
  - "2. Answered by No. 1.
- "3. Rights must be acquired under the 'Water Act.' The general conditions under which the company will be given the privilege to apply under the 'Water Act.' are: Preliminary investi-

gation for eighteen months and construction of a pulp and paper mill of capacity of not less than 200 tons, to be commenced within the eighteen-month period and completed and in operation within five years thereafter.

- "4. Primary purpose, pulp and paper mill. It is understood that the company proposes to ultimately develop plant to capacity of 1,000 tons per day.
- "5. The company is applying for all the power possible of development at Campbell River. All features must be considered by the Water Board and proper provision will be made for the protection of public interests."

Mr. Hinchliffe asked the Hon, the Provincial Secretary the following questions:—

- 1. How many patients received free treatment for venereal diseases at the clinics provided by the Province during the year 1926?
- 2. How many of these patients had been previously treated and discharged as cured? How many of these came for treatment for new infection?

The Hon. Dr. MacLean (on behalf of the Hon. Mr. Sloan) replied as follows:—

- "1. New cases, 1926: Vancouver, 1,985; Victoria, 338. Total treatments, 1926: Vancouver, 31,988; Victoria, 12,078.
- "2. Discharged, 1926: (a.) Vancouver, 1,764; Victoria, 356. (b.) Returned owing to reinfection, 1926: Vancouver, 48; Victoria, 19."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-day.

And then the House adjourned at 12.23 p.m.

## Wednesday, March 2nd, 1927.

Half-past Two o'clock P.M.

The Hon. Mr. Manson (on behalf of the Hon. Mr. Stoan) presented the Annual Report of the Commissioner of Fisheries for the Year ended December 31st, 1925.

The House resumed the adjourned debate on the motion moved by Mr. Coventry on January 25th, as follows:—

Whereas, in regard to eggs, butter, cheese, fresh fruits and vegetables, and other farm products produced in Canada, the foreign tariffs thereon are higher than the corresponding Canadian tariffs on similar articles produced in such foreign countries and imported into Canada:

And whereas this has resulted in a serious diminution in export of such products from Canada into the said foreign countries:

And whereas the farmers and producers of British Columbia are suffering loss thereby:

And whereas it is advisable that the position of the farmers of British Columbia should be strengthened and the Canadian market preserved for them as far as possible:

Therefore be it Resolved, That this Legislature is of the opinion that the Government of British Columbia should urge upon the Government of the Dominion of Canada that the Canadian tariffs upon said farm products be raised to at least an equality with the tariffs of foreign countries on similar products; that the dumping clause passed by the Dominion Government of 1921 be again adopted; and that the principles of a seasonable tariff on fruit and vegetables be endorsed.

The debate continued.

On the motion of Mr. Perry, the debate was adjourned to the next sitting.

The House resumed the adjourned debate on the motion moved by Mr. *Hinchliffe* on February 11th, as follows:—

Whereas the Department of Education has prescribed for use in high schools a certain book—namely, "English Prose Selections," edited by W. L. Macdonald, M.A., Ph.D., Associate Professor of English, University of British Columbia:

And whereas a certain "selection" contained in the said book belittles and ridicules, among other things, the Parliament of Great Britain:

Therefore be it Resolved, That in the opinion of this House it is not to the best interests of this Province that the pupils in its schools should be required to read or study literature that tends to detract from the dignity of, or bring into ridicule, any lawfully constituted Parliament or Legislature within the British Empire.

Mr. I. A. Mackenzie moved in amendment, seconded by Mr. Colley,-

To strike out all the words after the word "whereas" in the fourth line thereof, and substitute the following: "certain criticisms have been directed in this House against portions of the said book:

"Therefore be it Resolved, That this House expresses its confidence in the Text-book Selection Committee chosen by the Department of Education, and in the teaching staff employed in the schools of British Columbia, and goes on record as being of the opinion that the men and women engaged on such teaching staffs and the Department of Education itself will always seek to inculcate principles of loyalty to British parliamentary institutions."

On the motion of Mr. Jones, the debate was adjourned to the next sitting.

The House resumed the adjourned debate on the motion moved by Mr. Twigg on February 21st, as amended on the motion of the Hon. Mr. Oliver on February 24th, as follows:—

Whereas we are credibly informed and do believe that we will be able to establish by satisfactory evidence the truth of the allegations of one John A. Gauthier set out below:

And whereas by declaration on oath of one John A. Gauthier, dated the 16th day of February, 1927, the said John A. Gauthier doth make statements reflecting upon the honour of certain members of this Legislature, and upon the manner in which the public business of this Province has been transacted:

And whereas the said declaration is in the words following:-

- "DOMINION OF CANADA: \ In the Matter of John A. Gauthier and the Government of British To Wit. \ Columbia.
- "I, John A. Gauthier, late of 561 Eighth Avenue West, Vancouver, B.C., now of Seattle, State of Washington, U.S.A., salesman, do solemnly declare:—
- "1. That I first arrived at Vancouver, B.C., in the year 1908 and was variously engaged in business in that city until the year 1920, when I obtained the agency of various French manufactures—amongst others, for wines and liquors.

- "2. In May, 1922, whilst on the train going East from Vancouver I met John A. Buckham, M.L.A. of British Columbia for Golden, B.C., and discussed with him the quality of liquor being then sold by the Government of British Columbia in its vendors' stores.
- "3. I suggested to said Buckham that I was in a position to obtain better liquor at better prices, and he said he would take the matter up with the proper authorities.
- "4. I heard nothing more about the matter until I returned to Vancouver at the end of June, 1922, when by arrangement with said Buckham I went to Victoria and was introduced by him to Alec Manson, Attorney-General for British Columbia, in the latter's office. The question of sending me over to the Old Country was then discussed, but said Manson did not like the idea as it would interfere with existing arrangements, and mentioned that McArthur and Paterson would not like it. Said Buckham and I, after discussing the matter generally, then left his office, and said Buckham took me to Dr. Sutherland's office, said Sutherland being Minister of Public Works for British Columbia. I had never met said Sutherland before. After the advisability of my going to the Old Country to purchase liquor had been fully discussed, said Sutherland gave it as his opinion that the idea was a good one as liquors of better quality and at a cheaper price would be obtainable. I gained the impression at the time that said Sutherland was then in control of the liquor business for the Government. It was finally arranged he would look into question and let me know.
- "5. In November, 1922, by arrangement I met Dr. Sutherland in his office at Victoria and he told me to hold myself in readiness; that everything was being arranged. We also settled a code of communication. He handed me a copy of a Report of the Liquor Commissioners and asked me to go through the brands being bought and to advise him of those which were no good. I did so advise him by writing.
- "6. By arrangement I again met Dr. Sutherland and said Buckham at one Stewart's office in Vancouver; said Stewart being an Inspector of Factories. This meeting was in the beginning of January, 1923. Said Sutherland told me he was going to Ottawa in February and to be sure to meet him there, that he would have orders for 20,000 cases signed by the Purchasing Agent, and that he would have my credentials as representative of the Government to purchase liquor and make arrangements with the distilleries in the Old Country.
- "7. On or about February 12th, 1923, said Buckham informed me that orders for only 10,000 cases could be obtained, and these would be mailed to my post-office box at Vancouver by Paterson, Purchasing Agent for the Government.
- "8. I shortly after received at said box said orders for 10,000 cases of Scotch whisky signed by said Paterson.
- "9. I left Vancouver on February 22nd, 1923, for Ottawa, and on arrival there met Dr. Sutherland and I showed to him said orders, three in number, signed by said Paterson. Dr. Sutherland asked me to see Senator Bostock, but I refused until he had seen him first and arranged matters. I did not know Senator Bostock. Later, being the following day, I called at the Senate Building and saw said Bostock, and he warned me that great powers were being given to me, and that at Dr. Sutherland's request he had signed an authority which he handed to me and which had been dictated by said Sutherland as the fullest kind of credential. Said document was written in said Senator's own handwriting and was upon the Speaker of the Senate's note-paper. A true copy of said credential, save the crest at the top and the place, is now produced and shown to me marked 'Exhibit A' hereto. Said Senator also arranged as to my passport.
- "10. In addition to the orders for 10,000 cases aforesaid, it was arranged in Vancouver at the meeting in Stewart's office in January, 1923, that I should place orders for 50,000 cases of various liquors per year for the length of time the Government would be in power, estimated at two and a half years. These orders were to be subject to said Paterson's confirmation before delivery.
- "11. After seeing said Bostock as aforesaid I again met Dr. Sutherland at the Chateau Laurier Hotel in Ottawa, and he wrote out an agreement between us to the effect that I was to have the whole of the commission on the said three orders for 10,000 cases of Scotch whisky plus \$3,000 on account of my expenses, but that thereafter the commission payable on any of the 50,000 cases a year arrangement was to be equally divided between said Sutherland and myself; and, further, that all commissions were to be paid by the manufacturers to my credit at the

Seattle National Bank at Seattle; and, further, that later when I made withdrawals the said Sutherland was to have a representative present. Both said Sutherland and myself signed said agreement and said Sutherland retained same.

- "12. Under said arrangement I was to obtain my commissions from the manufacturers, no commissions being paid by the Government of British Columbia.
- "13. I left for England shortly after aforesaid events on board S.S. 'Montcalm' and on arrival went to Glasgow.
- "14. I placed an order for 5,000 cases Scotch whisky with Peter Dawson, carrying 5 shillings a case commission; a further order with J. & W. Hardie, of Edinburgh, for 2,500 cases of Scotch whisky with commission at 5 shillings per case; both these orders were confirmed by cable by Purchasing Agent Paterson. I placed a further order for 2,500 cases with Macdonald & Muir. of Leith, commission at 10 shillings a case, but this was not confirmed by said Paterson by cable, said Paterson cabling instead that he would confirm on arrival in Scotland. This he never did.
- "15. I cabled Buckham aforesaid of Paterson's attitude, and he cabled in reply to go ahead and place orders, everything would be all right.
- "16. I therefore proceeded to carry out my instructions as arranged in Vancouver and Victoria and visited various manufacturers in Scotland, England, and France, being also instructed by Buckham by cable to make arrangements for orders which would be confirmed and closed by Paterson on arrival. In this manner I arranged for about 50,000 cases of various liquors per year for two years. So far as I know, none of these orders were confirmed by said Paterson.
  - "17. I left for British Columbia on May 10th, 1923, and passed said Paterson at sea.
- "18. About three weeks after my arrival in Vancouver said Buckham informed me that Manson, the Attorney-General, was objecting, and had cabled the Agent-General in London repudiating my credentials. I knew in London that said Manson was objecting, but heard nothing there of repudiation.
- "19. Later in Vancouver I received letters from Peter Dawson and Hardie saying that Paterson had informed them that my credentials were bogus.
- "20. In September, 1923, I saw said Paterson by appointment with Dr. Sutherland, and said Paterson then informed me that he had told the distillers that my credentials were a forgery and bogus and he had made arrangements that I would never see a cent of the commission.
- "21. I had various meetings with Sutherland and Buckham after my said return, and, not being able to obtain any commission, said Dr. Sutherland instructed aforesaid Stewart, Inspector of Factories, to give me sums of money up to a total of \$3,000, and this the said Stewart did.
- "22. In November, 1923, said Buckbam informed me that Sutherland and he could do no more, that they were in a jack-pot.
- "23. I then decided that I should take action against said Paterson for defamation of character, and I wrote to Senator Bostock and finally in March, 1924, I wrote to Premier John Oliver, stating all the facts and demanding payment of my commission. I received no reply, but very shortly after I was requested by one W. T. McArthur to call at his office in Vancouver, which I did. He asked me various questions, stating that I had written to John Oliver. He also threatened me and offered me \$1,000 in settlement of my claim for defamation against Paterson. I refused and left. The next day, in consequence of a letter I wrote said McArthur demanding an immediate settlement, said McArthur asked me to see him, and I went to his office and finally agreed to accept \$5,000 in full of my claim against Paterson and \$20,000 in full on account of commission, said \$20,000 to be paid in two months' time.
- "24. A couple of days later I met McArthur again by appointment and we went to his lawyer's office. The lawyer's name was Alex. Henderson. McArthur there produced from his pocket a receipt and a statutory declaration, paid me \$5,000 in cash, and I signed receipt and swore to declaration before said Henderson. I asked McArthur to leave said documents with said Henderson, and after McArthur had left I made copies and had them certified as correct copies by said Henderson. This all occurred on April 1st, 1924.
  - "25. I did not receive the said sum of \$20,000 in two months or at all.
- "26. In December, 1924, I again saw said McArthur and demanded payment, and he refused, saying I had no case as I had signed said receipt and declaration. He also stated that if I was going to 'cause us' any more trouble he would fix me, and went on to say they could soon frame up something against me to put me away.

"27. When I signed the declaration on oath on April 1st, 1924, I handed to said McArthur copy of letter to John Oliver, original letters from J. & W. Hardie, Macdonald & Muir, and my copies of orders approved by Purchasing Agent Paterson. All my other documents, including Bostock's credential, had been given by me to aforesaid Buckham in Stewart's office in Vancouver in the beginning of August, 1923, and about the same time Dr. Sutherland informed me and I verily believe that he had given our agreement made in Ottawa to said Buckham.

### (IN THE COMMITTEE.)

Resolved, That the Committee rise and report to the House, recommending the introduction of a Bill (No. 90) intituled "An Act to amend the 'Noxious Weeds Act,'" a draft of which is annexed to this Resolution.

Resolution and Bill reported.

Bill introduced and read a first time.

Second reading at the next sitting.

Mr. Twigg moved, seconded by Mr. Peck,—

Whereas we are credibly informed and do believe that we will be able to establish by satisfactory evidence the truth of the allegations of one Frank Carlow set out below:

And whereas by declaration on oath of one Frank Carlow, dated February 28th, 1927, the said Frank Carlow doth make statements reflecting upon the manner in which the public business of this Province has been transacted by the present Government of the Province of British Columbia, and upon the methods adopted by the said Government and their party officials to obtain campaign funds:

And whereas the said declaration is in the words following:-

"DOMINION OF CANADA:

PROVINCE OF BRITISH COLUMBIA.

To WIT:

- "I, Frank Carlow, of the City of Victoria, in the Province of British Columbia, do solemnly declare:—
- "1. That I am a native son of the City of Victoria and have carried on business in said city for practically my whole life.

- "2. That I have held the following official positions in the Victoria Liberal Association, namely: Ward secretaryship, ward presidency, the vice-presidency and presidency of the Central Liberal Association; also I have been in fact organizer for the south end of Vancouver Island, and was a Liberal candidate for Esquimalt in the 1924 Provincial election, and I have an intimate knowledge of the matters hereinafter referred to.
- "3. I became president as aforesaid in the summer of 1922 and immediately took up the question of my party's organization in Victoria and neighbouring district. In connection with this I had interviews with Honourable Dr. J. D. MacLean, Honourable A. M. Manson, and Honourable John Hart, and was finally referred to H. C. Hall, K.C., of Victoria, as being the person empowered to make all arrangements.
- "4. In consequence I had many interviews with said Hall on the subject of organization and he informed me on several occasions that the great difficulty in proceeding with the work was the shortage on Vancouver Island of Liberal party funds and that some method of raising such funds was necessary.
- "5. The said Hall finally suggested that I should acquire an agency for the sale of liquor to the Government and that my commissions as such agent should be applied towards organization expenses and my proposed salary as organizer.
- "6. The said Hall suggested I should obtain the agency for the sale of MacDonald & Muir's brand of whisky, but I refused as a personal friend held the agency for that firm.
- "7. I then saw one Samuel McHaffie, who was agent for Whiteley's House of Lords Scotch Whisky, and arranged that he should have me appointed as agent in his place, and later that I arranged to pay him 15 cents a case out of any commissions I received. I was so appointed agent in or about August, 1922.
- "8. The said Hall then requested me to see Honourable A. M. Manson and I did so, explaining to him the whole arrangement. The said Manson referred me to Honourable J. D. MacLean as being the Cabinet's representative in matters of this nature.
- "9. I thereupon discussed the whole matter of raising funds as aforesaid with said MacLean and he approved of the same but said it would have to be looked into.
- "10. It was estimated by said Hall and myself that the commissions payable on the purchase by the Government of some 8,000 cases of whisky, at the rate of 4,000 cases a year for two years, would be sufficient for organization expenses in Victoria and allow me a salary of \$400 a month, equal to my estimated earnings at that time in my own business.
- "11. Finally, towards the end of October, 1922, said H. C. Hall instructed me to take the matter up with Mr. James Paterson, Purchasing Agent for the Government of British Columbia.
- "12. I went to see said Paterson, but before doing so saw McHaffie aforesaid and explained to him that any commission I received over 15 cents a case was to go to the Liberal party funds for organization and that this was the only basis on which I could hope to get an order from said Paterson. Said McHaffie accepted the situation.
- "13. I then saw said Paterson and fully explained to him the whole matter and that if he gave me an order the commission would be used for party purposes aforesaid.
- "14. Said Paterson did not care for the Whiteley brand and suggested an agency for MacDonald & Muir, which I refused to have anything to do with. He finally agreed to the Whiteley whisky.
- "15. I informed said Paterson that it would require a minimum of 4,000 cases a year and an immediate order for 2,000 cases at 55 shillings a case. Said Paterson asked me if I had seen the Attorney-General about it and I informed him that Mr. H. C. Hall had arranged with him. Paterson promised to look into it and made an appointment for me to see him next day.
- "16. The next day I saw said Paterson and he stated he would give me an order for 1,000 cases of Whiteley's whisky to start with and a further order in two weeks for 1,000 cases more, and that he could handle 4,000 cases a year for two years.
- "17. An order for 1,000 cases was shortly after sent to Whiteley's, but I did not receive the second order.
- "18. The said firm of Whiteley, having been informed that said second order was shortly following, sent out the second 1.000 cases, which duly arrived and was subsequently accepted by the Purchasing Agent aforesaid.
- "19. H. C. Hall aforesaid then saw me and informed me that said Paterson was very angry and that I must get rid of the second 1,000 cases if possible to the Consolidated Importers.

I refused to do this as I had received my commission from Whiteley's at 10 shillings a case and had disbursed a part of it in organization work.

- "20. In May, 1923, I approached said Hall with a request for a second order and was informed by him that the whisky was not selling well and that no further orders would be given at present.
- "21. Later said Hall paid me \$500 in cash and paid me \$100 a month for four months, and in October, 1923, arranged a monthly payment of \$250 a month for eleven months, which I received on account of salary and expenses.
- "22. In June, 1923, one L. G. Thomas requested me to use my influence to obtain for him a foreshore lease from the Provincial Government at the rear of his property in English Bay, Vancouver, and that he would pay \$150 to \$250 a year rental and would pay me a fee of \$250 if successful.
- "23. I thereupon saw said H. C. Hall and arranged that the \$250 fee would be used for organization expenses if lease granted, in part lien of liquor commissions as arranged and which were not then forthcoming.
- "24. Later I again saw said Hall and he suggested to me to tell said Thomas that if he paid a \$5,000 fee, to go to organization expenses, said lease might be obtained. I then saw said Thomas and he agreed to take lease and pay me fee of \$5,000. I told him said money was to be used for party purposes.
- "25. I again saw said H. C. Hall and he instructed me to formally request as for a client the aforesaid foreshore lease and this I did by letter to Honourable Pattullo, Minister of Lands.
- "26. I followed up said letter by seeing said Pattullo in his office and at first he demurred as this foreshore was required for park purposes.
- "27. After many negotiations and with the assistance of said H. C. Hall, said lease was granted and said Thomas gave me a promissory note for \$5,000. During the course of said negotiations at an interview with said Pattullo he informed me that we should be getting something good for this and he would grant the lease upon hearing from one M. B. Jackson, K.C., that he, Jackson, was satisfied and that Jackson was to receive a portion of any commission. I thereupon saw said Jackson and arranged with him that he should receive two-fifths of said \$5,000 and I three-fifths of same.
  - "28. Said note was not paid on maturity and was renewed for \$4,000.
- "29. I still continued my organization, carried said note, and received no orders for liquor and I had several interviews with Honourable A. M. Manson regarding the matter but could get no satisfaction.
- "30. Finally, after the 1924 general election, I was told by said Hall that the collection of the said note was my own affair and that nothing more could be done for me. I thereupon discounted said note for \$4,000 with one A. D. Ford, of Victoria, for the sum of \$1,000 in cash and an equity in real estate valued at \$1,000.
- "31. I endeavoured to recoup my losses by selling to the Government of British Columbia during the years 1924 and 1925 a motor road safety-signal device, and the Honourable Dr. Sutherland informed me that provision for such would be made in the 1925 estimates and such provision was made, but I received no orders.
- "32. After the session of 1925 was over I interviewed the Honourable John Oliver and told him the whole story of the foreshore lease and my losses through failure to collect the \$5,000 note, and the said Oliver said he would take the matter up with the Honourable Dr. Sutherland. Nothing, however, happened.
- "33. About the month of May, 1926, I instructed a solicitor, P. J. Sinnott, of Victoria, to collect for me the sum of \$6,750, being the amount due under my arrangement with said H. C. Hall, and said P. J. Sinnott attempted to do so, but without success, said Hall making threats of criminal proceedings if the matter was pursued.

  - "8. Fire-engine and equipment at University Buildings available.
  - "9 No
- "10. British Columbia Electric Railway Company has undertaken and are providing adequate bus service."

"1 to 6. The main trunk road on the north side of the Fraser follows for a short distance only through Maple Ridge on the Dewdney Road; then follows Ontario Street and the River Road. The road on the north side of the Fraser was classified as a secondary highway from New Westminster to and through Mission Municipality in June, 1922, and reclassified as a primary highway in February, 1926, because of its increasing importance as a trunk highway.

As the road is classified as a whole through Maple Ridge Municipality, it is impossible to segregate the small portion where it follows the Dewdney Trunk Road from the rest of the highway through the same municipality."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-day.

"'(2.) Where a licensed real-estate agent or real-estate salesman to whom subsection (1) applies fails for a period of one month at any time to furnish, renew, or maintain in force and unimpaired the security required by that subsection, the Superintendent shall suspend his licence until the security is furnished, renewed, or maintained, and if such failure continues for a second period of one month the Superintendent shall cancel his licence.'

"(2.) This section shall come into force on the first day of July, 1927."

In relieving you from further duty at this time, I trust that the blessing of Divine Providence will rest upon you and upon your labours.

The Hon. Mr. Oliver, Premier, then said:-

Mr. Speaker and Members of the Legislative Assemblu:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
