- "(b) by adding after the word 'post' in the fifth line the words 'or survey monument',

so that the section shall read as follows:-"

Section 52: To amend by striking out the words "To be used only for claim staked by witness posts." in the third and fourth lines of clause (a).

"(c) By striking out the word and figures 'section 31' in the second line of paragraph 7 of Form H and substituting the words 'the provisions', so that the paragraph shall read as follows:—"

"54. This Act comes into force and effect on the first day of May, 1964."
