Prayers by Mr. Speaker.

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

The debate continued.

On the motion of the Hon. Mr. Weir, the debate was adjourned to the next sitting of the House.

On the motion of Mr. Leary, seconded by Mr. Tupper, it was Resolved,—

That the name of Louis LeBourdais be added to the Select Standing Committee on Railways.

By leave of the House, on the motion of the Hon. Mr. MacDonald, seconded by the Hon. Mr. Gray, it was Resolved,—

That this House authorize the Select Standing Committee on Agriculture to consider such matters affecting the agricultural industry as may be laid before it by the Advisory Board of Farmers' Institutes, and to report its recommendations to this House.

The Hon, Mr. Wismer presented the following papers:-

Annual Report of the Inspector of Gaols on Oakalla Prison Farm for the Year ended March 31st, 1937.

Annual Report of the Inspector of Gaols on the Nelson Provincial Gaol for the Year ended March 31st, 1937.

In reply to the following question by Mr. Anscomb relating to the Workmen's Compensation Board, the Hon. Mr. Pearson presented a Return:—

"2. Into what type and class of securities is the amount divided? Give full details of each case, maturity dates, etc."

Mr. E. E. Winch asked the Hon. the Premier the following questions:-

- 1. Has the attention of the Premier and Directors of the P.G.E. Railway been called to the "auto-rail" cars now in use on the Canadian National Railways system?
- 2. Has consideration been given to the use of such cars on the P.G.E. Railway for the purpose of providing a quick, economical, and daily passenger service?
- 3. If not, will the Premier bring this matter to the attention of the Directors or management of the P.G.E. Railway with a recommendation for favourable consideration of the institution of such service?

The Hon. Mr. Pattullo in reply presented the following copy of report from the General Manager of the Pacific Great Eastern Railway Company:—

" PACIFIC GREAT EASTERN RAILWAY.

"VICTORIA, B.C., November 5th, 1937.

" Hon. T. D. Pattullo,

President, Pacific Great Eastern Railway, Victoria, B.C.

"DEAR SIR,—With reference to the question of Mr. E. E. Winch in Votes and Proceedings No. 6, dated 3rd instant, regarding the use of auto-rail on the Pacific Great Eastern Railway, the officials of the Company have for the last eighteen months been obtaining reports from railway companies on the American and European continents about the operations of locomotives and cars propelled by Diesel engines, and have accumulated much information on the subject.

"As a result of these investigations, a Diesel engine was installed at the beginning of the year in one of the Company's motor-cars which is being operated between Lillooet and Bridge River for the transportation of passengers, express, and vehicles. The result has been satisfactory both from the standpoint of reduced costs and efficient service.

"The subject is still engaging the attention of the officials of the Company.

The Acting-Secretary in the office of the Minister of Mines referred this letter to the late Deputy Minister, who acknowledged its receipt on July 17th. On July 22nd R. E. Barker, president of Hedley Amalgamated Gold Mines, Limited, wrote the Minister of Mines advising him that the matter was receiving attention, and he would write again. The Acting-Secretary in the Minister of Mines' office referred this letter to the late Deputy Minister of Mines. No further information, as the late Deputy Minister, whose health was failing at the time, apparently did not follow up the matter."

3. Was any appointment of counsel to the Commission made? If so, who, and what fee has been paid to them or is yet due to them?

The Hon. Mr. Weir replied as follows:-

A negative vote will be interpreted (rightly or wrongly) as a vote of non-support for the progressive policies in education, health, and welfare, which I have sponsored, and will make it much more difficult for me to obtain further progress in these fields. But an affirmative vote will act, in effect, as a vote of confidence in the other policies which have been carried out by the two departments over which I preside"?

 - 4. How many copies of said document were sent out?

The Hon. Mr. Weir replied as follows:-

 - "3. No; nor was the postage paid by the Government.
 - "4. No record was kept; possibly 500."

The Hon. Mr. Weir replied as follows:-

Mr. Finland asked the Hon. the Provincial Secretary the following questions:—

- 1. Has Dr. Alfred K. Haywood been paid anything as the consultant to the Health Commission under the State Health Insurance Act? If so, how much?
- 2. Is Dr. Alfred K. Haywood paid any remuneration by the Government other than for services rendered under the State Health Insurance Act? If so, how much?
- 3. Is the said Dr. Alfred K. Haywood Superintendent of the Vancouver General Hospital? If so, has the Department knowledge of his salary paid for such position?

- "1. No.
- "2. No.
- "3. Yes. The salary is fixed and paid by the Board of the Vancouver General Hospital."

Mr. E. E. Winch asked the Hon. the Minister of Education the following questions:-

- 1. Upon what basis does the Provincial Government contribute to the remuneration of the School Health Inspectors appointed under section 170 (1), (2) of the "Public Schools Act"?
- 2. Upon what basis does the Provincial Government remunerate the School Health Inspectors appointed under section 171 of the "Public Schools Act"?

3. When is the remuneration of the School Health Inspectors paid: (a) At regular periods; (b) if so, at what periods; (c) after receipt of their inspection reports?

4. Within what time following the close of periods covered by the health inspection

reports are they required to be in the hands of the Department?

- 5. On what schools—in the respective classifications of High, Junior, Graded City, Rural Municipal, Rural and Assisted—were reports from the responsible School Board or Health Inspector (giving the results of the physical examination of staffs, pupils, and the condition of the schools and appurtenances) not forthcoming for the years ended June 30th, 1936 and 1937, respectively?
- 6. (a.) Had any of these been similarly delinquent on previous occasions? (b.) If yes, what action, if any, was taken to remedy same?
- 7. Does the Government withhold its share of the cost of making of the statutory inspection until the report thereon has been received by the Department?

- "1. The Provincial Government does not contribute to the remuneration of School Health Inspectors appointed in cities or municipalities under section 170 (1), (2) of the 'Public Schools Act.'

- "Graded City Schools: On checking over reports received with the Education Report for same year, we find that all these schools have been examined.
 - "Rural Municipal Schools: Same as for Graded City Schools.
- "Rural and Assisted Schools: Alert Bay, Alice Arm, Bella Bella, Big Bar Creek, Big Bar Lake, Camp Creek, Canyon Creek, Cedarvale, Cheam View, Copper City, Cranbrook Mills, Criss Creek, Curzon, Digby Island, Dorreen, False Bay, Forks, Gibson Creek, Granby Bay, Hutton, Isle Pierre, Jesmond, Kispiox, Kitwanga, Lakelse Valley, Lee Creek, Longworth, Longworth South, Maple Grove, Mountain, McGuigan, McMurphy, Ness Lake, Newlands, Omineca, Oona River, Pacific, Pender Harbour, Penny, Pitt Lake, Red Lake, Reid Lake, Remo, Shawnigan Lake West, Sinclair Mills, Stuart Island, Swift Creek, Sylvan Glade, Tucker Bay, Usk, Vesuvius, Woodcock, Woodpecker.
- "The report for the year ended June 30th, 1937, is at present being compiled and figures are not available.
- "6. (a) and (b). The schools that are not examined vary from year to year owing to weather and road conditions at the time the Inspector intends making the examination, which makes it impossible for him to reach the school at times.
 - "7. Answered by No. 3."

Mr. E. E. Winch asked the Hon. the Minister of Education the following questions:-

- 1. How many children are at present attending the Deaf and Blind School?
- 2. Has a survey been made by the Department for the purpose of ascertaining the number of children who are (a) deaf, (b) blind, (c) partially blind, and (d) partially deaf, of (i) school and (ii) pre-school age respectively?

- "1. Assuming that these questions relate to the 'Hospital Act,' not the 'Health Act,' a uniform system of monthly and annual reports has been in effect for a number of years. The Department proposes to put into effect shortly a new system of reports, based upon the joint recommendations of the Canadian Hospital Council and the Dominion Bureau of Statistics and with the approval of the British Columbia Hospitals Association. The Department is also undertaking to encourage by every means possible uniformity of accounting and record-keeping by the individual hospitals.
 - "2. Not yet. This is a complex subject under close study by the Department.
- "3. Revised hospital regulations are in course of preparation. Annual reports have been made to the Department since 1921.
- "4. No specified date. Particulars contained in annual report forms are collected and printed in a statistical report."

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:-

- 1. What number of prisoners are at present confined in Oakalla under sentence?
- 2. For what periods were they sentenced: (a) Under three months; (b) three months and under six months; (c) six months and under twelve months; (d) twelve months and over?

- "2. (a) Under three months, 58; (b) three months and under six months, 94; (c) six months and under twelve months, 144; (d) twelve months and over, 168.

Therefore be it Resolved, That this Legislature is of the opinion that the Government has forfeited the confidence of the people in neglecting to put the "Health Insurance Act" into operation.

The Lieutenant-Governor transmits herewith an amendment to Bill (No. 3) intituled "An Act to create a Department of Trade and Industry and to provide for the Investigation of Matters of Economic Importance, the Encouragement of Industry, the Collection and Publication of Statistics, the Development of Trade, and the Stimulation of Tourist Traffic," enclosed herewith, and recommends the same to the Legislative Assembly.

Government House,

November 18th, 1937.

(Enclosure.)

To insert the following as section 27 of said Bill, and renumber the following section:—
"27. (1.) Subject to subsection (2), all powers, authorities, and functions which under the 'Department of Industries Act,' chapter 127 of the 'Revised Statutes of British Columbia, 1936,' are at the commencement of this Act vested in or exercisable by the Minister of Industries, either by himself or upon the recommendation of the Advisory Council or with the approval of the Lieutenant-Governor in Council, shall, so far as the same continue in existence and capable of being exercised after the commencement of this Act, be vested in and exercisable by the Minister of Trade and Industry either by himself or with the approval of the Lieutenant-Governor in Council, as the case requires.

- "(2.) After the commencement of this Act, no assistance to any person by way of loan, guarantee, or guarantee of securities shall be authorized or given by virtue of the provisions of the 'Department of Industries Act.'
- "(3.) Subject to the provisions of sections 7 and 9 of the 'Department of Industries Act' remaining in force to the full extent necessary to administer and apply the Industrial Development Fund and to administer, safeguard, and dispose of the property and securities acquired or held under that Act, the 'Department of Industries Act' is hereby repealed."

To add to said Bill the following section:-

"28. Any of the moneys appropriated by the Legislature for the purposes of the Economic Council for the fiscal year ending the thirty-first day of March, 1938, remaining unexpended may be paid and applied for the purposes of Part II. of this Act."

Ordered, That the said Message, and the amendment accompanying the same, be referred to the Committee of the Whole House forthwith.

Resolved, That the Committee rise and report to the House, recommending the introduction of the proposed amendment to Bill (No. 3) intituled "An Act to create a Department of Trade and Industry and to provide for the Investigation of Matters of Economic Importance, the Encouragement of Industry, the Collection and Publication of Statistics, the Development of Trade, and the Stimulation of Tourist Traffic," a draft of which is annexed to the Message from His Honour the Lieutenant-Governor.

Resolution and amendment reported.

Amendment introduced and read a first time.

Ordered, That the said amendment be added to and stand part of the Bill and be placed on the Orders of the Day for second reading at the next sitting of the House.

The Hon. Mr. Weir presented a Return in reply to the following questions by Mr. $E.\ E.\ Winch:$ —

- 1. Are any of the school free-text, authorized, or complementary books written by officials who occupy positions in the educational system of the Province?
- 2. If yes, what books, names of the authors, and what position do they respectively occupy?
 - 3. Do such authors receive royalties on the sale of their books?
- 4. Are any of the authors of the books above mentioned members of a committee which advises the Department of Education as to the course of studies and the books specified and authorized? If yes, which?

Mr. Finland asked the Hon. the Minister of Finance the following questions:

- 1. What is the total industrial pay-roll of British Columbia?
- 2. How much by way of 1-per-cent. tax was collected for the fiscal year ended March 31st last?
- 3. How much of this amount was returned to the wage-earners who did not have a taxable income?

The Hon. Mr. Hart replied as follows:—

- "1. No segregation kept as between industrial and other pay-rolls.
- "2. \$1,750,611.57.
- "3. For total amount refunded, see Votes and Proceedings for November 10th, 1937, page 4.
 - "No segregation is kept as between amounts wholly and partially refunded."

Mr. Macintosh asked the Hon. the Minister of Public Works the following questions:-

- 1. How many gallons of gasoline were used in (a) passenger-cars and (b) motor-trucks owned by the Department of Public Works during the fiscal year ended March 31st, 1937?
- 2. How many gallons of gasoline have been used in such passenger-cars and motor-trucks for each month from April 1st, 1937, to September 30th, 1937?

The Hon. Mr. MacPherson replied as follows:—

- "1. (a) Passenger-cars, 35,093; (b) motor-trucks, 355,361.
- "2. Passenger-cars: April, 3,171; May, 3,662; June, 3,558; July, 3,713; August, 3,162; September, 3,107. Motor-trucks: April, 31,302; May, 35,357; June, 39,154; July, 39,608; August, 33,540; September, 31,559."

Mr. Eyres asked the Hon. the Minister of Public Works the following questions:-

- 1. What has been the total sum paid between November 17th, 1934, and November 1st, 1937, by way of commissions at the rate of 7½ per centum upon the construction of the Fraser River (New Westminster) Bridge to the Fraser River Bridge Co., Ltd.?
- 2. Have any other payments for any other purpose or by way of fees or expenses been made to the Fraser River Bridge Co., Ltd., between November 17th, 1934, and November 1st, 1937?
- 3. If question No. 2 is answered in the affirmative, what were such payments made for and what was the amount of each?
- 4. Have any payments been made in the form of commissions, fees, salary, wages, or in any other form to James A. Collins, except for and on behalf of the Fraser River Bridge Co., Ltd.?

The Hon. Mr. MacPherson replied as follows:—

- "1. See Public Accounts for fiscal years 1935-36 and 1936-37. Payments during fiscal year 1937-38 will be published in due course. Percentage of payments has been retained until final and satisfactory completion of the work.
 - "2. No.
 - "3. Answered by No. 2.
 - "4. No."

Mr. Maitland asked the Hon, the Minister of Public Works the following questions:-

- 1. Have any extras been allowed or paid on Project No. 2 (now Project No. 1) contract awarded to the Associated Engineering Company for reconstruction of 4.7 miles of Malahat section, Victoria-Menzies Bay Highway?
 - 2. If so, what amount has been allowed or paid?
 - 3. Are there any outstanding amounts or claims in relation to the said contract?

The Hon. Mr. MacPherson replied as follows:—

- "1. No; a relocation of part of the work was carried out, with a consequent increase in the quantities.
 - "2. See answer to No. 1.
 - "3. No."

Mr. Eyres asked the Hon. the Minister of Public Works the following questions:—

- 1. What was the amount, if any, paid by the Government to the Fraser River Bridge Co., Ltd., between November 17th, 1934, and November 1st, 1937, for expenditures incurred by the Fraser River Bridge Co. under clause 6 of the agreement dated November 17th, 1934, between the said Bridge Company and the Government (chapter 35, Statutes of British Columbia, 1935)?
- 2. Was any interest allowed to the Fraser River Bridge Co., Ltd., for moneys so expended?

The Hon. Mr. MacPherson replied as follows:—

- "1. No payments made.
- "2. See answer to No. 1."

Mr. Finland asked the Hon. the Minister of Public Works the following questions:-

- 1. Has the Associated Engineering Co., Ltd., Vancouver, been engaged upon reconstruction-work on the Malahat Drive between Goldstream and the Summit between January 1st, 1936, and November 1st, 1937?
- 2. What was the tender, or tenders (if contracts awarded in sections), of the Associated Engineering Co., Ltd., for such work?
 - 3. What will be the total cost of such work?
- 4. Did the original tender of the Associated Engineering Co., Ltd., for that section of the Malahat Drive between Goldstream and Scenic View include hard-surfacing the road?
- 5. If question No. 4 is answered in the negative, what was the extra cost for such hard-surfacing, and by whom was it done?

The Hon. Mr. MacPherson replied as follows:-

- "1. Yes.
- "2. For contract let in 1936 see Public Works Annual Report, 1936-37. Details of tenders received and contracts awarded during 1937-38 will be published in Public Works Annual Report in due course.
- "3. For expenditures during 1936-37 see Public Accounts for that year, page 285, under Project No. 1, and page 286, under Project No. 2; expenditures during 1937-38 will be published in due course.
 - " 4. No.
 - "5. \$10,246.07; by Department,"

Mr. Macintosh asked the Hon, the Provincial Secretary the following questions:-

- 1. How many gallons of gasoline were used in (a) passenger-cars and (b) motor-trucks owned by the Department of the Provincial Secretary during the fiscal year ended March 31st, 1937?
- 2. How many gallons of gasoline have been used in such passenger-cars and motor-trucks for each month from April 1st, 1937, to September 30th, 1937?

The Hon. Mr. Weir replied as follows:-

- "1. (a) 13,119% gallons; (b) 10,046% gallons. In addition, 1,688 gallons were used for tractors and 151 gallons for lawn-mowers, laboratory, garage, cement-mixer, and general use.
- "2. Passenger-cars, 7,397 gallons; motor-trucks, 5,638 gallons. In addition, 742 gallons were used for tractors and 127 gallons for lawn-mowers, laboratory, garage, cement-mixer, and general use. (Figures segregated by months are not available.)"

Mr. Eyres asked the Hon. the Minister of Public Works the following questions:

- 1. At any time between November 17th, 1934, and November 1st, 1937, did the Hon. the Minister of Public Works approve of the Fraser River Bridge Co., Ltd., incurring any financing or legal costs for the protection of the Government's interest, relative to the construction of the Fraser River (New Westminster) Bridge, in accordance with provisions of clause 7 of the agreement dated November 17th, 1934, and being the Schedule to chapter 26, Statutes of British Columbia, 1935?
- 2. If answered in the affirmative, what were the costs so approved, and for what purposes was approval given?

The Hon. Mr. MacPherson replied as follows:-

- " 1. No.
- "2. Answered by No. 1."

Mr. Finland asked the Hon. the Minister of Public Works the following questions:-

- 1. Was the Court-house at Rossland decorated for Coronation Day?
- 2. If so, what was the total cost of such decoration, and who was the contractor?

The Hon. Mr. MacPherson replied as follows:-

- " 1. Yes.
- "2. \$249. Jones Tent & Awning Co., for flags and bunting, etc.; C. W. Gibbard, Rossland, for erecting scaffold, putting up and taking down decorations."

Mr. Macintosh asked the Hon. the Minister of Finance the following question:—
What is the number of employees at present with the Bureau of Provincial Information?
The Hon. Mr. Hart replied as follows:—
"Five."

Mrs. Steeves asked the Hon. the Minister of Labour the following questions:-

- 1. Has the Economic Council done any work on the survey of the housing problem in British Columbia, instructions for which were given by the Legislative Assembly in a Resolution passed on March 23rd, 1936?
- 2. If yes, will any interim findings be available for the information of members of the House?
 - 3. Approximately when will the report be completed?

The Hon. Mr. Pearson replied as follows:-

- "1. Report has been tabled with the House.
- "2. Answered by reply to question 1.
- "3. Answered by reply to question 1."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

And then the House adjourned at 5.44 p.m.

Prayers by Mr. Speaker.

The Hon. Mr. Pattullo presented the Report (in two volumes) of the Commissioner, the Hon. Mr. Justice M. A. Macdonald, relating to the Coal and Petroleum Industries.

The House resumed the adjourned debate on the motion "That Mr. Speaker do now leave the chair" for the House to go into Committee of Supply.

The debate continued.

On the motion of Mr. Murray, the debate was adjourned to the next sitting of the House.

On the motion of Mr. E. E. Winch—Bill (No. 24) intituled "An Act to amend the 'Marriage Act.'"

On the motion of Mr. $E.\ E.\ Winch$ —Bill (No. 25) intituled "An Act to amend the 'Coalmines Regulation Act.'"

On the motion of Mr. Cameron—Bill (No. 26) intituled "An Act respecting Industrial Settlements."

On the motion of the Hon. Mr. Weir—Bill (No. 10) intituled "An Act to amend the 'Marriage Act."

On the motion of Mrs. Steeves—Bill (No. 27) intituled "An Act to amend the Insurance Act."

On the motion of Mrs. Steeves—Bill (No. 28) intituled "An Act to amend the 'Female Minimum Wage Act.'"

On the motion of the Hon. Mr. Weir—Bill (No. 21) intituled "An Act to amend the Duncan and North Cowichan Schools Act, 1936.'"

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. E. E. Winch, was withdrawn:—

Whereas it is desirable to inquire as to the working of the "Provincial Elections Act"; and

Whereas an analysis of the recent general election will disclose an imperative need for amendments to said "Provincial Elections Act":

Be it therefore Resolved, That a Select Committee of this House be appointed forthwith to inquire fully into the operation of the provisions of said Act.

Be it further Resolved, That the said Committee be empowered to send for persons, papers, and records, to examine same and to take evidence under oath, and to report their findings to this House.

Be it still further Resolved, That said Committee be empowered to consider ways and means of amending said "Provincial Elections Act" in order to increase its value and efficiency, and to report their recommendations to this House.

The Hon. Mr. Pattullo presented a Return with reference to the following notice of motion standing on the Order Paper in the name of Mr. Telford:—

That a Return be filed of all correspondence, all tenders submitted, and all contracts in connection with the supplying of bridge and other timbers used, or on hand to be used, for the construction of the Pacific Great Eastern Railway.

Whereupon, by leave of the House, the notice of motion was withdrawn.

The House resumed the adjourned debate on the motion moved by Mrs. Steeves on 16th instant as follows:—

Whereas "An Act to provide for the Establishment of a Provincial System of Health Insurance" was passed by the Legislature on March 31st, 1936; and

Whereas Health Insurance progressively applied was endorsed by a majority vote of the people of British Columbia in a plebiscite submitted to them on June 1st, 1937; and

Whereas the Government has not brought the provisions of the "Health Insurance Act" into operation; and

Whereas it has been reported in the public press on October 12th, 1937, that the Premier stated that Health Insurance would not be brought into operation until the Rowell Commission had reported:

Therefore be it Resolved, That this Legislature is of the opinion that the Government has forfeited the confidence of the people in neglecting to put the "Health Insurance Act" into operation.

The debate continued.

The Hon. Mr. Weir presented the following papers:-

Report of the Royal Commission appointed under the "Public Inquiries Act" with reference to the Home of the Friendless.

Report of the Royal Commission appointed under the "Public Inquiries Act" with reference to the Beban Mine disaster.

Report of the Royal Commission appointed under the "Public Inquiries Act" with reference to Burns & Company, Limited, labour dispute.

Annual Report of the King's Printer for the Year ended March 31st, 1937.

Mr. E. E. Winch asked the Hon. the Minister of Education the following questions:—

- 1. What are the *per capita* costs to the Government for the free text-books supplied for use in each grade from I. to XII. respectively?
- 2. Exclusive of free books, what are the costs per pupil of text-books required for use in each grade from I. to XII. respectively?
- 3. Exclusive of free books, what are the costs per pupil for supplementary books authorized for use in each grade from I. to XII. respectively?

The Hon. Mr. Weir replied as follows:-

- "1. The cost per pupil to the Government for free text-books is as follows: Grade I., $77\frac{1}{2}$ cents; Grade II., $52\frac{1}{2}$ cents; Grade III., $94\frac{1}{2}$ cents; Grade IV., \$1.14; Grade V., \$1.87 $\frac{1}{2}$; Grade VI., \$2.02 $\frac{1}{2}$; Grade VII., $86\frac{1}{2}$ cents; Grade VIII., 95 cents. There are no books on the free list above Grade VIII. In addition to the above, drawing-paper, flags, wall-maps, and some supplementary readers, etc., are also supplied free.
- "2. The average cost of prescribed text-books (exclusive of free books) to be purchased by the parents of pupils in Grades I. to XII. is as follows: Elementary School—Grade I., nil; Grade II., 25 cents; Grade III., 75 cents; Grade IV., 25 cents; Grade V., \$1.95; Grade VI., 25 cents; average, 59 cents a grade. Junior High—Grade VII., \$7.25; Grade VIII., \$1.65; Grade IX., \$2.80; average, \$3.90 a grade. Senior High—Grade X., \$8.45; Grade XI., \$8.05; Grade XII., \$3.10; average, \$6.53\% a grade. The cost differs somewhat according to options chosen by a pupil in junior or senior high school.
 - "3. Pupils are not required to purchase supplementary books."
 - Mr, E. E. Winch asked the Hon. the Minister of Education the following questions:—
- 1. In what high schools, if any, did a substantial reduction (10 per cent. and upward) in the enrolment of pupils take place for the school-years ended June, 1936 and 1937, respectively?
- 2. Did a proportionate reduction take place in the elementary school enrolment in the same districts?
 - 3. What explanation accounts for such discrepancy, if any?

- "1. Of the 43 high schools in operation in cities in June, 1937, only one, Merritt, had fewer in attendance during the school-year 1936–37 than during 1935–36. The number in attendance at Merritt High School for 1935–36 was 76 and for 1936–37 was 66. The total attendance at the Merritt schools dropped from 365 in 1935–36 to 335 in 1936–37. The total attendance at all city high schools increased from 15,866 in 1935–36 to 16,529 in 1936–37. The attendance at all high schools in district municipalities increased in 1936–37. In 1935–36 the total attendance was 3,819 and in 1936–37, 4,157. In rural districts five high schools showed slight decreases in 1936–37. Howe Sound decreased from 37 to 26, North Bend from 23 to 19, Qualicum Beach from 47 to 42, Smithers from 53 to 51, University Hill from 55 to 41, and Vanderhoof from 18 to 16. These were usual fluctuations. The total attendance in rural high schools increased from 1,434 in 1935–36 to 1,652 in 1936–37.
- "2. Yes, approximately, except at North Bend, Qualicum Beach, and Tsolum, where usual fluctuations gave increases in elementary schools of 3, 17, and 11, respectively. University Hill showed no change.
 - "3. Answered by No. 2."

Mr. Macintosh asked the Hon, the Minister of Labour the following question:--

Since the "Old-age Pension Act" has been in operation in British Columbia, what sum has been recovered from the estates of pensioners by the Province; and, of such amount recovered, is the Federal Government credited with the 75 per cent. which it has contributed to the fund?

The Hon. Mr. Pearson replied as follows:-

"The 'Old-age Pension Act' became operative in British Columbia on September 1st, 1927. From that date to November 16th, 1937, there has been received from the estates of deceased pensioners the sum of \$79,614.59. The Federal Government have received their share of this collection—namely, from September 1st, 1927, to November 1st, 1931, 50 per cent. and thereafter 75 per cent."

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:—

- 1. Did one J. Evans Flack, Burnaby, die intestate, and was property taken in charge by the Department of the Attorney-General?
 - 2. If yes, what disposition has been made of the property?
 - 3. If sold, through whom was the sale made?
 - 4. Were tenders called for?
 - 5. If by advertisement, in what papers did same appear and dates thereof?
 - 6. To whom was commission paid, if any, and what was the amount thereof?
 - 7. Had the deceased any relatives?
 - 8. What attempts have been made to locate same?

The Hon. Mr. Wismer replied as follows:-

"1 to 8. The estate of the said J. Evans Flack, intestate, was not taken in charge by the Department of the Attorney-General, but was administered through the Official Administrator, New Westminster, and from whom such information as is desired may be obtained according to the provisions of section 54 of the 'Administration Act.'"

Mr. E. E. Winch asked the Hon, the Minister of Education the following question:

What action, if any, has been or will be taken to remedy the condition referred to in the Report of Public Schools for the year 1935–36, page 67: "The fees of the Summer School for Teachers, held each year in Victoria, are high for teachers who have to go from outlying parts of the Province, and have to keep themselves on \$780 per year, and also, in many cases, have to send occasional remittances home. The fees of the University of British Columbia summer session are absolutely prohibitive where such persons are concerned," thereby enabling teachers from outlying parts of the Province to take the summer courses referred to?

The Hon. Mr. Weir replied as follows:-

"The average salary paid to the teachers in the public schools of the Province during the year 1936-37 showed a considerable increase over that of the previous year. This average increase was greater than the cost of tuition fees at the Summer School in Victoria or at the University. In July, 1937, more than 1,000 teachers from practically all parts of the Province were able to attend the Summer School of Education in Victoria and over 600 at the University of British Columbia at Point Grey."

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:—

- 1. Has the attention of the Attorney-General been called to the exceptionally large amount of unsettled life-insurance claims (non-resisted) outstanding as reported in the Twenty-fifth and Twenty-sixth Annual Reports of the Superintendent of Insurance: 1936 (1935 business), \$296,675.55; 1937 (1936 business), \$548,427.19?
- 2. What action, if any, does the Department recommend in dealing with those companies which are persistently tardy in effecting settlement of unresisted claims?

- "1. Yes. However, if the reports of the Superintendent of Insurance for a longer period than 1936 to 1937 are examined, it will be found that the figures quoted for those two years are not exceptionally large relatively to the total amounts paid out by the companies.
- "2. The Department is not aware that any company is persistently tardy in effecting settlement of unresisted claims."

Mr. Telford asked the Hon. the Attorney-General the following questions:-

- 1. What was the daily average cost of keeping prisoners in Oakalla Gaol for the last fiscal year?
 - 2. At the present time?
- 3. What is the cost of administration and overhead per prisoner per day at Oakalla Gaol?

The Hon. Mr. Wismer replied as follows:-

- "1. See report tabled in the House.
- "2. Information will be available in report for current fiscal year to be submitted next Session.
 - "3. See report tabled in the House."

Mr. Paton asked the Hon. the Attorney-General the following questions:-

- 1. What were the travelling expenses of the Attorneys-General, and each of them, between March 31st, 1937, and August 31st, 1937?
 - 2. Have all such expenses incurred between such dates been paid?

The Hon. Mr. Wismer replied as follows:-

"1 and 2. This information will appear in due course in the Public Accounts for the current fiscal year."

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:—

- 1. Has the attention of the Game Department been called to the small concrete-floored cages in which the bears are confined at Victoria and Stanley Park, Vancouver?
- 2. Is it proposed to amend the "Game Act" to prohibit confining wild animals under such unnatural conditions, and to require that all forms of wild life, when in captivity, must be kept under conditions approximating that of their natural habitat?

The Hon. Mr. Wismer replied as follows:-

- "1. No, but matter will be investigated.
- "2. It is not intended to amend the 'Game Act' with reference to animals in captivity."

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:—

- 1. Were permits to trap beaver granted by the Game Department during this past year?
- 2. If yes: (a) In what districts; (b) how many were trapped; (c) were they taken alive for transport to other districts for stocking purposes or killed for the value of their skins?

The Hon. Mr. Wismer replied as follows:-

- "1. Yes.
- "2. (a) Alberni, Courtenay, Nanaimo, and Bowron Lake Game Reserve; (b) 108; (c) 33 were taken alive by Game Branch officials at Bowron Lake Game Reserve for liberation in other districts, and 75 were trapped in those places where they were doing damage, or had increased on registered trap-lines, warranting their trapping under permit. Pelts in the latter case are sold."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. on Monday next.
