The Hon. David Barrett replied as follows:

"2. (a) 734.25 and (b) consultant services at the Parksville Conference on Industrial Development in the Province.

"3. See No. 1."

24 Mr. Bennett asked the Hon. the Minister of Finance the following question: With respect to Clause III, subsection 6, of the Joint Transportation Development Programme Northern British Columbia Agreement filed September 20, 1973, in this House, what total amount of waived claim is involved with respect to any prior claims for Federal construction grants toward former Pacific Great Eastern rail-lines?

The Hon. David Barrett replied as follows:

"No specific amount is calculated. The Pacific Great Eastern Railway received a grant of \$15,000 a mile from Quesnel to Prince George and \$25,000 a mile for 50 miles north of Prince George, and no other grants have been forthcoming."

25 Mr. Bennett asked the Hon. the Minister of Finance the following questions:

The Hon. Jack Radford replied as follows:

"1. Since project SAM's inception in August 1971 up until January 31, 1974, the project has compacted 51,081 vehicles plus countless old stoves, washing-machines, and refrigerators in 211 depots in 110 communities within 22 regional districts.

"2. Since SAM's inception in August 1971 until January 31, 1974, 33,466 compacted vehicles have been hauled to the shredding plant in Richmond.

"3. No Government-owned compacted cars have been transported to other shredding plants. One customer, Knox Mt. Metals of Kelowna, paid for our compaction services and sold the scrap metal to a firm in Alberta, he had 210 cars crushed. One other customer, Associated Auto Wrecking of Victoria, paid for our compaction service and sold the scrap to Richmond Steel, we compacted 933 vehicles for him. Of the 28 regional districts covering the Province we have now serviced 22, eight of these have been serviced twice."

Paul Lake Park, 3.6 acres deleted as not being relevant to park. Kleanza Creek Park, 12.19 acres deleted for B.C. Forest Service right-of-way road."
