Mr. Place asked the Hon. the Attorney-General the following questions:-

- 1. When were instructions given to all Chief Constables that all special as well as regular constables must be British subjects, and when sworn in must take the oath of allegiance?
  - 2. What proof of citizenship (if any) is required of special constables?

The Hon. Mr. Bowser replied as follows:-

- "1. The practice has always been both in the Vancouver and Victoria offices, where the great majority of constables are appointed from and sworn in, to see that they were British subjects, and the Oath of Allegiance, which is attached, bears this out, as well as the Application Form which each constable must sign, and which, on the face of it, shows his nationality. In July last the Superintendent issued instructions to Chief Constable Minty, of Fernie, that this must be done in taking on all special constables, and in January last express instructions were given to Chief Constable Stephenson to the same effect; but the latter informs the Department that he always followed this out, except, perhaps, in one or two cases where a rush took place in connection with the late trouble on Vancouver Island.
- "2. Men are always interrogated as to their citizenship, and the Form of Application, a copy of which is hereto attached, which they must sign, gives evidence to this effect."

The Hon. Sir Richard McBride replied as follows:—

"The Government will give the matter its very best consideration."

Mr. Williams asked the Hon. the Attorney-General the following questions:-

- 1. Is the Attorney-General aware that Mrs. H. H. Poterfield, of 1350 Tenth Avenue West, was killed at six o'clock in the afternoon of December 4th, at the intersection of Broadway and Manitoba Streets, Vancouver, by being struck by Auto No. 3004, driven by H. J. Littler, of the Terminal City Ironworks, Vancouver?
- 2. Has the Attorney-General's Department received a copy of the evidence taken at the inquest held on December 6th and 12th, and of the verdict found by the jury?
- 3. Is the Attorney-General aware that the jury found that Littler was open to censure, as he knew that the location was very dangerous and he should have applied the brakes sooner?
  - 4. Have any proceedings been taken against Littler?
  - 5. If the answer to the last question is in the negative, why not?

The Hon. Mr. Bowser replied as follows:—

- "1 and 2. Yes.
- "3. Copy of verdict of the jury is as follows:—
- "'That the deceased came to her death at the Vancouver General Hospital, Vancouver, B.C., December 4th, 1913, through the injuries sustained by the accident, December 4th, 1913, at the corner of Broadway and Manitoba Streets. Having heard the evidence of all parties pertaining to the death of Mrs. Poterfield, we, the empanelled jury, hereby testify, after due deliberation, that there was no incriminating evidence adduced whereby Mr. Littler could be held responsible. There is this consideration which leaves the said Mr. Littler open for much censure: He states in his evidence that where the accident occurred he admitted it was an exceedingly dangerous location; therefore, knowing the location, he should have applied the brakes earlier. We would suggest that urgent measures should be enforced so that repetitions of this nature be obviated; further, we, as a body, suggest that the Attorney-General, also the City Council, have this matter placed before them: First, that all auto-drivers pass a rigid examination regarding ability; second, that all autos be excluded from all the principal streets, or streets traversed by street-cars.'
  - "4. No.
- "5. The responsibility of prosecution up to committal for trial is on the Vancouver City Police, and they have come to the conclusion that there is not sufficient

evidence to base a charge of manslaughter against Littler, and have accordingly not proceeded with a prosecution. The Attorney-General, of course, can prosecute independently if he sees fit; but from the evidence obtainable it would not appear that it is a proper case for prosecution."

- "1. In the case of the Administrator of Stevan Plecas v. J. W. Stewart, under the 'Workmen's Compensation Act,' His Honour Judge Grant, Junior County Court Judge of Vancouver, decided against the claimant on two grounds: First, that his death was caused by his own negligence; and, secondly, that as the work in which he was employed was being executed on the Lord's Day he could not recover.
- "2. I do not care to offer any opinion as to the effect of the judgment on railroad-men, as that is a purely civil question.
- "3. I see by the press reports that His Lordship Mr. Justice Gregory has not agreed with Judge Grant on the question of the 'Lord's Day Act,' and has referred the case back to him for further consideration. The Government will have to await the final determination of this case in the Courts before considering the matter further."

On the second reading of Bill (No. 13) intituled "An Act to amend the 'Master and Servant Act,' "Mr. Speaker *Eberts* said he thought the Bill was irregularly before the House, and after considering the point gave the following ruling:—

When the Order for the second reading of the Bill was called I requested the Honourable Member from Newcastle to let the motion stand until I had an opportunity of looking into the effect of the provisions of the Bill, and whether the motion for second reading of a Bill of this nature was in keeping with the Rules of our House.

I am of the opinion that the Bill, in its present shape, is one of those measures which would affect trade, and therefore is in violation of Rule 58 of our Rules and Orders, and cannot be introduced until the provisions of the Bill shall have first been considered in a Committee of the Whole House and agreed to by the House.

Such procedure not having been followed, the Honourable Member for Newcastle cannot proceed further with the Bill.

4. What action (if any) was taken in regard to the constable who is alleged to have done the shooting?

The Hon. Mr. Bowser replied as follows:—

- "1. An Indian named Raffell was shot by Special Constable Howieson at Lytton on the night of July 1st, 1912.
- "2. Coroner Sanson held an inquest right after the death at Lytton, and this Department sent our Inspector of Police to Lytton, who held a further investigation on July 4th.

"3. Answered by No. 2.

"4. The Coroner's jury brought in the following verdict:-

"'We find the deceased died by misadventure, being killed by a chance shot fired in the dark by Provincial Constable Howieson in the execution of his duty.

We do not believe that the constable fired except with the object of stopping the

deceased, who was running away, and would not stop when called upon.'

"A statement was made by Chief Paul McCarthy and four other Indians to the Inspector of Police in his investigation, and from information received by the Department it appeared that the Indians were satisfied with the investigation, but suggested that the constable should be removed from that point, which was accordingly done. The shooting arose through the constable suspecting a white man giving liquor to two Indians, and he followed them to arrest them, and in doing so they started to run in the dark. He called upon them to stop, but on their not doing so he fired a shot with the idea of frightening them; apparently, it either struck some other object and glanced, or he was shot by the constable shooting under these circumstances in the dark when both of them were running. The Department did not feel, under the circumstances, that it was a proper case for prosecution."
