Mr. *Tomlinson* presented the Report of the Select Standing Committee on Municipal Matters, as follows:—

REPORT.

LEGISLATIVE COMMITTEE ROOM,

March 1st, 1956.

MR. SPEAKER:

Your Select Standing Committee on Municipal Matters begs leave to report as follows:---

Upon direction from the House, amendments to the "Municipal Act" were given consideration by the Committee and representations were made by Mr. C. D. McQuarrie, solicitor for the Union of British Columbia Municipalities, and Mr. T. R. Adams, secretary of the Union of British Columbia Municipalities.

Others to appear before the Committee and present briefs were Mr. Vaughan, of the British Columbia Telephone Company; Mr. Mainwaring and Mr. D. A. M. Patterson, counsel for the British Columbia Electric; Mr. DesBrisay, of the British Columbia Hotels' Association; Mr. George Gregory, member of the Legislative Assembly, on behalf of the citizens of Victoria; the Greenhouse Operators' Association, through its secretary, Mr. Bert Saunders; Mr. C. McElhinney, on behalf of the citizens of White Rock; Mr. Livingstone, manager of the Municipality of Surrey, on behalf of the Council of Surrey; Mr. Rowell; and Mr. Gamble. Further submissions were heard in respect to the Retail Merchants' Association of British Columbia, which presented a brief by Mr. H. C. Bolton, general manager; Mr. Norman Brown, president of the Liquid Gas Facilities; Mr. Chapman, of Nelson, representing McKay & Chapman Limited, retailers; Mr. Ross McRae, of the Retail Merchants' Association of Vancouver; and Mr. P. H. Bibley, of the Bibley Brothers Retail Merchants' Association.

Your Committee also heard a report by the Deputy Minister, Mr. Brown, on the taxation of transmission-lines, prepared by the Department of Municipal Affairs.

Your Committee, in relation to the Union of British Columbia Municipalities' brief, begs leave to report from its findings that subsections (1), (3), and (5), as proposed amendments to the "Municipal Act," be proceeded with.

Your Committee begs leave to report that subsection (2) of section 22 of the "Municipal Act," being chapter 232, be proceeded with, as amended, with the addition of the words " or portion thereof " at the end of section 2.

Your Committee recommends that subsections (4), (8), and (11) be not proceeded with.

Your Committee begs leave to report that subsections (6), (7), (9), and (10) be referred to the Department of Municipal Affairs for further study.

In respect to the recommendation of the Department of Municipal Affairs, your Committee begs leave to report that section 22 be further amended by adding the following subsection (8):---

"(8) No person shall be held to be disqualified from being an elected member of the Council or from serving as a member of the Council of any municipal corporation by reason of his being employed by a Board of School Trustees, but no such person shall vote in the Council on any question pertaining to school matters."

Your Committee recommends that section 2 of the "Municipal Act," being chapter 232 of the "Revised Statutes of British Columbia, 1948," was approved as amended.

Your Committee begs leave to report that the amendment to subsection (24) of section 58 be not proceeded with.

Your Committee reports that sections 239, 239 (2), and 239A, and sections 240, 245, 246, 270, 272, 314A, 483B, 490B, 537, and 237 be proceeded with.

Your Committee recommends that sections 333 and 236, as amended, be further amended by changing the word "ten" to the word "twenty," which would now read "not exceeding 20 per cent," and that the sections, as amended, be proceeded with.

Your Committee recommends that an amendment to the "Municipal Act," submitted by George Gregory, for the prevention of illegal parking of vehicles in the City of Victoria on private property, be proceeded with.

Your Committee wishes to advise the Legislature that the petition presented by Mr. C. McElhinney, on behalf of the citizens of White Rock, was not approved.

Your Committee recommends that section 290A of the "Municipal Act" be amended in the following manner to confine the operation of the distribution of bottled gas by the Municipality of Nelson within the city limits.

On further consideration, your Committee recommends that the proposed amendmen to clause (a) of subsection (40) of section 328 of the "Municipal Act" and clause (a) of subsection (38) of section 95 of the "Village Municipalities Act" be not proceeded with at this Session and referred to the Department of Municipal Affairs.

In respect to the brief presented by the greenhouse operators, your Committee recommends that, owing to the lack of factual information, it do not attempt to deal with the problem at this time, but recommends that a Committee representing the Departments of Finance, Municipal Affairs, and Agriculture be set up forthwith to go into the problem thoroughly and be prepared to place recommendations before this Committee at the next Session.

#### MARCH 1st.

Your Committee recommends that, in respect to the sharing of utility revenues, it be referred back to the Departments of Municipal Affairs, Education, and Finance for study and presentation of financial implications to this Standing Committee and the Union of British Columbia Municipalities at the next Session of the House.

What would be the resulting average prices of timber sales in the (a) Vancouver Forest District, (b) Prince George Forest District, (c) Prince Rupert Coast Forest District, (d) Prince Rupert Interior Forest District, (e) Kamloops Forest District, and (f)Nelson Forest District, with forest management licences excluded?

Your Select Standing Committee on Labour begs leave to report as follows:----

Whereas the Select Standing Committee on Labour was directed by this House to make certain inquiries into problems of welfare, health, and housing as they pertain to the native Indians of British Columbia:

And whereas your Committee on Labour has met seven times during the current Session to consider these matters and has heard witnesses and testimony concerning these problems from governmental and ethnic groups for the purpose of making recommendations thereto:

And whereas the Federal Government, which has jurisdiction in these matters, announced its intention of again amending the Federal Indian Act:

And whereas the Indian Act, which in general provides the necessary legislative machinery for administering Indian affairs throughout Canada, may undergo such changes as to make any recommendations of this Committee at the present time difficult:

Therefore be it Resolved, That for these reasons, and while uncertainty prevails concerning the future of the Indian Act, the Select Standing Committee on Labour is able to make only a few specific recommendations at the present time, but recommends that this Committee, or a special committee of the House, continue its inquiries at the next Session of this Legislature, and further it is recommended that such a committee with fewer members than the existing Committee would be better able to conduct its inquiries, holding more meetings and hearing wider representations and giving the committee more time for presentations and considerations.

We also wish to report as follows:----

- Health: The Committee heard representations in this regard and feel that the Department of Health is doing its utmost to provide adequate health facilities to the native peoples, and that it will be possible to give health matters further consideration when the provisions of the new Federal Act become known.
- Welfare: After hearing representations by Warden Christie, of Oakalla, we recommend that consideration be given by the Government to provide a probation parole supervision programme which will assist in transporting back to and rehabilitating former inmates in their communities.
- Housing: It would appear from submissions that financial assistance for home construction is adequate but that supervision is lacking, and we recommend that the Government consider the possibility of assistance to the native Indians in the matter of supervision of and training in home construction, such as is presently under way at the Nanaimo Vocational

School; also supervision as tried in the Cowichan Agency, where a native carpenter has been employed to supervise construction of homes.

All of which is respectfully submitted.

Honourable Members,—As there seems to have been some misunderstanding as to my position regarding the suspension of Commander Jamieson, I should like to clarify this point.

As the administrative officer of the Legislative floor, my duties include the control of the staff, and when Commander Jamieson admitted that he had been out to "break" a Cabinet Minister, I could not but regard this as a breach of loyalty to this House.

On page 7 of the Journals of February 3rd, 1953, you will find the following:-----

"That the appointment of Lieutenant-Commander E. A. Jamieson, R.C.N. (retired), as Sergeant-at-Arms of the Legislative Assembly, made by His Honour the Lieutenant-Governor, by and with the advice of his Executive Council, on the 30th day of December, 1952, be, and the same is, hereby ratified pursuant to section 44 of the 'Constitution Act,' being chapter 65 of the 'Revised Statutes of British Columbia, 1948.'"

Therefore be it Resolved, That this House is of the opinion that the Government of British Columbia should notify the Federal Government of Canada that the United Nations Convention on the Political Rights of Women should be ratified by Canada on behalf of the Provinces.

The debate continued.

Further, since such proposed increase would work a direct and unwarranted hardship on British Columbia farmers and ranchers, that no effort be spared to not only resist the proposed increases but to continue to advocate a reduction in the existing rates.

The debate continued.

The amendment was negatived.

The debate on the original motion was resumed.

The Hon. W. K. Kiernan moved in amendment, seconded by the Hon. W. R. T. Chetwynd,—

"That the word ' by ' after the word ' proposed,' in the second line, be struck out, and the word ' to ' substituted therefor."

Amendment agreed to.

Motion as amended agreed to.

Mr. Shantz moved, seconded by Mr. Reid,-

Whereas, in the opinion of this House, the development of potential water power in British Columbia is being unduly delayed as a result of the deadlock that appears to exist between the Canadian and American sections of the International Joint Commission:

And whereas the Government of Canada and the Government of the United States have recognized the principle of up-stream storage and down-stream benefits on rivers common to both countries:

And whereas this House feels that discussion at Government level is an urgent prerequisite to desired action:

This Legislature therefore urges the Federal Government to make the necessary representations to the Government of the United States leading to a conference of the Government of Canada, the Government of the United States, and the Government of British Columbia.

A debate arose.

Mr. Harding moved in amendment, seconded by Mr. Segur,-

"That the motion be amended by striking out the two last words, 'British Columbia,' and substituting 'any Province in Canada which may be interested.""

A debate arose.

The amendment to the amendment was negatived.

The debate was resumed on the amendment to Mr. Shantz's motion.

The debate was resumed on the original motion.

The Hon. L. Wicks moved that the question be now put.

Motion agreed to.

Previous question agreed to.

# Mr. Shelford moved, seconded by Mr. Corbett,-

Whereas the Canada "Forestry Act" was assented to December 10th, 1949, setting up the means by which the Federal Government can participate in the cost of protecting the forest resources from fire:

And whereas the revenue of the Federal Government from British Columbia forest industries in the fiscal year 1954–55 is estimated to be one-third of the total collections of the Government of Canada in British Columbia, namely, one-third of \$431,900,000, or \$144,000,000:

And whereas the forest revenue of the Provincial Government for the fiscal year 1954–55 was \$21,150,800:

Be it Resolved, That this Legislature deplores the fact that, although the Provincial Government has voted for protecting our forests from fire \$3,700,000 for the fiscal year 1956–57, the Federal Government still has not appropriated any money for protecting from fire British Columbia forests, which forests produce such huge revenues for the Federal Treasury:

And be it further Resolved, That the Government of Canada be again urged to participate financially on a 50–50 basis with British Columbia in the protection of this very vital resource.

A debate arose.

The motion was agreed to.

Mr. Reid moved, seconded by Mr. Robinson,-

That this House is of the opinion that the existing tariff arrangements on United States potatoes entering Canada is such that it discriminates against the British Columbia potato-producers:

That such unfair tariff arrangements are forcing the British Columbia producers out of the potato-growing industry:

And that this House go on record as urging the Federal Government to rectify this situation at the earliest possible moment.

A debate arose.

The motion was agreed to.

Mr. Winch moved, seconded by Mr. Eddie,-

That this Legislature is of the opinion that the Government of Canada should increase the amount presently being paid to recipients of old-age assistance and to recipients of old-age security to an amount which will be adequate to assure the recipients a standard of living commensurate with their needs and at a standard which will assure to them comfort and freedom from financial worry during their remaining years, and that this Government is requested to inform the Government of Canada of this Resolution and to urge its implementation.

LEGISLATIVE COMMITTEE ROOM, March 2nd, 1956.

MR. SPEAKER:

Your Select Standing Committee on Social Welfare and Education begs leave to report as follows:—

That your Committee held a meeting on January 31st, 1956, at which Dr. Gee, of the Provincial Mental Home, gave a short address on occupational therapy and also showed coloured lantern-slides depicting work being done by the patients of that institution.

That your Committee held a meeting on February 7th, 1956, at which Dr. George Stevenson, research expert on narcotics, spoke on the narcotic problem in British Columbia.

That your Committee held a meeting on February 27th, 1956, at which Warden Christie, of Oakalla Prison, gave an address on juvenile delinquency and related some of the problems being encountered in the rehabilitation of juveniles.

All of which is respectfully submitted.

The report was read and received.

Pursuant to Order, the Hon. R. G. Williston (Minister of Lands and Forests) presented photostatic copies of correspondence with Frobrisher Company pertaining to power development on the Nass River.

Pursuant to Order, the Hon. R. G. Williston (Minister of Lands and Forests) presented a return concerning (1) Alaska Pine & Cellulose Company, (2) British Columbia Forest Products Limited, (3) MacMillan & Bloedel Company, and (4) the Tahsis Company and roads through forest management licence areas.

The Hon. W. K. Kiernan (Minister of Agriculture) presented the Annual Report of the Department of Agriculture for the Year 1955.

Pursuant to Order, the Hon. W. D. Black (Minister of Municipal Affairs) presented copies of Orders in Council and file of correspondence relating to Nakusp Regulated Area.

Mr. Laing asked the Hon. the Minister of Lands and Forests the following questions:-

1. Since August 2nd, 1953, was an Order in Council passed removing from reserve certain lands on Seymour Arm of Shuswap Lake?

2. Thereafter were certain parcels of land sold and, if so, to whom and at what price?

3. Was the reserve then reimposed and, if so, give dates of both Orders in Council?

The Hon. R. G. Williston replied as follows:----

" 1. No.

"2. Since the answer to No. 1 is negative, this question is not pertinent.

"3. No."

Mr. Howard asked the Hon. the Provincial Secretary the following questions:---

1. Is, or was, E. M. Gunderson an employee of the Province of British Columbia in the capacity of economic adviser to direct studies of Federal-Provincial fiscal relations?

2. If so, (a) what was the date of his appointment, (b) what salary, by calendar months, has he received in this capacity, and (c) what personal travelling, living, or other expenses, by calendar months, has he received in this capacity?

3. What positions, if any, other than that listed in No. 1, does E. M. Gunderson hold with the Province of British Columbia or with any agencies, commissions, authorities, or boards thereof?

4. What (a) salary and (b) expenses, by calendar months, has he received in each capacity?

The Hon. W. D. Black replied as follows:-

"1 and 2. (a) and (b) Yes; was appointed by Order in Council No. 2872, dated December 17th, 1954, effective January 1st, 1955, at a fee of \$600 per month; he still holds the appointment; and (c) actual personal expenses while travelling only, March, 1955, \$56.45; 1955–56 travelling expenses for the current year will be shown in the Public Accounts in due course.

"3. Vice-president and director of Pacific Great Eastern Railway Company and member of Toll Highways and Bridges Authority.

"4. (a) Fee of \$100 per month as director of Pacific Great Eastern Railway Company; no remuneration as member of Toll Highways and Bridges Authority; and (b) outof-pocket travelling expenses only, paid by the company while on business of the Pacific Great Eastern Railway Company; accounts are not maintained by the Government."

Mr. Harding asked the Hon. the Minister of Finance the following questions:-

1. What was the net public debt of the Province of British Columbia on February 14th, 1952?

2. What amounts, if any, were paid or placed into special funds for reduction of public debt between February 14th, 1952, and August 2nd, 1952?

3. What was the net public debt of the Province of British Columbia on August 2nd, 1952?

The Hon. W. A. C. Bennett replied as follows:---

"1. The net public debt of the Province as at February 14th, 1952 was \$191,091,-839.03 (see page 14 of the 1952 Budget Speech).

"2. Transactions between February 14th, 1952, and July 31st, 1952:-

"Source of Funds: (a) Revenue surplus, without specific legislative authorization, there was applied from the \$12,576,945.89 of unappropriated revenue surplus available on March 31st, 1952, \$10,927,084.20; (b) Current Revenue Account, 1952–53 (by specific appropriation of the Legislature), \$3,429,681.67; (c) Hospital Construction Fund (by the application of the funds at the credit of the Fund), \$1,050,000; total, \$15,406,765.87.

"Nature of repayments: Debentures, \$2,722,000; Treasury bills, \$12,684,765.87; total, \$15,406,765.87; *less* new borrowings by way of Treasury bills, \$10,490,000; excess of repayments over borrowings, \$4,916,765.87.

"Increase in sinking funds in the same period: By authorized instalments, \$8,674,-431.28; by subsidiary payments, \$1,500,681.76; total, \$10,175,113.04.

"3. The net debt of the Province as of July 31st, 1952, was \$175,999,960.12.

"(NOTE.—Debt repayments without specific legislative authority and subsidiary payments to sinking funds exhausted nearly the whole of the unappropriated revenue surplus available on March 31st, 1952.)"

Mr. Turner asked the Hon. the Minister of Lands and Forests the following questions:-

1. How many forest management licences were appealed?

2. List those appealed with dates of appeal.

3. How were they disposed of?

4. How many are not yet disposed of?

The Hon. R. G. Williston replied as follows:----

"1. Thirteen.

"2 and 3. Name of applicant for management licence, date appeal heard, and disposition of appeal: (1) Celgar Development Company Limited, October 8th, 1952, disallowed; (2) Evans Products Company Limited, January 6th, 1954, disallowed; (3) Timberland Development Company Limited (extension to Management Licence No. 10), January 7th, 1954, disallowed; (4) F. & R. Logging Company Limited, January 20th, 1954, disallowed; (5) Osborne Logging Company Limited, January 21st, 1954, disallowed; (6) Lamb Lumber Company Limited, January 21st, 1954, disallowed; (7) L.M. & N. Logging Company Limited, January 21st, 1954, disallowed; (8) Tahsis Company Limited, May 10th, 1954, disallowed; (9) Empire Mills Limited, September 7th and 8th, 1954, decision reserved; (10) The Moore-Whittington Lumber Company Limited, protested December 14th, 1951 (protest withdrawn December 3rd, 1954); (11) British Columbia Forest Products Limited, January 27th, 1955, disallowed; (12) Church Sawmills Limited, January 27th, 1955, withdrawn; and (13) Clayburn Company Limited, appeal filed December 13th, 1951 (not heard to date).

2. What steps, if any, are being taken to relieve the "roller-coaster" effect caused by deviations in the road surface above and below a plane surface?

3. Since the new surface was laid, have repairs been necessary?

4. If so, what was the cost of the repair work done?

The Hon. P. A. Gaglardi replied as follows:---

"1. \$471.224.61.

"2. Some excavation has been done on high points and, in some cases, asphalt mix has been placed on low spots.

"3. Yes.

"4. \$3,500."

Mr. Segur asked the Hon. the Minister of Highways the following questions:---

1. Was a contract entered into with the Interior Tug & Transport Company to operate a ferry service on the Upper Arrow Lake between Beaton, Arrowhead, and Nakusp?

2. What previous experience did the Interior Tug & Transport Company have in similar ferry service?

3. What financial responsibility did they post with the Minister when they undertook this service?

4. Did the Interior Tug & Transport Company, former owners of the ferry "Arrowpark," go bankrupt?

5. Did the Minister purchase the "Arrowpark" and, if so, what was the price paid?

6. Is the "Arrowpark" at present under repair?

7. If so, what is the nature of repair?

8. What is the estimated cost of repair?

The Hon. P. A. Gaglardi replied as follows:---

" 1. Yes.

"2. None.

" 3. \$1,000.

"4. Not to this Department's knowledge.

" 5. Yes; \$180,000.

"6. Yes.

"7. Damage to underwater parts caused by exceptionally severe ice conditions on the lake, while endeavouring to maintain service.

"8. \$10,000 (estimated)."

Mr. Gibbs asked the Hon. the Provincial Secretary the following questions:-

1. What was the total number of persons on the Provincial payroll at December 31st, 1952, 1953, 1954, and 1955?

2. What was the total remuneration paid to employees of the Provincial Government for each of the fiscal years ended March 31st, 1952, 1953, 1954, 1955, and for the nine months ended December 31st, 1955?

3. What increases in salaries have been authorized since 1945 and on what dates were the increases granted?

4. (a) How many Civil Servants retired superannuated in 1952, 1953, 1954, and 1955, and (b) how many Civil Servants resigned?

5. How many people on the payroll of the Provincial Government are classified as permanent Civil Servants and how many are classified as non-permanent Civil Servants?

The Hon. W. D. Black replied as follows:---

"1, 1952, 12,246; 1953, 12,284; 1954, 12,314; and 1955, 13,141.

"2. Unable to assign special staff required to compile answer in full; for fiscal year 1954–55, Public Accounts show total payroll of \$41,534,888.

"3. Since 1945 to present recommendations in Estimates there have been annual increases of various degrees, including general increases and statutory increases within salary ranges in accordance with a policy of keeping Government salaries in line with those of good employers in industry.

"4. (a) 1952, 58; 1953, 66; 1954, 66; and 1955, 56; and (b) 1952, 1,665; 1953, 1,857; 1954, 1,772; and 1955, 2,037.

"5. As at December 31st, 1955, there were 8,138 Civil Servants, of which 6,973 were permanent and 1,165 were probationary."

Mr. Strachan asked the Hon. the Minister of Highways the following questions:-

1. On what date did the Toll Highways and Bridges Authority purchase the majority of shares in the First Narrows Bridge Company?

2. At that time what percentage of profit was the First Narrows Bridge Company showing on its common stock after bond interest, depreciation, and all operating costs had been met for that year?

3. Was the Public Utilities Commission contemplating the issuance of an order to the First Narrows Bridge Company to reduce the toll charges on the bridge because of the unusually large net profits being made on the operation of the bridge?

4. What was the original cost of the First Narrows Bridge at time of construction?

5. What price was paid for the First Narrows Bridge by the Toll Highways and Bridges Authority?

6. What was the depreciated value of the First Narrows Bridge on the books of the First Narrows Bridge Company at time of purchase of the bridge by the Toll Highways and Bridges Authority?

If a district School Board wishes, or is forced, to exceed the Provincial salary scale, the excess must necessarily be borne by the ratepayers of the local school district. If this policy were not followed, the principle of providing each district with an equitable share of Provincial revenue would be violated.

"In cases where an arbitration board decrees that district School Boards shall pay salaries in excess of those stipulated in the Provincial salary grant scale, the arbitration board takes into consideration the ability of the district to pay the added costs of the salaries." Mr. Calder asked the Hon. the Minister of Mines the following questions:---

1. Is it the intention of the Provincial Government to commence construction of the road from Stewart to Cassiar in 1956?

2. How much money, if any, will be allocated in 1956 toward this construction?

3. How much money, if any, will be allocated in 1956 toward the road construction from Cassiar to Dease Lake?

The Hon. W. K. Kiernan replied as follows:---

"1. Yes.

"2. Provision in Estimates for 610,000, including surveys and engineering, 1956 and 1957 construction.

"3. Provision in Estimates for \$840,000, including surveys and engineering, 1956 and 1957 construction."

3. If no specific undertakings were guaranteed except to investigate possibilities, why was a bond required?

The Hon. W. A. C. Bennett replied as follows:-

"1. The answer to this question can be found in the agreement between Frobisher-Ventures group and the Government of British Columbia, which was filed in the Legislature on March 1st, 1955.

"2. Correspondence was also filed last Session of the Legislature and any further correspondence will be filed during this Session.

"3. See above."

Mr. Howard asked the Hon. the Provincial Secretary the following questions:-

1. Relative to the Lillooet by-election of September 12th, 1955, have any returns been made pursuant to section 174 of the "Provincial Elections Act"?

2. What were the total election expenses listed by the Social Credit, C.C.F, Liberal, and Conservative candidates respectively, and upon what date was each return filed?

The Hon. W. D. Black replied as follows:----

"1. Yes.

"2. Social Credit: Candidate's expenses, \$2,781.01; date return filed, November 10th, 1955. C.C.F.: Candidate's expenses, \$1,272.68; central committee expenses, \$1,272.68 (as reported, possibly refers to expenditure in column 1); date return filed, December 1st, 1955. Liberal: Candidate's expenses, \$3,527.62; central committee expenses, \$188.55; date return filed, November 28th, 1955. "2. Tulsequah, Mr. Harold Lancelot Abbott; Lower Post, Mr. John and Mrs. Marjorie L. Dowsett; Telegraph Creek, Mrs. Shirley E. Brand; Stewart, Mrs. Frances Macleod; Alice Arm, Mr. Arthur Dickey York; and the Mining Recorder at Atlin is Mr. W. E. McLean."

Mr. Segur asked the Hon. the Premier the following question:—

What progress, if any, is being made regarding the setting-up of a faculty of dentistry at the University of British Columbia?

The Hon. W. A. C. Bennett replied as follows:—

"The University engaged Dr. John B. Macdonald to make a survey concerning the setting-up of a dental faculty at the University of British Columbia; it is understood the report has been presented to the Board of Governors, but to date the Government has not been made aware of their recommendation; the Government has already expressed support of the programme."

Then Mr. Speaker addressed the Lieutenant-Governor as follows:-

# MAY IT PLEASE YOUR HONOUR:

We, Her Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to Her Majesty's person and Government and humbly beg to present for Your Honour's acceptance Bill (No. 79) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:---

"In Her Majesty's name, His Honour the Lieutenant-Governor doth thank Her Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—

# Mr. Speaker and Members of the Legislative Assembly:

In closing this, the Fourth Session of the Twenty-fourth Parliament, I desire to express my appreciation for the attention which you have given to the numerous matters submitted for your consideration.

I am advised by my Government that since the opening of this Session a new member has been elected to the Legislature, and I take this opportunity of congratulating Mr. Leslie Peterson upon being chosen as representative of Vancouver Centre constituency.

Improvements in our labour laws and the granting of an increase in the Provincial bonus to old-age pensioners, blind pensioners, persons receiving social assistance and mothers' allowances will greatly improve the welfare of our people.

The implementation of the recommendations of Mr. Justice Clyne under the "Milk Industry Act" will be most beneficial to the production and marketing of milk in the Province.

The enactment of legislation to permit the British Columbia Toll Highways and Bridges Authority and the British Columbia Power Commission to expand their activities, along with the provisions made for the largest highway-building programme in the history of British Columbia, will make an important contribution to the industrial growth of the Province. I am indeed gratified that measures have been passed to grant further financial assistance to cities and municipalities of our Province.

The Prime Minister and his advisers are leaving within the next few days to confer further with the Government of Canada on the Federal-Provincial Tax Agreement.

I thank you for the supplies which you have granted for the Public Service, which will enable the continuation of my Government's programme throughout the fiscal year.

In closing this Session, I trust that the blessing of Divine Providence will accompany you to your respective homes.

The Hon. W. D. Black (Provincial Secretary) then said:-

# Mr. Speaker and Members of the Legislative Assembly:
