Mr. Speaker gave his reasons for his decision yesterday on Mr. Strachan's motion "That Mr. Perrault be now heard," as follows:—

Honourable Members,—At the hour of 8 p.m. last evening the Honourable the Leader of the Opposition moved the following motion under Standing Order 37, "That Mr. Perrault be now heard."

I ruled the motion out of order on the ground that the honourable first member for North Vancouver had exhausted his right to speak to the amendment motion which was presently before the House and could only speak again to that amendment with unanimous consent.

Prior to my leaving the chair at 6 p.m. under Standing Order 3 and the motion for two distinct sittings, the honourable first member for North Vancouver had risen to his feet. The Leader of the Opposition then rose to a point of order suggesting that under Standing Order 3, as the hour of 6 o'clock had arrived, I should leave the chair and return at 8. I acknowledged the point of order but pointed out that as the honourable the first member for North Vancouver was on his feet immediately before the point of order was raised and had been recognized by the Chair I must give that member the opportunity to be heard whether on a point of order, matter of privilege, or to request the recording of a division. However, when the honourable first member for North Vancouver commenced to speak on the amendment

motion before the House I then in accordance with Standing Order 3, and the motion for two distinct sittings, announced I would leave the chair and return at 8.

In this instance the right to speak in a resumed debate appears restricted to a member who has successfully moved adjournment of that debate (May, 16th edition, page 447). As the debate had not been adjourned the honourable first member for North Vancouver had exhausted his right to speak and could not speak again (Standing Order 42 (1)).

Standing Order 37 pre-supposes that both members who rise to speak are qualified so to do. This was not the case in this instance.

Accordingly the Leader of the Opposition's motion under Standing Order 37 is not in order and I have so ruled.
