LEGISLATIVE COMMITTEE ROOM, December 1st, 1924.

MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders begs leave to report as follows :---

That the preamble of Bill (No. 50) intituled "An Act for the Relief of the Associated Growers of British Columbia, Limited" has been proved, and the Bill ordered to be reported with amendments.

All of which is respectfully submitted.

The report was read and received. The Rules were suspended and the report adopted.

On the motion of Mr. Lister, seconded by Mr. Jones, it was Resolved.-

That an Order of the House be granted for a Return of all correspondence between the Capilano Timber Company and the Department of Lands or any other department of the Government.

Mr. Browne moved, seconded by Mr. Neelands,-

Whereas the present system of the production of commodities occasions a permanent margin of unemployed workers:

And whereas the natural resources of this Province are being exploited for profit without regard to the necessities of our citizens:

And whereas the control of these natural resources in many cases is in the hands of alien capitalists employing underpaid and Oriental labour:

And whereas many of His Majesty's lieges are thereby deprived of the right to earn the means of subsistence for themselves and their families:

Therefore be it Resolved, That, in the opinion of this House, the first charge on industry should be the maintenance of the unemployed workers.

A debate arose, which was, on the motion of Mr. *Hinchliffe*, adjourned to the next sitting of the House.

TWO O'CLOCK P.M.

On the motion of Mr. Hinchliffe, seconded by Mr. Pooley, it was Resolved,-

That an Order of this House be granted for a Return giving a list of the papers, periodicals, and magazines purchased during 1924 for the Provincial Library, classifying such papers, etc., according to the countries in which they were published.

The Hon. Mr. Sloan moved, seconded by the Hon. Mr. Manson,-

Whereas it is the announced policy of the Federal Liberal Party in Canada that an "adequate system of insurance against dependence in old age should be provided in so far as is practical and having regard for Canada's financial position":

And whereas it is accepted as between the Dominion Government and the Provincial Governments that the Dominion has jurisdiction in respect of questions having to do with health insurance, unemployment, and old-age pensions, and the Provinces in respect of such other social legislation as may be in the public interest:

And whereas the Government of the Province of British Columbia passed the "Mothers' Pensions Act" in the year 1920, and has since been administering it at a cost of approximately \$500,000 per annum:

And whereas State responsibility in the matter of the proper maintenance of aged citizens has been recognized by Great Britain, Australia, New Zealand, and a number of the nations of the Continent of Europe:

Therefore be it Resolved, That this House puts itself on record as approving the principle of old-age pensions and as being favourable to the enactment of legislation by the Dominion Government bringing the same into effect in Canada at an early date.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that he will cause to be conveyed to the Secretary of State for Canada the foregoing Preamble and Resolution.

A debate arose, which was, on the motion of Mr. *Uphill*, adjourned to the next sitting of the House.

The House resumed the adjourned debate on the motion moved by Mr. *Hinchliffe* on 19th November, as follows :---

That a Select Committee of this House, consisting of Messrs. *Perry, McRae, Wrinch, Browne*, and *Twigg*, be appointed to inquire into any or all of the operations of the Provincial Bureau of Information, and the management thereof, from its inception to the present time; and, without in any way restricting the extent of the inquiry, the said Committee is hereby directed to inquire more particularly into the methods used by the officials of the Bureau in carrying out their work; the results of the work of the Bureau; whether such results were satisfactory; if not satisfactory, the reasons therefor; the relations of the officials of the Bureau to and their dealings with the Government and with Cabinet Ministers; the difficulties that the said officials had to grapple with; the assistance such officers received from the Government and from heads of departments; and the uses to which moneys voted for the work of the Bureau have been put.

And it is also Resolved, That the said Committee do report its findings to this House.

The Hon. Dr. MacLean moved in amendment, seconded by Mr. Perry,-

To strike out the words "a Select Committee of this House, consisting of Messrs. *Perry*, *McRae*, *Wrinch*, *Browne*, and *Twigg*," after the first word "That," and substitute the following therefor: "the Select Standing Committee on Public Accounts."

The Resolution as amended was carried.

Mr. Jones asked the Hon. the Minister of Agriculture the following questions :---

1. What sum of money has been expended by the Department in connection with the Wembley Exhibition?

2. Did the Government have any person in charge of the exhibit from the Department? If so, whom, and what remuneration was paid for his services?

The Hon. Mr. Barrow replied as follows :---

"1. No money was expended by the Department of Agriculture in connection with the Wembley Exhibition.

"2. No."

Mr. Hinchliffe asked the Hon. the Minister of Agriculture the following questions :----

1. What firms supplied clover and timothy seed for the Sumas Reclamation Scheme?

2. Were tenders called for same?

3. What firms tendered, and at what price per pound for each class of seed?

4. To whom was the contract given?

5. How much has been supplied up to November 1st, 1924?

6. To whom was the 1924 crop of oats grown on reclaimed land held by the Government sold, and at what price per ton?

7. To whom was the contract awarded for building fence on each side of the Vedder Canal, and at what price per rod?

8. Were tenders called for same?

9. What firms tendered, and at what price?

The Hon, Mr. Barrow replied as follows :---

The Hon. Mr. Pattullo replied as follows :---

"1. \$115,172.07.

"2. \$16,216.40."

Mr. Catherwood asked the Hon. the Minister of Public Works the following questions :-

1. Have restrictions been recently placed upon motor-trucks and horse-drawn vehicles in the ridings of Esquimalt and Saanich in the matter of loads?

2. If yes, what is the reason for the said restrictions?

The Hon. Dr. Sutherland replied as follows :---

"1. Yes.

"2. The purpose of such restrictions is to protect the roads from 'extraordinary' traffic during the winter season—namely, middle of November, 1924, to middle of April, 1925. (Nore.— The restrictions in said ridings are exactly similar to those imposed by Order in Council No. 1144, approved October 29th, 1924, covering all highways in unorganized territory and primary highways in organized territory within the area known as 'Traffic District No. 1.')" Mr. Wallinger asked the Hon. the Minister of Lands the following questions :---

1. What is the total amount paid since April 1st, 1924, to November 1st, 1924, to the following newspapers: Victoria Daily Times, Victoria Daily Colonist, Vancouver Sun, Vancouver Star, and Vancouver Province?

2. For what services were these sums paid, and when?

The Hon. Mr. Pattullo replied as follows :----

"1. Victoria Daily Times, \$509.67; Victoria Daily Colonist, \$2.049.30; Vancouver Morning Sun, \$1,065.20; Vancouver Evening Sun, \$1,120.40; Vancouver Sun (Special British Empire Edition), \$1,000; Vancouver Star, \$356.17; Vancouver Province, \$1,278.60.

"2. Advertising and job-work during period mentioned."

Mr. Jones asked the Hon. the Minister of Lands the following questions :---

1. How many Hebrideans located in British Columbia during 1924-men, women, and children?

2. What was the total sum of money paid to them as bonus?

3. What other assistance has been rendered by the Department?

The Hon. Mr. Pattullo replied as follows :---

"2. Nothing; no intention to bonus Hebrideans or any one else.

"3. Departmental officer escorted party of Hebrideans looking over situation."

1. Who is the Government Agent for the City of Prince Rupert?

2. When was he appointed?

3. When did he take over his position?

4. Where was he employed before taking the position?

5. Where was he at the time he was given the appointment?

And whereas many of His Majesty's lieges are thereby deprived of the right to earn the means of subsistence for themselves and their families:

Therefore be it Resolved, That, in the opinion of this House, the first charge on industry should be the maintenance of the unemployed workers.

Mr. Hinchliffe moved in amendment,---

That all the words of the Preamble and the Resolution after the first word "Whereas" be deleted, and the following inserted in lieu thereof:—

"The unemployment situation in this Province at the present time is serious, many men who are unable to obtain work being compelled to accept assistance for themselves and their dependents from charitable organizations:

"And whereas for some years past there have been recurrences of periods of widespread unemployment:

"Therefore be it Resolved, That this House urge the Government to take such immediate steps as may be necessary for the relief of unemployment, and to use every effort to devise and adopt such general policy in regard to labour, industries, and capital as will tend to reduce the possibility of acute unemployment problems arising in the future."

A pari-mutuel machine automatically records the bets made by providing an automatic connection between the drawing of the mutuel ticket and the registering of the bet on the central totalizator board.

"3. No information, but it is presumed that the system used is installed at the request of the operators of the track.

"4. Calculators employed by the Racing Association."

The Hon. Mr. Sloan presented a Return, pursuant to an Order of the House of the 2nd instant, giving a list of the papers, periodicals, and magazines purchased during 1924 for the Provincial Library, classifying such papers, etc., according to the countries in which they were published.

With the leave of the House, the Hon. Dr. *MacLean* presented a Return in answer to the following questions standing on the Order Paper in the name of Mr. *Jones*:--

1. What industries have been taken over by the Department of Industries, and for what reason?

2. What was the total amount of loans made in each case to these firms?

3. What amount of salary and travelling expenses has been paid to D. B. Martyn, Deputy Minister of Department of Industries, for the period from April 1st to November 1st, 1924?

4. What has been the cost of the Department in salaries and expenses each year since formed?

The petition from the Corporation of the City of Nanaimo, for leave to introduce a Bill for the purpose of confirming boundaries, was received. Mr. Jones asked the Hon. the Minister of Industries the following questions :---

1. What was the total amount of arrears due on repayment of loans to the Department of Industries as at November 1st, 1924?

2. What was the total amount of arrears of interest as at November 1st, 1924?

The Hon, Dr. MacLean replied as follows :--

5. If so, who is the deputy, and what salary does he receive?

6. Who is Acting Superintendent of Industrial Schools, and what salary does he receive?

7. Has he been continuously employed throughout the last year?

8. What vacation (if any) has he received?

The Hon. Mr. Sloan replied as follows :--
