- "(3.) Plays at any game or sport therein ; or
- "(4.) Discharges firearms (save at a military funeral) therein; or
- "(5.) Wilfully and unlawfully disturbs persons assembled for the purpose of burying a body therein; or who
- "(6.) Commits a nuisance in such cemetery."

On Mr. Speaker resuming the Chair, Mr. E. Brown, acting Chairman of the Committee, reported the Bill complete, with the amendments.

Ordered, That the Report be considered forthwith.

Upon its being discovered, however, it was at once transmitted to the Right Honourable the Secretary of State for the Colonies.

"This will account for the Petition not having been answered by the Colonial Secretary.

"I have to add, that by an Order in Council of the 3rd September last, a copy of which was enclosed to the Lieutenant-Governor on the 9th of that month, the British Columbia Government was requested to convey to the Dominion Government certain lands along the line of railway, as shown on a plan, which plan was enclosed to the Lieutenant-Governor on the 23rd of the same month. "I do not remember any particular circumstances attending the receipt of that Despatch, or its transmission to the Ministry, but I have no doubt that, as noted on the margin of the original, a copy of the Despatch was sent to the Executive Council in the usual course, namely, in an envelope addressed to the Clerk of the Executive Council.

"I know no reason-nor can I suggest any-why such copy of this Despatch should not have reached its proper destination, and I am, therefore, unable to afford any explanation of the miscarriage, which, from the statement contained in your Telegram, would appear to have occurred.

MAY IT PLEASE YOUR HONOUR :

We, Her Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour, at the close of our labours, with sentiments of unfeigned devotion and loyalty to Her Majesty's person and Government, and humbly beg to present, for Your Honour's acceptance, a Bill initialed "An Act for granting certain Sums of Money required for defraying the Expenses of Civil Government for the eighteen months ending 30th June, 1880, and for other purposes." To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:-

"In Her Majesty's name, His Honour the Lieutenant-Governor doth thank Her Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following Speech :--

#### Gentlemen of the Legislative Assembly:

I have much pleasure in thanking you for the care and attention which you have so freely bestowed on the work of the Session.

Your attendance has been unusually prolonged, at great personal inconvenience, I fear, to yourselves; but I venture to think that you will hereafter derive pleasure from the reflection that your patient efforts to secure Railway construction this year resulted happily for the Province. The assurance given by the Dominion Government that railway work in the Province will not only be commenced, but be vigorously prosecuted, this season will be cheerfully received throughout the country, and will tend to restore confidence in our future prosperity.

I hope ere long to be enabled to place the Graving Dock works on a more satisfactory footing.

The amount placed at my disposal for public works is small compared with that of former years, but I regard this fact as an earnest of your desire to co-operate with me in an endeavour to balance our public income and outlay.

I have cheerfully assented to the measures you have passed, and have to congratulate you on the highly useful character of many of them.

I shall now relieve you from further attendance, and trust that your devotion to the interests of the public will be fully appreciated.
