Whereas sugar is of prime importance in diet and essential to the health and comfort of people of all ages and conditions of life and of health, and is of vital necessity in the diet of the infant and the invalid:

And whereas throughout British Columbia an adequate supply of sugar has been for many months unobtainable by private households, and in consequence great hardship and suffering has ensued:

And whereas the lack of an adequate supply of sugar to preserve the fruit-crop of last year resulted in great economic loss to the fruit-producer and the housewife:

And whereas there is operating within this Province a sugar-refinery capable of manufacturing sugar in quantities greatly in excess of all demands within this Province; yet, not-withstanding the fact that whole ship-loads of raw sugar have been received and manufactured at such refinery, the grave shortage in domestic supply available still exists:

And whereas there is every indication that similar adverse conditions will continue to the serious inconvenience of our people and danger to health in many instances, together with economic disaster to the fruit industry of British Columbia, unless steps be taken to correct the situation:

And whereas candy and fancy cakes and confectionery employ enormous quantities of sugar in their manufacture, and all these products abound without restriction and are being manufactured and sold in greatly increasing volume:

And whereas the use of such candy, fancy cakes, and confectionery is a pure luxury and not essential in dietetics:

And whereas it is the just demand of our own people that their wants should be first supplied, and, furthermore, that ample sugar should be furnished for domestic use before any should be diverted to the manufacture of non-essential luxuries:

And whereas grave unrest and dissatisfaction abound in the premises, and it is therefore expedient that all the facts and circumstances surrounding the matter of production and distribution of sugar should be investigated and published:

Therefore be it Resolved, That a Select Committee of five Members of this House shall be appointed, with instructions to inquire into the truth of the above allegations and all matters, including prices and cost, pertaining thereto, with power to call for persons, papers, books, and documents, to examine witnesses under oath, and to report their findings, recommendations, and the evidence to the House.

That such Committee consist of Mr. Jackson, Mrs. Smith, Messrs. Pooley, Thompson, and Giolma.

On the motion of the Hon. Mr. Farris, seconded by the Hon. Dr. King, it was Resolved,— That the Public Accounts for the year 1918-19 be referred to the Public Accounts Committee.

- "3. None. The year's residence in British Columbia referred to in a previous question was in 1912-13, when Mr. Manning was employed in the C.P.R. forestry service."

Mr. Schofield asked the Hon, the Minister of Agriculture the following questions:-

 - 2. If so, what is the authority for coming to this conclusion?
