His Excellency considered that a delegation would not hasten the settlement of the Crown Lands question; the Evidence that had been taken by the committee of the House on this important question was not obtained on Oath, and was therefore,

in the opinion, valueless to the Secretary of State for the Colonies.

If His Excellency appointed a delegation, he would be obliged, in common justice, to send a representative of the Hudson's Bay interests as well as a representative of the people's. Such an arrangement, however, would not place Mr. Cardwell in any better position to arrive at the merits of the question; for, it would be merely laying before him two conflicting Statements.

His Excellency on the above grounds and in consequence of certain despatches which had been forwarded to the Colonial office some time ago and with which a delegation might conflict would not assume the responsibility of appointing Agents to settle the vexed question. He would, however, be quite willing to accept the Appointments made by the House and would place on the Supplementary Estimates any Sum the House might suggest to cover the expenses of such delegation.

Insert between Clauses 2 and 3 the following, which will become Clauses 2 and 3:

The General Board of Education shall be a body corporate, with all the general powers of law affecting, or relating to Bodies Corporate, and all School property shall be vested in such general Board.

The General Board of Education, shall meet at least once a month and shall report to the Governor as to the state and condition of Common Schools, and other particulars relating thereto, at such times, and in such manner and form as the Governor shall from time to time in that behalf direct.

Carried.

Strike out Clause 4.

Not agreed to. Clause 4 (Bill) to stand.

Strike out Clause 5.

Carried.

Amend Clause 6 as follows: "It shall be lawful for the said Board, from time to time, with the approval of the Governor, to establish as many School Districts in the said Colony as they shall deem expedient, and to prescribe such course of education and discipline, and to select and prescribe for use in each District School, such Books as they may think best, and to authorize the purchase and distribution thereof."

Carried.

Strike out Clauses 7 to 40, and substitute for them the following:—

- 7 It shall be lawful for the Governor from time to time to appoint such persons as he think fit to be Teachers of Common Schools.
 - 7 Carried.
- 8 It shall be lawful for the Governor from time to time to appoint a local Board of Education of not less than three persons in any School District, if he shall think it expedient so to do.
 - 8 Carried.
- 9 Such last named Board shall have power and authority to visit and report on the state of the Schools within its District for the information and guidance of the General Board of Education.
 - 9 Carried.
- 10 The general mode of transacting business by such local Board of Education, and the nature of the reports to be furnished, shall be subject to the order and direction of the General Board of Education.
 - 10 Carried.
- 11 The duties of all Teachers of Common Schools shall be subject to the order and direction of the General Board of Education.
 - 11 Carried.
- 12 It shall be the duty of the Superintendent of Education to visit Common Schools and report thereon by the order and according to the instructions of the General Board of Education.
 - 12 Carried.

Amend Clause 42 by inserting the word "General" before the word "Board." Clause 42 to be Clause 14.

Strike out Clauses 43 to 55 and substitute the following:—

Every Common School shall be open to the Children of persons of all denominations; the power of expulsion in cases of gross misconduct shall be at the discretion of the Board of Education or in the absence of such local Board at the discretion of the teacher. To be Clause 15.

Carried.

The General Board of Education shall have power to regulate the amount of School fees payable for Educational purposes, in any Common School, so however that the same do not exceed 50 centimes per month for each Scholar,

Referring to the Resolution of the Legislative Assembly in Committee of Supply relative to the sum of \$34,066.20 under the head of re-imbursements forwarded to me on the 11th instant, I have the honor to supply the following information.

By the statement of the Treasurer dated 5th Novr. 1864 submitted to the Legislative Assembly on the 13th Jany. 1865 it appears that the actual balance of Crown Revenues on the 31st Decr. 1863, amounted to \$34,321.65/100. The particulars of this balance will be seen by examination of the return of the Treasurer dated 23rd Feby. 1865 and furnished to the House on that date.

It further appears that the estimated proceeds of the various sources of Crown Revenues for 1864 were \$27,413.00 making, together with the sum of \$34,321.65 an amount of \$61,734.65 available for Crown purposes during 1864.

On the other hand the following Sums were payable during 1864, out of that \$61,734.65.

The difference between \$27,668. $^45/_{100}$ and \$61,734. $^65/_{100}$ viz., \$34,066. $^29/_{100}$ therefore represents the amount which should have been in hand on 31st Decr. 1864, on account of Crown Revenues. That balance however was wholly expended

during that year for the general expenses of the Colony including a Sum of \$10,670. paid in the same year for the salaries of the Chief Justice, the Attorney General, the Treasurer, and the Surveyor General.

Resolved That this House considers the Scale of Salaries proposed as a Civil List in the Despatch of June 15th 1863, far too high for the present small population of the Colony of Vancouver Island exclusively to bear. But as this House has during the present Session expressed an earnest desire to establish a settled policy conducive to the furtherance of Imperial and local interests by declaring itself in favor of an immediate Union of this Colony with British Columbia under such Constitution as Her Majesty's Government may grant, and in order to remove any impediment to the consummation of such Union. This House is willing to vote the Civil List proposed in the Despatch of 13th [15th] June, 1863 for the period ending the 31st day of Decr. 1866, on condition that the control of the Crown Lands and Revenues be granted to the local Legislature; And on this further condition that the said Action of this House shall not in any way be construed by Her Majesty's Government to be a renunciation of the claim which the people of this Colony through their representatives have preferred to the lands, water frontage, and proceeds of land sales set aside by the Indenture of February, 1862, to the Hudson's Bay Company.

Provided that nothing in these Resolutions shall in any way be construed to conflict with the Resolutions in favor of Union with British Columbia passed by this House, on the 22nd January, 1865, the Resolutions passed this day being simply and solely intended to remove possible obstacles to the speedy consummation of that Union.

Provided however that if Union of the Colonies be not consummated before the 31st day of December, 1866, the Officials shall be made responsible to the people by election to the Legislature or otherwise; or the people's Representatives shall have power to reduce the Civil List to a figure more commensurate with the revenue of the Colony.

Resolved that the foregoing Resolutions be forwarded to His Excellency the Governor for transmission to Her Majesty's Government.

I have the honor to acknowledge the receipt of Resolutions passed in Committee and confirmed by the Legislative Assembly on the 3rd May 1865, stating the conditions upon which the House is disposed to accept the Crown Lands and vote a Civil List for this Colony and conveying a request that those Resolutions may be transmitted to Her Majesty's Government. It will afford me great pleasure to transmit this manifestation of a desire on the part of the Legislative Assembly to adjust a difference which has seriously impeded, and must, while unsettled, continue to retard the progress of the Colony. I must, however, point out to the House that the conditions laid down in these Resolutions differ so materially from those proposed in the Duke of Newcastle's Despatch dated 15th June 1863 that I do not feel justified in departing from the instructions conveyed to me in the subsequent Despatch of Her Majesty's Secretary of State for the Colonies, a Copy of which I enclose.

In reference to that portion of the Resolutions expressing the opinion of the L. Assembly that the Scale of Salaries proposed (in the Despatch, 15th June 1863) is far too high I take this opportunity of assuring the House of my hearty co-operation in recommending or establishing any Scale which, after full deliberation, may be found compatible with true economy which consists in obtaining for the public the best possible Services at a reasonable cost.

I would suggest that the Salaries of Officers necessary for the conduct of the public Service be voted and charged against the General Revenue pending the reply of Her Majesty's Government to the proposal submitted in the Resolutions of 3rd

May, 1865.

I have the honor to acknowledge the receipt of An Address recommending that those bonâ fide Settlers whose lands are liable to be forfeited on the 31st May shall have an extension of time; paying interest as usual for the accommodation. In reference thereto I submit the following facts for the information of the Legislative Assembly. The total amount due under this head, exclusive of interest is \$11,773.

This amount is overdue and outstanding since 1862 & 1863. Payment was demanded on the 7th Octr. 1864 and the period again extended generally for Six months.

The demands for time on the part of bonâ fide Settlers have always received special consideration.

AMENDMENTS TO "A BILL RESPECTING THE MEDICAL BOARD AND PRACTITIONERS IN MEDICINE AND SURGERY."

That in the Title of the Act the words "The Medical Board and" be struck

That the general enacting part of the Act be according to the usual form.

"Be it therefore enacted by the Governor of the Colony of Vancouver Island and its dependencies by and with the advice and consent of the Legislative Council and Assembly thereof as follows":

That in lieu of the first eighteen clauses the following clauses be inserted.

I. It shall be lawful for the Governor for the time being of the said Colony from time to time to appoint a Registrar of Medical Practitioners within the said Colony.

II. It shall be lawful for the said Governor as occasion shall require to direct the mode and manner in which the Medical Register hereinafter mentioned shall be kept by the said Registrar in such particulars as are not provided for by this Act.

III. It shall be the duty of the said Registrar to keep the said Register correctly and to erase the names of all registered persons who shall have died and shall from time to time make the necessary alterations in the addresses or qualifications of the persons registered under this Act; and to enable the said Registrar duly to fulfil the duties imposed upon him it shall be lawful for the said Registrar to write a letter to any registered person addressed to him according to his address on the Register, to enquire whether he has ceased to practice, or has changed his residence, and if no answer shall be returned to such letter within the period of three months from the recording of the letter, it shall be lawful to erase the name of such person from the Register; provided also that the same may be restored by direction of the said Governor should he think fit to make an order to that effect or by fresh registration.

IV. Upon the application of any person being a Doctor, Fellow, Licentiate Bachelor, Master or Member of any School, College, Society or Faculty of Surgery or Medicine, or being possessed of any qualification to practice Medicine or Surgery from any School, College, Society or Faculty of Medicine or Surgery, either in the United Kingdom, or in any British Possession or Foreign Country; such person shall on payment of a fee of ten dollars be entitled to be registered by the Medical Registrar on producing to such Registrar the document conferring or evidencing the qualification or each of the qualifications in respect whereof he may desire to be registered and producing an affidavit made before the Chief Justice of the Supreme Court to the effect that he is the person named in such document of qualification; and such register may be amended in respect of any qualification subsequently acquired by any registered person on production and proof of such fresh qualification, and on payment of an additional fee of ten dollars for the same.

V. The said Register shall be open for inspection by the Public free of charge, and also as from time to time altered, corrected and revised by the said Registrar shall be published in the Government Gazette of the said Colony at least once in every year.

That section nineteen be numbered section six and be amended by inserting after the words "no person" in the commencement of the section the words "except as hereinafter excepted" and that after the words "provided always that nothing in this" and in lieu of the residue of the section be inserted the words "act contained shall be held to apply to Dentist, or to the practice of a Dentist."

That after section six be inserted the following section:

VII. Nothing in this Act contained shall be held to apply to any Medical officer in Her Majesty's service on full pay, and on active service.

That section 20 be numbered 8.

After this section insert the following section:

IX. Any Registrar who shall wilfully make or cause to be made any falsification in the said Register, shall be deemed guilty of a misdemeanor, and shall on conviction thereof be imprisoned for any term not exceeding twelve calendar months.

X. If any person shall wilfully procure or attempt to procure himself to be registered under this Act by making or producing, or cause to be made or produced any false or fraudulent representation or declaration, either verbally or in writing, every such person so offending, and every person aiding and assisting him therein, shall be deemed guilty of a misdemeanor, punishable by fine or imprisonment, and shall on conviction thereof be liable to imprisonment for any term not exceeding twelve calendar months.

XI. Every fine or penalty imposed under the provisions of this Act may be recovered with costs by way of summary conviction, and in default of payment by distress and sale of the goods and chattels of the offender, and in case of the insufficiency of such distress by imprisonment of the offender for any term not exceeding three calendar months, but no proceedings for the recovery of any such fine or penalty shall be commenced after the period of six months from time of the accruing of such fine or penalty.

XII. All fines, penalties, and fees imposed under the provisions of this Act shall be payable to Her Majesty the Queen, Her Heirs and Successors for the public uses of the said Colony, and in support of the Government thereof.

Bills read a 3rd time and passed.

A Bill Entitled An Act to repeal a portion of the First Telegraph Act, 1864.

A Bill Entitled An Act to impose landing permit dues on the importation of certain Stock and Carcasses.

On motion by Mr. De Cosmos, seconded by Mr. Duncan Ordered That House go into Comtee. tomorrow upon His Excellency's Communications Nos. 66, 67, 68, respectively.

Mr. De Cosmos from the Select Comtee. appointed to report upon the management of the "Victoria Harbour Dredging Machine" laid upon the table the report of the said Comtee.

Report read—and Ordered to be taken into consideration on Friday next in Committee.

The House then took under consideration and agreed to the following Amendment by the Honble. L. Council to "A Bill To amend the manner of taking the verdict of a Jury in civil cases."

In the enacting Clause Strike out the words "His Excellency" before the words "The Governor." For the words "on behalf of Her Majesty" insert the words "of the Colony of Vancouver Island and its Dependencies." Strike out the words of "Vancouver Island and its Dependencies and by authority of the same," and insert the word "thereof."

On motion by Mr. De Cosmos The House Ordered that A Communication be sent to The Honble. The Legislative Council requesting them to grant a Conference in re "A Bill Entitled An Act respecting The Medical Board and Practitioners in Medicine and Surgery."

In Comtee, of the whole House "A Bill Entitled An Act to explain and amend the Victoria Incorporation Act."

Mr. Speaker left the Chair.

Mr. Dennes in Chair of the Committee.

Mr. Speaker resumed the Chair.

The Chairman reported that the Comtee. having had under consideration the above mentioned Bill begged to report thereupon A Resolution "That the Chair do now rise."

Also "A Bill To grant a Supplemental Supply of Thirty Seven Thousand Six Hundred and Eight Dollars and Thirty Nine Cents for the Service of the Year One Thousand Eight Hundred and Sixty Four."

Ordered to be referred to Committee of "Ways and Means."

On motion by Mr. Burnaby, seconded by Dr. Dickson, Ordered That Communication (No. 69) from H. Excy. The Governor on the subject of Steam Communication with Panama be the order of the Day for Monday (5th inst.).

- Mr. Burnaby obtained leave to bring in "A Bill Entitled An Act to confirm certain Titles to real property in Vancouver Island and its Dependencies" which Bill On motion by Mr. Burnaby, seconded by Dr. Tolmie, was Read a 1st time and Ordered to be printed.
- Mr. McClure from the conference reported that the Honble. The Legislative Council and the Legislative Assembly had met in conference this day upon "A Bill Relating to Gold Mining" but that they had not been able to agree thereupon.
- A Communication was read from the Honble. The Legislative Council enclosing "A Bill relating to Gold Mining"—The Honble. The Legislative Council insisting upon its Amendment that Clause 28 be amended by the omission of the words from the commencement down to the word "And" before the words "all penalties."
- On motion by Mr. McClure, seconded by Mr. De Cosmos "A Bill To amend the Road Act, 1860" was read a first time and Ordered to be printed.

The House then took under consideration the Amendment by the Honble. The Legislative Council to "A Bill relating to Gold Mining"—which Amendment was not agreed to.

The House insisted upon its own Amendment, and Ordered that the Bill be returned to the Council.

That this House would further state that it believes His Excellency the Governor will, on further enquiry, find a sufficient number of Settlers of integrity and ability resident in the said Districts, who are willing to discharge the duties of Justices of the Peace; and would respectfully recommend that further steps may be taken to carry out the views of this House respecting their Appointment as such."

In regard to the Second viz. "The Church Reserve" The Chairman reported "That he had not any report to make."

In regard to the third.

The Chairman reported A Resolution "That His Excellency be respectfully requested to allow to 'bonâ fide' Settlers a reasonable extension of time to pay the instalments due on the 31st May 1865."

Ordered that reports be agreed to respectively.

The House then adjourned till tomorrow.
