Thursday, January 25, 1973

THREE O'CLOCK P.M.

This being the first day of the second meeting of the Thirtieth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable John Owen Wilson, Administrator of the Province, dated the 9th day of November 1972, the members took their seats.

Prayers by the Rev. R. B. Knipe.

Colonel the Honourable John R. Nicholson, P.C., O.B.E., Q.C., LL.D., Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:

Mr. Speaker and Members of the Legislative Assembly:

I am pleased to welcome you to this, the Second Session of the 30th Parliament of our Province. I extend to you my best wishes as you, my new Government and Legislature, embark upon the course of action required to face the changes of the 70's.

This last year has been an eventful one and we are mindful of the high level of expectation that our citizens have from governments across the nation. Consequently, the policies and programmes of my Government, as evidenced by the Special Session last October, will continue to be carefully designed to meet both the priorities and the expectations of our peoples in the most appropriate way.

All Canadians have felt deep and abiding concern over the horrors of the war in southeast Asia. It is, therefore, with an overwhelming sense of relief that we welcome the Vietnam cease fire and peace treaty announced this week.

Since last September many of my Ministers have met with their counterparts in other provinces and with the Cabinet Ministers of our Federal Government. Sincere appreciation for our contributions has been expressed by many at these important discussions, and the expressions of optimism regarding the Province's future role in Confederation and the future of Canada are highly significant.

All Canadians were recently saddened by the loss of the Right Honourable Lester B. Pearson, Canada's Prime Minister from 1963 to 1968. Mr. Pearson, a

Nobel Peace Prize winner, was a dedicated and a very highly respected diplomat who brought honour and dignity to the country he loved and served so well.

I note with regret the death, on November 13 last, of Herbert Anscomb, a Minister of the Crown from 1941 to 1952. Mr. Anscomb was an able politician and servant of the people whose passing was mourned by all who had come in contact with him.

I am pleased to report that my First Minister and members of the Executive Council met with the Honourable Daniel J. Evans, Governor of the State of Washington, and members of his administration in Olympia earlier this month to discuss matters of mutual interest. Such discussions and the frank exchange of ideas should prove to be beneficial. While in Olympia, the Honourable the Premier was afforded the honour of addressing the Joint Houses of the Legislature. I note with pleasure that Governor Evans has been invited to visit British Columbia in the fall of this year in order to carry on with these discussions.

In mid-November of last year we were honoured by the visits of the Honourable William A. Egan, Governor of the State of Alaska, and Mr. James Smith, Commissioner of the Yukon Territory. These visits were for the purpose of discussing ideas as to the improvement of our environment and ecology and other matters of joint co-operation.

During this Session of the Legislature you will be asked to consider, among others, the following measures:

A British Columbia Bill of Rights.

Legislation to implement a Government-operated automobile insurance plan.

Amendments to improve the pension plans administered by the Government.

Amendments to the *Constitution Act* and a revision of some departmental Acts to reflect the new thrusts and priorities of my Government.

Amendments to the Park Act and the Litter Act.

Amendments to the Land Act and the University Endowment Lands Act. In the important field of health care you will be asked to consider legislation for the following:

An Ambulance Services Act, and

Amendments to the Medical Act and the Mental Health Act.

Major administrative and legislative changes will be made in the Department of Industrial Development, Trade, and Commerce and the Legislative Assembly will be asked to discuss measures to complement these changes.

Two major problems will come before you as a result of your actions in the Special Session last October. They are the continuing study of the effects of the consumption of and the advertising of tobacco and alcoholic products; and the report from the Speaker as a result of the passage of the Legislative Procedure and Practice Inquiry Act.

The administrative and legislative programmes will be carefully designed and will be based on the clear necessity to plan our future so that we may live in harmony with our environment and at peace with our fellow men, and to depart from the acquisitive North American values that have seen profligacy and waste on all sides. To implement these programmes, our Government will bolster services to our people, industry, and labour, to catch up with modern society's demands for quality services provided by skilled people. Our citizens have spent vast sums

educating our young people in special skills. These talents will be tapped as we update the Civil Service, which has been handicapped for some time by the lack of sufficient staff. Therefore, our Government will institute measures that will create close to one thousand new Government jobs in the Civil Service of our Province.

The complexities and burdens of government in these troublesome times clearly suggests that your wisdom and advice will be required more frequently than in the past.

It is my Government's intention to call you together as the work load expands and also to increase the work and designed use of the Standing Committees of the House so that our citizens will be best served at all times. To these and all other matters which may come before you, I ask your most careful attention and I pray that Divine Providence may guide your deliberations.

Mr. Speaker and Honourable Members, I leave you now to the discharge of your legislative duties.

His Honour the Lieutenant-Governor was then pleased to retire.

The Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

On the motion of the Hon. David Barrett, seconded by the Hon. Eileen E. Dailly, it was Ordered—

That the Select Standing Committees of this House, for the present Session, be appointed for the following purposes:

- 1. On Standing Orders and Private Bills;

- 6. On Forestry and Fisheries;

which said Committees shall severally be empowered to examine and inquire into all such matters and things as shall be referred to them by this House, and to report from time to time their observations and opinions thereon, with power to send for

persons, papers, and records, and that a Special Committee be appointed to prepare and report, with all convenient speed, lists of members to compose the above Select Standing Committees of this House under Standing Order 68 (1), said Committee to be composed of the Hon. A. B. Macdonald, the Hon. R. M. Strachan, and Messrs. Dent, Richter, and D. A. Anderson.

On the motion of Ms. Rosemary Brown, seconded by D. T. Kelly, it was Ordered—

Mr. Chabot rose on a matter of privilege, namely the alleged release by the Government of a preliminary report prior to such report having been made available to members of the House.

Mr. Speaker stated that he would give his ruling on the matter concurrently with his ruling on a related question of privilege raised in the House yesterday.

Mr. D. A. Anderson asked leave to move adjournment of the House to discuss a definite matter of urgent public importance, namely the closure of schools in the Greater Victoria area.

Mr. Speaker stated that pursuant to Standing Order 35 it was his duty to determine the urgency of debate rather than the urgency of the particular matter. Mr. Speaker further stated that as the House for several days had been engaged in debating the Address in reply to the Speech of His Honour the Lieutenant-Governor, and that as such debate was continuing, the opportunity already existed for the matter in question to be debated by any honourable member wishing to do so.

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

The debate continued.

On the motion of Mr. Gabelmann, the debate was adjourned to the next sitting of the House.

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. tomorrow.

Mr. Speaker made the following statement:

Honourable Members—At the opening of yesterday's sitting the honourable second member for Victoria raised a question of privilege relating to ministerial statements of policy made outside the House, and I advised the House that I would reserve consideration of the matter.

The privileges of Parliament are those defined by ancient custom set out in May's Parliamentary Practice, 16th edition, at page 42, as ". . . the sum of the peculiar rights enjoyed by each House collectively as a constituent part of the High Court of Parliament, and by members individually, without which they could not discharge their functions, and which exceed those possessed by other bodies or individuals."

The privileges of the Commons have been defined as "the sum of the fundamental rights of the House and of its individual members as against the prerogatives of the Crown . . . "

Parliamentary privilege is to some extent indefinite, but ancient rights and privileges of members include freedom from arrest and all molestations, liberty of speech in all their debates, and the right of access to the Sovereign.

Certain offences against the authority and dignity of Parliament are not specifically breaches of privilege but more correctly described as contempt. Such acts are dealt with exhaustively in Sir Erskine May's *Parliamentary Practice*, 18th edition, chapter 10.

Examples of this are cited, such as members misleading the House or any committee thereof (p. 140). At page 143 May states: "Upon this principle the Commons on 21 April, 1837, resolved, 'That the evidence taken by any select committee of this House, and the documents presented to such committee, and which have not been reported to the House, ought not to be published by any member of such committee or by any other person."

The publication or disclosure of draft reports of committees before they have been reported to the House will constitute a breach of privilege or a contempt, and may lead to reprimand and sometimes a refusal to nominate the offender to further select committees. As can be seen, all of these breaches concern matters initiated by the House in its legislative or committee work and the gravamen of the offence is that it is a discourtesy to disclose business in the hands of the House at the time of the disclosure by the member.

The honourable member's complaint is that a member of the Government disclosed a proposed policy to the public before informing the House. No proceedings relating to this policy were in charge of the House or its committees. In examining the authorities no case can be found in the citations presented by the honourable member holding it to be an offence for the Government publicly to announce its intentions. Indeed this practice has been a common occurrence for many years and were it a breach of privilege some ruling must surely be recorded. To the contrary, my view is reinforced by the decision of Mr. Speaker Lamoureux in the House of Commons, recorded in the *Debates of the House of Commons*, March 31, 1969, at pages 7298–7300, relating to an announcement by a Minister concerning a new airport, and again his decision on October 30, 1969, at pages 269–270, with reference to the publicizing of a policy statement by the Communications Minister, wherein it was indicated there was no precedent whereby policy statements had to be made in the House.

As was indicated *ex mero motu* yesterday, the House rules do not provide for statements by Ministers, although unanimous consent to suspend the rules for such purpose can be and is often granted.

If it were shown to be a prima facie case of breach of privilege then the matter would be one for the determination of the House, but in the circumstances and in view of the authorities as they appear to be, no prima facie case has been shown.

On the same principle, the honourable member for Columbia River today complained of the disclosure of a Government report to the press. The Honourable the Premier advised the House that such report was not, in fact, released and his statement must, of course, end the complaint. Beyond that, it was not a report ordered by the House nor was it the property of the House or any if its committees and the same reasons apply that no prima facie case of breach of privilege exists.
