#### MARCH 5TH.

Therefore be it Resolved, That this House is of the opinion that the Provincial Government should apply to the Federal Government of Canada to have the control of the British Columbia Telephone Company Limited and its subsidiaries within the Province of British Columbia revert to Provincial jurisdiction in order that the rates and services of the said telephone company can be controlled on behalf of the people of the Province by the Public Utilities Commission of British Columbia.

#### A debate arose.

On the motion of the Hon. R. W. Bonner, the debate was adjourned to the next sitting of the House.

#### Mr. Nimsick moved, seconded by Mr. Squire,---

That briefs presented to the Cabinet by recognized labour and management organizations be referred to the Select Standing Committee on Labour and that the Committee be authorized to hear further representations and report its findings to this House.

A debate arose.

The motion was negatived.

Mr. Gregory moved, seconded by Mr. Gibbs,-

That all correspondence between Provincial Ministers and the Minister of Citizenship and Immigration since 1952, and dealing with the ability of British Columbia to absorb immigrants, be filed with this House.

A debate arose.

The motion was agreed to.

By leave of the House, the notice of motion standing on the Order Paper under the name of Mr. *Gregory*, as follows: "That all correspondence between the Minister of Health and Welfare and all municipal officials concerned and dealing with construction of a new hospital at North Vancouver be filed with this House," was withdrawn.

Mr. Gregory moved, seconded by Mr. Gibbs,-

Whereas there has been ample evidence that for many years the drug traffic has centred in the Province of British Columbia:

And whereas by a Return filed in the House of Commons on December 9th, 1957, the Minister of Justice has pointed out that of 745 penitentiary inmates in all Canadian penitentiaries either convicted under the "Opium and Narcotic Drug Act" or who have a record of drug addiction, no less than 358 are in the British Columbia Penitentiary:

And whereas concern over the situation has already been expressed in this House:

Be it Resolved, That this House record its disappointment with the results of efforts toward suppression of this traffic in this Province and calls upon the Minister of Justice of Canada and the Attorney-General of British Columbia to undertake forthwith a vigorous campaign aimed at its total elimination.

A debate arose.

A point of order was raised by the Hon. R. W. Bonner.

Mr. Speaker ruled the motion out of order and *Ordered* it to be dropped from the Order Paper.

Mr. Gregory moved, seconded by Mr. Gibbs,-

Whereas natural gas originating in the Province of British Columbia is being sold at a lesser price for consumption in the United States than for domestic consumption within the Province:

And whereas Order in Council P.C. 1957-907, section 9, provides as follows: "The price charged by a licensee for power or gas exported by him shall not be lower than the price at which power or gas, respectively, is supplied by him or his supplier in similar quantities and under similar conditions of sale for consumption in Canada":

And whereas power rates and gas rates are currently being examined by a Royal Commission:

Therefore be it Resolved, That the Minister of Mines be urged to present a brief on behalf of the Province urging that gas produced in British Columbia be sold in British Columbia at a price not exceeding that charged in the United States.

A debate arose.

The Hon. W. K. Kiernan moved in amendment, as follows:---

That the first paragraph of the recital be struck out, and that all words after "That," in the first line of the last paragraph, be struck out and the following substituted therefor: ". . . this House recommends to the Federal Government that it take such action as is necessary to assure consumers that the intent of Order in Council P.C. 1957-907, section 9, is carried out."

A debate arose.

The amendment was agreed to.

The motion as amended was agreed to.

Mr. Strachan moved, seconded by Mr. Turner,-

Whereas during proceedings of the Legislature statements on public policy are made in this Legislature but not officially recorded:

And whereas it is in the public interest that the proceedings and statements made in this House should be accurately recorded:

Therefore be it Resolved, That this House is of the opinion that the Government should give consideration to the advisability of establishing a system of verbatim reporting of the proceedings of the British Columbia Legislative Assembly.

A debate arose.

On the motion of the Hon. W. D. Black, the debate was adjourned to the next sitting of the House.

Mr. Cox moved, seconded by Mr. Nimsick,-

That this Assembly urge the Government of Canada to intensify its efforts to promote the relaxation of international tensions, aiming toward world disarmament by international agreement and that it urge the United Nations Organization to explore every means to this end, including its support of holding a summit conference.

A debate arose.

Mr. Price moved in amendment, seconded by Mr. Shelford,-

That all words after "Canada," in the first line, be struck out and the following substituted therefor: ". . . through the United Nations to intensify its efforts toward attaining peace among all nations of the world."

A debate arose.

The amendment was agreed to.

The motion as amended was agreed to unanimously.

Mr. Turner moved, seconded by Mr. Eddie,-

Be it Resolved, That this House is of the opinion that the Government should take under advisement the calling of a Provincial-municipal conference to consider all phases of Provincial-municipal relations and jurisdiction.

A debate arose.

The motion was negatived.

Mr. Eddie moved, seconded by Mr. Turner,-

Whereas the Federal Government, by recent amendments to the "Municipal Grants Act," has recognized the principle that it should pay its fair share of the cost of municipal services provided in respect of Crown property:

Therefore be it Resolved, That this House expresses the opinion that the Provincial Government should examine its policy with respect to grants in lieu of taxes on Crown Provincial property situate within municipal boundaries.

A debate arose.

The motion was negatived.

Mrs. Haggen moved, seconded by Mr. Dowding,---

Whereas procedure used in many public abattoirs and slaughter places in British Columbia in killing food animals and fowls is not now consistent with proven humane and modern methods:

And whereas information is available on these methods now in use the world over:

Therefore be it Resolved, That, in the opinion of this House, the Government should consider implementing immediately the terms of the "Meat Inspection Act," being chapter 22, section 18, subsection (2), clause (c) of the Statutes of British Columbia, 1954, to ensure that when animals and fowls are slaughtered commercially for food humane methods are used.

A debate arose.

The Hon. N. P. Steacy moved in amendment,-

That all the words after the word "Resolved," in the first line of the third paragraph, be struck out and the following substituted therefor: "That this House recommends the Government of Canada amend section 387 of the Criminal Code at the next Session of Parliament in accordance with the terms of Bill 241, introduced at the last Session by the Hon. the Minister of Justice, and that this House further recommends that fowl be included in the scope of the proposed legislation."

A debate arose.

The amendment was agreed to.

The debate continued.

The motion as amended was agreed to.

Mr. Strachan moved, seconded by Mr. Squire,—

Resolved, That this House protests the actions of the Milk Board in eliminating the differential on the producer price of milk on Vancouver Island thereby reducing the financial return to the dairy-farmers of that area and that the Minister of Agriculture take this matter under immediate review to determine what action is required to assist the dairy-farmers of Vancouver Island.

A debate arose.

On the motion of the Hon. N. P. Steacy, the debate was adjourned to the next sitting of the House.

# Mr. Nimsick moved, seconded by Mr. Harding,-

Be it Resolved, That this House is of the opinion that the Government should take into consideration the making of a survey of the housing situation in British Columbia in relation to the needs of senior citizens.

#### A debate arose.

On the motion of the Hon. N. P. Steacy, the debate was adjourned to the next sitting of the House.

## Mr. Dowding moved, seconded by Mr. Harding,---

That the Standing Committee on Social Welfare and Education be authorized to examine briefs and submissions by the British Columbia Medical Association, the Canadian Mental Health Association (British Columbia Division), and other organizations and persons interested in the subject of mental health services and staffing of Provincial mental institutions and to report its finding to the House.

## A debate arose.

With respect to iron-ore surveys in 1957 and the sum of \$100,000 provided therefor:---

1. What part of this amount was spent in 1957?

2. Are the results of these surveys available to the public?

3. Were such surveys made by contract and, if so, by what firm?

The Hon. W. K. Kiernan replied as follows:---

"1. (a) For aeromagnetic surveys in search of iron ore, \$29,826.42; and (b) in search for coking-coal to strip, dig, and load 97 tons of coal from Upper Pine River to Squamish, \$7,303.18; shipping charges to Ottawa of selected samples, \$10.18; total, \$37,139.78.

"2. Maps recording results of all aeromagnetic surveys have been released to the public from both the 1956 and 1957 magnetometer work; a total of thirteen different maps have been released, the latest on January 9th, 1958.

"3. The aeromagnetic surveys were made under contract by the Photographic Survey Corporation Limited, Western Division, of Vancouver.

"The expenditures quoted above do not include geological work done by the Department."
