Your Select Standing Committee on Municipal Matters begs leave to report as follows:— That the preamble to the undermentioned Bill has been proved, and the Bill ordered to be reported with amendments.

Bill (No. 17) intituled "An Act respecting Town Planning." All of which is respectfully submitted.

The report was received.

Dr. *Rothwell* presented the report of the Select Standing Committee on Agriculture, as follows :---

LEGISLATIVE COMMITTEE ROOM, December 10th, 1925.

Your Committee begs to report as follows :---

We have received from the Advisory Board of Farmers' Institutes recommendations upon matters of very great importance to the development of the agricultural institutes of our Province, and after giving them the most exhaustive consideration possible, we respectfully submit the following recommendations :—

(1.) Regarding the Destruction of Sheep by Dogs.—It has been shown that the injury from this source to our sheep-raisers is so serious that in not a few cases the farmers have been compelled to abandon this source of revenue, notwithstanding that it should be, under normal conditions, one of the most profitable they could engage in. The matter was deemed of such importance that it was referred to a special sub-committee to bring in resolutions. These were again considered by the Select Committee, and are now being drafted into a Bill, which will be submitted to the House during the present Session.

(2.) Bills on Agriculture.—A resolution suggesting the desirability of such Bills being submitted for the consideration of the Select Committee on Agriculture before being presented to the House was taken up by the Committee and endorsed. It was felt that by this means a good deal of time might be saved in discussion by the Legislature by having such matters carefully considered in this manner. The recommendation was forwarded to the Hon, the Minister of Agriculture proferring this request, to which he readily acceded.

(3.) Debate on Agricultural Reports.—A recommendation from the Advisory Board that all reports of this Select Committee on Agriculture receive careful consideration on the floor of the House received a favourable endorsation from this Committee, as it was felt that a matter that has been found of sufficient importance to pass the Advisory Board of Farmers' Institutes, and again after discussion by this Select Committee be deemed of sufficient importance to be forwarded to the Legislature, should receive careful consideration.

(4.) Re Orientals owning Land.—The following resolution was submitted by the Advisory Board :—

"Resolved, That the Legislature be requested to investigate as to whether legislation can be enacted to prevent Chinese and Japanese from owning, selling, leasing, or renting land in British Columbia, or, in the alternative, imposing conditions upon their rights of ownership."

Your Select Committee considers that this resolution is absolutely reasonable and most desirable and forwarded their endorsation.

(5.) Dealing with Date of Taxation Exemption.—The report of your Select Committee of last year included a recommendation that the date when taxes became delinquent should be extended, particularly in the case of our farming communities, from June 30th to October 31st.

The reasonableness of this is apparent when it is understood that, with but a few exceptions, the great bulk of the farmer's income does not reach his hands for the year's operations until the fall months. Prior to that time he is advancing money to finance his farming operations and the month of June is for this reason a most difficult time for him to finance. Your Committee urges action in compliance with this most reasonable request from the farmers themselves.

(6.) Pulp-wood Resources.—The following is the Advisory Board's resolution bearing upon this possible source of income for the farmer:—

"Resolved, That we request the Government to use every effort in giving publicity to the pulp-wood possibilities of the Interior districts, giving special attention to the opportunity of economic production of pulp through the operation of small local units where the raw material can be ground and baled and shipped to suitable centres. We desire to point out that there appears to be water-power available for the development of small local units for making pulp. The clearing of land of wood suitable for pulp which would otherwise be wasted would assist in providing a revenue during the period of time that must elapse whilst the settler is clearing up his farm."

This matter was taken up by your Select Committee with the Forestry Department, from which source it is learned that there is apparently no system in operation that would enable farmers in our rural districts to dispose of their timber for pulp-wood purposes to comparatively small units of pulp-manufacturing character within reasonable access to such communities.

We would recommend that the Forestry Department follow up this matter in the hope that in suitable localities such pulp-manufacturing plants may be established, as such would afford a means for our farmers, particularly in the early years of their occupancy of the land, to obtain an income from the timber while the land is in the process of development to the point where it may be used in production of more specific agricultural products. This is a matter of very great importance, particularly to the operations of our Province in the earlier stages of development.

(7.) Importance of Abandoned Pre-emptions.—The Advisory Board makes the following recommendations :—

"That the value of the improvements which have been made by the original pre-emptor on pre-emptions which have reverted to the Crown should not be charged to a new pre-emptor."

Your Committee recognizes the necessity of the present system of our Lands Department in making a charge to a new applicant for at least some portion of the improvements left by the 16 GEO. 5

former occupant upon abandoned pre-emptions. It has been found in practice, however, that the charge to a new settler for improvements already made upon his place has had a deterrent effect upon them, and not infrequently led to desirable settlers declining to pre-empt land which carried such a charge for improvements. Your Select Committee recommends and urges that the utmost liberality be used towards settlers in this regard, realizing that it is of infinitely greater importance to secure a satisfied settler on the land than to collect a few dollars for improvements already made, the cash payment for which improvements has so often been found to work a hardship upon the settler.

E. J. ROTHWELL, Chairman.

10. Are they employed on any other duties? If yes, state what other duties.

11. Were any big-game licences issued without charge during the years 1923, 1924, and 1925? If so, how many and to whom?

12. Have any permits been issued to "pit-lamp" deer? If yes, to whom were permits issued?

Mr. Lyons asked the Hon. the Minister of Public Works the following questions:-

1. What is the total sum of money paid to the University Taxi Company, of Vancouver, for transporting workmen from the end of car-line to the University site at Point Grey since the date of commencement of construction on the Science Building to date?

2. Has the University Taxi Company been paid in full? If not, how much is still due?

3. Has any other firm been paid any moneys for transporting workmen to Science Building? If so, how much?

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.
