THREE O'CLOCK P.M.

This being the first day of the fourth meeting of the Twenty-second Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable Gordon McGregor Sloan, Administrator of the Province, dated the 11th day of January, 1952.

His Honour Clarence Wallace, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Madam Speaker and Members of the Legislative Assembly:

In opening the Fourth Session of the Twenty-second Parliament of British Columbia, I wish to express my profound sorrow at the passing of His Most Excellent Majesty King George VI.

The grief felt by the people is great indeed. Our sincere and heartfelt sympathies have been extended to Her Most Excellent Majesty Queen Elizabeth II and to the members of the Royal Family.

It is my desire to express on behalf of Her Majesty's subjects their deep and abiding affection and loyalty. We would have her know that she, who was with us so recently, is constantly in our thoughts as she takes up the task that once was borne with such distinction by her illustrious father.

The grave and important responsibilities that are now hers, we trust, will be made easier to discharge with the knowledge that her people are with her in their thoughts.

The citizens of this Province feel fortunate indeed that they had the opportunity of meeting Her Most Excellent Majesty and her Consort, His Royal Highness the Duke of Edinburgh. We trust that the more recent tour to other parts of the realm, which was so abruptly ended by the tragic news of the late King's death, will, at some future date, be possible to resume, so that other parts of the Commonwealth will also have the opportunity of meeting their Sovereign.

Since the Legislature last met, Earl Alexander of Tunis has completed his tenure of office as Governor-General of Canada, and His Excellency the Right Honourable Vincent Massey has been appointed to succeed him. I would first express the warm regard in which Earl Alexander and the members of his family were held by the people. We wish him every success in his new post with the British Government. Canada

has been indeed fortunate in having so distinguished a soldier and statesman as the representative of the Crown in Canada.

In the appointment of His Excellency the Right Honourable Vincent Massey, Canada, for the first time in her history, has chosen one of her native sons to occupy the position of representative of Her Most Excellent Majesty Queen Elizabeth II. In the new appointment, we have a distinguished Canadian who has rendered outstanding public service, both as a Minister of the Crown and, in later years, as High Commissioner, Envoy Extraordinary and Minister Plenipotentiary for Canada. On behalf of the people of British Columbia, I wish to express our warmest felicitations and heartiest good wishes to him as he assumes the important responsibilities that go with his high office.

It is with gratification that I note that my Government has removed the tolls from the Fraser River (New Westminster) Bridge. This action should redound greatly to the benefit of the people.

Since last you met there have been some changes in the personnel of the Government, and in view of the circumstances that have transpired, the only business to be placed before you will be of a nature considered to be essential for the maintenance of public service. All other matters will be deferred until the people have been afforded an opportunity of clarifying the present situation.

Legislation asking for the ratification of a tax agreement between the Federal Government and this Province will be placed before you.

Reports dealing with the operation of the "Workmen's Compensation Act," the "Industrial Conciliation and Arbitration Act," and the "Hospital Insurance Act" will be filed with the Legislature.

I note with gratification that you will be asked to implement certain recommendations of the Royal Commission's report on the operations of the "Workmen's Compensation Act."

You will be asked to make provisions for a number of important undertakings, including construction of the Squamish to Vancouver Highway; secondary roads; the Northern Trans-Provincial Highway, along which so much industrial development is taking place; erection of new schools, hospitals, and other public buildings.

I am pleased to observe that it is my Government's intention to place a plebiscite before the people on the question of liquor sales.

The Public Accounts will be presented, and Estimates for the ensuing year will be submitted.

I pray the blessing of Divine Providence will rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. H. E. Sexton, Bishop of British Columbia.

Madam Speaker reported that, to prevent mistakes, she had obtained a copy of His Honour's Speech.

On the motion of the Hon. Mr. Wismer, Bill (No. 1) intituled "An Act to amend the 'Consumer Credit Act'" was introduced, read a first time, and Ordered to be read a second time at the next sitting.

The Speaker addressed the members as follows:-

Honourable Members,—Since this Legislative Assembly last met, certain members of the House have seceded from the Government ranks.

Sir Erskine May, in "Parliamentary Practice," fifteenth edition, page 245, states: "The prevalence (on the whole) of the two-party system has usually obviated any

uncertainty as to which has the right to be called the 'Official Opposition'; it is the largest minority party which is prepared, in the event of the resignation of the Government, to assume office."

Sir Ivor Jennings, in his "Law and The Constitution," page 115, says: "The Leader of the Opposition means 'that member of the House of Commons who is for the time being the Leader in that House of the Party in Opposition to His Majesty's Government, having the greatest numerical strength in that House'; and in case of doubt as to which is the Party in Opposition having the greatest numerical strength, or as to who is the Leader in the House of that Party, the question will be determined by the Speaker."

Prayers by the Rev. S. V. H. Redman.

The Hon. Mr. Bowman made the following statement:-

Madam Speaker,—I ask leave of the House to discuss a matter of urgent public importance.

The outbreak of foot-and-mouth disease among the cattle in sections of Saskatchewan has given the Government great concern.

Representations have been received from the cattle-owners and game associations who feel that the dread disease, with its disastrous consequences, may enter British Columbia from other Provinces.

The situation is not yet clarified but, in view of the serious menace that an outbreak of any such disease in British Columbia would occasion, the Government has decided to pass an Order to exclude, at least temporarily, the shipment into British Columbia of animals which might carry the disease.

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

The debate continued.

On the motion of Mr. Whisker, the debate was adjourned to the next sitting of the House.

Mr. Haggen asked the Hon. the Attorney-General the following questions:—

- 1. Did the Attorney-General or any responsible officer of his Department recommend the release on parole from the British Columbia Penitentiary of one John Sherstobitoff?
- 2. If yes, (a) for what crime had said Sherstobitoff been sentenced, (b) what sentence did he receive, and (c) how much of it had he served?
 - 3. If released, what was the date of release?
 - 4. Had Sherstobitoff any previous record of violating terms of parole?
- 5. Has the Department received any protest regarding release from Penitentiary of said Sherstobitoff?
 - 6. Has the Department any knowledge of Sherstobitoff's present whereabouts?
- 7. Have any cases of suspected arson been reported from the Grand Forks or Brilliant areas during the year 1952?
 - 8. If so, on what dates did the suspected arson occur?

The Hon. Mr. Wismer replied as follows:-

Mr. Haggen asked the Hon. the Minister of Education the following questions:—

- 1. Have any guards been employed on school buildings in School Districts Nos. 8, 9, 10, 11, and 12 respectively during the past year?
 - 2. If so, how many and on what schools?
- 3. If guards are employed, (a) why are they deemed necessary, (b) from what sources are they paid, and (c) what has been the total cost of guarding schools from February 1st, 1951, to January 31st, 1952, inclusive?
- 4. Did the Dominion Government make any contribution toward cost of such guards?

The Hon. Mr. Straith replied as follows:-

- "1. Yes, in School Districts Nos. 8, 9, and 12; no, in School Districts Nos. 10 and 11.
- "2. School District No. 8, twenty guards on Slocan City, Perry Siding, Appledale, Winlaw, Vallican, Slocan Park, Crescent Valley, Mount Sentinel, and South Slocan Schools; School District No. 9, seventeen guards on Stanley Humphries, Castlegar, Kinnaird, Robson, and Tarrys Schools; School District No. 12, nine guards on Grand Forks Junior-Senior High and Central Elementary Schools.
- "3. (a) Guards were placed on school buildings, at the time the Tarrys School was burned, on representations made by the School Boards of the district; further acts of incendiarism were expected; this opinion was supported by the Provincial Police; repeated attempts by the Department have been made to end this situation, but it has been reported by School Boards and concurred in by the Consultative Committee on Doukhobor Problems that it would be unwise to remove the guards at the present time.

 (b) From special warrant raised by Attorney-General. (c) \$95,810.02.

- Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:—
- 1. Is information available covering the period of the latest annual report of the insurance department showing the amount of unpaid claims of each individual insurance company in the respective fields of insurance?

2. Will this information be included in future reports as it was prior to the 1941

report?

The Hon. Mr. Wismer replied as follows:—

"1. Particulars of unpaid claims by each Province are not included in the annual statements of the insurers filed with the Department, which form of statement is uniform throughout all the Provinces, the figures for the Dominion of Canada are given, but are not segregated by Provinces.

"2. Prior to 1941 this information was shown on the statements filed by life insurance companies and was included in the annual report of the Superintendent, but, as stated above, the information is not now required and therefore will not be shown in

future reports."

The Hon. Mr. Kenney replied as follows:-

- 1. Have any amounts been paid with respect to building a bridge over Rock Creek Canyon, Southern Trans-Provincial Highway, approximately 1 mile east of Bridesville?
 - 2. If so, to whom were said amounts paid?
 - 3. Have all costs of the said bridge been paid?
- 4. If any amounts remain unpaid, what is the total amount of them and to whom are they due?

The Hon. Mr. Kenney replied as follows:—
