On the motion of the Hon. Mr. McBride, Bill (No. 81) intituled "An Act to amend the 'Mineral Act'" was introduced, read a first time, and Ordered to be read a second time to-morrow.

Mr. Martin asked the Government the following questions:—

(1.) Is the Government Reserve near *Barkerville*, better known as *Steele's Ranch*, leased; and if so, to whom? If not, what is being done with said ranch?

(2.) When said ranch was leased some time ago, to whom was the same leased? Were

tenders called for, and if so, what tenders were received?

(3.) Was said lease renewed recently, and if so, on what terms? Were any tenders asked for or received?

The Hon. Mr. Wells replied as follows:-

"(1.) The Government Reserve near Barkerville, which is known as Pleasant Valley, is leased to Mr. S. A. Rogers.

"(2.) To S. A. Rogers. Yes; tenders were received as follows:—From S. A. Rogers, \$40 per annum, and Wm. Kelly, \$20 per annum, rental.

"(3.) Yes; on the same terms as the former lease. No.

The Report on Bill (No. 32) intituled "An Act to Incorporate the Royal Columbian Hospital" was adopted.

Bill read a third time and passed.

The Report on Bill (No. 28) intituled "An Act to amend the 'Inspection of Metalliferous Mines Act' and Amending Act" was considered.

Mr. Houston moved that the following be substituted for sections 21A and 21B:-

"21A. Every person who, after the first day of January, A.D. 1902, being employed in or about a metalliferous mine, in which mine the machinery hereinafter mentioned shall be operated for more than twenty hours in each twenty-four, operates or handles for more than eight hours in any twenty-four any direct-acting, geared or indirect-acting hoisting machine, shall be guilty of an offence under this Act.

"21B. Every person who, after the said date, in or about any such mine, operates a stationary engine or electric motor developing fifty horse-power or more, and shall perform any of such duties for more than eight hours in any twenty-four, shall be guilty of an offence

under this Act.

"21c. Any person, corporation or company who shall induce or persuade any person or persons to do any act, matter or thing in contravention of the two preceding sections hereof shall be guilty of an offence under this Act, but it shall not be deemed an offence under this or the two preceding sections if any person operates any such machinery for more than the period mentioned for the purpose of relieving another employee in case of accident, sickness, or other unforeseen cause."

A debate arose, which was adjourned until to-morrow.

The Report on Bill (No. 25) intituled "An Act to provide for the Collection of a Tax on Persons" was considered.

The Hon. Mr. Turner moved to amend section 3 by adding after the word "dollars," on the 9th line of the section, the words "and who shall make a statutory declaration as to their age and income, when required so to do."

Carried.

Mr. Gilmour moved to amend section 3 by striking out the words "until the said tax shall be increased as hereinafter provided," in the second and third lines thereof, and by striking out sub-section (a).

A debate arose, which was adjourned until to-morrow.

Bill (No. 45) intituled "An Act for the Protection and Reformation of Neglected and Dependent Children" was again committed.

Reported complete with amendments. Report to be considered to-morrow.

On the third reading of Bill (No. 62) intituled "An Act to Incorporate the Chilkat and Klehini Railway and Navigation Company"—

Mr. Green moved to amend section 28 by adding at the end of line 35 the word "Act."

The Hon. Mr. Eberts moved in amendment to add the following new sections:—

"The Company shall, before the railway is opened for the carriage of freight and passengers, give security to the satisfaction of the Lieutenant-Governor in Council—

"(1.) That the Lieutenant-Governor in Council shall have the absolute control of the

rates for freight and passenger traffic:

"(2.) That in the event of a charter being granted by the Dominion Government to the promoters herein for a line of railway over or parallel to the route proposed in this Act, the foregoing conditions shall be assumed and carried out by the Company so incorporated, as a contract and obligation of said Company prior to any other charge thereon."

Mr. Martin moved in amendment to the amendment-

"That all the words after the word 'sections' be struck out, and the following substituted therefor:—

"This Act shall not come into force or effect until such time as the Company shall give

security to the satisfaction of the Lieutenant-Governor in Council-

"(1.) That the Lieutenant-Governor in Council shall have the right to fix maximum rates for freight and passenger traffic, and the Company shall not charge rates higher than those so fixed:

"(2.) That in the event of Dominion legislation bringing this railway company under the exclusive jurisdiction of the Parliament of Canada, the foregoing conditions shall be carried out by the company so incorporated, as a contract and obligation of said company prior to any other charge thereon."

Amendment to the amendment carried.

Amendment, as amended, carried and added to the Bill.

Mr. Curtis moved—That the Bill be referred back to the Committee of the Whole, with instructions to insert the following as a new section:—

"1. The plans, specifications, and conditions of any proposed contract for the construction of the railway shall be subject to the approval of the Lieutenant-Governor in Council; and that the contracts shall be submitted to public tender and competition, under such conditions as the Lieutenant-Governor in Council shall approve; and no contract shall be awarded, or work or material thereunder accepted, without the like approval; and no mortgage charge shall be put against the line of railway beyond the fair cost of same and its equipment."

Also to add a new section as follows:-

"That no aliens shall be employed on the railway during construction, unless it is demonstrated to the satisfaction of the Lieutenant-Governor in Council that the work cannot be proceeded with without the employment of such aliens."

A debate arose, which was adjourned until to-morrow.

Resolved, That the House, at its rising, do stand adjourned until two o'clock to-morrow.

Mr. Tatlow asked the Hon. the Chief Commissioner of Lands and Works the following auestion :-

Is it the intention of the Government to extend the system of small holdings in Burnaby and South Vancouver during the present year?

The Hon. Mr. Wells replied as follows:-

"Yes; if upon examination it is found that available lands are suitable for that purpose."

Mr. Tatlow asked the Hon, the Chief Commissioner of Lands and Works the following question :-

What amount has been expended up to date on the following works:—Barnet-Hastings Road? Reformatory site?

The Hon. Mr. Wells replied as follows:-

"Barnet-Hastings Road, \$4,981.75.

"Reformatory site, \$1,468.22."

Mr. McInnes asked the Hon, the Chief Commissioner of Lands and Works the following questions :-

Have any "fence-viewers" been appointed for Cowichan District? If so, who are they? The Hon. Mr. Wells replied as follows:

"Yes; G. Bartlett and W. R. Robertson for South Cowichan District; James Dougan and W. G. Manley for Shawnigan District."

Mr. Neill asked the Hon. the Chief Commissioner of Lands and Works the following questions :-

1. Does the Toronto and B. C. Lumber Co. hold any lease or leases of timber lands in the Alberni Electoral District?

2. If so, what are (a) the number of such lease or leases? (b) the area of such lease or

leases? (c) the annual rental of such lease or leases?

3. What is the total sum (if any) now due by the said company to the Government of B. C. on account of such timber lease or leases in the Alberni Electoral District, and inclusive of taxes, rents and interest chargeable on overdue rent?

4. What is the total sum (if any) now due by the said company to the Government of B. C. on account of any timber leases held by them within the Province, and situate outside of the Alberni Electoral District, and inclusive of taxes, rents and interest chargeable on overdue rent?

The Hon. Mr. Wells replied as follows:—

"1. Yes.

"2. (a) 2; (b) 35,661 acres and 4,251 acres; (c) \$5,349.15 and \$425.10.

"3. \$11,973.60.

"4. \$18,829.50."

Mr. Curtis moved, seconded by Mr. E. C. Smith,—

That the House do now adjourn to discuss certain phases of the railway question.

Mr. Speaker Booth: I must rule the motion out of order. No definite matter of urgent public importance is disclosed in the motion upon which a discussion can proceed. See English Rule, May, 826.

On the third reading of Bill (No. 62) intituled "An Act to Incorporate the Chilkat and Klehini Railway and Navigation Company"-

The adjourned debate on the motion moved by Mr. Curtis on the 23rd inst., as follows:-That the Bill be referred back to the Committee of the Whole, with instructions to insert the following as a new section:-

"1. The plans, specifications and conditions of any proposed contract for the construction of the railway shall be subject to the approval of the Lieutenant-Governor in Council; and that the contracts shall be submitted to public tender and competition under such conditions

as the Lieutenant-Governor in Council shall approve; and no contract shall be awarded, or work or material thereunder accepted, without the like approval; and no mortgage charge shall be put against the line of railway beyond the fair cost of same and its equipment."

Also to add a new section as follows:-

"That no aliens shall be employed on the railway during construction, unless it is demonstrated to the satisfaction of the Lieutenant-Governor in Council that the work cannot be proceeded with without the employment of such aliens—"

"An agreement made and entered into this day of A.D. 190, between the Crow's Nest Pass Coal Company, hereinafter called the 'Company,' of the one part, and His Majesty the King, represented herein by the Chief Commissioner of Lands and Works for the Province of British Columbia, of the other part:

"Whereas the Company are engaged in the production of coal and the manufacture of

coke in the Province of British Columbia and in the supply thereof in said Province:

"And whereas it is desirable to secure for the smelters and refineries in the Counties of Yale and Kootenay, in the said Province, an adequate and sufficient supply of coal and coke:

"Now therefore this Agreement witnesseth, that the parties hereto mutually covenant

and agree as follows, that is to say:-

"1. If at any time hereafter it shall appear to the Lieutenant-Governor in Council that there is reason to believe that a supply of coal and coke for use in the Counties of Yale and Kootenay is not furnished by the Company at all times, now or hereafter, in sufficient quantities to the smelters and refineries in said counties, the Lieutenant-Governor in Council may, by Order in Council, refer such question to arbitration under the provisions of the 'Arbitra-

tion Act" and amending Acts:

- "2. The Lieutenant-Governor in Council and the Company shall each appoint an arbitrator, and the two arbitrators so appointed shall select a third, and the decision of the Board of Arbitration shall be final, and the terms and conditions of their award shall be assumed and carried out by the Company until such time as the same may be superseded by any other award made hereunder; and so from time to time as occasion may require, or the Lieutenant-Governor in Council may deem necessary. The Company shall appoint their arbitrator within forty-eight hours of being notified by the Lieutenant-Governor in Council so to do, and the arbitrators shall thereafter appoint a third arbitrator within the like time; and the Board of Arbitration shall sit forthwith after appointment and continue in session de die in diem until the matters hereunder referred to them shall have been finally heard and determined:
- "3. The costs of the arbitration shall be paid and borne as the arbitrators may determine.

  "4. Pending the award, that is, between the date of the appointment of an arbitrator by the Lieutenant-Governor in Council and the performance of the conditions of any award made

hereunder, the Company shall furnish to the smelters and refineries in Yale and Kootenay, as aforesaid, a supply of coal and coke satisfactory to the Lieutenant-Governor in Council, failing which the Company shall pay to the Lieutenant-Governor in Council, as liquidated damages, the sum of two dollars per ton in respect of the shortage.

"In witness whereof the Company has caused its Common Seal to be affixed to these

presents the day and year first above written.

"The Common Seal of the Crow's Nest Pass Coal Company was affixed hereto in the presence of "

Carried.

Mr. Curtis moved—That the Bill be amended by adding a new section as follows:—

paper circulating in the district in which the railway of the Company runs:

A duplicate of each agreement referred to in this section shall, within thirty days after its execution, be filed in the office of the Provincial Secretary, and notice thereof shall be given by the Company in the Provincial Gazette, and the production of the Provincial Gazette containing such notice shall be primâ facie evidence of the requirements of this Act having been complied with."

shall be guilty of an offence under this Act.

"21c. Any person, corporation or company who shall induce or persuade any person or persons to do any act, matter or thing in contravention of the two preceding sections hereof, shall be guilty of an offence under this Act, but it shall not be deemed an offence under this or the two preceding sections if any person operates any such machinery for more than the period mentioned for the purpose of relieving another employee in case of accident, sickness, or other unforeseen cause"—
