# Thursday, February 21st, 1946.

### THREE O'CLOCK P.M.

This being the first day of the first meeting of the Twenty-first Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable WILLIAM CULHAM WOODWARD, Lieutenant-Governor of the Province, dated the 22nd day of January, 1946, the members having been sworn took their seats.

His Honour WILLIAM CULHAM WOODWARD, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

### The Honourable Mr. Pearson, Provincial Secretary, said :---

#### Members of the Legislative Assembly:

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

The Hon. Mr. Hart, first member for Victoria City Electoral District, addressing himself to the Clerk, moved, seconded by Mr. H. E. Winch, first member for Vancouver East Electoral District, that Norman William Whittaker, Esquire, member for Saanich Electoral District, do take the Speaker's chair and preside over the meetings of this Assembly, and it was so Resolved.

R. S. Stuart Yates, Esquire, the Clerk of the House, having declared Norman William Whittaker, Esquire, duly elected, he was then taken out of his place by the mover and seconder, and conducted to the chair, where, standing on the upper step, he expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

And thereupon he sat down in the chair, and the mace was laid upon the table.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect (standing on His Honour's right) then spoke to the following effect:—

#### MAY IT PLEASE YOUR HONOUR:

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

#### The Honourable Mr. Pearson then said:-

MR. SPEAKER:

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their respective proceedings will be conducted with wisdom, temper, and prudence, he grants, and upon all occasions will recognize and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech:—

### Mr. Speaker and Members of the Legislative Assembly:

I welcome you to this the first Session of the Twenty-first Parliament of British Columbia.

In doing so, I unite with you in the general thanksgiving that hostilities have ceased. The sacrifices that have been made to free the world of sinister influences and bring about peace will long remain in our memories. I rejoice with you that so many of our men and women have been spared to enjoy happy reunions with those nearest and dearest to them, and extend my sincere sympathy and condolences to those whose hearts are sad because they wait in vain for the return of their loved ones.

Their loss and grief is a challenge to all to face the future with the determination that the horrors of war shall never again be inflicted upon a peace-loving people, and that upon new foundations, established by the sacrifices made by our gallant men and women, a better world will be built where mutual understanding will supplant the distrust of the past.

It has given me great satisfaction to note that my Government has planned so well for the future and that even now many of those plans are being carried into effect for the welfare of those who are re-establishing themselves in civilian life.

Since you last met, the Province has lost an outstanding public man through the death of the Honourable K. C. MacDonald, Minister of Agriculture. He devoted a great part of his life to others, and during his long period of public service did much to encourage the development of the Province, particularly in the sphere of agriculture.

Within the past few days there passed away Mr. James Alexander Paton, a member of this Legislature since 1937. His contributions to the debates in this House 10 GEO. 6

will be missed greatly. He was a man who devoted the major part of his time to public affairs and always had the welfare of the people at heart.

During the past year, British Columbia had the pleasure and the honour of receiving a final visit from His Excellency the Earl of Athlone, Governor-General, and Her Royal Highness the Princess Alice before they concluded their term of office.

I join with the citizens of this Province in looking forward with pleasant anticipation to the occasion when Field-Marshal the Right Honourable Viscount Alexander, newly appointed Governor-General, and Viscountess Margaret will visit British Columbia.

During the course of this Session, my Government will submit measures of considerable importance.

Foremost among these will be legislation implementing the recommendations of the Royal Commission appointed to inquire into the cost of education, and which will result in lightening the tax burden on cities and municipalities.

I am gratified to learn that my Government has taken steps to conduct a survey of other Provincial-Municipal spheres of responsibility and that one of the most outstanding authorities on the subject in the Dominion of Canada has been appointed to undertake this task.

You will have placed before you for your consideration the report of the Royal Commission on Forestry. In accordance with the recommendation of the Commissioner, my Government will take appropriate steps to determine the competence of the Provincial Legislature to impose a severance tax on timber cut by purchasers of Esquimalt & Nanaimo Railway timber land.

Provision will be asked for a further \$10,000,000 to enable the British Columbia Power Commission to extend its programme of rural electrification and power development.

There will be placed before you legislation providing for the establishing of separate Departments of Health and Welfare in recognition of the increasing importance of these two services.

I am gratified to learn that considerable progress has been made in the examination of all existing surveys and reports in connection with the proposal to extend the Pacific Great Eastern Railway into the Peace River district and so to develop our vast northern resources.

Legislation will be introduced repealing the "Pacific Great Eastern Railway Aid Act" of 1925, so that the resources involved in the land grants provided therein may be retained for the people of British Columbia.

It is likewise gratifying to note that the expansion programme for the University of British Columbia already has commenced and that my Government has played so important a rôle in assisting that institution to provide additional facilities to meet the needs of those discharged from the services who are desirous of completing their education.

My Government has been represented at the several Dominion-Provincial Conferences held in Ottawa to discuss financial readjustments and social services, and I am pleased to report that satisfactory progress has been made.

Legislation will be introduced extending assistance to municipalities in connection with slum clearance.

There will be submitted to you a "Probation Act" providing for the supervision of persons convicted, and the employment and conduct and general conditions under which they shall be placed during the period of probation.

I am happy to observe that excellent progress has been made in connection with the construction of the Peace River Highway and the Hope-Princeton Road, and that my Government proposes to implement other important highway and public building programmes. Since the last Session, a land-clearing scheme to assist farmers to bring more acreage under production has been started and I am pleased to learn that it is my Government's intention to expand this service as rapidly as possible.

The financial transactions of my Government during the past year will be presented, showing a further improvement in the Province's credit position.

The Public Accounts will be presented and Estimates for the ensuing year will be submitted.

Minor legislation designed to improve existing Acts will be placed before you.

I pray that the blessing of Divine Providence may rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. H. E. Sexton, Bishop of British Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

The Certificate of the Deputy Provincial Secretary of the result of the election of members to represent the respective electoral districts of the Province in the Legislative Assembly at the general election was read, as follows:—

"Whereas His Honour the Lieutenant-Governor, by Proclamation dated the thirtyfirst day of August, 1945, was pleased to dissolve the Legislative Assembly of the Province:

"1. 37.839.

"2. Yes.

"NOTE.—There are some twelve hundred registered doctors in British Columbia."

Mr. E. E. Winch asked the Hon. the Minister of Education the following questions:—

1. What is the known or estimated number of children of school age, whose intelligence quotient is below eighty, who would benefit by the facilities of special classes for retarded or mentally deficient children?

2. What classes, if any, exist in the public schools of the Province for the training of children of school age with an intelligence quotient under eighty?

3. What number of children attend same?

The Hon. Mr. Weir replied as follows:-

"1. Tests of general intelligence are made by most School Boards, but not by the Department of Education. The total number in any intelligence age-group in the Province is therefore not known. It is thought that the children in British Columbia do not differ from similar groups in other parts of Canada in this respect. Normal distribution indicates that approximately 7 per centum of the total numbers tested would have intelligence quotients below eighty.

"2. Special classes for retarded children are held in Vancouver and Victoria.

"3. In Victoria, 57, and in Vancouver, 399."

Mr. *Gargrave* asked the Hon. the Minister of Lands and Forests the following questions:--

1. Have any members of the Forest Branch service above the rank of assistant forest ranger left the service in the past year?

2. If yes, how many and positions held?

The Hon. Mr. Kenney replied as follows:--

"1. Yes.

"2. Forty-three. Details of positions held are given hereunder:---

"Resigned (Technical and Field Staff): 1 Forester (in charge of Operation Division), 3 Assistant Foresters (2 Economics Division and 1 Management Division), 1 Forest Ranger, and 1 Scaler.

"Resigned (Clerical and Stenographic): 33, including 19 temporary employees.

"Superannuated: 1 District Forester, 1 Assistant Forester, 1 Ranger, and 1 Chief Clerk."

Mr. E. E. Winch asked the Hon. the Minister of Education the following questions:---

1. Since February, 1943, has any survey been made of the needs of post-war education in this Province?

2. If yes, did such survey take into consideration a probable influx of new population into this Province after the war and the need to develop skills for new industry and agricultural development?

3. Has any estimate been made of the probable costs of post-war plans for education?

4. Has any survey been made for school building needs?

5. Has any plan been drawn up for a school building programme?

6. If yes, did such programme pay particular attention to the construction of adequate rural schools?

7. Has any survey been made of teacher needs, with particular emphasis upon the new types of specialized and vocational teaching?

8. Have plans been made for more extensive teacher-training?

9. Has any study been made of the constitutional aspects of Dominion grants to education?

10. Has consideration been given to setting the school-leaving age at 16 and a system of compulsory part-time education to the age of 18?

The Hon. Mr. Weir replied as follows :---

"1. A survey is now proceeding in connection with the establishment of large School Administrative Areas.

"2. Yes.

"3. See answer to No. 1.

"4. Yes; see answer to No. 1.

"5. Each School Administrative Area will prepare such a plan, which will be submitted to the Department of Education for approval.

"6. Yes.

"7 and 8. A committee of the Department of Education, the University, and the Normal Schools, with a representative of the Teachers' Federation, is studying the question of teacher-training in all its aspects.

"9. The principle of Dominion grants to education is embodied in the 'Vocational Training Co-ordination Act' and the 'National Physical Fitness Act,' which are both Federal statutes.

"10. This matter is being studied."

Mr. E. E. Winch asked the Hon. the Minister of Education the following question:--

What support is (a) provided and (b) available from Government resources toward the cost of providing hot free meals for children attending school?

The Hon. Mr. Weir replied as follows :---

"(a) Rural school districts are given a grant of 50 per cent. of the cost of the equipment necessary to prepare hot lunches; (b) 33,000 was voted for this purpose in the fiscal year 1944-45 and a like amount in 1945-46 (see Vote 72 (b))."

Mr. E. E. Winch asked the Hon. the Provincial Secretary the following questions:---

1. What number of patients are in residence in the Provincial Infirmary at Marpole?

2. What number, if any, of applications for admission are on the waiting list?

3. What is the estimated number of persons in the Province whose physical condition is such as to warrant provision for care and treatment similar to that now provided in the Provincial Infirmary?

The Hon. Mr. Pearson replied as follows:-

"1. Provincial Infirmary has 142 patients in residence.

"2. Number of applications for admission on waiting list: 123 recommended, plus 15 under study; of these, 92 are now being cared for in hospitals and 6 in licensed welfare institutions.

"3. Number of persons estimated in the Province whose physical condition is such as to warrant provision for care and treatment similar to that now provided in the Provincial Infirmary: Infirmary applications received at rate of two per day; estimate 300 or more in hospitals; field service staff active; no known need is neglected."

*Resolved*, That the House, at its rising, do stand adjourned until 3 o'clock p.m. to-morrow.

"2. (a.) (i.) One D-8 Caterpillar tractor, towing winch, logging arch, and angle dozer blade; (ii.) one Allis-Chalmers HD-10 Crawler tractor, towing winch, angle dozer blade, and special clearing blade; (iii.) two model TD-18 International Trac tractors equipped with winch hoists and special clearing blades. (b.) (i.) War Assets Corporation, Vancouver, B.C.; (ii.) Rendell Tractor & Equipment Co., Vancouver, B.C.; (iii.) Galbraith & Sons, Vernon, B.C. (c.) (i.) \$13,000; (ii.) \$14,125.95; (iii.) \$24,437.80. (NOTE.--Two HD-7 Allis-Chalmers Crawler tractors have been ordered and are now in Vancouver being equipped with auxiliary machinery; delivery has not yet been taken. Three D-7 Caterpillar tractors have been ordered, but, owing to labour conditions in the United States, delivery may be delayed until early summer.) "3. Only in exceptional cases."

Mr. E. E. Winch asked the Hon: the Provincial Secretary the following question:----Are the "findings and recommendations" of the Superintendent and the Superintendent of Child Welfare available to members of the Legislature (vide forty-first annual report, Provincial Industrial School for Boys, page L 6, paragraph 5)?

The Hon. Mr. Pearson replied as follows:---

"Yes; copies will be available shortly to members of the House."

Mr. Harding asked the Hon. the Minister of Agriculture the following questions:-1. Has the Government as yet decided on the locations for their land-clearing units?

2. If yes, (a) is a unit to be located in the Kootenays and (b) at what location? The Hon. Mr. Putnam replied as follows :---

2. On what basis and facts are present electric light rates or monthly cancellation of light bills established?

3. By whom are these facts submitted to the Public Utilities Commission?

4. Does the Public Utilities Commission make any check to verify the correctness of the information supplied?

5. Is the securing of any new data on British Columbia Electric Railway Company, Limited, operations contemplated by the Public Utilities Commission?

The Hon. Mr. Hart replied as follows :---

"1. 1943, but since appointment of new Chief Engineer of Commission on November 13th, 1945, an investigation and audit has been undertaken and is still in progress.

"2. After hearings and on consideration of Commission's appraisal and report on properties and earnings of the companies and of reports required from the companies as to operations in subsequent years.

"3. Commission's appraisal and report were submitted by Commission's Chief Engineer. Annual reports of operations are filed annually by British Columbia Electric Railway Company, Limited. Supplementary information is submitted as required by the Commission by British Columbia Electric Railway Company, Limited.

"4. Yes.

"5. Yes."

Mr. Harding asked the Hon. the Minister of Public Works the following question :---

In the fiscal year ended March, 1945, what was the total amount paid in wages and salaries to the permanent staff in the Public Works Department at New Denver?

The Hon. Mr. Anscomb replied as follows :---

"\$9,843.50."
