Mr. Speaker delivered the following decision with regard to Bill (No. 39) intituled "An Act to amend the 'Workmen's Compensation Act,' standing on the Order Paper for second reading in the name of Mr. E. E. Winch:—

Honourable Members,—A perusal of Bill (No. 39) intituled "An Act to amend the 'Workmen's Compensation Act,'" and after reference to decisions given on similar Bills, leads me to the conclusion the Bill is out of order in the hands of a private member.

Similar Bills previously have been before the House and when not withdrawn have been ruled out of order.

The history of such decisions shows that they have been based upon the objections that such Bills affected the revenues of the Crown, and violate section 52, chapter 45, R.S.B.C. 1924, the "Constitution Act," and Standing Order 67. (See Speakers' Decisions, Vol. I., p. 132, Mr. Speaker Eberts, March 10th, 1910; Vol. II., p. 57, Mr. Speaker Manson, November 24th, 1921; Vol. II., p. 57, Mr. Speaker Pauline, December 4th, 1923; Vol., II., p. 58, Mr. Speaker Jones, February 3rd, 1930.)

I have been concerned as to whether the payments made to the Workmen's Compensation Board could be classed as Crown revenue.

Section 53, chapter 278, R.S.B.C. 1924, the "Workmen's Compensation Act," in part is as follows: "All moneys belonging to the Accident Fund collected or received by the Board shall be delivered to the Minister of Finance, or may be deposited to his credit in such banks throughout the Province as he may designate, and all moneys so delivered or deposited shall be credited by the Minister of Finance to the Accident Fund, and shall be accounted for as part of the Consolidated Revenue Fund of the Province. No moneys collected or received on account of the Accident Fund shall be expended or paid out without first passing into the Provincial Treasury and being drawn therefrom as provided in this Part."

This clearly states both revenues and expenditures are passed in and out of the Provincial Treasury, and therefore affect Crown revenues and expenditures. I must therefore rule the Bill out of order.

MR. SPEAKER:

Your Select Standing Committee on Forestry begs leave to report as follows:-

- 1. Our meetings have been addressed by the Chief Forester, who dealt with general policies of the Department. We also had representations from the British Columbia Loggers' Association and others. The Assistant Chief Forester spoke to us on research-work in reference to forest regeneration and reproduction.
- 2. We particularly recommend, at this time, continuance and extension of the Young Men's Forestry Training Plan which proved so successful last year.

- 3. We recommend that especial attention be given to extension of the work of forest-protection, so that our young stands may be better protected against the ravages of forest fires.
- 4. We commend the good work done each year by the Canadian Forestry Association. We believe that future policy may well lie in the co-ordination of all educational and publicity effort under the Forest Branch.
- 5. We recommend that more intensive research-work be undertaken, and that therein the co-operation of the University of British Columbia and of the timber and pulp and paper industries be invited.

We wish specially to commend the Forest Branch for its effective action in carrying out many of the recommendations in our report tabled in this House at last Session.

MR. SPEAKER:

Your Select Standing Committee on Fisheries begs leave to report as follows:—

Your Select Standing Committee on Fisheries has met on various occasions throughout the present Session.

That in the interests of the propagation of salmon we recommend that the Provincial Department of Fisheries ask the Department of Fisheries at Ottawa to have various small streams on spawning-grounds cleared of fallen timber which now impedes the passage of salmon to same for the purpose of natural spawning.

We would urge that serious consideration be given to the matter of the closing-down of the nine hatcheries on this Coast, and suggest that at least one or two of them be left in operation at the headwaters of the spawning-ground.

We also reiterate a previous recommendation that in the matter of issuance of cannery licences the Fisheries Department use their efforts to devise ways and means of a more equitable regulation of these fees.

We would also respectfully call attention to the recommendation of the Canadian Halibut Fishing Vessel Owners' Association of Prince Rupert in advising their affiliated boat-owners to refuel their boats in the northern waters at Craig or Ketchikan, Alaska, in view of the fact that gasoline at these points may be purchased at 10.2 cents per Imperial gallon as compared with a cost of 20.5 cents per gallon at Prince Rupert.

- "5. (a) and (b) Maintenance and repairs are grouped in one account, \$484,504.90; (c) \$436,798.17.
 - "6. (a) \$417,297.17; (b) \$21,231.20."

Mr. E. E. Winch asked the Hon. the Minister of Lands the following questions:—

- 1. Has any acreage at Sumas previously acquired by the Columbia Tobacco Company for tobacco-raising reverted to the Government?
 - 2. If yes: (a) What was the original acreage acquired; (b) what acreage has reverted? The Hon. Mr. Gray replied as follows:—
- "1. No. (If question refers to Canadian Tobacco Company answer is the same, forfeiture pending.)
 - "2. Answered by No. 1."

Mr. Bakewell asked the Hon. the Minister of Lands the following questions:-

- 1. What is the total amount received by the Government on Sumas lands sold by Fell & Scharfe?
 - 2. Principal and interest?
 - 3. Total amount of commissions paid?
 - 4. Over what period of time were these sales made?

The Hon. Mr. Gray replied as follows:-

- "1. \$208,266.04.
- "2. Principal, \$191,702.88; interest, \$16,563.16.
- "3. \$92,952.24.
- " 4. March, 1930, to April, 1933."
