THREE O'CLOCK P.M.

This being the first day of the fifth meeting of the Nineteenth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable Eric Werge Hamber, Lieutenant-Governor of the Province, dated the 24th day of September, 1940,

His Honour Eric Werge Hamber, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I welcome you to the Fifth Session of the Nineteenth Parliament of British Columbia. Since the last Session of this Legislature His Majesty the King has been pleased to appoint the Earl of Athlone as his representative in Canada. As Governor-General of the Dominion, His Excellency has already brought to his office that high sense of duty and devotion to the interests of the Dominion and the Empire that have, in the past, distinguished his life and career, and to him and to his Royal Chatelaine, the Princess Alice, our Province extends most cordial welcome.

The war, which started in September, 1939, is still waging in more frightful form than ever. Notwithstanding all that has happened, Great Britain stands stronger than ever as the bulwark of freedom and liberty. Into this conflict the people of Canada are bringing to bear the full weight of their resources in man-power, material, and money.

From within our own Provincial boundaries many hundreds of trained troops have left for various destinations and many more are being rapidly trained in numerous camps throughout the Province. To them, and to those men who remain to guard our shores, we extend heartfelt good wishes in the services which they are rendering for the maintenance of civilized society and for the cherished freedom which is our heritage.

The people of British Columbia, in common with the rest of Canada, view with great satisfaction the appointment of a joint Defence Council representing the United States of America and the Dominion of Canada, which Council is taking such preliminary steps as may be deemed necessary to ensure the security of our shores against possible aggression.

The joint official opening of the new King George VI. Highway, which is part of a vital link connecting the two countries, is another symbol of the close friendship existing and being further strengthened between the United States of America and Canada.

Amendments to the "Teachers' Pensions Act," the "Provincial Elections Act," the "Forest Act," and various other Acts will be submitted for your consideration.

The Public Accounts will be presented and Estimates for the ensuing year will be laid before you.

I pray that the blessing of Divine Providence may rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. H. E. Sexton, Lord Bishop of Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

The Certificate of the Deputy Provincial Secretary of the result of the by-election of a member to represent the Electoral District of Mackenzie was read, as follows:—

Forester, Kenney, Straith, Maitland, and H. E. Winch.

That this House in reverence and affection expresses its great regret at the loss of life with the going-down of His Majesty's destroyer "Margaree," many of the personnel of which were British Columbians, and extends to the bereaved deepest sympathy and regard.

- "3. To date, 3,359 acres; this year, 1,084 acres; additional planting of about 350 acres now in progress.
 - "4. About \$11.20 per acre."

- Mr. Maitland asked the Hon. the Minister of Trade and Industry the following questions:-
- 1. What is the total amount expended by the Province of British Columbia in connection with the San Francisco Fair?
- 2. How many persons were sent by the Government to San Francisco in connection with the British Columbia exhibit?
 - 3. What is the total amount expended on the San Francisco Fair in travelling expenses? The Hon. Mr. Asselstine replied as follows:—

- . Mr. Maitland asked the Hon. the Minister of Trade and Industry the following questions:—

The Hon, Mr. Asselstine replied as follows:-

 - 4. If so, what was the cost of the said broadcast?
 - 5. What was the cost of advertising the said broadcast?

The Hon. Mr. Pattullo replied as follows:-

- "1 and 2. A Return has been made, giving information requested.
- "3. Yes.
- " 4. \$25.
- " 5. \$148.30."

Mr. Maitland asked the Hon. the Premier the following questions:—

- 1. Has the Government made any representation to the Dominion Government or Board of Transport in reference to freight rates on mill-feed and feed-grain since December 9th, 1938?
- 2. If so, what was the nature of such representation and what was the result of the same?

The Hon. Mr. Pattullo replied as follows:-

- " 1. Yes.
- "2. A request for further lowering of freight rates and inclusion of wider range of feed-stuffs under the schedule. The results were, in addition to the special rates shown in Supplement 21 to Tariff No. 145, effective June 24th, 1940, additional advantage to users of feed-grain in British Columbia has been secured in that the tariff rates are protected on certain off-grades, such as Nos. 5 and 6 special wheat, sample wheat heated, sample wheat bin heated, sample wheat mixed heated, sample bin burnt, Nos. 4, 5, and 6 mixed wheat, No. 1 mixed grain, under ruling issued to freight agents in 1940. Also, under further ruling of September, 1940, the following have been included for protection under C.F.A. Tariff No. 145: Car-loads of wheat, oats, or barley on which the Federal Inspection Certificate contains the word 'Sample' before the species of grain and the word 'Heated' following."

Mr. E. E. Winch asked the Hon. the Minister of Public Works the following questions:-

- 1. What was the contract price for the erection of the new Women's Gaol at Oakalla?
- 2. What extras, if any, have been incurred in the construction of same?
- 3. What was the construction cost per cubic foot of: (a) New Women's Gaol; (b) T.B. Hospital Unit, Vancouver; (c) new Nurses' Home at Essondale.

The Hon. Mr. Leary replied as follows:-

- "1. \$63,000.
- "2. Contract not completed.
- "3. (a) 40 cents; (b) 37 cents; (c) 19 cents."

Mr. E. E. Winch asked the Hon. the Minister of Public Works the following questions:—

- 1. Have plans been drawn for the erection of a new laboratory building at the University of British Columbia?
 - 2. Has a contract been let for the construction of such a building?
 - 3. If such contract has not been let, is it proposed to do so during the coming year?

The Hon. Mr. Leary replied as follows:-

Mr. Eyres asked the Hon. the Minister of Public Works the following questions:-

- 1. Has the Government purchased any or all of the land necessary for the 1-mile road extension from the port of entry at Huntingdon to the Trans-Canada Highway, known as "C" Street Extension?
 - 2. If so, what price was paid for this property?

The Hon. Mr. Leary replied as follows:-

Mr. H. E. Winch asked the Hon. the Premier the following questions:—

- 1. Is the Premier in receipt of complaints relative to housing shortage and rental charges in the City of Prince Rupert?
 - 2. If so, is any remedial action being taken?
 - 3. If no action yet taken, is any contemplated?

The Hon. Mr. Pattullo replied as follows:--

- "1. Yes; one from Prince Rupert C.C.F. Club.

It may be pointed out also that a student who has enlisted for war service may enrol for our correspondence lessons, and in that way would have an opportunity of gaining full university entrance standing at any time in the year that the work is completed to the satisfaction of our High Correspondence School. Such a student would not need to wait for the annual examinations in June or August, 1941.

It may be noted that in another letter addressed to the Provincial Secretary under date of December 20th, 1938, one month before leaving the Department, Dr. Cassidy wrote in part as follows: 'Under your regime more has been accomplished, I believe, to build up efficient, modern health and welfare services in British Columbia than in any other similar period of time. To you and to the Government which has supported your progressive moves great credit is due for these advances.' The letter mentioned in the questions refers to a report written by Dr. Cassidy on his own initiative in Chicago, Illinois, U.S.A., several months after leaving the employ of the Department. This report, while containing a number of useful suggestions which have been given careful consideration by the Department, dealt with many

matters completely beyond the jurisdiction of the Department itself and also beyond the jurisdiction of Dr. Cassidy while he was Director of Social Welfare. The recommendations of the report, if carried out, would involve the creation of at least one additional portfolio and a very considerable number of additional departmental bureaus, divisions, committees, and boards. The additional trained personnel which would be required to carry out the functions of these various bureaus does not exist in British Columbia, and it is doubtful whether a sufficient number could be found available in Canada. The cost to the Provincial Treasury of carrying out the recommendations contained in the report was estimated by Dr. Cassidy himself at approximately \$700,000, and the Department has good reason for assuming that, if the cost is estimated by Dr. Cassidy at \$700,000, the actual cost would be well in excess of \$1,000,000."

Prayers by the Rev. George Biddle.

The Hon. Mr. Pattullo rose and read to the House the following statement with reference to the report of the Rowell-Sirois Commission:—

"On Monday of this week I received a communication from Prime Minister Mackenzie King with reference to report of the Rowell-Sirois Commission. A copy of this letter was presented to Parliament to-day by the Prime Minister. "In view of the fact that Prime Minister King has stated in his letter that in the opinion of the Dominion Government the adoption of the Commission's recommendations is necessary to put our country in a position to pursue a policy which will achieve the maximum war effort and at the same time lay a sound foundation for post-war reconstruction, it seems to me that I should make a statement to this Legislature as to the position of the Provincial Government.

"I had heretofore refrained from making any pronouncement because I felt that no definite and unalterable commitment should be made until opportunity had been afforded to discuss the whole situation with the Dominion Government and the other Provinces. I have stated upon many occasions that it is the desire of this Government to co-operate to the full with the Dominion and the Provinces looking to adjustments on a mutually satisfactory basis, and that this would necessarily involve some give and take.

"Prior to the submission by Prime Minister King of his letter to Parliament, I telephoned to Mr. King. He advised me that while the Dominion Government was making known its general attitude towards the report of the Rowell-Sirois Commission, that at the conference which it is proposed to hold in January his Government was prepared to hear representations of all the Provinces and to make any adjustments which circumstances and conditions appeared to dictate.

"I look upon the report of the Rowell-Sirois Commission as of most valuable character, but this Government is not prepared to accept the recommendations of this report in toto as suitably applicable to British Columbia. I do not agree with all its conclusions, and the very bases upon which those conclusions were arrived at by the Commission have, in this already short space of time, very considerably altered and have changed the picture.

"I submit that there are five economic and social units in Canada—the Maritimes, Quebec, Ontario, the Prairie Provinces, and British Columbia—and while I think it is desirable that as far as possible the same yardstick shall apply to all, the fact is that in a country as far flung as Canada it is not possible that a single measure would meet the circumstances of each individual Province. There must be a degree of elasticity. It is this lack of elasticity that has brought about the present situation.

"I know that the people of this Province are prepared to make any necessary sacrifice in winning this war and that that object is beyond all else, but this Government will not concur in enactments of permanent character which may, and in considerable probability, will, be inapplicable to conditions which may arise after and out of the war.

"There are those who would advocate placing in the hands of the Federal authority plenary powers even to the extent of those which are now exercised during this war period. In peace time such authority could only lead to disruption and disunity. Undue centralization of any kind would be harmful. There are certain jurisdictions which should be exclusive to the Dominion and the Provinces respectively and these should be clearly and definitely stated. There are other jurisdictions where joint participation would appear desirable. These also should be clearly defined.

"This Government proposes to co-operate to the full with the Federal Government and other Provincial authorities to reach common ground, but in so doing we must not sacrifice the well-being of British Columbia."

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

The debate continued.

On the motion of Mr. Uphill, the debate was adjourned to the next sitting of the House.

On the motion of the Hon. Mr. Pattullo, seconded by the Hon. Mr. MacDonald, it was Resolved,—

Mr. Eyres asked the Hon. the Provincial Secretary the following question:-

What was the total cost of the Macdonald Report to the Province up to 1940?

The Hon. Mr. Weir replied as follows:-

"See Public Accounts."

Mr. Maitland asked the Hon. the Minister of Education the following questions:-

- 1. How many students failed in the junior matriculation examinations held in June, 1939?
- 2. How many of those failed were passed in the supplementary examinations held in August, 1939?

The Hon. Mr. Weir replied as follows:-

- "1. In June, 1939, 694 candidates wrote a full university entrance (junior matriculation) examination. Of these, 409 passed in all subjects and 281 were granted partial standing; 4 failed in all subjects.
- "2. One hundred and eighty-four candidates who had failed in June were successful in completing university entrance in August, 1939.
- "Notes.—(1.) In addition to the number specified above who wrote on the full examination in June, 1939, there were 4,413 candidates who wrote a partial examination. These candidates were mostly Grade XI. students who had completed two or three subjects of university entrance at the end of that grade; 3,002 were successful in gaining standing. (2.) A candidate who fails in June and August may return to school and take not only the subjects in which he has failed but also a sufficient number of other subjects of the same or a higher grade to make a full year's work. Moreover, any candidate who fails in university entrance in June or August may complete his studies by correspondence and is granted full standing at any time in the year that he completes the work and reaches the standard required by our High Correspondence School."
 - Mr. E. E. Winch asked the Hon. the Provincial Secretary the following questions:—
- 1. Has any member of the nursing staff of any tuberculosis or other hospital under Provincial administration developed symptoms of tuberculosis which has necessitated leaving work and taking medical treatment during the past twelve months?
- 2. If yes, is compensation paid to such staff employees during the period of their partial or total disability?
- 3. What number of Provincial public or private hospital employees were admitted to any tuberculosis unit for treatment during 1939 and 1940, respectively?

- "1. Yes; the unknown case of tuberculosis in an institution represents the main problem. Every endeavour is being made to bring these to light. Many new steps have been taken in the last two years to prevent tuberculosis among hospital employees.
- "2. No compensation is paid to any hospital employee who develops tuberculosis. They, however, are given free treatment in a Provincial institution.
- "3. While the occupations of patients admitted to tuberculosis units are known, it is impracticable to state definitely in every case where a patient was in fact employed immediately prior to admission. It is estimated, however, that approximately thirty-nine admissions were of employees from Provincial public and private hospitals during the period January 1st, 1939, to September 30th, 1940, and it may be noted that of these, seven cases were admitted from the Mental Hospital, four from the Vancouver tuberculosis unit, three from the Tranquille unit, and six from the Vancouver General Hospital. The above figures include employees generally."

- 1. How many students failed in the senior matriculation examinations held in June, 1939?
- 2. How many of those failed were passed in the supplementary examinations held in August, 1939?

- "1. In June, 1939, 472 candidates wrote a full senior matriculation examination; of these, 274 passed in all subjects and 198 were granted partial standing.
- "2. Eighty-nine candidates who had gained partial standing in June were successful in completing senior matriculation in August, 1939.
- "Notes.—(1.) In addition to the number specified above who wrote on the full senior matriculation examination in June, 1939, there were 692 who wrote a partial examination; 535 were successful in gaining standing. (2.) Students of senior matriculation who fail to gain standing at the supplemental examinations in August are in much the same position as students who do not gain standing at the end of the first year in the university and fail in the supplemental examinations held at the university in September. There is, however, this difference: Senior matriculants who have taken the June and August examinations set by the Department of Education in any year and do not gain complete standing may register for our senior matriculation correspondence courses. If they complete the required work during the year to the satisfaction of our High Correspondence School and for some good reason want official standing before June of the following year, it is possible to arrange a special examination for them."

Mr. Paton asked the Hon. the Minister of Education the following questions:-

- 1. How many students tried the junior matriculation examination in 1939-40?
- 2. How many students failed in the examination?

The Hon. Mr. Weir replied as follows:-

"1 and 2. In June, 1940, 7,143 candidates wrote on the university entrance examinations. Many of these were Grade XI. students who had completed one or two subjects of university entrance at the end of that grade; 2,187 gained full standing and 4,676 partial standing; 280 candidates failed. In August, 1940, 1,226 candidates wrote on the university entrance examinations, of whom 408 gained full standing and 581 partial standing; 237 failed.

"Note.—A candidate who fails in June and August may return to school and take not only the subjects in which he has failed but also a sufficient number of other subjects of the same or a higher grade to make a full year's work. Moreover, any candidate who fails in university entrance in June or August may complete his studies by correspondence and is granted full standing at any time in the year that he completes the work and reaches the standard required by our High Correspondence School."

Mr. Anseomb asked the Hon. the Minister of Trade and Industry the following questions:—

On the motion of the Hon. Mr. Pattullo, seconded by the Hon. Mr. Wismer, it was Resolved,—

That on Wednesday, November 13th, and all following days of the Session there shall be two distinct sittings in each day, one from 2 p.m. to 6 p.m. and the other from 8 p.m. until adjournment, unless otherwise ordered.

The Hon. Mr. Weir presented the Annual Report of the Mental Hospitals for the Year ended March 31st, 1940.

Mr. Eyres asked the Hon. the Provincial Secretary the following questions:—

- 1. What was the per diem educational cost per pupil in the Chilliwack Municipality and Chilliwack City in the year 1929, both in high and elementary schools?
 - 2. What was the per diem educational cost per pupil in the same areas in 1939?
 - 3. What percentage of such cost was borne by the Department in (a) 1929 and (b) 1939? The Hon. Mr. Weir replied as follows:—
- "1. (a.) Chilliwack City: According to the annual report submitted by the School Board the total cost to the city for the school-year 1928–29 was \$46,879.54; of this amount \$34,769.82 was for ordinary expenses and \$12,109.72 for extraordinary expenses. In the same school-year the Government contributed \$12,495 for ordinary expenses and a grant of \$34,866.68 towards the cost of a new building. The total of ordinary expenses was \$47,264.82. The number of pupils enrolled was 681. The average cost per pupil on the basis of ordinary

expenditures was \$69.40 per annum, of which the Government contributed 26.4 per cent. (b.) Chilliwack District Municipality: According to the annual report submitted by the School Board the total cost to the district municipality for the school-year 1928-29 was \$37,058.91. In the same year the Government contributed \$20,141.25. The total cost for the school-year was \$57,200.16. The number of pupils enrolled was 1,042 and the average cost per pupil \$54.89 per annum, of which the Government contributed 35.2 per cent. (c.) Chilliwack City: According to the annual report submitted by the City School Board the total cost to the city for the school-year 1938-39 for the elementary school was \$15,730.07. The Government contributed \$7,783.27. The total cost for the school-year was \$23,513.34. The enrolment of pupils was 482 and the average cost per pupil \$48.78 per annum, of which the Government contributed 33.1 per cent. (d.) Chilliwack District Municipality: According to the annual report submitted by the School Board the total cost to the district municipality for the school-year 1938-39 was \$34,588.13. In the same year the Government contributed \$30,568.60. The total cost for the year was \$65,156.73. The number of pupils enrolled was 1,359 and the average cost per pupil \$47.94 per annum, of which the Government contributed 46.9 per cent. (e.) Chilliwack High School Area (comprising the city and district municipality): According to the annual report submitted by the Board of the High School Area for the school-year 1938-39 the total cost to the area for that year was \$88,040.77, of which \$28,000 was a capital expenditure covering the purchase of school-buses and \$33,025 was for new school-sites and construction of school buildings. The ordinary expenditures, including debt charges and sinking fund but not including the capital expenditure for school-buses, were therefore \$27,015.77. In the same year the Government contributed \$13,120.48. The total amount of ordinary expenses, exclusive of capital expenditure for school-buses, was \$40,136.25. The number of pupils enrolled was 503, and the average cost on basis of this ordinary expenditure was \$79.79 per pupil, of which the Government contributed 32.6 per cent. The Government also contributed 40 per cent. of the cost of a new school building.

- "2. Answered by No. 1.
- "3. Answered by No. 1."

Apples: 1936, 4,625,098 boxes, valued at \$4,336,820; 1937, 5,798,312 boxes, valued at \$5,136,458; 1938, 6,048,523 boxes, valued at \$4,886,929; 1939, 6,208,261 boxes, valued at \$5,151,413. Apricots: 1936, 3,853 crates, valued at \$4,042; 1937, 158,015 crates, valued at \$122,048; 1938, 187,964 crates, valued at \$155,442; 1939, 177,150 crates, valued at \$149,728. Peaches: 1936, 82,889 crates, valued at \$66,599; 1937, 417,313 crates, valued at \$288,758; 1938, 391,270 crates, valued at \$251,668; 1939, 530,973 crates, valued at \$350,029. Prunes: 1936, 238,525 crates, valued at \$114,209; 1937, 330,088 crates, valued at \$160,029; 1938, 340,648 crates, valued at \$164,305; 1939, 455,981 crates, valued at \$162,234.
- "Note.—Figures include shipments, bulk, and manufactured by-products. Values are based on returns received from shippers on an f.o.b. basis, and include such charges as cost of containers and packing charges.
- "4. No information. It would be almost impossible to arrive at the exact farm values, due to the fact that there is a lack of uniformity in packing and container costs, not only in different centres but with regard to different fruits as well.
- "5. The McGregor Investigation reports freight and protection from Valley points to Regina, 57 cents, and to Edmonton, 48 cents per box. - "2. Major S. F. M. Moodie was appointed Chief Civilian Protection Officer (A.R.P.) for British Columbia, and Inspector, British Columbia Provincial Police.
 - "3. \$250 per month."

Mr. Paton asked the Hon. the Minister of Agriculture the following questions:-

- 1. What is the total tree-fruit crop of the Okanagan District for 1940?
- 2. For what portion has a market been found or can reasonably be expected to be marketed as fresh fruit?
 - 3. What portion remained unpicked?
 - 4. What is being done to conserve fruit surplus to present market requirements?

The Hon. Mr. MacDonald replied as follows:-

- "4. Large quantities of apples being either canned, dehydrated, or manufactured into juice. Exact data not available until end of shipping season."

- 1. Are data available relative to the number or percentage of Workmen's Compensation permanent partial disability cases who are rehabilitated in (a) the industry in which they were injured, (b) in another occupation, or (c) not rehabilitated?
- 2. Do some industries make a general practice of re-engaging permanent partial disability cases?
 - 3. If yes, what industries or particular employers do so?

The Hon. Mr. Pearson replied as follows:-

- "1. The Workmen's Compensation Board advises that no record is kept of disabled workmen who are rehabilitated through their efforts. They state that, generally speaking, employers co-operate with the Board in an effort to find suitable employment for a disabled workman where he cannot follow the occupation engaged in before his accident. Frequently it is found that the employer cannot find suitable employment, but the Board advises that it is only the occasional employer who makes no effort to co-operate with them in this regard.
 - "2. Answered by No. 1.
 - "3. Answered by No. 1."
 - Mr. E. E. Winch asked the Hon. the Minister of Labour the following questions:—
- 1. On what date was the Twenty-third Annual Report of the Workmen's Compensation Board received from the Board?
 - 2. On what date was this report placed with the King's Printer?
 - 3. On what date was the printed report made available to the public?
- 4. If a lengthy delay occurred between the receipt of the report from the Board and it becoming available to the public, what was the reason for same?

- "3. (a) \$409.815 to October 31st, 1940, and (b) \$79,773 to October 31st, 1940."

Mr. H. E. Winch asked the Hon. the Minister of Labour the following questions:-

- 1. Has the Minister received complaints or protests relative to building contractors contravening the principles and regulations of hours of work statutes and conditions of employment as outlined in labour agreements on defence and war contract construction?
- 2. If so, has any complaint been lodged with governing or administrative authorities at Ottawa?
- 3. What action has been taken to protect working conditions and standards in this Province?

The Hon. Mr. Pearson replied as follows:-

- "1. Occasionally employees employed on Dominion Government contracts do, in error, refer questions involving wages and conditions of labour to the Provincial Department of Labour. Wherever this occurs our Department gives all possible assistance in directing complaints to proper quarter for redress, namely, the Federal Department of Labour.
 - "2. Answered by No. 1.
- "3. Dominion Government policy governing fair wages, conditions of labour, and hours of work."

Mr. Shepherd asked the Hon. the Minister of Fisheries the following questions:-

- 1. Has the Department any report on the rock-slide at Hell's Gate in the Fraser River in 1913?
- 2. If so, has satisfactory action been taken to assure free passage of salmon to the spawning-grounds?

The Hon. Mr. Pearson replied as follows:-

"1 and 2. Salmon conservation in British Columbia is the responsibility of the Federal Government."
