Prayers by the Rev. *Baugh Allen*.

Mr. *Williams* asked the Hon. the Minister of Lands the following questions:—

1. Have any pulp leases been granted during the period January 1st, 1914, and January 31st, 1915?
2. If so, to whom, for what quantity (estimated), and on what conditions and price?
3. Has any undertaking or promise been made to any parties that leases will be granted?
4. If so, to whom, for what quantities, and on what conditions and price?

The Hon. Mr. *Ross* replied as follows:—

"1. No pulp leases have been granted since the provision therefor was repealed in 1903. It was provided by section 9 of the 'Forest Act Amendment Act' last session that holders of pulp leases issued under the Act of 1901 might surrender these leases for fresh leases containing the same terms and conditions, the only change being that the royalty on pulp-wood was raised to 25 cents a cord from the commencement of the new leases. The existing leases were duly surrendered, and new leases are being issued accordingly.

"2. The following sales of pulp timber, in accordance with the 'Forest Act,' have been made to the B.C. Sulphite Fibre Company, Limited, whose plant is at Mill Creek, Howe Sound, after due advertising, by the terms of which the Company pay an annual rental at 10.93 cents per acre, cost of cruising, advertising, and Forest Protection Fund contribution, and the following stumpage:—

"The prices for saw timber in the above sales are those which would be set were an ordinary timber sale being made. The pulp-wood prices are dictated by the fact that considerable expenditure is necessary in opening up the somewhat inaccessible areas in question, and the pulp-wood stumpage is of low value, being material that would not ordinarily be logged.

"3. I have reason to believe that these sales will be duly completed with the B.C. Sulphite Company. No guarantee can, of course, be given to that Company unless it contracts to comply with the conditions of each sale and makes the necessary deposits.

"4. Answered by the preceding replies."
