Honourable Members:

I have given further consideration to the matter raised under Standing Order 35 by the Honourable the Leader of the Opposition relating to the matter of a shortage of railway boxcars.

In a preliminary way I indicated to the Honourable Member that the matter had some days ago been raised during question period and therefore did not appear to meet one of the requirements of Standing Order 35, namely, that the matter be raised at the earliest opportunity and, further, as the estimates of the Minister of Economic Development had not yet been considered, there would be an opportunity for discussion during those estimates.

In response, the Honourable Member indicated that new information or facts had just come to light.

It is stated in May, 16th edition, page 370, that if the matter is not raised at the earliest opportunity, it fails in urgency and the fact that *new* information has been received regarding a matter that has been continuing for some time does not in itself make the matter one of urgency. I would not wish to dispose of the matter on this ground alone if it were unduly strict to do so.

However, I am bound to follow numerous other Speakers of this House in declining the motion when an ordinary parliamentary opportunity for debate will occur shortly or in time, in this instance during Estimates (reference, May, 16th edition, page 371).

2. What was the total amount of royalty or land tax in lieu of royalty paid on coal mined?

"1. The estimated production of clean coal in 1977 is 8 592 416 metric tonnes or 9,471,567 short tons.

"2. \$3,206,330.93 of royalty was collected from coal sold during 1977."

NOTE—(1) \$3,206,330.93 is the revenue collected as *Coal Act* royalty. (2) The assessments under the *Mineral Land Tax Act* will not be issued until May 1, 1978, and are payable by July 31, 1978. The estimate of mineral land tax assessments for coal sold during 1977 is \$7,765,973.00.

Mr. Speaker delivered a reserved decision as follows:

Honourable Members:

Earlier today the Honourable Leader of the Opposition rose on a point of order which I undertook to rule on after reading the relevant passage in Hansard. At page 316/2 of the "Blues," it is recorded that the Honourable Provincial Secretary said: "Obviously the more responsible Member for Mackenzie must have been overridden in caucus by the irresponsible team . . . of *Lea, Lauk, Barrett, Macdonald,* and *Skelly.*"

The Honourable Leader of the Opposition claims that it is his prerogative to determine whether the allegations are, in his words "imputing motives". I think it would be more correct to say that any Honourable Member may bring any such complaint to the attention of the Speaker who then has the responsibility of seeing that order prevails.

In so doing, the Speaker of course would attach considerable weight to the view of the offended Honourable Member.

In the present circumstances I feel that the statement in question could, as the Honourable Leader of the Opposition claims, impute an improper motive to him and I would invite the Honourable Minister to conclude the matter by withdrawing the statement.

In so doing I wish to say that the Chair may only deal with points of order when they are raised immediately, but not otherwise (May, 16th edition, at page 470). However, there is a special circumstance existing in that the "Blues" indicate that the Honourable 1st Member for Vancouver East immediately called for a withdrawal when the statement was made.
