"And whereas, by section 16 of said chapter 54, it is enacted that the lines of railway mentioned in the schedule, together with branches and extensions, shall constitute the Columbia and Western Railway:

"And whereas it is conditional to the granting of the aid, as provided by chapter 8, Statutes of 1896, that the Company construct the said Columbia and Western Railway within the time and according to the terms of their Act of Incorporation:

"And whereas the Company has not complied with the conditions of the Subsidy Act as set forth in section 1, chapter 8:

"And whereas it was enacted that 'No lands shall be granted to the Company which are not designated and surveyed by them within seven years from the passage of this Act':

"And whereas the said Subsidy Act was passed on the 17th day of April, 1896, and whereas the lands to be granted were not designated and surveyed within the time nor in the manner prescribed by Statute, and are not yet surveyed : 2ND MARCH.

1906

"And whereas it was contemplated that by the granting of the subsidy as set forth in the Columbia and Western Railway Subsidy Act, being chapter 8, Statutes of 1896, that that portion of British Columbia extending from the Columbia River to Penticton, as well as the country bordering upon and tributary to Okanagan Lake, and also the Okanagan and Spallumcheen Valleys and the country tributary to the Shuswap and Okanagan Railway, would be developed and made profitable at an earlier period than if no such subsidy was granted; and further, that the Coast cities would be very materially benefited by securing a more direct route into the mining and smelting camps of the Boundary District, via Penticton; and it is further contemplated that the annual loss to the Province of British Columbia on account of its guarantee of interest upon the bonds of the Shuswap and Okanagau Railway would, by the construction of the Columbia and Western Railway to or near Penticton, be very materially reduced, if not altogether eliminated :

"And whereas to secure the construction of the Columbia and Western Railway at the earliest possible date it was enacted that the Railway Company should deposit security to the amount of fifty thousand dollars, which said amount was to be forfeited if the railway was not built to or near Penticton within four years from the 17th day of April, 1896:

"And whereas the railway has not yet been built to Penticton:

"And whereas the security before mentioned has not been estreated :

"And whereas the failure of the Columbia and Western Railway Company to construct their line of railway to Penticton has resulted in incalculable loss to the Province of British Columbia and made it necessary to provide a subsidy of \$750,000 in aid of a line of railway from Midway to Vernon.

"Therefore, this House is of the opinion that the Columbia and Western Railway Company is not entitled to any further aid."

Dr. King moved the adjournment of the debate.

Mr. Speaker *Pooley* gave the following ruling on the point of order raised yesterday on Bill (No. 61) intituled "An Act to amend the 'Vancouver Incorporation Act, 1900,'" in Committee of the Whole :—

In the Committee of the Whole upon Bill (No. 61), "An Act to amend the Vancouver Incorporation Act, 1900," (a Private Bill), a point of order was taken as to whether an amendment to the Bill, which would give the Corporation the power to interfere with private rights could be introduced into the Bill without proper notice having been given by notice or petition.

Dr. Young, the Chairman of the Private Bills Committee, informed the House that the proposed amendment had been over-ruled in the Private Bills Committee because proper notice of it had not been given as required by the Standing Orders.

No petition has been presented to the House for leave to introduce new provisions.

May, p. 778, states: It must be borne in mind that the Committee may not admit clauses or amendments which are not within the order of leave, or which are not authorised by a previous compliance with the Standing Orders applicable to them, unless the parties have received permission from the House to introduce certain provisions in compliance with petitions for additional provisions.

Rule 57 requires that a notice, clearly and distinctly specifying the nature and object of the application, etc., shall be published in the British Columbia Gazette and in one newspaper

published in the District affected, etc., for six weeks prior to the Session, and that copies of such notice shall be sent by the parties printing such notice to the Clerk of the House, to be filed amongst the Records of the Committee on Standing Orders.

It was stated to the House, that the House was a paramount authority and could insert any provision in a Private Bill it thought fit. This is in a certain sense correct, but the House is not able to deal with any matter which is not brought before it in conformity with the Rules and Procedure of the House.

I refer to the decision of Mr. Speaker *Higgins* upon a similar point, page 50 of Speakers' decisions.

I am of opinion that the proposed amendment interferes with private rights, and no notice of this intention having been given by notice or petition as required by the Standing Orders, is not properly before the House and cannot be dealt with. If a practice of this kind were allowed any Private Bill could be introduced and new clauses affecting private interests inserted without the parties affected having any notice of them.

Bill read a third time and passed.

Bill (No. 44) intituled "An Act to amend the 'Health Act,'" was read a third time and passed.

The Report on Bill (No. 13) initialed "An Act respecting the Use and Manufacture, within British Columbia, of Timber cut on Lands of the Crown," was adopted.

Third reading to-morrow.

The following Bills were read a second time and Ordered to be committed to-morrow:----

Bill (No. 85) intituled "An Act to amend the 'Victoria Terminal Railway and Ferry Act, 1901.'"

Bill (No. 84) intituled "An Act to incorporate The Life-boat and Life-saving Association of British Columbia."

Bill (No. 46) intituled "An Act to Accelerate the Incorporation of the City of North Vancouver."

Resolved, That the House, at its rising, do stand adjourned until two o'clock to-morrow.

On the motion of Mr. *Brown*, the Standing Rules and Orders were suspended, and Bill (No. 87) intituled "An Act to amend the 'Liquor Traffic Regulation Act,'" was introduced, read a first time and *Oadered* to be read a second time to-morrow.

And then the House adjourned at 10:30 P.M.

Prayers by the Rev. T. W. Gladstone.

Mr. Manson presented a petition from Rev. Albert Carman, General Superintendent of the Methodist Church, and the Rev. John Potts, General Secretary of Education for the Methodist Church, urging the bringing into effect of the existing charter of the University of British Columbia.

Received.

The Hon. Mr. Fulton presented the Ninth Annual Report of the Provincial Board of Health.

Mr. Wright asked the Hon. the Chief Commissioner of Lands and Works the following questions :--

1. Number of inches of water granted to the West Kootenay Power and Light Company, Limited, at Upper and Lower Bonnington Falls, West Kootenay District, respectively.

2. Statement of original record fees for same, and annual fees payable on same ?

3. Total amount due Province as at 16th December, 1902, in connection with each record ?

4. Total amount actually paid in commutation thereof ?

5. What amount of work was done in connection with record at Upper Bonnington Falls from 1897 to 1905, and, if any, at what dates from time to time was the same done, and the nature thereof?

6. The names of the owners of Crown-granted lands abutting on both shores of Kootenay River between the said Falls ?

The Hon. Mr. Green replied as follows :--

"1. On the 19th July, 1897, a record of 100,000 inches was granted to J. B. McArthur, and a record of 100,000 inches to P. C. McArthur. These records were assigned on the 20th August, 1897, to the West Kootenay Power and Light Company, Limited, and in December, 1902, were reduced to 50,000 inches each.

"2. \$2,720.75 for each record. \$2,066.60 for each record.

"3. On the 19th July, 1902. \$13,050.75 on each record.

"4. \$14,860.

"5. Department has not sufficient information to answer.

"6. South Side: John Miles, Lewis D. Little, Wm. Kirkup, Gordon Logan, Corporation of the City of Nelson. North Side: Martin Anderson, Col. & K. Ry. and Navigation Co., Donald Stewart, Harry Davis, Jno. M. Smith, Sir Charles Ross and W. K. Power & Light Co."

The Report on Bill (No. 56) initialed "An Act to amend the 'Midway and Vernon Railway Company Act, 1901," was considered.

Mr. Ellison moved to amend section 4 thereof by inserting before the first word in the seventh line thereof the words "sections 3, sub-section (1), and section 4 of."

Carried.

Report, as amended, adopted.

Third reading to-morrow.

Bill (No. 61) intituled "An Act to amend the 'Vancouver Incorporation Act, 1900," was again committed.

Progress reported.

Committee to sit again to-morrow.

Bill (No. 71) intituled "An Act to amend the 'False Creek Foreshore Act, 1904," was committed.

Reported complete without amendment.

Report adopted.

Bill read a third time and passed.

Bill (No. 50) intituled "An Act to incorporate the Royal Plate Glass Insurance Company of Canada," was read a second time and committed.

Reported complete without amendment.

Report to be considered to-morrow.

The Hon. Mr. *Green* presented to Mr. Speaker a Message from His Honour the Lientenant-Governor, which reads as follows :---

HENRI GUSTAVE JOLY DE LOTBINIÈRE,

Lieutenant-Governor.

The Lieutenant-Governor transmits herewith a Bill intituled "An Act to amend Chapter 54 of the Statutes of 1902," and recommends the same to the Legislative Assembly.

Government House,

7th March, 1906.

Ordered, That the said Message, and the Bill accompanying the same, be referred to a Committee of the Whole House forthwith.

(IN THE COMMITTEE.)

Resolved, That the Committee rise and report to the House a Bill (No. 88) intituled "An Act to amend Chapter 54 of the Statutes of 1902," and recommend the introduction of the same.

Report adopted.

Bill introduced and read a first and second time and committed. Reported complete without amendment.

Report to be considered to-morrow.

The House resumed the adjourned debate on the second reading of Bill (No. 69) intituled "An Act to amend the 'West Kootenay Power and Light Company (Limited) Act, 1897."

Bill read a second time.

To be committed to-morrow.

Bill (No. 52) intituled "An Act to amend the 'Pacific Coast Fire Insurance Company's Act, 1890," was read a second time.

To be committed to-morrow.

Mr. Garden presented a report from the Select Committee appointed to inquire into all matters pertaining to the acquisition, or attempted acquisition, by the Grand Trunk Pacific Railway Company, or by any other person or persons or bodies corporate, of Crown lands in the vicinity of Tucks Inlet, Kaien Island or other islands, and on the mainland in the vicinity of Kaien Island.

Mr. Garden moved—" That the report be received.

A debate arose, which was adjourned until to-morrow.

Mr. Brown asked the Hon. the Chief Commissioner of Lands and Works the following questions :---

1. At what date were Government Agents instructed to refuse applications of locators on vacant Crown lands now known as Lots 2,711, 2,712, 2,713, 2,714, 3,634, 3,635, 3,636, 3,637 3,638 and 3,639, in the Similkameen District, and Lots 7,159, 7,160 and 7,161, Kootenay District?

2. What are the words of the instructions so given?

3. Is it known to the Government that since the date of such instructions locators have been refused their locations on any of said lots?

4. If not known, will the Government telegraph these Agents and obtain the desired information, with names of locators, the character of their locations, and where located, and reasons for refusal of locations, and communicate such information to the House?

5. Has the Government refused applicants for timber licences on any of the lots mentioned in question 1 ?

6. If so, what are the names of such applicants, and what reasons in each case were given for such refusal ?

7. Is it the intention of the Government to refuse future applicants for timber licences and other locations on said lots ?

8. Is the Government willing to grant fiats to rejected applicants, so that they may appeal to the Courts to prove their right to their locations and timber licences?

The Hon. Mr. Green replied as follows :---

"1. 29th September, 1904.

"2. Agents were instructed not to permit any alienation by pre-emption, purchase or otherwise within the said blocks. Of course this did not debar free miners from entering and prospecting, etc.

"3. Yes.

"4. Answered by No. 3.

"5. Yes.

"6. James H. Christie.

"7. Yes.

"8. Any application for a fiat will be considered and decided on its merits."

Mr. Hawthornthwaite asked the Hon. the Minister of Mines the following questions :--1. How many metalliferous mines are in actual operation in the Province at the present time ?

- 3. How many Inspectors are employed to examine and report upon these mines?
- 4. How often do these Inspectors examine each mine?

5. Is a return made of all accidents occurring in these mines, showing cause of same?

The Hon. Mr. McBride replied as follows :-

- "1. From returns to hand, approximately, 145 shipping mines during 1905.
- "2. 2,299 below ground; 1,101 above ground.

" 3. 3.

"4. As often as possible, approximately, once a month.

"5. Yes, and published in annual report."

Resolved, That the House, at its rising, do stand adjourned until two o'clock to-morrow.

And then the House adjourned at 6 P.M.

Thursday, 8th March, 1906.

Two o'clock p.m.

Prayers by the Rev. T. W. Gladstone.

Mr. Speaker laid on the table a letter from His Honour the Lieutenant-Governor, transmitting a petition from John Pinkerton, free miner.

Mr. J. A. Macdonald moved the suspension of the Standing Rules and Orders, to enable him to move that the Votes and Proceedings of yesterday be corrected by setting out in full a motion moved by him in amendment to the motion that the report of the Select Committee, re Kaien Island, be received.

The motion was negatived.

The House resumed the adjourned debate on the motion "to receive the report from the Select Committee appointed to inquire into all matters pertaining to the acquisition, or attempted acquisition, by the Grand Trunk Pacific Railway Company, or by any other person or persons or bodies corporate, of Crown lands in the vicinity of Tucks Inlet, Kaien Island or other islands, and on the mainland in the vicinity of Kaien Island."

Mr. Speaker *Pooley* gave the following ruling on a proposed amendment to the resolution moved by Mr. J. A. Macdonald:---

On the 31st day of January, 1906, a Committee consisting of five Members, namely, Messrs. Garden, Ross, Young, J. A. Macdonald and Munro, subsequently, on motion, changed to Paterson, were appointed to inquire into all matters pertaining to the acquisition, or attempted acquisition, by the Grand Trunk Pacific Railway Company, or by any other person or persons, or bodies corporate, of Crown lands in the vicinity of Tuck's Inlet, Kaien Island or other islands, and on the mainland in the vicinity of Kaien Island, with power to summon witnesses, call for papers, documents, letters, telegrams and records, and to take evidence under oath, and to procure the printing of said evidence from day to day, and report said evidence from time to time to the House, together with their findings on the same.

On Wednesday, the 7th day of March, the Chairman of the Committee reported the evidence and the findings of the Committee thereon to the House.

Mr. Garden, after the reading of the Report, moved "That the Report be received"; and, Mr. J. A. Macdonald moved in amendment, seconded by Mr. T. W. Paterson (both members of the Committee appointed to inquire into all matters pertaining to the acquisition, or attempted acquisition, by the Grand Trunk Pacific Railway Company, or by any other person or persons, or bodies corporate, of Crown lands in the vicinity of Tuck's Inlet, Kaien Island or other islands, and on the mainland in the vicinity of Kaien Island), "to strike out all the words of the motion after the first word 'That,' and to substitute the following words: 'the report be referred back to the Committee with instructions to append to the said Report the following Minority Report as an appendix.'" A minority report (so-called) was attached to the motion.

A point of order has been raised as to whether this amendment is in order, and whether it is competent to move an amendment to the motion "That the Report be received."

The motion, in my opinion, is open to amendment.

The question then arises, is this amendment in order?

The motion asks that "the Report be referred back to the Committee with instructions to append to the said Report the following Minority Report as an appendix.

The House, so far, knows nothing of a Minority Report, the only Report the House has any knowledge of is the Report of the Committee presented by the Chairman. By the decision of Mr. Speaker *Mara*, folio 83 of the Speakers' decisions, and the decision of Mr. Speaker *Forster* on page 61 of the Journals, 1899, a Report can only be presented by the Chairman.

I cannot find any mention of the presentation of a Minority Report in *May's* Parliamentary Practice.

"As the conclusion of a minority is not the decision of the Committee, a minority cannot, according to Parliamentary law, make a report; and such a report is unknown to English practice. It is also contrary to English custom to allow a report to be accompanied by any counter statement or protest from the minority."—(Speakers' decisions of Quebec, folio 781. Citing Bourinot 548, 3rd Edition; Palgrave Edition, 1884, p. 87; Johnson's Appendix, p. 21). This decision is based on English authority.

This House is asked to deal with a minority report of which it has no knowledge, it not having been presented by the Chairman of the Committee, and if this practice of presenting minority reports were allowed it would enable every member of a committee to present his individual report, and the object of the Legislature to obtain a report of the Committee would be defeated. I declare the amendment out of order.

The Report was received, and is as follows :---

To the Speaker of the Legislative Assembly of the Province of British Columbia :

SIR,—We, your Special Committee appointed to inquire into all matters pertaining to the acquisition, or attempted acquisition, by the Grand Trunk Pacific Railway Company, or by any other person or persons, or bodies corporate, of Crown lands in the vicinity of Tuck's Inlet, Kaien Island, or other islands, and on the mainland in the vicinity of Kaien Island, with power to summon witnesses, call for papers, documents, letters, telegrams and records, and to take evidence under oath, and procure the printing of said evidence from day to day, and report said evidence from time to time to the House, together with our findings on the same, beg to report as follows :—

On the 31st day of January, 1906, on the motion of Mr. J. A. Macdonald, seconded by Dr. King, it was Resolved,-

"That a Select Committee, consisting of five Members of this House, namely: Messrs. Garden, Young, Ross, Munro and the mover, be appointed to inquire into all matters pertaining to the acquisition, or attempted acquisition, by the Grand Trunk Pacific Railway Company, or by any other person or persons, or bodies corporate, of Crown lands in the vicinity of Tuck's Inlet, Kaien Island, or other islands, and on the mainland in the vicinity of Kaien Island, with power to summon witnesses, call for papers, documents, letters, telegrams and records, and to take evidence under oath, and procure the printing of said evidence from day to day, and report said evidence from time to time to the House, together with their findings on the same."

Pursuant to said Order, a meeting of your Committee was held on the 2nd of February, 1906, and since that date fifteen meetings were held and eight witnesses examined. All witnesses requested to be called appeared and gave evidence, with the exception of Peter Larsen, of Helena, Montana, who excused himself on account of illness, and F. W. Morse, of the Grand Trunk Pacific Railway Company, Montreal, who excused himself on account of pressure of business.

No subpœnas were issued for these witnesses, as your Committee were advised by the Deputy Attorney-General that we possessed no powers over extra-provincial witnesses. All evidence given was taken in shorthand and a copy of the transcribed notes is transmitted herewith, along with the exhibits produced or copies thereof, as well as telegrams and copies, etc., despatched and received by the Committee.

Although no restriction was placed on the scope of the inquiry, the only lands in the vicinity of Kaien Island about which questions were asked were the following:—Lots 443, 444, 251, 450, 446, 447, 448, 449, 501, 502, 503, 505, 507, in Range V., Coast District.

1. Your Committee find that Lots 443, 444 and 251, comprising, approximately, 10,000 acres, were acquired by the Grand Trunk Pacific Railway Company under the provisions of an Order in Council dated 30th April, 1904, and approved by His Honour on May 4th, 1904, passed under the authority of section 39 of the Land Act, which latter date is hereinafter referred to as the date of acquisition.

The lands in question were originally attempted to be acquired by one Peter Larsen, with whom was associated as a partner or employee one James Anderson, apparently with the object of ultimately transferring the same to the said the Grand Trunk Pacific Railway Company. The terms of the proposed acquisition are outlined in a letter from E. V. Bodwell, dated January 19th, 1904.

2. Your Committee find that, after receipt of the letter in question, the Executive Council refused to deal with any intermediaries in the matter, but stated that they would only deal direct with the Railway Company. Upon being made aware of this decision, Mr. Bodwell, on the 29th of April, 1904, secured and produced to the Executive a telegram from C. M. Hayes, President of the Company, authorising him (Bodwell) to act for the Company in the transaction under review, and on the following day the Order in Council was passed by the Executive, which was subsequently approved by His Honour. In pursuance thereof, Crown grants for the lands in question were in due course and upon payment of the purchase money (\$10,000.00) by the Railway Company, duly issued to the said Railway Company.

3. Your Committee find that the Company acquired these lands in accordance with the terms of the Order in Council, and dealt for the same directly with the Government, as stated by the members thereof who were called to give evidence.

4. Your Committee find that section 39 of the Land Act gives ample authority for the Order in Council in question, and the Crown grants for Lots 433, 434 and 251, in Range V., issued in pursuance thereof, and were properly so issued and delivered to the Company.

5. Your Committee find that the Railway Company paid to the Province the sum of \$10,000, the purchase money agreed upon by the terms of the Order in Council, and in addition thereto repaid to Peter Larsen a portion of the moneys paid out by him for surveys, said to be about \$8,000.

6. Your Committee find that the two payments referred to in the preceding paragraph were all the moneys actually paid by the said Railway Company in connection with the acquisition of said Lots 443, 444, and 251, R. V., and further that there is no obligation, either directly or indirectly, upon the said Railway Company to pay any further amount or grant any further consideration to any person or persons in respect of said lands.

7. Your Committee find that Peter Larsen, above referred to, knowing that the Grand Trunk Pacific Railway Company would sooner or later require a Pacific Coast terminal, conceived the idea of securing such a terminal for the Company, and in pursuance of such idea, the negotiations herein referred to were undertaken.

From the evidence it would appear that Peter Larsen is a very wealthy man, an extensive railway contractor and wholesale merchant, and the negotiations undertaken by him were not for the sake of any immediate gain arising out of the transaction under review, but rather with the object of establishing a friendly connection with the Railway Company, with an eye to securing business whenever the active operations of the Company should commence.

This finding is corroborated by the incident related in the next succeeding paragraph :--

8. Your Committee find that subsequent to the date of the acquisition of the lands in question, the above-named James Anderson, acting for himself and Peter Larsen, entered into an option, or agreement in writing, with the officials of the Grand Trunk Pacific Railway. No copy of the document was produced, but from the best evidence obtainable, your Committee find that the option contained a proviso for the payment of \$40,000 to Larsen and Anderson by the Company, upon the happening of certain contingencies. The option was not approved by Peter Larsen when he became aware of it, and the same was cancelled by him within a few days after signature and without being consummated.

9. Your Committee find that the above-named Peter Larsen and James Anderson were associated in a number of other transactions besides their dealings with the lands under review, but which transactions did not come within the scope of the present investigation, and that upon a general settlement between the said Larsen and Anderson, about March, 1905, Anderson received from Larsen, as a part of the settlement, the sum of \$10,000.

Your Committee are of the opinion and so find that this incident is not properly within the scope of the Commission, as it occurred about a year after the acquisition of the lands in question, and was a private settlement not affecting the acquisition of the lands by the Railway Company. There was no obligation on the part of the Company to repay this money to Peter Larsen, and the same was not repaid.

10. Your Committee find that by an Order in Council dated on the 12th day of October, 1891, a reserve from sale or pre-emption was placed upon the following lands, viz.: "All the land which is situated on Tsimpsean Peninsula, and which lies to the north of a line drawn due west from the head of Work Channel."

11. During the investigation, an effort was made to establish the fact that Lot 251, Range V., on Kaien Island (a portion of the land acquired by the Grand Trunk Pacific Railway Company) was not intended to be included in this reserve. This contention was based upon the use of the word "Peninsula," in the Order in Council; but your Committee are cf t is opinion, from the evidence of W. S. Gore, at that time the Deputy Commissioner of Lands and Works, and the official most likely to be acquainted with the facts of the matter, that the reserve was intended to include all Crown lands lying to the north of a line drawn due west from the head of Work Channel to the eastern boundary of the Dominion Government Indian Reserve, and so find. This finding is also supported by the evidence of E. B. McKay, the present Surveyor-General, who was in 1891 a draughtsman in the Lands and Works Department.

12. This would include the greater part of the land now known as Lot 251, Range V., on Kaien Island, and your Committee further find that the language of the Order in Council was so understood and interpreted by the officials of the Department.

13. The whole of Kaien Island was subsequently, by Order in Council dated 3rd August, 1904, reserved from pre-emption or sale. This action was taken in the public interest.

14. During the investigation a petition was received from one George T. Kane, setting out that he located a pre-emption under the provisions of the Land Act, as well as several applications for lands under provisions of the "South African War Land Grant Act, 1891," and amendments.

Your Committee find that the pre-emption claimed by Mr. Kane was located within the boundaries of the Reserve created by the Order in Council of October 12th, 1891, and that his application, therefore, was properly refused.

15. With regard to the applications under the "South African War Land Grant Act, 1891," and amendments, your Committee find that, under the provisions of section 3 of the said Act, the consent of the Chief Commissioner of Lands and Works is an essential element of such a holding.

In the case under review your Committee find that this pre-requisite was not obtained, the applications were properly refused, and such refusal was in the public interest.

16. Your Committee find that the Grand Trunk Pacific Railway Company, through it officials and agents, were, at all times from the inception of the transaction, or very shortly thereafter, fully aware of the negotiations being carried on by Messrs. Larsen and Anderson, ostensibly on behalf of said Company. From the evidence given, your Committee find that the said Railway Company have confirmed the transaction in every respect, and have not signified any dissatisfaction with the matter, although afforded ample opportunity to do so.

"Provided, also, that in the event of any of the lands hereby granted being divided into town lots, one-fourth of the blocks of lots, to be selected as provided in section 32 of the Land Act, shall be re-conveyed to Us and Our successors.

"Provided, further, that the land hereby granted fronting on the sea or waterway shall be divided into blocks having a frontage on the sea or waterway of not less than one thousand (1,000) feet, and the selection of the water front lands so divided shall be in conformity with the land appurtenant thereto above and below low-water mark, upon the request of the Chief Commissioner of Lands and Works. "Provided, further, that there shall be re-conveyed to Us and Our successors, upon the request of the Chief Commissioner of Lands and Works, one-fourth of the land embraced in this grant that shall not be divided into town lots or water front blocks, the said lands to be divided into blocks containing not more than eighty acres, and the selection of said lands to be in conformity with section 32 of the Land Act.

"Provided, further, that any re-conveyance to Us and Our successors of any of the lots hereinbefore mentioned shall include (when the lands so described abut upon or from the shore of any tidal waters, or the bank of any river, lake or stream) all the foreshore and riparian rights, including the lands above and below low-water mark.

"Provided, also, that all travelled streets, roads, trails and other highways existing over or through said lands at the date hereof shall be excepted from this grant."

18. In the course of the investigation some effort was made to blame the Executive for preserving secrecy with regard to the details of the transaction, but your Committee find that the element of secrecy with regard to public business on the part of the Executive is absolutely essential, and that no unusual secrecy was observed in this transaction, and no more secrecy than the circumstances of the case warranted.

19. Your Committee find that the sale of the lands in question by the Government to the Railway Company, upon the terms and conditions imposed, was a deal pre-eminently to the public advantage, and hold the opinion that the extraordinary reservations contained in the Crown grants set forth in paragraph 17 hereof will enure to the lasting benefit of the Province.

20. Evidence was given before the Commission as to the comparative merits of Port Simpson and Kaien Island harbours, and your Committee find that the selection of Port Simpson as a terminus would bring no advantage to the public, such as will accrue from the transaction under review, inasmuch as all the desirable townsite lands at Port Simpson Harbour, or the immediate vicinity thereof, were alienated prior to 17th April, 1896, from which date section 32 of the Land Act became effective, by reserving to the public a fourth part of subdivided lands.

21. Your Committee find that the land comprised in Lots 443, 444 and 251, Range .V, is third-class land within the meaning of the Land Act, and the statutory price of the same, under said Act, is one dollar per acre.

Your Committee find that there is no reason to look for any immediate enhancement of the value of these lands, except such as may arise by the creation of a transcontinental railway terminal on Kaien Island, and that the future value of said lands must depend entirely on the operations of the Company.

22. Your Committee find that no member or official of the Government received any direct or indirect emolument or reward in connection with any of the matters enquired into, or any direct or indirect promise of same in the future, and that the members of the Government were actuated solely by a desire to secure to the Province every advantage obtainable under the circumstances.

23. With regard to Lots 446, 447, 448, 449, 450, 501, 502, 503, 505 and 507, in Range V., Coast District, your Committee find that these lands did not fall within the boundaries of the reserve created by the Order in Council dated October 12th, 1891, and were always open to location by purchase or otherwise.

24. Your Committee find that these lands were located by J. Fred Ritchie, P. L. S., for Peter Larsen and James Anderson, under the provisions of the "South African War Land Grant Act, 1891," and amendments, in the month of January, 1905, and acquired in due course and according to law.

All of which is respectfully submitted.

That a respectful Address be presented to His Honour the Lieutenant-Governor, asking that a copy of the Order in Council relative to the retirement of Mr. B. H. John be brought down to this House, together with copies of all correspondence passing between Mr. B. H. John and any Member of the Government relative to such retirement, and between any Member of the House and the Government.

On the motion of Mr. Williams, seconded by Mr. Hawthornthwaite, it was Resolved,-

That an Order of the House be granted for a Return of all correspondence relating to the Wharf Road crossing E. & N. Railway tracks and the lands of the Wellington Colliery Company's land at Ladysmith.

Mr. J. A. Macdonald moved to add the following as a new section :---

"The lands hereby granted, including all timber and other surface rights thereon, shall be subject to pre-emption and to purchase by any person who is entitled to pre-empt or purchase unoccupied and unreserved lands of the Crown, upon the same terms in respect of payment as now apply to pre-emptors or purchasers of such lands of the Crown:

"And for the purpose of carrying out this provision, all applications and records which, under the provisions of the laws affecting Crown lands, would be made to or granted by the Chief Commissioner, or any Commissioner, may be made to the Company or its authorised officer:

"Provided always, that the Company shall be at liberty to adopt such regulations as it shall see fit in respect of the survey of lands by applicants, the periods of payment, and the time for the delivery of a conveyance of the lands applied for :

"Provided also, that any person affected by any decision of the Company or its authorised officer in regard to the pre-emption or purchase of any of the said lands may, within one calendar month after being notified of such decision, appeal therefrom in a summary manner to any Judge of the Supreme Court in Chambers:

"Any person affected by the judgment shall have the right to appeal therefrom to the Full Court pursuant to the practice and procedure of the Supreme Court of British Columbia."
