Motion negatived.

Mr. Hobbs moved, seconded by Mr. Strachan,—

That a copy of the Crippen Wright engineering report on the Columbia River be tabled in this House forthwith.

Motion negatived.

Mr. Price moved, seconded by the Hon. W. D. Black,-

Resolved, This House is of the opinion that the Government of Canada should proceed with all possible haste to investigate the cost of drugs in order to establish whether or not fair and reasonable prices are charged to the public and that a copy of this motion be sent to the Prime Minister and the Minister of Health and Welfare at Ottawa.

Motion agreed to. Nem. con.

Mr. Macdonald moved, seconded by Mr. Nimsick,—

That this House authorize an inquiry to be undertaken by the Standing Committee on Social Welfare and Education into the advisability of bringing into effect without delay a comprehensive medical-care plan covering all the people of the Province.

By leave of the House, the motion was withdrawn.

Mr. Macdonald moved, seconded by Mrs. Haggen,-

That the order for the second reading of Bill (No. 42) intituled the *Labour Relations Act Amendment Act*, 1961, be discharged, and the said Bill be referred to the Select Standing Committee on Labour for inquiry and report.

By leave of the House, the motion was withdrawn.

Mr. Rhodes moved, seconded by Mrs. Mather,—

That the Department of Agriculture consider reinstitution of the practice of having the Advisory Board of the Farmers' Institutes meet the Legislative Select Standing Committee on Agriculture.

By leave of the House, the motion was withdrawn.

Mr. Calder moved, seconded by Mr. Turner,—

That all correspondence and communications since February 6th, 1956, between all departments of the Government and any official of the Frobisher Company and its subsidiary, the North West Power Industries Limited, pertaining to power development on the Nass River be filed with this House.

Motion agreed to.

Resolved, That all correspondence and documentary evidence relating to the construction experience of Union Contractors Limited, Continental Contractors Limited, and L. & M. Logging Limited prior to their receiving their first Government contracts or highway work not covered by a contract be tabled in this House.

Mr. Gargrave moved, seconded by Mr. Dowding,-

Resolved, That this House is of the opinion that the Provincial Government should apply to the Federal Government of Canada to have the control of the British Columbia Telephone Company Limited and its subsidiaries within the Province of British Columbia revert to Provincial jurisdiction in order that the rates and services of the said telephone company can be controlled on behalf of the people of the Province by the Public Utilities Commission of British Columbia.

A debate arose.

Motion negatived.

Mr. Smith moved, seconded by Mr. Murray,—

That the Government give consideration to permitting local authorities to give a tax amnesty to home-owners and others who improve their properties.

Motion agreed to.

Mr. Rhodes moved, seconded by Mrs. Mather,-

That all correspondence, telegrams, telephone conversations, or other documents between the Provincial Department of Social Welfare and the Surrey Department of Social Welfare for the years 1955, 1956, 1957, 1958, 1959, 1960, and 1961, in connection with suggestions for changes or improvements in the operations and organization of the department in Surrey be tabled in this House.

By leave of the House, the motion was withdrawn.

Mrs. Mather moved, seconded by Mrs. Haggen,-

Be it Resolved, That this Assembly urge that the Government of Canada (1) continue to oppose the testing of nuclear weapons, (2) oppose the production of nuclear weapons, (3) oppose the introduction of nuclear weapons to any other countries, including Canada, and (4) through the United Nations, continue to further progressive disarmament by all nations.

Motion agreed to.

Mr. Murray moved, seconded by Mr. Campbell,—

That all correspondence between the Department of the Attorney-General and the Department of Immigration for Canada dealing with the subject of liquor rights for those residents of British Columbia who are subject to the provisions of the *Indian Act* of Canada be tabled in this House.

Motion agreed to.

Mr. Turner moved, seconded by Mr. Harding,—

That in view of a letter published in the Vancouver Sun dated March 15th, 1961, and signed by A. S. Matthew, M.L.A., Deputy Speaker, Parliament Buildings, Victoria, which expressed opinions as to the merits of a certain Bill—namely, Bill No. 42—this House is of the opinion that the Deputy Speaker has violated all the cherished traditions of the high office of Speaker of the Legislative Assembly of British Columbia, these traditions demanding that a member occupying this position shall at all times practise neutrality and impartiality in the exercise of this office; this House therefore regrets that the member referred to no longer enjoys the full confidence of this House and must be removed from office.

A debate arose.

By leave of the House, the motion was withdrawn.

Mr. Cox moved, seconded by Mr. Calder,-

That this Assembly consider calling together the members of the Legislative Assembly for a meeting of the British Columbia members of the Commonwealth Parliamentary Association for the purpose of organizing the British Columbia Branch and electing a delegate to the forthcoming Commonwealth Parliamentary Conference, to be held in England in September of this year.

By leave of the House, the motion was withdrawn.

Mr. Strachan moved, seconded by Mr. Turner,-

That in view of the fact that private power companies (a) are required to pay corporation tax and (b) charge the consumer a high price for electricity in order to provide profits for shareholders, the Government consider the advisability of placing the B.C. Electric and the East and West Kootenay Power Companies under public ownership in accordance with the provisions of the *Power Act*.

By leave of the House, the motion was amended by striking out the words, in the second and third lines, "charge the consumer a high price for electricity in order to provide profits for shareholders."

Motion as amended agreed to.

Mr. Perrault moved, seconded by Mr. Macfarlane,—

That all pronouncements and statements made by the Public Utilities Commission and its members in respect of the Pacific Northern Railway and any correspondence between the Public Utilities Commission and its members and the principals, spokesmen, or representatives of the Pacific Northern Railway be tabled in this House.

By leave of the House, on the motion of the Hon. W. A. C. Bennett, the House proceeded to the Order "Public Bills and Orders."

By leave of the House, the Rules were suspended and Bill (No. 72) intituled An Act for Granting Certain Sums of Money for the Public Service of the Province of British Columbia was read a second time.

By leave of the House, the Rules were suspended and the Bill referred to a Committee of the Whole House to be considered forthwith.

The Bill was committed, reported complete without amendment, and, by leave of the House, the Rules were suspended and the Bill read a third time and passed.

That the Report of the Select Standing Committee on Public Accounts and Printing be adopted.

Leave was not granted.

 - 2. Give reasons for the change.
- 3. Are patients, as well as paid employees, required to work on Sundays under this arrangement?
 - 4. Is the arrangement to be regarded as permanent?
 - 5. If not, what steps are to be taken to restore the normal work-week?

The Hon. W. D. Black replied as follows:—

- "1. October 15th, 1959.
- "2. The seven-day operation of the Essondale laundry was introduced upon medical recommendation having regard to the health needs of the patients in the Crease Clinic, Provincial Mental Hospital, Valleyview Hospital, and The Woodlands School in order to ensure an uninterrupted supply of clean linen. Seven-day laundry operation is characteristic of large hospital units; for example, Vancouver General Hospital and Royal Columbian Hospital.
- "3. Patients are not required to work on Sundays, but some do. No patient works for more than five days per week. No patient is denied the privilege of attending the hospital church service of his choice.
 - "4. No changes contemplated at this time.
 - "5. Answered by No. 4."

Mr. Rhodes asked the Hon. the Minister of Social Welfare the following questions:—

With reference to Surrey Social Welfare Department:—

- 1. What was the total number of recipients of social welfare assistance for the months of December, 1960, January, 1961, and February, 1961?
- 2. In each of the months in No. 1, how many were (a) heads of families, (b) dependents, (c) single men, and (d) single women?

The Hon. W. D. Black replied as follows:-

- "1. The number of Social Allowance recipients in December, 1960, was 3,939 and in January, 1961, was 4,220; figures for February, 1961, are not yet available.
- "2. December, 1960: Heads of families, 807; dependents, 2,643; single men, 302; and single women, 187; total, 3,939. January, 1961: Heads of families, 1,017; dependents, 2,726; single men, 291; and single women, 186; total, 4,220."

Mrs. Mather asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. What was the total number of all hospital budget deficits reported to the Minister of Health Services and Hospital Insurance in the year 1959?
- 2. What amounts, if any, were paid to hospital boards to cover the deficits referred to in No. 1?

The Hon. E. C. F. Martin replied as follows:—

- "1. Sixty-three.
- "2. \$630,488.30."

Mr. Strachan asked the Hon, the Minister of Highways the following questions:—

With reference to Project No. 882, contract awarded to Ben Ginter Construction Company for \$983,276 (Department of Highways Annual Reports, 1957/58 and 1959/60):—

- 1. What was the total amount paid to Ben Ginter Construction Company on completion of the project?
- 2. Did the construction call for paving of the full 7.66 miles by Ben Ginter Construction Company?
- 3. If the answer to No. 2 is yes, did the Ginter Company complete the paving and, if not, why?
- 4. If the answer to No. 2 is in the negative, (a) what portion did the Ginter Company contract to pave, (b) did it complete the relevant portion, and (c) has this paving broken up since completed?
- 5. Was any portion of the 7.66 miles paved by the Department of Highways and, if so, at what cost?
- 6. Was any day-labour used on this project and, if so, what was the total cost of this labour?

The Hon. P. A. Gaglardi replied as follows:—

"1. \$1,002,657.67.

"2. Yes; pulvi-mix base processing.

"3. No; 2 miles partially completed; weather conditions precluded further pulvi-mixing in 1959; contractor paid only for work completed.

"4. (c) Some breaks developed.

- "5. Yes; 5 miles of two-lane width pulvi-mix base processing and 0.7 mile of three-lane width pulvi-mix base processing, \$25,197.16.
- "6. Yes; \$9,400 (this amount is included in the figure of \$25,197.16 shown in No. 5). Additional expenditure was occasioned for the increased quantity of solid rock over the original estimate because of a revision of alignment. Embankment over muskeg between Station 260 and Station 266 required more material than was originally estimated."

Mr. Barrett asked the Hon. the Minister of Social Welfare the following question:—

What was the total cost of dental services for recipients of Social Allowance classed as unemployed employables for the fiscal year 1959/60?

The Hon. W. D. Black replied as follows:—

- "Information not available. No separate statistics kept of cost of dental services to unemployed employables."
- Mr. Perrault asked the Hon. the Minister of Health Services and Hospital Insurance the following question:—

As at the latest date available, how many people resident in the Province are receiving (a) the universal Old Age Pension, (b) of (a) how many receive the full Provincial subsidy, (c) of (a) how many receive Old-age Assistance, and (d) of (c) how many receive the full Provincial subsidy?

The Hon. E. C. F. Martin replied as follows:—

[&]quot;Does not come within the jurisdiction of this Department."

Mr. Barrett asked the Hon. the Minister of Social Welfare the following question:—

What was the total of new applications for social assistance and how many dependents were involved in the said applications in each of the following months in 1960: (a) July, (b) August, (c) September, (d) October, (e) November, and (f) December?

The Hon. W. D. Black replied as follows:—

"Information not available."

Mr. Barrett asked the Hon. the Minister of Social Welfare the following questions:—

1. Were any cases referred to the Rehabilitation Co-ordinator of the Public Health Branch by the Social Welfare Branch during the calendar year 1960?

2. If the answer to No. 1 is yes, (a) how many and (b) how many of these cases were successfully rehabilitated during the year?

The Hon. W. D. Black replied as follows:—

" 1. Yes.

"2. (a) Of the patients referred to the Rehabilitation Service, twenty-six persons were in receipt of Social Allowance at the time of referral and (b) cases closed, two; in gainful employment, two; in part-time employment, two; in regular vocational training, six; and receiving other active rehabilitation service, fourteen."

Mr. Rhodes asked the Hon. the Minister of Social Welfare the following questions:—

With reference to the Social Welfare cost-sharing formula between the Government and the municipalities:—

1. What was the total amount paid by the Government under this formula in the fiscal years (a) 1958 and (b) 1959 and (c) the calendar year 1960?

2. What was the total amount paid by the municipalities in the fiscal years (a) 1958 and (b) 1959 and (c) the calendar year 1960?

3. In the case of each individual municipality, what was the amount paid (a) by the Government and (b) by the municipality during the relevant years?

The Hon. W. D. Black replied as follows:—

"By virtue of the fact that Mr. Rhodes, second member for Delta, has intimated to this Legislative Assembly that he is in possession of an answer to the question posed, it is unnecessary to answer."

Mr. Barrett asked the Hon. the Minister of Social Welfare the following questions:—

- 1. Were any recipients of social assistance prosecuted for making false declarations in order to qualify for assistance during (a) the fiscal year 1959/60 and (b) the calendar year 1960?
- 2. If the answer to No. 1 is yes, (a) how many were prosecuted in each year and (b) were any found guilty and, if so, how many?
- 3. If the answer to No. 2 (b) is in the affirmative, how many, if any, of those found guilty were given prison sentences?

The Hon. W. D. Black replied as follows:—

" 1. (a) and (b) Yes.

"2 and 3. Prosecutions made by administering authority, which include municipal offices, and record of total prosecutions not maintained centrally."

Mr. Calder asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

With reference to the districts of Atlin, Lower Post, Cassiar (McDame Creek), Dease Lake, Porter Landing, Telegraph Creek, Glenora, Lake Bennett, Alaska Highway (British Columbia section), Alice Arm, and Stewart:—

1. Has the Government any agreement with (a) a non-resident doctor, (b) a non-resident dentist, or (c) a non-resident health nurse to visit any of these

districts?

- 2. If the answer to any part of No. 1 is yes, which districts are visited by (a), (b), and (c) and how often are visits made?
- 3. If the answer to any part of No. 1 is in the negative, are services to the relevant districts contemplated in the near future?

4. Are there any resident health nurses in any of the relevant districts?

- 5. If the answer to No. 4 is yes, (a) what are the names of the nurses and (b) in which district do they reside?
- 6. If the answer to any part of No. 5 is in the negative, will resident health nurses be placed in these districts in the near future?

7. Are there resident doctors in any of the relevant districts?

8. If the answer to No. 7 is yes, what are the retaining fees paid to each doctor?

The Hon. E. C. F. Martin replied as follows:—

- " 1. (a), (b), and (c) No.
- "2. See above.
- " 3. No.
- "4. There is a public health nurse at Telegraph Creek.
- "5. (a) Miss L. Whiteside and (b) Telegraph Creek.
- " 6. No.
- "7. Yes; Cassiar, Dr. W. J. McColl, and Stewart, Dr. W. J. Buschlen.
- "8. Dr. McColl, Cassiar, is not paid a retaining fee; Dr. Buschlen, Stewart, receives a monthly fee of \$350."

Mr. Rhodes asked the Hon. the Minister of Social Welfare the following question:—

With reference to the Minister's answer recorded in the Journals of the House, page 175, 1960, relating to the case load of a social worker in the Social Welfare Branch, Abbotsford, is the worker still responsible for a case load of 1,653 cases and, if not, how many cases does he now carry?

The Hon. W. D. Black replied as follows:-

"As at January 31st, 1961, 1,771 (Abbotsford, 1,264; Haney, 507), pensioner case load only."

Mr. Rhodes asked the Hon. the Minister of Social Welfare the following question:—

How much was claimed from the Federal Government under the *Unemployment Assistance Act* for Social Assistance Grants made in the following months of 1960: (a) May, (b) June, (c) July, (d) August, (e) September, (f) October, (g) November, and (h) December?

The Hon. W. D. Black replied as follows:—

"This information will not be available until the Public Accounts for the fiscal year 1960/61 are finalized."

Mr. Barrett asked the Hon, the Minister of Social Welfare the following questions:—

With reference to the Minister's answer recorded in the Journals of the House, page 35, 1960, confirming that in the Social Welfare Branch "overtime work is the rule rather than the exception":—

1. Were social workers required to work overtime during (a) 1956/57, (b)

1957/58, (c) 1958/59, (d) 1959/60, and (e) the calendar year 1960?

- 2. If the answer to No. 1 is yes, (a) what was the total number of hours of overtime worked and (b) if figures are not available, was the number of hours worked considerable?
- 3. If the answer to No. 1 is yes, were social workers paid for this overtime and, if so, at what rate?

The Hon. W. D. Black replied as follows:-

"1. (a), (b), (c), (d), and (e) Yes.

- "2. (a) Figures not available and (b) yes, in certain areas due to emergent situations.
- "3. Overtime regulations not applicable, except with approval of the Lieutenant-Governor in Council, to certain classifications of employees including social workers where conditions of employment require irregular hours."

Mrs. Mather asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

With respect to the nursing staff at The Woodlands School:-

- 1. What was the total number of nurses employed as at December 31st, 1960?
- 2. (a) How many are graduate psychiatric nurses and (b) how many are registered nurses?

3. Did any nurses resign during the year 1960?

4. If the answer to No. 3 is yes, (a) how many were graduate psychiatric nurses and (b) how many were registered nurses?

The Hon. E. C. F. Martin replied as follows:-

" 1. 242.

"2. (a) 235 and (b) seven.

"3. Yes.

"4. (a) Graduate psychiatric nurses: Personal reasons, five; health reasons, five; further education, two; family reasons, nineteen; residential move, five; and other employment, eight; total graduate psychiatric nurses, forty-four. (b) Registered nurses, nil."

Mrs. Mather asked the Hon. the Minister of Social Welfare the following questions:—

With reference to the Child Welfare Division:-

- 1. What was the total number of social workers employed in the Child Welfare Division as at December 31st, 1960?
 - 2. What was the total case load as at December 31st, 1960?

The Hon. W. D. Black replied as follows:—

" 1. Nine.

"2. Total number of children in care, 5,164 (this includes children in care of children's aid societies, staff of children's aid societies, and Social Welfare Department Field Service deal with these cases)."

Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

1. What was the total number of permanent staff employed by the Mental

Health Services as at December 31st, 1960?

2. What was the total number of temporary staff employed by the Mental Health Services as at December 31st, 1960?

The Hon. E. C. F. Martin replied as follows:—

"1. 2,988.

"2. Forty-five; total, 3,033."

Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

1. What was the total number of psychiatrists employed at the Provincial

Mental Hospital at Essondale as at December 31st 1960?

2. What was the total number of patients in the Provincial Mental Hospital at Essondale at December 31st, 1960?

The Hon. E. C. F. Martin replied as follows:—

"1. Psychiatrists, thirteen; other medical specialists, two; Physicians—Grade 2, eighteen; and Physicians—Grade 1, one; total, thirty-four.
"2. 2,976."

Then Mr. Speaker addressed the Lieutenant-Governor as follows:—

MAY IT PLEASE YOUR HONOUR:

We, Her Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to Her Majesty's person and Government and humbly beg to present for Your Honour's acceptance Bill (No. 72) intituled An Act for Granting Certain Sums of Money for the Public Service of the Province of British Columbia.

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In Her Majesty's name, His Honour the Lieutenant-Governor doth thank Her Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

Your labours on behalf of our citizens during this First Session of the Twenty-sixth Parliament of British Columbia have befitted the importance of the many measures brought before you, and I desire to express my appreciation for your earnest attention to them.

Legislation which will be of lasting significance and benefit has been enacted. Notable amongst measures authorized by you are major changes in the provisions for protection of those persons involved in automobile collisions, and in the extension of new protection against loss of, or damage to, property.

Amendments to the *Public Schools Act*, which implement some of the recommendations of a Royal Commission, will improve educational standards and provide broadened opportunities for our youth.

Your authorization of the *Public Accommodation Practices Act*, which recognizes the God-given right of all to equal treatment without regard to race, religion, colour, or nationality, stands as an example to governments the world over.

Measures to provide greater security in retirement for those who enter the all-important teaching profession are incorporated in the Teachers' Pensions Act.

I note with pleasure that further encouragement has been given, through passage of the Copper Bounty Act, to the development of secondary industry within the Province.

The continued sound operation of credit unions for the benefit of their many members is facilitated by the new Credit Unions Act.

The programme of my Government for the continued progress of our Province will continue throughout the coming year, and I thank you for the supplies which you have granted for public service.

Honourable Members, I now relieve you of your legislative duties. As you

return to your homes, may Divine Providence accompany you.

The Hon. W. D. Black (Provincial Secretary) then said:—

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please the Lieutenant-Governor to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
