On the motion of the Hon. Mr. Pearson, seconded by the Hon. Mr. Maitland, it was Resolved,—

That the following members of the Legislature shall be appointed to serve as a Special Committee appointed to consider the provisions of the "Provincial Elections Act": Messrs. R. H. Carson, Straith, Brown, Wismer, Eyres, King, H. E. Winch, Gargrave, and Love.

On the motion of Mrs. Hodges, seconded by Mrs. Rolston, it was Resolved,-

That this House authorize the Select Standing Committee on Social Welfare to consider the questions of cancer control, arthritis, and maternity benefits, with power to send for persons, papers, and records; to hear representations from individuals and public bodies; and to report to the House such findings and recommendations in respect thereof as the said Committee may deem advisable.

- Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:—
- 1. Do the annual records show that any physicians have been issuing liquor prescriptions in excessive numbers?
- 2. If yes, what action, if any, has been taken by the Attorney-General or Liquor Control Board to prohibit the issuance of prescriptions by such physicians?

The Hon. Mr. Maitland replied as follows:-

- "1. Section 22 of the 'Government Liquor Act' provides that any physician who deems liquor necessary for the health of a patient of his whom he has seen or visited professionally may give to the patient a prescription signed by the physician. While a number of prescriptions issued by certain physicians have been greater in number than those issued by other physicians, it is difficult for the Board to determine whether the number of the prescriptions issued is deemed to be excessive. Where the Board had reason to believe that the authority of physicians to issue prescriptions for liquor had been abused, the Liquor Control Board has endeavoured to correct such abuses by personal contact with the physician, co-operating with the College of Physicians and Surgeons, and legal action.
  - "2. Answered by No. 1."

Mr. Turner asked the Hon. the Minister of Public Works the following question:—
What arrangements, if any, have been made with the Dominion Government which would indicate progress toward the completion of the proposed road between Atlin and the Alaska Highway?

The Hon. Mr. Anscomb replied as follows:-

The Hon. Mr. Hart moved, seconded by the Hon. Mr. Maitland, "That Mr. Speaker do now leave the chair" for the House to go into Committee of Supply.

A debate arose, which was, on the motion of Mr. H. E. Winch, adjourned to the next sitting of the House.

The Hon. Mr. Hart presented the Report of Committee on Resources and Railways, 1945.

Mr. E. E. Winch asked the Hon. the Provincial Secretary the following questions:—

- 1. What forms of mechanical restraint of patients, if any, are used in Provincial and private mental hospitals?
- 2. What is the maximum continuous period during which a patient can be kept under mechanical restraint without relaxation or complete freedom of bodily movement?
  - 3. What regulations are in force to ensure that such period shall not be exceeded?

The Hon, Mr. Pearson replied as follows:-

- "1. There are two forms of mechanical restraint used; namely, camisole and restraining sheet.
- "2. The maximum period is four hours, following which the patient is removed from restraint, bathed if necessary, and always given an alcohol rub and exercised.
- "3. Mechanical restraint is used only on doctor's written prescription. The patient is always under the direct supervision and control of the Supervisor in charge of the ward who is responsible for seeing that this standing order is carried out. The type of camisole used is made of 12-oz. duck fitting over the arms and chest of the patient. It laces up at the back; the ends of the arms are blind and terminate in long straps which may be tied behind the patient rather loosely to merely control rather than eliminate movement of the arms. The restraining sheet is made of 12-oz. duck, the full size of the bed. It goes over the bed and laces underneath the bed thereby forming an envelope in which the patient is placed with the head out on a pillow. It does not prevent movement but limits it to movement within the envelope."
- Mr. E. E. Winch asked the Hon the Provincial Secretary the following questions:—
- 1. What action has been taken by the Government relative to the Resolution passed by the House on March 9th, 1944, "That this House petition the Government of the Dominion of Canada, urging that the 'Old Age Pensions Act' and its regulations be so amended that property used by pensioner as his home and contributions reasonably expected from children, donations, and benevolences be not treated as income" (vide Journals, 1944, page 71)?
  - 2. If any action was taken, what reply was received from the Federal Government? The Hon. Mr. *Pearson* replied as follows:—
- "1. This Resolution was forwarded to His Honour the Lieutenant-Governor on April 21st, 1944, for transmission to the Under Secretary of State, Ottawa.

The Hon. Mr. Weir presented the Report of the Provincial Museum of Natural History and Anthropology for the Year 1944.

Mr. E. E. Winch asked the Hon, the Provincial Secretary the following questions:—

- 1. How many (a) day and (b) dormitory wards are there in Essondale, New Westminster, and Saanich Mental Hospitals respectively?
  - 2. How many of them respectively have radios?
  - 3. What programmes are broadcast and for what periods?
  - 4. Are all of the ward radios in working order at the present time?

The Hon. Mr. Pearson replied as follows:—

- "1. (a) and (b). Essondale: Day wards—male building 11, acute building 6, female building 15, veterans building 4, farm annex 1, farm cottage 2; dormitories—male building 14, acute building 10, female building 52, veterans building 8, farm annex 3, farm cottage 3; dormitories on the female side are divided. New Westminster: Day wards—male 8 and female 7; dormitories—male 8 (divided) and female 7 (divided). Colquitz: There are three day wards and 160 patients sleeping in dormitory wards, the remainder (129) in single rooms.
- "2, 3, and 4. At Essondale loud speakers are installed on each ward and in the dining-rooms during meal times. They are on from 8 in the morning until about 9 at night. The patients prefer the local stations and these are tuned in for them. All radios are in good working order but are not modern; the new orders have not been filled. They could not be renewed due to war conditions. At New Westminster fourteen of the day-rooms are equipped with loud speakers and the other day-room has a radio. The loud speakers were not used during the construction period but are now functioning once more. Suitable programmes are selected. The loud speakers are on for two hours in the morning and two hours in the afternoon. At night special programmes are put on for the older patients. At Colquitz the three wards and the dining-room are serviced by one master radio which is on for periods from 7.15 to 9

a.m., 11.30 a.m. to 1.30 p.m., 4.30 to 6.30 p.m., and any other time when there is any special programme which the patients particularly request. There is another radio in the patients' recreation-room which is operated under the control of the patients themselves. All ward radios are in working condition at the present time. Should any radio go out of order it is immediately serviced."

Mr. E. E. Winch asked the Hon. the Provincial Secretary the following question:— What personnel and equipment facilities are available in each of the three mental hospitals for (a) eye and (b) foot ailments of patients?

The Hon, Mr. Pearson replied as follows:--

- "(a.) Eyes: Essondale and New Westminster, optometrist, staff doctors, nurses, attendants, treatment rooms, and consultant specialists; Colquitz, these are attended to by the visiting physician, Dr. G. Hall, or Dr. J. A. Stewart, eye specialist. (b.) Foot ailments: Essondale and New Westminster, staff doctors, nurses, attendants, and consulting orthopædic specialists; Colquitz, these are also attended to by Dr. Hall."
- Mr. E. E. Winch asked the Hon. the Provincial Secretary the following questions:-
- 1. How many wards are there in each of the three mental hospitals exclusively for male patients?
  - 2. In how many respectively are female nurses part of the ward staff?

The Hon. Mr. Pearson replied as follows:-

- "1. Essondale, 19 wards are used exclusively for male patients; New Westminster, 8 wards are used exclusively for male patients; Colquitz, all male patients at this institution.
- "2. Essondale, female nurses are used on two wards, E-2 and infirmary; New Westminster, one male ward of small boys has female nurses on its staff; Colquitz, there are no female nurses employed at this institution."
