REPORT LEGISLATIVE COMMITTEE ROOM,

June 21, 1977

MR. SPEAKER:

I am pleased to present the report of the Special Committee of the Legislative Assembly setting out our recommendation to the Assembly for the selection of an Auditor General.

Recruitment

The Special Committee was formed pursuant to section 2 (2) of the Auditor General Act, 1976 (a copy of the act is given as Appendix A of this report).

The Committee held its first meeting on August 3, 1976, to plan and agree upon the requirements for the position of the Auditor General and the approach to be used in attracting qualified applicants.

The Committee resolved to place an advertisement in major newspapers across Canada (a copy of this advertisement is given as Appendix B to this report). In addition the Institute of Chartered Accountants of British Columbia was alerted to our advertisement and asked to encourage suitable members of that Institute to apply.

As a result of these efforts we received a total of 55 applicants for the position of Auditor General. Candidates responded from every province in Canada.

Preliminary Screening

The Committee carried out a preliminary screening of the 55 applicants on the basis of their written presentations. As a result of our preliminary screening the list of candidates was reduced to 22 which we then processed for further evaluation.

Candidate Evaluation

The Committee decided at this point to consider the services of a consulting firm to carry out interviews and other investigations of the 22 remaining candidates. The management consulting firm of Stevenson & Kellogg, Ltd., was selected and accordingly members of the Committee met with the Vice-President of that firm in the Stevenson & Kellogg, Ltd. Vancouver Office, on December 16, 1976. We outlined our needs and asked for a written submission of their program for evaluation and applicable budget. A detailed written proposal of Stevenson & Kellogg, Ltd. was considered by the Committee and accepted at a meeting on January 12, 1977.

The consultants were required to interview each of the candidates in depth and check carefully each candidate's credentials and references. They were also required to seek advice from the Federal and several Provincial Auditors General on the most desirable characteristics of the person required for this post. Operating from their offices across Canada, Stevenson & Kellogg, Ltd. carried out the required evaluations and investigations and presented a written report in late February 1977. This report contained the results of the evaluations for each of the 22 candidates together with special mention of five whom the consultants considered most promising as finalists.

Finalists Selection

The Committee reviewed the written evaluation of the 22 candidates prepared by the consultants and then met with representatives from Stevenson & Kellogg, Ltd. to discuss the evaluations in detail.

It was unanimously agreed that all five candidates suggested by the consultants should be interviewed.

Accordingly, your Committee met with three of the five candidates on April 6, 1977, and the other two on April 8, 1977. The Committee was most impressed with the calibre and background of the five finalists.

The Selection

After interviewing the five finalists the Committee members carefully reviewed and discussed the qualifications of each finalist as well as having further discussions with the consultants. It was the Committee's unanimous decision to select the following candidate as our recommendation to the Legislative Assembly:

Mrs. Erma P. Morrison, C.A. Post Office Box 758 Fredericton, New Brunswick E3B 5B4.

Mrs. Morrison is a Chartered Accountant and a member of the Institute of Chartered Accountants of Prince Edward Island, Nova Scotia, and New Brunswick. She obtained her qualification in 1948. She has attended a number of professional development and management courses in the interim. She is also a Certified Internal Auditor.

Active in the affairs of the Institute of Chartered Accountants, Mrs. Morrison has served as President of both the Prince Edward Island and New Brunswick institutes and has served on a number of committees. She has been on the Board of Directors of the Atlantic Provinces' Association of Chartered Accountants. Nationally she was a member of the Council of the Canadian Institute of Chartered Accountants for two terms and active on a number of national committees. Mrs. Morrison is currently Deputy Auditor General and Appointee as Auditor General for the Province of New Brunswick. She joined the Provincial Public Service in 1965 as an auditor and assumed her present position in 1975. As Deputy Auditor General she is responsible for the administration of the office, recruiting, staffing and training, improving and co-ordinating programs, and for the direct and extensive participation in the preparation and editing of the Auditor General's Annual Report to the Legislative Assembly of New Brunswick.

Prior to joining the Public Service, she had her own practice for approximately 10 years in Moncton, New Brunswick.

In announcing our unanimous recommendation to the Legislative Assembly, I wish to place on record the splendid degree of interest and co-operative spirit which all members of the Committee displayed in bringing our task to a successful conclusion. I would also want to acknowledge the special efforts of Mr. Elwood Veitch, M.L.A. (Burnaby-Willingdon), who acted as Secretary of the Committee. His assistance in co-ordinating the meetings and communicating with the candidates was most appreciated.

Mr. Speaker, your Committee unanimously recommends to the Legislative Assembly that the name of Mrs. Erma P. Morrison be recommended to the Lieutenant-Governor for the position as Auditor General to exercise the powers and perform her duties as provided by the *Auditor General Act*.

Mr. Speaker delivered his reserved decision on the matter raised by the Member for Prince Rupert and quoted a previous ruling of the Chair from the Journals of the House, November 1, 1974 (2nd Session) at page 284 as follows:

"Honourable Members—I have given urgent consideration to the proposal by the Honourable the Leader of the Opposition for an emergency debate under Standing Order 35. I point out that May, in the 17th edition, which is the one that sets out all the rules with regard to such debate, very clearly states, with many examples on pages 364 through to 367, that the matter must be definite. That is, not a generalized matter, but a specific matter than can be isolated into an emergency, a very important situation, but where it must be debated now, and those instances, as you will note in looking through the authorities, are very few.

I will just recite what May says in general on the matter: 'It must be a single specific matter,' according to May at page 364. It must not be couched in general terms or covering a great number of cases; it is not offered when facts are in dispute or before they are all available; and it must not import an argument. In other words, it must be something that everyone can agree right away, instantly, that there is urgency of debate.

Now there are many instances in all the authorities, as I found in the House of Commons in Ottawa and at Westminster, where cases of unemployment and matters of a general nature which are an economic situation have been dealt with. Indeed, in our own jurisdiction on numerous occasions Speakers have dealt with

this matter, and I can do no better than refer the honourable members to volume 2 of Speakers' Decisions. Mr. Speaker Pauline at page 69 ruled out the matter of unemployment for urgency debate, and stated it must be done upon notice. He repeated that decision in the same year again, on the ground that I quoted from May, because it was an emergency situation in the general economy. He stated that the unemployment situation had reached the most acute stage and become of great urgency and public interest but, none the less, because we are bound by these rules respecting generality of such a subject, it was not an appropriate one, according to May, for an emergency debate.

Again, in 1923, this was ruled out of order on the same question of unemployment and also on a matter dealing with labour. All of these decisions are

found in volume 2 of Speakers' Decisions.

In Ottawa the question of the effect on the footwear industry, which laid off thousands of employees, became of such urgent consideration that the same motion was sought for an emergency debate and there, again, Mr. Speaker Lamoureux rejected it. I can give you various examples of that, for instance, on June 20, 1970, in the House of Commons records, and all of them lead to the same result.

Consequently, I am bound to follow the precedents I have recited and in view of that, in my opinion, the matter does not fall within the scope of Standing

Order 35."

Mr. Speaker stated the present matter was parallel to the decision referred to and accordingly the matter raised by the Honourable Member did not fall within the scope of Standing Order 35.

Honourable Members—On June 28, 1977, the Honourable Member for Nanaimo rose on a point of privilege and alleged that the Honourable Member for Coquitlam had improperly "persuaded" a witness, Mr. Norris, from attending a scheduled meeting of the Select Standing Committee on Public Accounts and Economic Affairs and had thereby committed a breach of privilege.

In reaching my decision I have considered the authorities cited by the Honourable 1st Member for Vancouver Centre and I have carefully examined the material provided by the Honourable Member for Nanaimo, namely, a memorandum addressed to him from the Honourable Member from Coquitlam

and his reply thereto.

I also note that, (1) under Standing Order 72, the Chairman and the members of a committee have the right to call witnesses in accordance with any agenda agreed to by the committee or arranged by the Chairman with the general consent of the committee, although no person has the right to bar the attendance of a witness; and that, (2) the Votes and Proceedings of this House for the 2nd day of March 1977 contain a list of the members of the committee and show that it is composed of 17 members representing all parties.

In his memorandum the Honourable Member for Coquitlam requested adjournment of a meeting scheduled for the following day as he had been advised that the Social Credit members on the Committee would be unable to attend.

Standing Order 71 (2) indicates that a quorum of the Committee would be a majority of its members, and based on information provided to the Chairman there could be no quorum for the meeting in question. That this was obvious on June 27 is confirmed by the letter of the Honourable Member for Nanaimo of the same date, which reads in part as follows:

"I have checked and established that all four of the NDP members will be present. I do hope that at least five of the Social Credit committee members will attend so that we may proceed with a quorum. . . ."

Any question of why a quorum was unable to be present is not before me

and is not relevant to my consideration of the matter.

In applying the words used by the Committee on Privileges (House of Commons, Westminster, June 6, 1934) I cannot find in this material "even an allegation or suspicion of corruption or intimidation or of any appeal, direct or indirect, to greed or fear". There is no evidence of any attempt in the context to a matter of privilege "to persuade" a witness not to attend. On the contrary, the memorandum of the Honourable Member for Coquitlam expressly requests that "the B.C. Rail delegation be recalled at a later date."

I can find no authority to suggest that it would be improper, as Secretary of a Select Committee, for a member, or his staff, to inform a witness that he need not appear on a particular occasion based on information that a scheduled meeting of the Committee could not transact business by reason of lack of a quorum.

The authorities I have referred indicate that it would require a positive move to intimidate, hinder, or deter with a wrong motive, a witness in order to constitute a contempt and such a situation is not indicated in the material at hand.

I therefore rule that no prima facie breach of privilege has been raised.

The Committee rose and reported progress. Report to be considered at the next sitting. Committee to sit again at the next sitting.

Mr. Speaker delivered his reserved decision relating to the matter of privilege previously raised by the Member for North Vancouver-Capilano, as follows:

Honourable Members:

On July 11, the Honourable Member for North Vancouver-Capilano read a statement which sets forth a number of actions which in his view presume the passage of Bill (No. 65) and alleges that a breach of privilege has been committed thereby.

The first action is that the Deputy Minister of Human Resources by letter, dated July 6, advises that specific approval of the Deputy Minister would be required for payments of \$5,000 or over, and in so doing, takes for granted the passage of Bill (No. 65).

The second action is that the Department of Public Works has measured space in the Vancouver Resources Board offices which the Honourable Member suggests is "under the assumption of a Provincial take-over."

The third action is that there has been an examination of the file systems of the Vancouver Resources Board which the Honourable Member suggests is in "preparation for integration."

The Honourable Member states his opinion that "The activities enumerated seek to make effective by Executive action what the Legislature has not yet, and may never provide for, by legislative action, and is, therefore, in contempt of the Legislature."

The Honourable Member further expresses his opinion that the action by the Deputy Minister is in contempt of the Legislature or by the Minister of Human Resources if the Deputy was acting under instruction.

As Honourable Members know, it is the duty of the Speaker as stated in May, 18th edition, page 226, and I quote: "Under usage when a complaint of breach of privilege is raised he has to decide whether a *prima facie* case has been made out which would justify such proceedings taking precedence over the other business of the House."

In reaching my conclusion on the matter raised I have considered the following passage from May, 18th edition, at page 132, under the heading "Acts or Conduct Constituting Breach of Privilege or Contempt", and I quote: "It may be

stated generally that any act or omission which obstructs or impedes either House of Parliament in the performance of its functions, or which obstructs or impedes any member or officer of such House in the discharge of his duty, or which has a tendency, directly or indirectly, to produce such results may be treated as a contempt even though there is no precedent of the offence."

The facts alleged do not, in my opinion, disclose any conduct tantamount to obstructing or impeding the House or any member in the discharge of his duties. I note that the Honourable Member has made no such charge but he complains of a "contempt of the House" arising from the enumerated actions. Without going into the merits of the case one can readily conclude that it would be only prudent, if not incumbent, upon a ministry of the Government to take preparatory steps in contemplation of the passage of legislation. I cannot see that to do so would impede the House or any member thereof in the performance of their functions.

If the actions complained of were thought to be improper or unlawful per se, then as stated in a ruling of Mr. Speaker Dowding (Journals 1975, page 209), "it would be a case to take up by one of several means at hand: By setting down a motion of privilege with notice, or instructing a Committee, or by normal debate as the occasion presents itself within the rules during Estimates, or when a specific Bill is called relating to this subject."

I find that no *prima facie* case of breach of privilege has occurred which would justify the complaint taking precedence over the other business of the House.

Mr. Speaker delivered his reserved decision relating to the matter of privilege previously raised by the Honourable Minister of Highways and Public Works, as follows:

Honourable Members:

On July 6 last, I took under advisement a matter of privilege raised by the Honourable Minister of Highways and Public Works.

I refer the Honourable Members to the ruling I have just concluded and, in accordance with the authorities therein cited, I find that the matter complained of would not impede the Honourable Minister in the discharge of his duties and rule that no *prima facie* case of privilege has been established which would require the ordinary business of the House to be set aside.

The Hon. E. M. Wolfe replied as follows:

"For the purposes of the fiscal year 1976/77 Quarterly Financial Reports, the Ministry of Finance made an independent estimate of the monthly cash flow

of the 1976/77 budget appropriation for each ministry, except for the salary contingencies, interest on public debt, and natural gas producers deemed income Federal income tax liability expenditures in the Ministry of Finance. The unique nature of these expenditures required their separation from the Ministry of Finance total budget for cash flow analysis. The forecasts of the monthly cash flows of the 1976/77 budget appropriations for each ministry were based essentially on recent and anticipated expenditure experience.

"1. The information on under-expenditure by vote in relation to the third quarterly report is not available for the Ministry of Human Resources as the original budget forecast was prepared on a monthly basis for total expenditures

for the Ministry.

"2. As explained above, certain under-expenditures by vote in the Ministry of Finance are available as follows: Vote 69—\$11,200,000; Vote 73—\$15,600,000; all other votes—\$3,300,000.

"3. Under-expenditures by vote are not available as the original budget forecasts were prepared on a monthly basis for total expenditures by ministry. Underexpenditures by ministry were: Health, \$17,400,000; Housing, \$14,300,000; Energy, Transport and Communications, \$11,200,000; and Forests, \$10,500,000. The above amounts do not total \$29,000,000 as there were under-expenditures and over-expenditures in other ministries which are included in the net amount."

95 Mr. Wallace asked the Hon. the Minister of Finance the following questions:

With regard to Mr. Bill McMinn, of Woods, Gordon Ltd., who has been retained as consultant to the Government for the purpose of rationalizing computer operations in British Columbia-

- 7. What is the purchase value of the computer machinery ordered so far by Mr. McMinn, and from what firm or firms was it purchased?
- 8. Before the purchase of this equipment, were tenders invited from suppliers of computer equipment and, if so, which firms submitted bids?
 - 9. What were the amounts of these bids?
