REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM, March 24th, 1947.

MR. SPEAKER:

Your Select Standing Committee on Agriculture held several meetings and was addressed by many different organizations.

The Committee recommends the following resolutions, presented by the advisory board of Farmers' Institutes:—

- (1.) That the Government establish an agricultural school in the Interior of the Province where a thoroughly practical training in farm and dairy work could be given, such school to be patterned somewhat after that of the one at Olds, Alberta.
- (2.) That the Department of Lands undertake either the impounding or destroying of wild horses ranging illegally in the District of East Kootenay.
- (3.) That fertilizers and feeds for live stock be contained in new or clean sacks sterilized for the purpose.
- (4.) That farmers desiring land-clearing should be allowed up to five years for payment, the first two years the payments to be nominal so as to give them an opportunity for returns from the cleared land.
- (5.) That the stock-breeders, dairymen, and Farmers' Institutes be represented by a member on the British Columbia Game Board or other boards or commissions that might be dealing with agricultural problems.
- (6.) That the use of coloured gas be reinstated when it is used for other than road purposes.
- (7.) That bounties on wolves be increased to \$50, on cougars to \$40, on coyotes to \$5 the year round, and the hunter to keep the hides.

The Committee discussed the Agrologists' Bill at several meetings, and, with proposed amendments, it was endorsed by the Committee, three members dissenting.

Mr. Carr, the Chairman of the Milk Control Board, was present at one meeting, and, after a full discussion on the workings of his office, the Committee was of the opinion that present control of milk reacted favourably to both producer and consumer.

It is a matter of regret to every member of your Select Standing Committee on Agriculture that Mr. Louis LeBourdais, M.L.A., through illness, was precluded from participation in our deliberations. In former years Mr. LeBourdais has served in the capacity of secretary and later of chairman of the Select Standing Committee on Agriculture and his absence was keenly felt by the other members of the Committee.

Prayers by Major N. B. Bell.

Mr. Speaker delivered his reserved decision on the point of order raised by Mr. H. E. Winch on the 26th instant, as follows:—

Honourable Members,—I have considered the point of order raised by the Honourable the Leader of the Opposition with respect to the amendment proposed by the honourable second member for Vancouver-Point Grey to motion No. 3.

The Honourable the Leader of the Opposition contends that the amendment is out of order because, in effect, it negatives his motion, which is for the appointment of a Select Special Committee of the Legislature. This is a novel and ingenious contention, but if it were sound the result would be that there could be no amendment to a motion for a Select Committee unless the amendment made provision for a Committee to be appointed. I do not think that this is the effect of the Rules relating to the relevancy of amendments. The amendment in question, so far as it goes, deals with one of the matters covered by the motion. Mr. Speaker Pooley, in a decision which will be found on page 5 of Volume I. of the Speakers' Decisions, ruled an amendment out of order on the following grounds:—

"There is a total absence of congruity between the proposed amendment and the main motion, so that the amendment is a new proposition upon a different subject. The amendment ought to be essentially analogous to the main question and be so framed that, if agreed to, the question, as amended, would be intelligible and consistent with itself."

I think the amendment proposed by the honourable second member for Vancouver-Point Grey complies with the requirements as laid down by Mr. Speaker Pooley, and in my opinion is in order.

MR. SPEAKER:

Your Select Standing Committee on Municipal Matters begs leave to report as follows:—

Several meetings of this Committee were duly held.

The executive of the Union of British Columbia Municipalities appeared before the Committee and presented amendments to the "Municipal Act" and to the "Municipal Elections Act." The Department of Municipal Affairs submitted amendments to the "Municipal Act" and to the "Village Municipalities Act."

Interested parties were given a hearing. A number of amendments were approved and will, in due course, be submitted to this Legislature for enactment.

The Committee approves the request of the Union of British Columbia Municipalities that the Provincial Government assume the responsibility for uniform changes in time throughout the Province.

The Committee further recommends that serious consideration be given to the following subjects:—

Taxation of Occupiers of Crown Lands.

Fraser River Authority or Control Board.

The problem involved in the taxation of occupiers of Crown lands is one of administration only; the principle of this taxation is now contained in the Statutes.

Matters relating to the control of the Fraser River are of grave concern to the affected municipalities.

In view of the annual appeals made by the municipalities affected for changes in the daily fees charged for horse-racing and the difficulty of deciding a fixed amount for any or all municipalities, the Committee further recommends that the Government consider a revision of its policy in respect of the collection of taxation from horse-racing with a view to reimbursing the municipality in which the taxation is collected for services supplied.

The Committee wishes to express its appreciation to the Minister and Deputy Minister of Municipal Affairs and to the executive of the Union of British Columbia Municipalities for assistance and advice.
